I've been a writer and producer of television and movies working in Hollywood for over 30 years. One of my recent jobs was on the TV series *Homeland*, where I was involved in creating the season just concluded. The season was about information warfare. It's a little-discussed subject, and it took a lot of research to find out exactly what this protean form of conflict is all about. The past season of *Homeland* offers a pretty good primer in some of the basic techniques and counter techniques.

In the course of my duties I happened to be loitering in a corner of the net frequented by cyber mercenaries. October 2017, I was in this anonymous digital casbah when something entirely ordinary happened. A poster dropped some "bombshell" intelligence. This anonymous entity called himself "Q" short for 'Q clearance patriot', and became known as Qanon, or Q and the Anon's. A Q clearance is the highest security clearance issued by the Department of Energy. It's basically a go-anywhere, talk to anyone, look at anything pass.

“Anons,” as the anonymous contributors to these forums are called, are often misfits. Some are autistic, or identify as such. These Anon's pride themselves on their ability to discriminate, to see things normal people miss, and on never being deceived. So there was no way they were buying Q.

On the chans, the cluster of websites known as 4chan and 8chan, there's something called a LARP, which stands for 'Live Action Role Play'. Anonymous imposters (L.A.R.P.ers) are common as dirt, and the autists thrive on ripping their pretense to shreds. So they set on Q like termites on fresh pine.

Q was supposedly a Trump confidant, working inside the administration. He had access to the man himself and to the most sensitive intelligence on key fronts. His posts were framed as dispatches from the shadow war between the deep state establishment (CABAL) and the Trump Alliance, the intended audience for which was the weird, huge pro-peace digital community which definitely does not get its news from ThinkProgress, or the *New York Times*, or even Fox News. You might think of it as Twitter for the great unwashed.

Yet where Twitter is a single “micro-blogging” advertising platform controlled by a man named Jack Dorsey who presents himself as having left-leaning celebrity-friendly politics, the underground community that Q was targeting does not have a single, shiny, brand-name home. Instead, it lives on a variety of bulletin boards, Facebook pages, etc. which host long forensic chains, and serve as assembly and distribution points for photo-hieroglyphic memes, which help knit this community together.

For some, this new form of information—or misinformation, or propaganda, or distributed reality-building, or whatever you want to call it—functions as the expression of a counter-aesthetic to the self-flattering collective reality that is manufactured for and by liberal arts college graduates on websites like Vox. For others, it is a political technology that allows for bottom-up distributed participation in building out story-lines, whose direct purpose is often to counter the story-lines that are broadcast by digital news organizations, often at the behest of professional political operatives, whether government or ex-government officials or hired guns like Fusion GPS. For others, perhaps many millions of them, it is a worm-hole into an *X Files*-like counter-truth which they believe to be real, which includes phenomena like Pedogate or warnings about secret pedophile rape camps.

Q's appearance caused considerable debate among the Anon's, and many “sperged out” before the matter was settled. Now, over 2 years and hundreds of proofs later, many believe that Q anon was exactly who he (or she) claimed.

Q started dropping “truth bombs” sometimes two and three times a day. The Anon's would go crazy spotting connections and digging up evidence publicly available on the Internet. They were building a parallel construction (re-writing history), following Q's crumbs to uncover rich lodes of evidence, which they processed and assembled into distributable forms, some of which were posted on 4chan. The individuals, institutions, and shadowy nation state actors being targeted by these memes, many of them heavily researched, struck back. Automated computer processes started posting child pornography, pictures of corpses, intermingled with user posts filled with hateful filth, turning the forum into a garbage dump. Q then led the Anon's out of 4 chan like a latter-day Brigham Young to another website called “the Great Awakening.”

When this second location was compromised, Q led another exodus, this one to a site somewhat protected from hostiles (how, and by whom, are surely fascinating questions to contemplate). The website is still populated with misfits and infested with whatever kinds of political operatives and spies, or people posing as such, but the collective research goes on, and the computerized attacks have been

somewhat neutralized well at least enough to maintain progress.

Do you know about predictive modelling in computers? I didn't. I'm a writer, a generalist, not a scientist, but I watched a few training videos on the subject. Large technology companies and government intelligence agencies do predictive modeling using the [machine learning language R with 'caret'](#) (Classification And REgression Training.) In the same way autistic people easily spot connections that normal people miss, machine learning sees causality that even autistic people are not able to process. Q and his colleagues appear to have used these techniques to model contingencies and to guide the development of their plan, while providing their followers with tactical guidance and updated predictions with data continually updated from reality.

To build such a machine, Q needed services unavailable on the market at any price. He needed a few hundred world wide, highly intelligent, autistically-inclined people of disparate talents to network together. Try hiring those, and if you have 20 million you're prepared to spend, how are you going to manage them?

I believe that Q had this figured out, too. You can't bully an Anon, and they are not primarily motivated by money. The same way an autistic can't stand something like magazines left in disorder on a coffee table, they can't stand living with obvious contradictions and lies. So, they are highly motivated truth-seekers. I think most of us are, to the degree that we have time; but where do you find it? The truth is a needle and out there are a thousand haystacks. Q knew that if he could convince the Anon's he was who he claimed, they would work night and day for him.

When the President made his trip to Singapore 2017, Q had a special present for the Anon's. It was a photograph taken from the window of a plane, below clouds, with a bit of a mountain poking through. So what? Q's Anon's photo analysts geo-located the photograph in an hour. It was taken on ascent out of Pyongyang airport, and suggested Air Force One had made an unscheduled stop. The President met the little rocket man and closed the North Korea nuke deal, November 2017. The Singapore meeting was just a show for the people and the mainstream!

Skeptical? I don't blame you. Q says they have done the same deal with Iran. That there is going to be peace there too. Peace throughout the Mideast. So let's wait and see. The world today is full of lies, which we politely call disinformation.

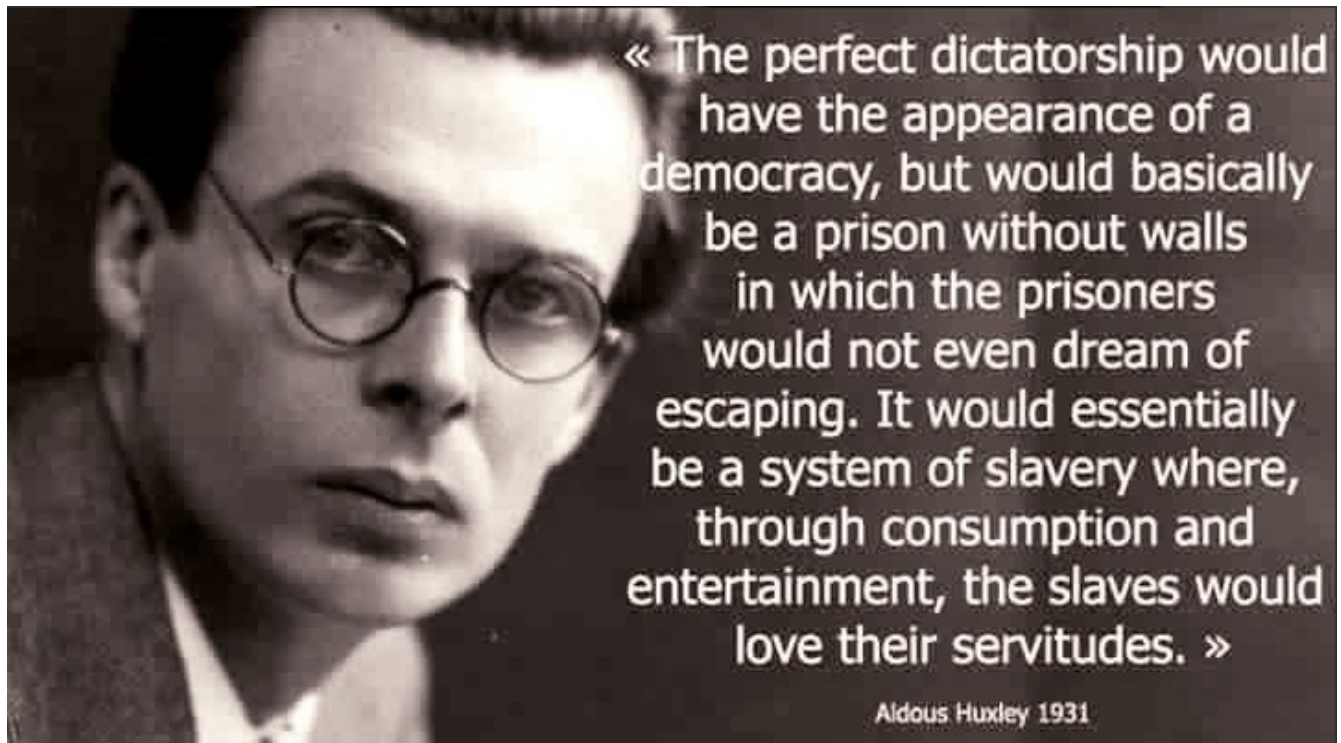

History

Due to an historic perversion and expert mind programming labeled as Babylonian Slave Driving Techniques. We are unwillingly being good obedient/oblivious slaves.

At the dawn of human history, some 6000 years ago, in the ancient city of Babylon, a spurt of great prosperity in agriculture brought about a population boom and the formation of family tribes, which also spirited a frenzy of fights and battles within and between these groups in an effort to establish tribal supremacy. Out of this confusion arose an intelligent and tyrannical individual by the name of Hamurabi. Hamurabi devised a system of mind control, population control and laws of conduct and trade, which was later defined as: The Babylonian Slave Driving Techniques. Hamurabi's system of controls was reduced into writing, in which he combined local folk wisdom and prophecy in an effort to lend to his system more credibility among the tribes and he included additional propaganda about the existence of an omniscient, omnipresent, Almighty God, who saw all things, rewarded all deeds and punished all misconduct.

NOTE: There was another civilization the size of the ancient Roman Empire that existed near the City of Babylon some two thousand years earlier, which has just recently been discovered by archeologists and it would be a reasonable conclusion or assumption that the folk wisdom and prophecy of Babylon was actually derived from this earlier civilization. The continent of Atlantis however existed several thousands of years before that, which continues to be denied by the royal and elite faction through their slave drivers, paid historians, paid scientists and media representatives.

Hamurabi's system of control, conduct, folklore and prophecy preempted the Christian Holy Bible and the general laws of government. His trade laws would eventually become known as the Law of Merchants, which is still used and recognized today internationally as the Uniform Commercial Code. Hamurabi plagiarized the concept and existence of an Almighty God, which had been prophesized for many years in folk legend and he cleverly included himself in these writings as the man name d: Abraham.

NOTE: As you read on you will see that according to these Asian historians, they have concluded that the Christian Holy Bible was actually compiled by the royal and elite classes to be used as a tool to keep them in power and to help them control and drive the ignorant and unwashed masses defined as their slaves!

Individuals in Mesopotamian eventually built upon Hamurabi's concept of crowd mind control, his all-seeing and all-knowing God, and the prophecy of Abraham. One of their members, a bearded man with a charismatic persona, appeared out-of-clean-air, sat upon a throne and proclaimed to all of the tribes that his royal status and bloodline was derived from none other than - Abraham.

There was no way to prove the truth of his statements and so in order to maintain this belief of his royal status and retain absolute control over the many tribes, a series of great visual aids and displays resembling miracles were engineered. Next, this god-king employed and empowered a special sect of slave drivers to further cement his will and control over the people, which initiated the birth of the Freemasons. One tenth of the wealth of the tribe's agriculture would be demanded of and surrendered to this god-king as a tax upon his subjects, which he called tithing.

Eventually, the combined tribes invaded the pagan empire of Egypt and the Freemasons added the Egyptian slave driving Techniques to their arsenal of knowledge. The symbol adopted by the Freemasons to identify their special sect was plagiarized from the pagan religion of Egypt, which was the 'all-seeing-eye' encased in the apex of a pyramid and which was intended to convey to the masses that their duties and authority was superior to them and was derived from the all-seeing and all-knowing Almighty God.

These slave control techniques created a parallel cultural evolution between the royal and elite ruling class and the ignorant, unwashed masses, by utilizing a combination of knowledge, food and financial restraints, which included a forced superiority over life and death! Any unusually intelligent individuals who discovered or deduced the true nature of this royal and elite movement were either inducted into it, murdered, or their position and influence was neutralized by an assortment of other devious means.

The royal and elite ruling class was constantly confronted by numerous rebellions. The same principal is applied in America this date!

After Rome invaded Judea and scattered the Jews, the Freemasons began to offer their services to other Kings and despots. Roman Emperor Constantine was convinced by one sect of Freemasons, to compile

a book of his own, which would encompass the Christian folk beliefs and prophecy and the Pagan beliefs of his people, establish his laws of conduct, and thus provide

The Roman Church at this time was totally a pagan church composed of doctrines that encouraged murder, human sacrifice, devil worship, peonage, the accumulation of wealth, and the worship of demon-god like idolatry. Emperor Constantine deduced that he needed to either crush or utilize the tide of this Christian rebellion, which was devouring his Kingdom and so Constantine ordered that the basic principles of the pagan Roman Church and the new Christian movement be merged together into one religion at the Council of Nicaea, which resulted in the birth of The Holy Roman Church.

Over many centuries to pass, the doctrines of The Holy Roman Church have been constantly expanded upon by the absorption of other ideas and beliefs procured from other religions, prophets and folklore. Those ideas and beliefs that were considered palatable to the royal and elite classes were promoted relentlessly in an effort to establish a universal mental control and culture!

NOTE: All of the Royal families located in Europe, Asia and South America eventually inter-married to make them all related by marriage. This was done to strengthen their royal bloodlines and to eliminate wars between the royal classes. Then they pooled their wealth to create a new business enterprise, which was the financing of currency for various world governments with the underlying motive to control and influence those governments through the debt that was owed to them. To increase the debt owed to them, they helped to instigate wars and conflicts between various countries and people.

A philosophical riff eventually developed between the European royal family factions regarding their beliefs in an Almighty God and their purpose and duties toward mankind. This riff split the royal families into two factions: the European royalty and the Chinese Royal Family. These are just names. The European royal family conceals their power and intervention behind the Rothschild name, a group which included most of the Nordic, Eastern European families, some Central and South American countries and the Vatican. The Sabbatean Jews follow the ancient religion of Babylon and practice an anti-traditional philosophy, which is highly pagan and which explains their attraction and connection to the Vatican. This faction believes that the concept of an Almighty God is an historic prevarication premised upon folk legend and/or prophets of the time and that their only duty was to the royal family, the elite class, the accumulation of greater wealth and their continued domination over governments and the ignorant, unwashed masses defined as their slaves.

The appointed administrator of the Jesuits is called "The Black Pope" and his pulpit is located within the confines of the United States Pentagon! He is Illuminati and on special occasions dons the traditional black robe of the Illuminati Priests. "The White Pope" is the Chief administrator of the church and the positive public image that the corporate Holy Roman Church desires to propagate upon the world's masses. His pulpit is located within the confines of the Vatican of Rome. He dons a white robe gilded in gold, which is supposed to symbolize the Almighty God's purity, property and the wealth of the Earth.

The reformation by Martin Luther was another rebellion against this Royal Catholic mono-culture and their Babylonian system of slave controls. Many of the European people being persecuted for their objections and ideas to these control techniques, found freedom from persecution in the New World and as a result, America flourished as no other civilization before it!

In a parallel to the genuine religious belief and feeling of the American people, manipulators from the European royal faction, secretly infiltrated the American society and the new deceptive concept of

government that certain American leaders were attempting to establish. These manipulators then planned and evolved increasingly sophisticated ways to regain control over their deposed slaves and control over the new Republican American government.

Several of the manipulations they employed were designed to drive the people into conflict and war, to strengthen them through competition, to reduce their population growth and to profit from the sale of arms to them. The European faction used the gold and jewels they had looted from India during the middle ages to finance both England and America during the American Revolution and the War of 1812. Their additional goal was to strengthen their influence over the King of England and regain control over their English slaves. This is also how Freemasonry became so central to the development and history of both England and America.

NOTE: The Chinese Royal Family faction had initially provided financing for the expansion and improvement of America but vacated their presence once the European faction sufficiently dug their claws into the corrupt American government and the life blood of the country and the rest is history.

There was a true idealism in the American adventure however the original concept of American Democracy proved to be too unruly and too difficult for the European faction to control! After the European royal family secured control of America's assets, by the passage of the Federal Reserve Act in 1913, their first planned strategy was to initiate preparations to immerse North America into a world war, which was accomplished by cleverly arranging for the sinking of the Lusitania and the circulation of propaganda world-wide, which accused the government of Germany "for this despicable act of cowardice!"

NOTE: It will not be discovered until some 80 years later that the Lusitania actually sunk from an internal explosion in the fire room, which could have been the result of a strategically placed bomb next to one of the ships boilers as opposed to a torpedo delivered from a German submarine! The American people believed the fictitious printed rumors instead of demanding proof, which eventually will become the American rule rather than the American exception! The American public has been taught to believe that everything reported by the media is the absolute truth, which succeeded in making them mentally lazy and highly gullible!

Chapter 2

United kingdom created Israel and Saudi Arabia

Sabba – As Mike Piper would say, whenever we see ‘British Empire’, we should read the ‘Yiddish Empire’ instead. One can not understand why the bin saud do what they do without understanding that Wahhabi is the Arabic offspring of Judaism.

The covert alliance between the Kingdom of Saudi Arabia and the Zionist entity of Israel should be no surprise to any student of British imperialism. The problem is the study of British imperialism has very few students. Indeed, one can peruse any undergraduate or post-graduate British university prospectus and rarely find a module in a Politics degree on the British Empire let alone a dedicated degree or Masters degree. Of course if the European led imperialist carnage in the four years between 1914 – 1918 tickles your cerebral cells then it’s not too difficult to find [an appropriate institution](#) to teach this subject, but if you would like to delve into how and why the British Empire waged war on mankind for almost four hundred years you’re practically on your own in this endeavour. One must admit, that from the British establishment’s perspective, this is a formidable and remarkable achievement.

In late 2014, according to the American journal, “[Foreign Affairs](#)”, the Saudi petroleum Minister, Ali al-Naimi is reported to have said “His Majesty King Abdullah has always been a model for good relations between Saudi Arabia and other states and the Jewish state is no exception.” Recently, Abdullah’s successor, King Salman expressed similar concerns to those of Israel’s to the growing agreement between the United States and Iran over the latter’s nuclear programme. This led some to report that Israel and KSA presented a “[united front](#)” in their opposition to the nuclear deal. This was not the first time the Zionists and Saudis have found themselves in the same corner in dealing with a perceived common foe. In North Yemen in the 1960’s, the Saudis were financing a British imperialist led mercenary army campaign against revolutionary republicans who had assumed authority after overthrowing the authoritarian, Imam. Gamal Abdul-Nasser’s Egypt militarily backed the republicans, while the British induced the Saudis to finance and arm the remaining remnants of the Imam’s supporters. Furthermore, the British organised the Israelis to drop arms for the [British proxies in North Yemen, 14 times](#). The British, in effect, militarily but covertly, brought the Zionists and Saudis together in 1960’s North Yemen against their common foe.

However, one must go back to the 1920’s to fully appreciate the origins of this informal and indirect alliance between Saudi Arabia and the Zionist entity. The defeat of the Ottoman Empire by British imperialism in World War One, left three distinct authorities in the Arabian peninsula: Sharif of Hijaz: Hussain bin Ali of Hijaz (in the west), Ibn Rashid of Ha’il (in the north) and Emir Ibn Saud of Najd (in the east) and his religiously fanatical followers, the Wahhabis.

Bin Saud had entered the war early in January 1915 on the side of the British, but was quickly defeated and his British handler, William Shakespear was killed by the Ottoman Empire’s ally Bin Rashid. This defeat greatly hampered Bin Saud’s utility to the Empire and left him militarily hamstrung for a year. [1] The Sharif contributed the most to the Ottoman Empire’s defeat by switching allegiances and leading the so-called ‘Arab Revolt’ in June 1916 which removed the Turkish presence from Arabia. He was convinced to totally alter his position because the British had strongly led him to believe, via correspondence with Henry McMahon, the British High Commissioner in Egypt, that a unified Arab country from Gaza to the Persian Gulf will be established with the defeat of the Turks. The letters exchanged between Sharif Hussain and Henry McMahon are known as the McMahon-Hussain

Correspondence.

Understandably, the Sharif as soon as the war ended wanted to hold the British to their war time promises, or what he perceived to be their war time promises, as expressed in the aforementioned correspondence. The British, on the other hand, wanted the Sharif to accept the Empire's new reality which was a division of the Arab world between them and the French (Sykes-Picot agreement) and the implementation of the [Balfour Declaration](#), which guaranteed 'a national for the Jewish people' in Palestine by colonisation with European Jews. This new reality was contained in the British written, Anglo-Hijaz Treaty, which the Sharif was profoundly averse to signing.[2] After all, the revolt of 1916 against the Turks was dubbed the 'Arab Revolt' not the 'Hijazi Revolt'.

Actually, the Sharif let it be known that he will never sell out Palestine to the Empire's Balfour Declaration; he will never acquiesce to the establishment of Zionism in Palestine or accept the new random borders drawn across Arabia by British and French imperialists. For their part the British began referring to him as an 'obstructionist', a 'nuisance' and of having a 'recalcitrant' attitude.

The British let it be known to the Sharif that they were prepared to take drastic measures to bring about his approval of the new reality regardless of the service that he had rendered them during the War. After the Cairo Conference in March 1921, where the new Colonial Secretary Winston Churchill met with all the British operatives in the Middle East, T.E. Lawrence (i.e. of Arabia) was dispatched to meet the Sharif to bribe and bully him to accept Britain's Zionist colonial project in Palestine. Initially, Lawrence and the Empire offered 80,000 rupees.[3] The Sharif rejected it outright. Lawrence then offered him an annual payment of £100,000.[4] The Sharif refused to compromise and sell Palestine to British Zionism.

When financial bribery failed to persuade the Sharif, Lawrence threatened him with an Bin Saud takeover. Lawrence claimed that "politically and militarily, the survival of Hijaz as a viable independent Hashemite kingdom was wholly dependent on the political will of Britain, who had the means to protect and maintain his rule in the region." [5] In between negotiating with the Sharif, Lawrence made the time to visit other leaders in the Arabian peninsula and informed them that they if they don't tow the British line and avoid entering into an alliance with the Sharif, the Empire will unleash Bin Saud and his Wahhabis who after all is at Britain's 'beck and call'. [6]

Simultaneously, after the Conference, Churchill travelled to Jerusalem and met with the Sharif's son, Abdullah, who had been made the ruler, "Emir", of a new territory called "Transjordan." Churchill informed Abdullah that he should persuade "his father to accept the Palestine mandate and sign a treaty to such effect," if not "the British would unleash Bin Saud against Hijaz." [7] In the meantime the British were planning to unleash Bin Saud on the ruler of Ha'il, Bin Rashid.

Bin Rashid had rejected all overtures from the British Empire made to him via Ibn Saud, to be another of its puppets. [8] More so, Bin Rashid expanded his territory north to the new mandated Palestinian border as well as to the borders of Iraq in the summer of 1920. The British became concerned that an alliance maybe brewing between Bin Rashid who controlled the northern part of the peninsula and the Sharif who controlled the western part. More so, the Empire wanted the land routes between the Palestinian ports on the Mediterranean Sea and the Persian Gulf under the rule of a friendly party. In March 1924, a year after the British awarded the 'grant' to Bin Saud, the Empire announced that it had terminated all discussions with Sharif Hussain to reach an agreement.[15] Within weeks the forces of Bin Saud and his Wahhabi followers began to administer what the British foreign secretary, Lord Curzon called the "final kick" to Sharif Hussain and attacked Hijazi territory.[16] By September 1924, Ibn Saud had overrun the summer capital of Sharif Hussain, Ta'if. The Empire then wrote to Sharif's sons, who had been awarded kingdoms in Iraq and Transjordan not to provide any assistance to their besieged father or in diplomatic terms they were informed "to give no countenance to interference in the Hedjaz".[17] In Ta'if, Bin Saud's Wahhabis committed their customary massacres, slaughtering women and children as well as going into mosques and killing traditional Islamic scholars.[18] They captured the holiest place in Islam, Mecca, in mid-October 1924. Sharif Hussain was forced to abdicate and went to exile to the Hijazi port of Akaba. He was replaced as monarch by his son Ali who made Jeddah his governmental base. As Ibn Saud moved to lay siege to the rest of Hijaz, the British found the time to begin incorporating the northern Hijazi port of Akaba into Transjordan. Fearing that Sharif Hussain may use Akaba as a base to rally Arabs against the Empire's Bin Saud, the Empire let it be known that in no uncertain terms that he must leave Akaba or Bin Saud will attack the port. For his part, Sharif Hussain responded that he had "never acknowledged the mandates on Arab countries and still protest against the British Government which has made Palestine a national home for the Jews." [19]

Sharif Hussain was forced out of Akaba, a port he had liberated from the Ottoman Empire during the 'Arab Revolt', on the 18th June 1925 on HMS Cornflower.

Bin Saud had begun his siege of Jeddah in January 1925 and the city finally surrendered in December 1925 bringing to an end over 1000 years of rule by the Prophet Muhammad's descendants. The British officially recognised Bin Saud as the new King of Hijaz in February 1926 with other European powers following suit within weeks. The new unified Wahhabi state was rebranded by the Empire in 1932 as the "Kingdom of Saudi Arabia" (KSA). A certain George Rendel, an officer working at the Middle East desk at the Foreign Office in London, claimed credit for the new name.

On the propaganda level, the British served the Wahhabi takeover of Hijaz on three fronts. Firstly, they portrayed and argued that Ibn Saud's invasion of Hijaz was motivated by religious fanaticism rather than by British imperialism's geo-political considerations.[20] This deception is propounded to this day, most recently in Adam Curtis's acclaimed BBC "[Bitter Lake](#)" documentary, whereby he states that the "fierce intolerant vision of wahhabism" drove the "beduins" to create Saudi Arabia.[21] Secondly, the British portrayed Ibn Saud's Wahhabi fanatics as a benign and misunderstood force who only wanted to bring Islam back to its purest form.[22] To this day, these Islamist jihadis are portrayed in the most benign manner when their armed insurrections is supported by Britain and the West such as 1980's Afghanistan or in today's Syria, where they are referred to in the western media as "[moderate rebels](#)." Thirdly, British historians portray Bin Saud as an independent force and not as a British instrument used to horn away anyone perceived to be surplus to imperial requirements. For example, Professor Eugene Rogan's recent study on the history on Arabs claims that "Ibn Saud had no interest in fighting" the Ottoman Empire. This is far from accurate as Bin Saud joined the war in 1915. He further disingenuously claims that Ibn Saud was only interested in advancing "his own objectives" which fortuitously always dovetailed with those of the British Empire.[23]

In conclusion, one of the most overlooked aspects of the Balfour Declaration is the British Empire's commitment to "use their best endeavours to facilitate" the creation of "a national home for the Jewish people". Obviously, many nations in the world today were created by the Empire but what makes Saudi Arabia's borders distinctive is that its northern and north-eastern borders are the product of the Empire facilitating the creation of Israel. At the very least the dissolution of the two Arab sheikhdoms of Ha'il and Hijaz by Ibn Saud's Wahhabis is based in their leaders' rejection to facilitate the British Empire's Zionist project in Palestine.

Therefore, it is very clear that the British Empire's drive to impose Zionism in Palestine is embedded in the geographical DNA of contemporary Saudi Arabia. There is further irony in the fact that the two holiest sites in Islam are today governed by the Saudi clan and Wahhabi teachings because the Empire was laying the foundations for Zionism in Palestine in the 1920s. Contemporaneously, it is no surprise that both [Israel](#) and [Saudi Arabia](#) are keen in militarily intervening on the side of "moderate rebels" i.e. jihadis, in the current war on Syria, a country which covertly and overtly rejects the Zionist colonisation of Palestine.

As the United States, the 'successor' to the British Empire in defending western interests in the Middle East, is perceived to be growing more hesitant in engaging militarily in the Middle East, there is an inevitability that the two nations rooted in the Empire's Balfour Declaration, Israel and Saudi Arabia, would develop a more overt alliance to defend their common interests.

So this brief history gives some insight into the two entities put in place to execute the final phase of Albert Pike's plan for 3 world wars. Many claim this to be a fraud yet it like the Protocols of the Learned Elders of Zion has proven to be very accurate.

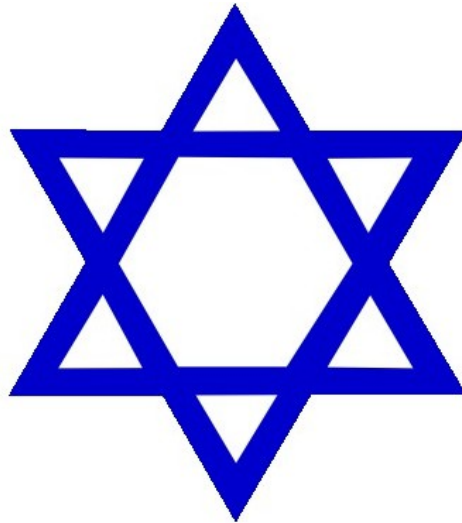

800 AD – The Ultimatum is delivered by Russia and other surrounding nations:

The leaders of the surrounding nations, especially Russia, have had so many years of complaints by their citizens that, as a group, they deliver an ultimatum to the Khazarian king. They send a communique to the Khazarian king that he must choose one of the three Abrahamic religions for his people, and make it his official state religion and require all Khazarian citizens to practice it, and socialize all Khazarian children to practice that faith.

The Khazarian king was given a choice between Islam, Christianity and Judaism. Gutle Schnaper, an Ashkenazi Jew (future wife of Mayer Amschel Bauer), born to respected merchant, Wolf Salomon Schnaper.

1760:

During this decade Mayer Amschel Bauer works for a bank owned by the Oppenheimers' in Hanover, Germany. He is highly successful and becomes a junior partner. Whilst working at the bank he becomes acquainted with General von Estorff.

Following his father's death, Bauer returns to Frankfurt to take over his father's business. Bauer recognises the significance of the red hexagram and changes his name from Bauer to Rothschild, after the red hexagram or sign signifying 666 hanging over the entrance door ("Rot," is German for, "Red," "Schild," is German for, "Sign").

The Rothschilds as the front Men for the Khazarian Mafia (KM) infiltrate and Hijack British Banking and then hijack the whole nation of England:

Bauer/Rothschild had five sons who infiltrated and took over European banking and the City of London Central Banking System through various crafty covert operations, including a false report of Napoleon winning against the British, when actually he lost. This allowed the Rothschilds to use fraud and deception to steal the wealth of the English nobility and the landed gentry, who had made business investments with the City of London Banking institutions.

The Rothschilds set up a private Fiat banking system that specialized in making counterfeit money from nothing — charging pernicious usury for the British people, using what should have been their own money.

The Rothschilds then covertly ran the British Empire and crafted an evil plan to recover the vast

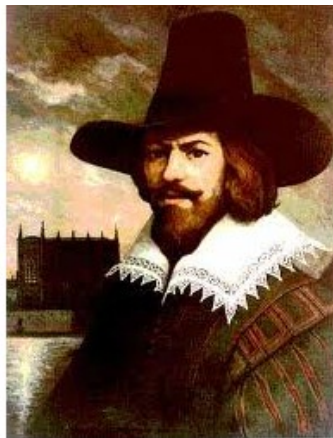
amounts of gold and silver the British had been paying to China for its high-quality silk and spices that were unavailable anywhere else.

The Rothschild's also followed the same business template in the Caribbean and in the Asian sub-continent of India, resulting in the murder of millions of innocent people.

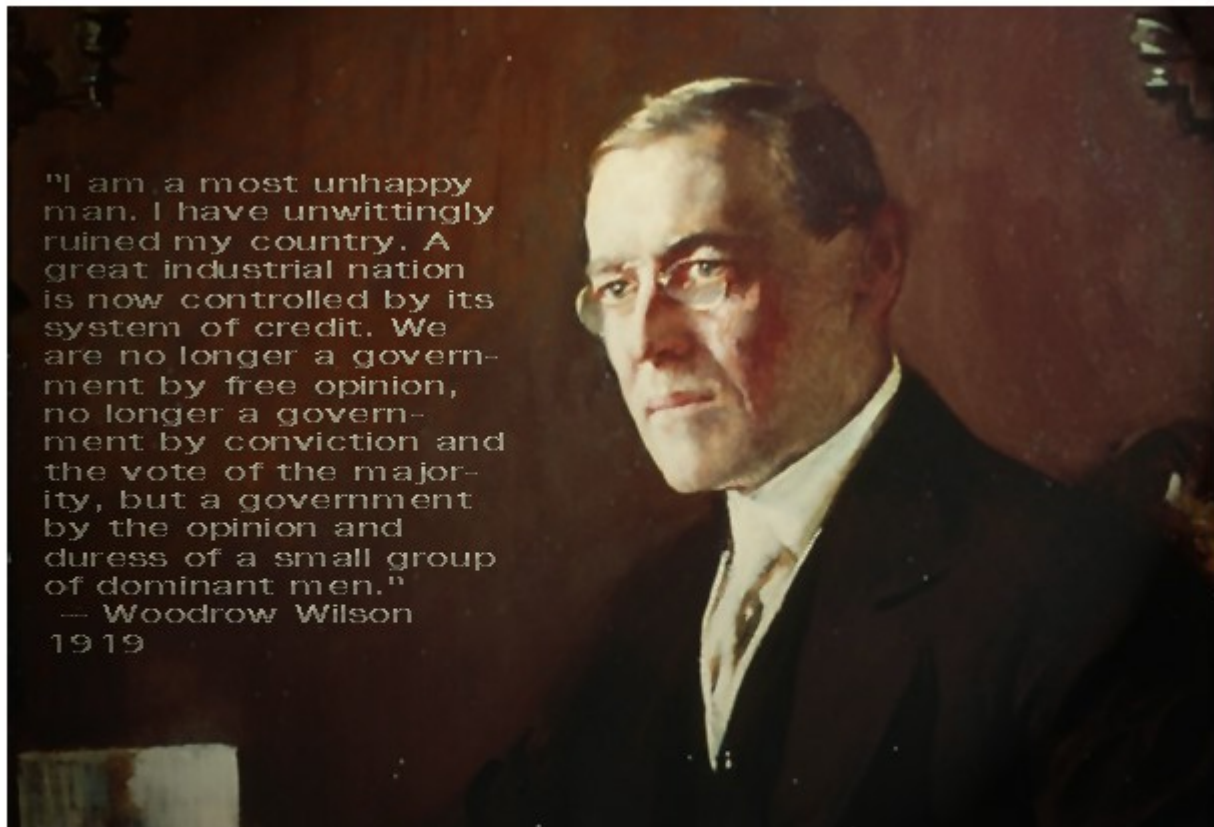

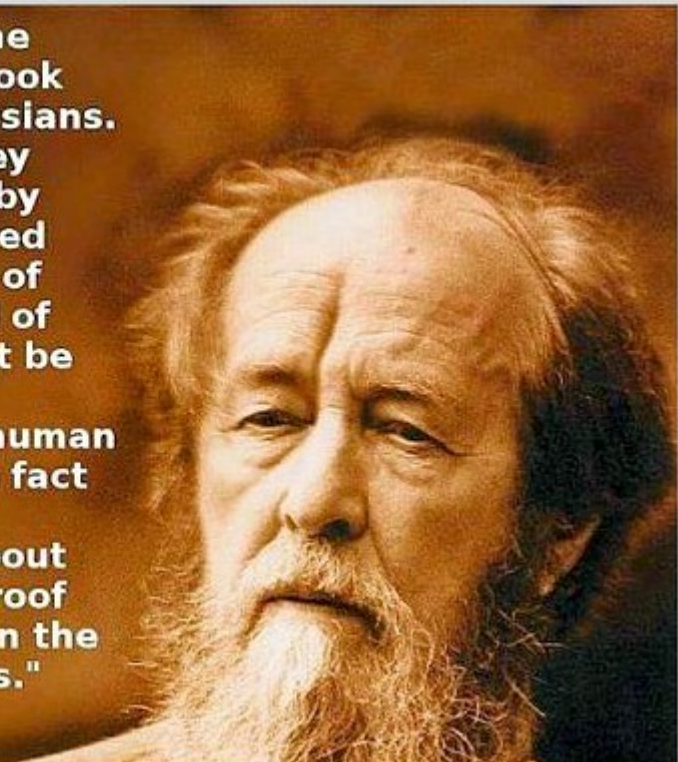
Note that the FBI has no official charter, according to the Library of Congress, and has no right to exist or issue paychecks.

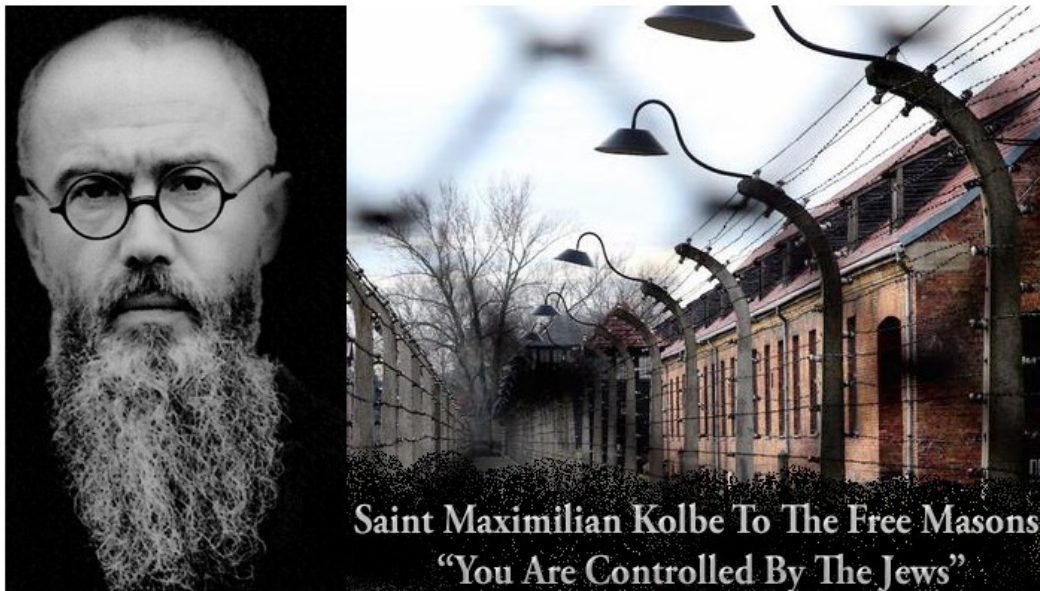

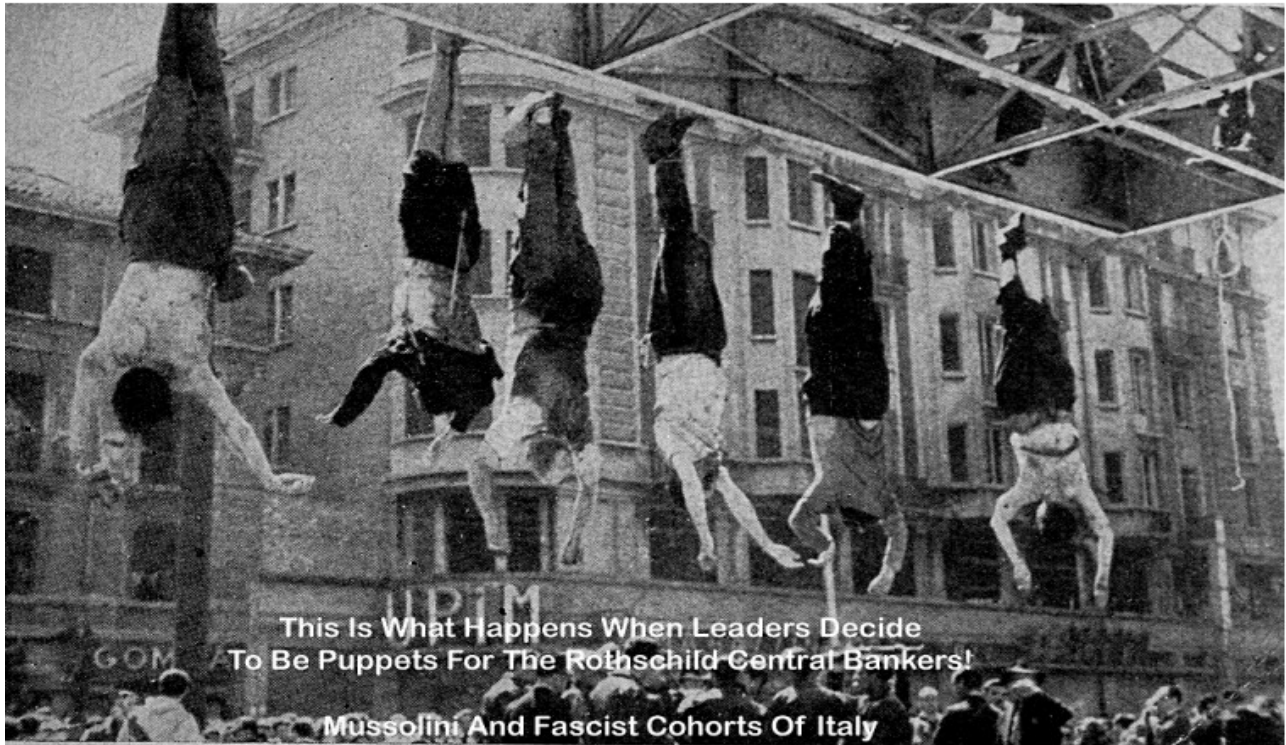

This allowed them to set up a worldwide spying and espionage system that far exceeded any of their prior efforts.

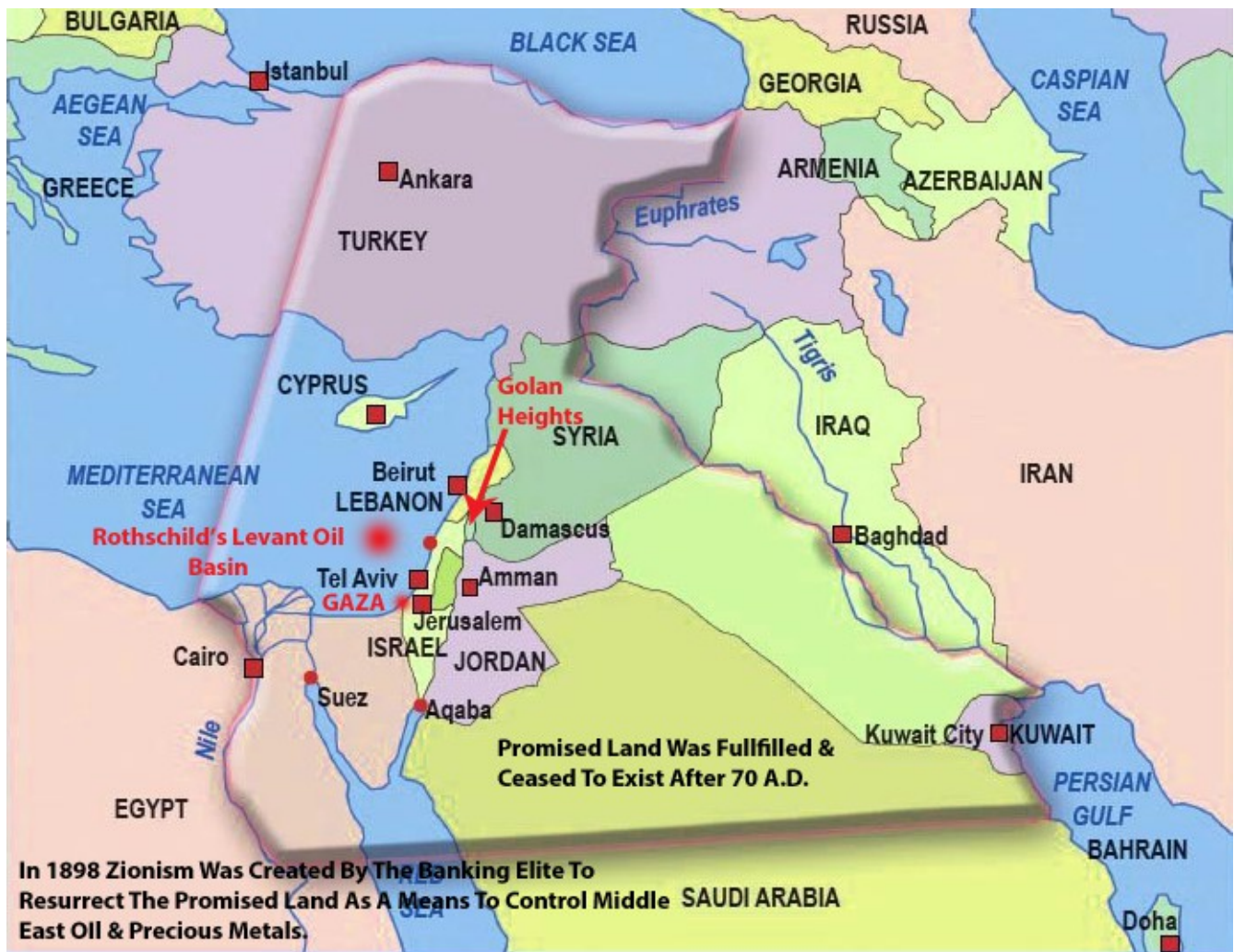

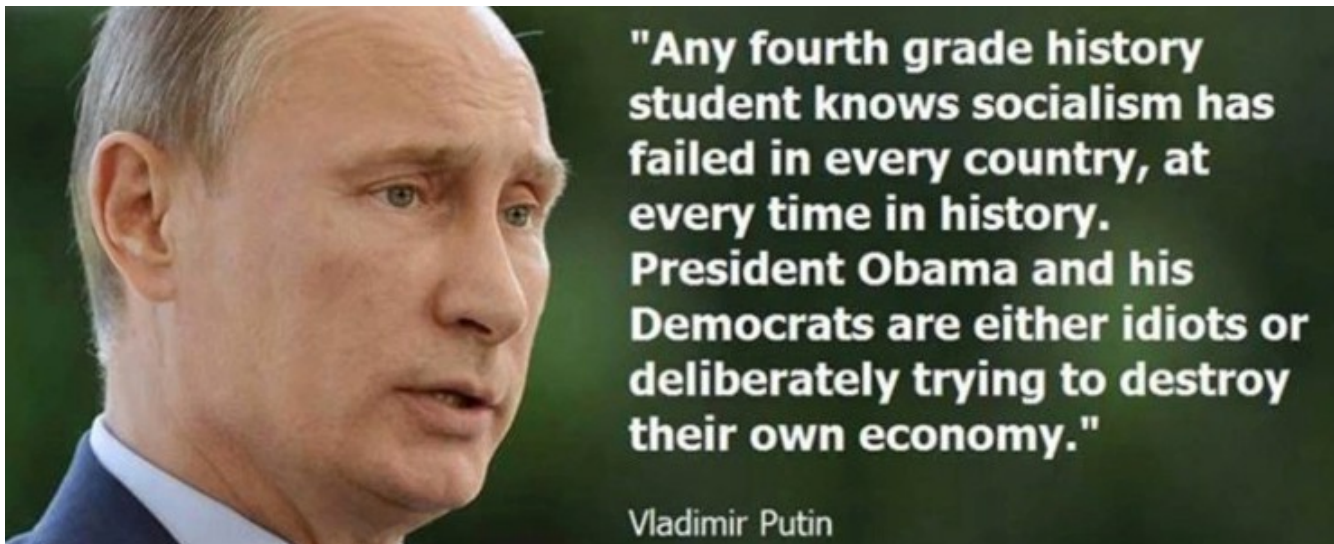

The Use Of Fluoridation For Mass Mind Control

The following letter was received by the Lee Foundation for Nutritional Research, Milwaukee Wisconsin, on 2 October 1954, from Mr. Charles Perkins, a chemist:

"I have your letter of September 29 asking for further documentation regarding a statement made in my book, *The Truth About Water Fluoridation*, to the effect that the idea of water fluoridation was brought to England from Russia by the Russian Communist Kreminoff. "In the 1930's, Hitler and the German Nazi's envisioned a world to be dominated and controlled by a Nazi philosophy of pan-Germanism. The German chemists worked out a very ingenious and far-reaching plan of mass-control which was

submitted to and adopted by the German General Staff. This plan was to control the population in any given area through mass medication of drinking water supplies. By this method they could control the population in whole areas, reduce population by water medication that would produce sterility in women, and so on. In this scheme of mass-control, sodium fluoride occupied a prominent place. ...

"Repeated doses of infinitesimal amounts of fluoride will in time reduce an individual's power to resist domination, by slowly poisoning and narcotizing a certain area of the brain, thus making him submissive to the will of those who wish to govern him. [A convenient light lobotomy]

"The real reason behind water fluoridation is not to benefit children's teeth. If this were the real reason there are many ways in which it could be done that are much easier, cheaper, and far more effective. The real purpose behind water fluoridation is to reduce the resistance of the masses to domination and control and loss of liberty.

"When the Nazis under Hitler decided to go into Poland, both the German General Staff and the Russian General Staff exchanged scientific and military ideas, plans, and personnel, and the scheme of mass control through water medication was seized upon by the Russian Communists because it fitted ideally into their plan to communize the world. ...

"I was told of this entire scheme by a German chemist who was an official of the great IG Farben chemical industries and was also prominent in the Nazi movement at the time. I say this with all the earnestness and sincerity of a scientist who has spent nearly 20 years' research into the chemistry, biochemistry, physiology and pathology of fluorine--any person who drinks artificially fluorinated water for a period of one year or more will never again be the same person mentally or physically."

Glyphosate Poison's History

Glyphosate poison's history begins in 1964. That's the year glyphosate was originally patented to clean pipes, like Drano, another famous poison you'd be wise not to drink or breathe in. The Stauffer Chemical Company of Westport, Connecticut patented glyphosate to remove unwanted mineral deposits from pipes. Yes, just like Drano removes deposits from pipes, so does glyphosate.

Monsanto's John E. Franz found that glyphosate also killed plants. Consequently, Monsanto brought glyphosate to market, in 1974, to do some killing. Glyphosate works as a non-selective, water-soluble pesticide with a specific mechanism of action. It directly interrupts plant development, killing plants by metabolically poisoning them. When something is unable to process nutrients for its health, it dies. People also die in this fashion. People die in many ways, but in the main, people die when their bodies can no longer process food for nutritional value needed to boost the immune system and sustain life.

How Glyphosate Kills Living Things

As with the pipe-cleaning patent, glyphosate binds (chelates) vital nutrients such as iron, manganese, zinc, and boron in the soil. By binding these nutrients, glyphosate prevents plants from absorbing them. Likewise, humans, farm animals, pets who consume Roundup Ready crops are also (likely) nutritionally starved. GMO soy plants (glyphosated) have lower levels of essential nutrients compared with non-GMO soy. Depleted nutrient uptake may also account for GMO soy's higher susceptibility to disease. An unhealthy plant can't protect itself as well as a healthy (non genetically modified) one.

Cows Poisoned with Glyphosate

A German Egyptian research team found all cows tested from Danish dairy farms excreted glyphosate in their urine and had low levels of manganese and cobalt. This again could be a direct result of glyphosate's chelation powers, designed for killing, for stripping away a living thing's nutrient absorption abilities.

Glyphosate Anti-biotic Resistance

Monsanto was also "awarded" a patent (in 2010) to use glyphosate as a potential antibiotic. Glyphosate has antimicrobial activity by "virtue" of its ability to chelate, to strip living things of their ability to uptake minerals. So, on top of glyphosate's other "virtues," it may also be "helping" to unleash superbugs impervious to anti-biotics because of the overuse of antibiotics. Got glyphosate yourself? You can bet that you do. You would be nearly insane to bet against it. Even if you think you avoid glyphosate as best you can, it's found in most rain water, it's found in many [popular foods](#), in [California wine](#) (including organic wine), even in most [vaccines](#).

People poisoned with Glyphosate

Virtually every man, woman and child in the U.S. is contaminated with glyphosate. Evidence from independent researchers is showing glyphosate can alter human and animal intestinal flora, leading to a harmful imbalance in the stomach's microbiome, thus stripping away (chelating) beneficial (and necessary) gut bacteria and increasing more toxic or harmful bacteria, just as it does in the soil.

How tiny toxic plastic particles are ending up in your food

Microplastic is defined as pieces of plastic that are less than 5mm in size. Think confetti, or sprinkles on your ice cream. They're that small, and they travel fast. And far.

In 2017, researchers from the University of Aberdeen sent a remotely-controlled vehicle into the Mariana Trench, the "Mount Everest of the oceans." It's the farthest you can get from any human source of pollution.

They didn't go in search of pollution, but that's exactly what they found. The vehicle returned with crustaceans carrying levels of [PCB](#) up to 50 times greater than crustaceans living in some of the most polluted rivers in the world.

Unbelievable, isn't it?

Well, remember those sea creatures? They're not the only ones eating microplastic. There are other animals busy transporting the toxins found in plastic all over the world, and right onto our dinner plates.

How poison travels up the food chain

A new study conducted by British and Irish researchers demonstrated that insects eat microplastics and carry them through the air. Not only that, but microplastics and their toxins survive from the larva stage right through the adult insect stage.

The researchers inserted two microscopic particles of polystyrene into young mosquitoes and observed the creatures throughout their life cycles. They found that the particles were still in the mosquitoes' systems as they passed through each life cycle stage and became flying adults.

A wide range of fish and animals eat mosquitoes and suffer the same toxic effects of BPA and phthalates as we do.

Chelsea Rochman, a post-doctoral researcher at the University of California Davis School of Veterinary Medicine, compared three groups of Japanese medaka, a species of fish often used in lab studies.

One group of fish received commercial fish food, another received 90 percent fish food and 10 percent clean plastic particles, and the third received 90 percent fish food and 10 percent plastic particles that had been floating in San Diego Bay for three months.

Both plastic-eating groups had low levels of glycogen in the liver, replaced by the excess fat that precedes fatty liver disease.

Even more ominous, both plastic-eating groups had tumor development. Those fed clean plastic had changes in their cells, but those who ate dirty plastic experienced cell **death**.

It doesn't take much to figure out what eating fish who've eaten plastic will do to us.

How to avoid eating microplastics

Seafood and shellfish are by far the food source most highly contaminated with microplastics.

But so many other things we eat and drink are, too, that it's almost impossible to avoid.

Drinking water, beer, even vegetables are contaminated with plastic and the chemicals they contain.

For example, leafy greens grown in plastic greenhouses have been shown to have higher levels of endocrine-disrupting phthalates.

There are certain things you can do to lower your risk:

1. **Buy organic.** Even better, know the source. If you can gain access to local farmers and fishermen, you stand a better chance of finding cleaner food.
2. **Use a water filter.** It may not get rid of everything, but it will rid your water of a lot of contaminants.
3. To **avoid the microplastics in salt**, use pink Himalayan rock salt.
4. If you're a beer drinker, try local breweries and look for one that uses **filtered water**.
5. Consider cleansing and EDTA chelation to help your body purge these poisons.

These Are The Most Dangerous & Heavily Promoted Prescription Drugs

While it's bad enough that almost half of the entire US population (48.7 percent) has used at least one of the most common [prescription drugs](#) in the past 30 days, according to the Centers for Disease Control and Prevention (CDC), over 10 percent of the population has used a whopping 5 or more of these drugs in the last month (1)!

And these medications are certainly not cheap. Statistics show that "between 2013 and 2015, the average annual drug spending for patients who stay in community hospitals increased by 23.4 percent, from \$5.2 million to \$6.5 million. And on a per admission basis, hospital spending on drugs jumped nearly 39 percent, to \$990." (2)

What's worse is that the number of [children](#) prescribed dangerous drugs is on the rise. Doctors seem to prescribe medication without being concerned with the side-effects.

Worldwide, 17 million children, some as young as five years old, are given a variety of different prescription drugs, including psychiatric drugs that are dangerous enough that regulatory agencies in Europe, Australia, and the US have issued warnings on the side effects that include suicidal thoughts and aggressive behavior.

According to Fight For Kids, an organization that "educates parents worldwide on the facts about today's widespread practice of labeling children mentally ill and drugging them with heavy, mind-altering, psychiatric drugs," says over 10 million children in the US are prescribed addictive stimulants, antidepressants and other psychotropic (mind-altering) drugs for alleged educational and behavioral problems (3).

1. Ritalin, Cylert, Dexadrine, And Adderal

Prescribed For: Attention Deficit Disorder (ADHD)/ Attention Deficit Hyperactivity Disorder (ADHD)

These drugs are some of the most common over-prescribed drugs for kids and they are also one of the most highly abused and misused medications. According to the CDC, as of 2011, approximately 11 percent of all US children between 4 and 17 were diagnosed with [ADHD](#).

The American Psychiatric Association (APA), however, says that only 5 percent of these children actually suffer from the disorder even though today, over 15 percent of all children are diagnosed with the condition (8). And the number is only rising.

Side Effects: While these drugs are supposedly short acting, they do cause some severe side effects like “zombie-like” behavior, and drooling. The FDA has further issued a warning about possible worsening of depression or suicidal thoughts in people who take these antidepressants.

2. Prednisone or Cortisone

Prescribed for: Rheumatoid [arthritis](#), lupus, asthma, allergies and many other conditions.

Corticosteroids are designed to mimic the effects of the natural hormones your [adrenal glands](#) produce, which sit just above your kidneys.

They are typically prescribed in doses that exceed your body’s normal levels in order to suppress inflammation.

3. Coumadin or Warfarin

Prescribed For: Blood Clots

This medication is an [anticoagulant](#) (blood thinner) that prevents the formation and migration of blood clots.

4. Cholesterol Lowering Drugs

Prescribed for: [Lowering Cholesterol](#)

There are several types of [cholesterol-lowering drugs](#). Atromid and Lopid, for example, work by absorbing bile acids that are produced from cholesterol in your intestinal tract. You’ve no doubt heard of “statin drugs.” These medications work by reducing the production of cholesterol in your liver and altering the way in which LDL cholesterol enters your cells.

5. Prozac, Zoloft, Paxil, Lovan and Luvox

Prescribed for: Depression

These drugs belong to a class of drugs that alter the levels of the neurotransmitter serotonin in your brain. Serotonin affects your mood, agitation, anxiety, and sleep. They essentially mock the re-uptake or removal of serotonin by the nerve cells in your brain, thus leaving more serotonin to bind to the receptor sites. This alters your mood and behavior.

6. Beta Blockers and Calcium Channel Blockers

Prescribed for: Hypertension

[Calcium-channel blockers](#) work by blocking “voltage-gated calcium channels (VGCCs)” in the muscle cells of your heart and blood vessels.

This then prevents calcium levels from rising in your cells when stimulated, thus leading to less muscle contraction. This decreases cardiac contractility (systolic pressure) in your heart and results in less contraction of the vascular smooth muscle in your blood vessels, thus an increase in vasodilation (diastolic pressure).

7. Cold and Flu Medications (aspirin, acetaminophen, ibuprofen, and decongestants)

Prescribed For: Cold or flu symptoms such as fever, aches, pains, congestion

Side Effects: While over the counter (OTC) medications may seem harmless, they are often highly often overused and abused and can cause severe repercussions such as [liver failure](#).

Acetaminophen is the leading cause for calls to Poison Control Centers across the US.

There are more than 100,000 instances per year that result in more than 56,000 emergency room visits, 2,600 hospitalizations, and an estimated 458 deaths due to acute liver failure ([19](#)).

Other studies show that these OTC medications actually suppress your immune system's response to the virus, resulting in increased healing time and greater respiratory discomfort.

8. Hydrocodone, Oxycodone and Morphine

If a person takes opioid prescription painkillers are extremely addictive. In general, opiates can make a person sleepy, chronically fatigued, or constipated, overdose often results in hospitalization and/or death.

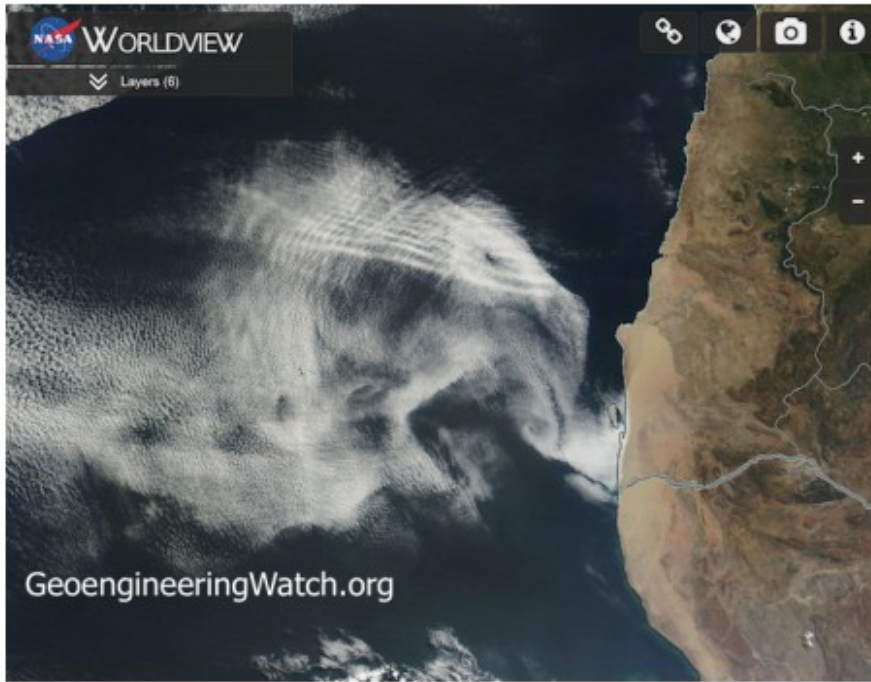
Atmospheric Spraying

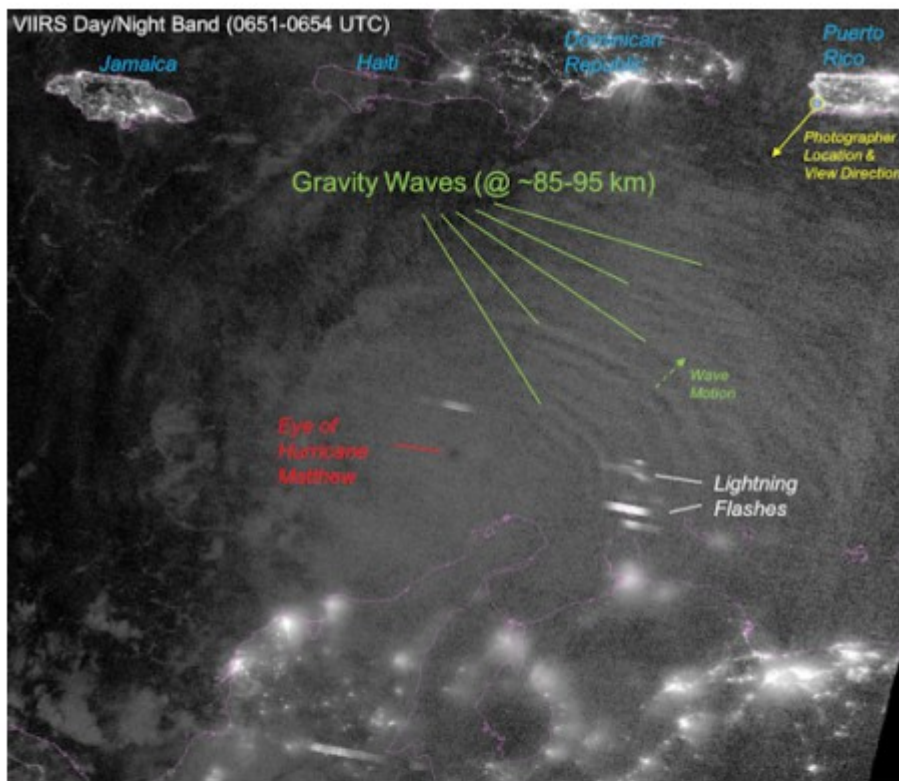

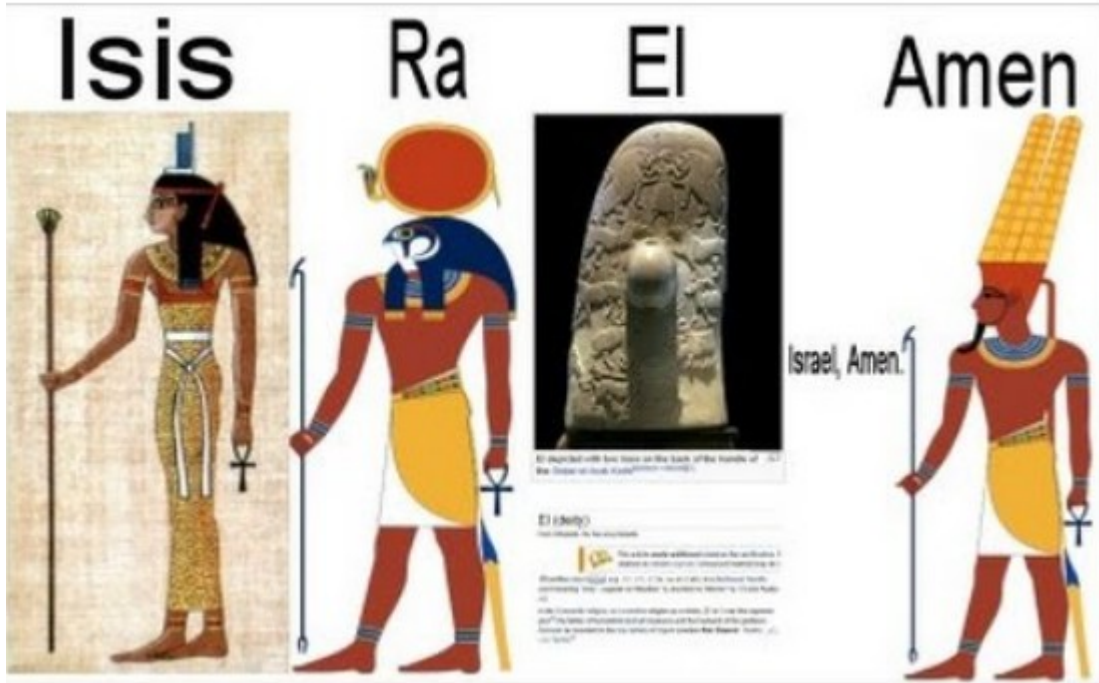

The Zionist paradox

Jewishness is full of paradoxes. For example, remarked Nahum Goldmann, founder and longtime president of the World Jewish Congress: “Even today it is hardly possible to say whether to be a Jew consists first of belonging to a people or practicing a religion, or the two together” (*The Jewish Paradox*, 1976)^[1]. The answer has always depended on the circumstances. Another paradox is the relationship of Jewishness to both tribalism and universalism: Israelis, “the most separatist people in the world,” in Goldmann’s words again, “have the great weakness of thinking that the whole world revolves around them.”^[2]

This great weakness is, of course, a great strength, and so is the ambiguity of Jewishness. It has served Israel—a secular “Jewish state”—very well. Theodor Herzl thought of Zionism on the model of European nationalistic movements, lobbying for the right of the Jews to become a nation among nations. But everyone can see now that Israel is no ordinary nation. It never was and never will be. It is the paradoxical nation.

Part of the ambiguity comes from the very name Israel, which already had a twofold meaning before 1948: it referred to an ancient kingdom supposedly founded in the first millennium BCE, and destroyed by the Romans in the first century CE. But for the following two thousand years, Israel was also a common designation for the Jewish community worldwide, “international Jewry” as some call it. That was the meaning of “Israel”, for example, when the *British Daily Express* of March 24, 1933 printed on its front page: “The whole of Israel throughout the world is united in declaring an economic and financial war on Germany.”^[3] The members of Israel were then called Israelites interchangeably with Jews. Although quite contradictory in terms, the two notions (national Israel and international Israel) have been conflated by the 1948 Law of Return, which made every Israelite of the globe a virtual Israeli.

Today, Zionism has shifted into a kind of meta-Zionism where the greatest number of the Israeli elite—including individuals with no stamped Israeli citizenship but a profound loyalty to the Jewish state—reside outside Israel. Some of them hold key positions in state administrations, particularly in the United States. As Gilad Atzmon remarks, “there is no geographical center to the Zionist endeavor. It is hard to determine where Zionist decisions are made”; “the Israelis colonize Palestine and the Jewish Diaspora is there to mobilize lobbies by recruiting international support.”^[4] The neoconservatives —“an intellectual movement in America to whose invention Jews can lay sole claim,” as correctly assessed the *Jewish Daily Forward*^[5] — are the most influential group of Diaspora Jews dedicated to Israel. They are no conservatives in the traditional sense, but rather crypto-Likudniks posturing as American patriots in order to align US foreign and military policies with the Greater Israel agenda—

high-level *sayanim*, so to speak (read John Mearsheimer and Stephen Walt, *The Israel Lobby and U.S. Foreign Policy*, 2008).

Their mentor Leo Strauss, in his 1962 lecture “Why We Remain Jews,” declared himself an ardent supporter of the State of Israel but rejected the idea that Israel as a nation should be contained within borders; Israel, he argued, must retain her specificity, which is to be everywhere.^[6] Indeed, this paradoxical nature of Israel is vital to its existence: although its stated purpose is to welcome all the Jews of the world, the state of Israel would collapse if it achieved this goal. It is unsustainable without the support of international Jewry. Therefore, Israel needs every Jew of the world to define his/her Jewishness as loyalty to Israel. Ever since 1967, the hearts of an increasing number of American Jews began to beat secretly, and then more and more openly, for Israel. Reform Judaism, which had originally declared itself to be exclusively religious and opposed to Zionism, soon rationalized this new situation by a 1976 resolution affirming: “The State of Israel and the Diaspora, in fruitful dialogue, can show how a People transcends nationalism while affirming it, thus establishing an example for humanity.”^[7]

How do they both affirm and transcend nationalism? The biblical way. The Hebrew Bible, the *Tanakh*, is the unalterable prototype of Jewish history: everything that follows the fall of the Hasmonean kingdom has to be biblical—the Holocaust, for example. Inevitably, Jewish nationalism, or patriotic love for Israel, resonates with the destiny of Israel as outlined in the Bible: “Yahweh your God will raise you higher than every other nation in the world” (Deuteronomy 28:1). Every nation is a narration, and Israel’s narrative pattern is cast into the Hebrew Bible. To love Israel is to love Israel’s biblical story, no matter of how mythical it is. And through biblical prophecy, the vision of the past becomes the vision the future: Solomon’s empire will come to pass.

That is why Zionism was never an ordinary form of nationalism, nor can Israel ever be a “nation like others.” The paradoxical nature of Israel is best embodied by its founding father Ben-Gurion: a secular Jew who saw himself as a new Joshua,^[8] hoped for “the restoration of the kingdom of David and Solomon,”^[9] and prophesized that Jerusalem will be “the seat of the Supreme Court of Mankind, to settle all controversies among the federated continents, as prophesied by Isaiah.”^[10] Let us be fair and assume that Ben-Gurion was simply referring to Isaiah’s prophecy that “the Law will issue from Zion” and that Yahweh will “judge between the nations and arbitrate between many peoples” (2:3-4), not to the Second Isaiah’s prophecy that Israel “will feed on the wealth of nations” (61:6), and that nations who do not serve Israel “will be utterly destroyed” (60:12).^[11] Ben-Gurion’s vision lives on: a 2003 “Jerusalem Summit” attended by three acting Israeli ministers including Benjamin Netanyahu and many American neoconservatives including Richard Perle, affirmed that “one of the objectives of Israel’s divinely-inspired rebirth is to make it the center of the new unity of the nations, which will lead to an era of peace and prosperity, foretold by the Prophets.”^[12] Zionists have always been in love with the Bible.

Such are the geopolitical implications of the Jewish paradox: Zionism cannot be a mere nationalistic aspiration, as long as it claims to be Jewish, for “Jewish” means “biblical”. And more than two thousand years ago, the ancient prophets had bent over the cradle of Israel to predestine it as “a nation above other nations.” Israel carries in its biblical genes the plan for a world order headquartered in Jerusalem. I’m not talking about a secret conspiracy here: the Jewish plan to rule the world has been plainly outlined in the global bestseller for more than two thousand years. If most people in the Christian world don’t see it, it is because it is right under their nose. Christians claim that the Jews don’t read their Bible correctly, or that they got their Zionism from the Talmud or the Kabbalah. Both claims are pitiful attempts to exonerate the Old Testament from the Zionist catastrophe: the Hebrew Bible was written by Jews for the Jews, and I have never heard a Zionist quote the Talmud or the

Kabbalah, whereas they quote the Bible every day.

The prophetic spirit that inspired Isaiah long ago has been very active since the beginning of the 20th century. It spoke through religious leaders like Kaufmann Kohler, a leading figure of American Reformed Judaism, who wrote in his major work on *Jewish Theology* (New York, 1918) that “Israel, the suffering Messiah of the centuries, shall at the end of days become the triumphant Messiah of the nations.”^[13] And it spoke through secular thinkers like Alfred Nossig, a Zionist who collaborated with the Gestapo in the Warsaw ghetto for the emigration of selected Jews to Palestine, who wrote in his *Integrales Judentum* (Berlin, 1922):

“The Jewish community is more than a people in the modern political sense of the word. It is the repository of a historically global mission, I would say even a cosmic one, entrusted to it by its founders Noah and Abraham, Jacob and Moses. [. . .] The primordial conception of our ancestors was to found not a tribe but a world order destined to guide humanity in its development.”^[14]

The Feuerbachian approach

The paradoxical nature of Jewishness (combining separatism and universalism), which is reflected in the ambiguous nature of Zionism (combining nationalism and internationalism), is ultimately linked to the Jewish conception of God. Is the biblical Yahweh the national god of Israel or the universal God of humankind? Let’s search for an answer into the Book of Ezra, the paradigmatic episode for the Jewish colonization of Palestine. It begins with an edict of the Persian king Cyrus, which says:

“*Yahweh, the God of Heaven*, has given me all the kingdoms of the earth and has appointed me to build him a Temple in Jerusalem, in Judah. [. . .] Let [every Jew] go up to Jerusalem, in Judah, and build the Temple of *Yahweh, the God of Israel*, who is *the God in Jerusalem*” (Ezra 1:2–3).

Here Cyrus speaks in the name of “the God of Heaven” while authorizing the Judean exiles to build a temple to “the God of Israel [. . .] the God in Jerusalem.” We understand that both phrases refer to the same God, called Yahweh in both instances, but the duality is significant. It is repeated in the Persian edict authorizing the second wave of return. It is now Artaxerxes, “king of kings,” who switches from the “God of Heaven” to “your God” or “the God of Israel who resides in Jerusalem” when addressing Ezra (7:12–15). The phrase “God of Heaven” appears one more time in the book of Ezra, and that is again in the edict of another Persian king: Darius confirms Cyrus’s edict and recommends that the Israelites “may offer sacrifices acceptable to the God of Heaven and pray for the life of the [Persian] king and his sons” (6:10). Elsewhere the book of Ezra only refers to the “God of Israel” (four times), “Yahweh, the God of your fathers” (once), and “our God” (ten times). In other words, according to the author of the book of Ezra, only the kings of Persia see Yahweh as “the God of Heaven” (a fiction, of course: for Persians, the God of Heaven meant Ahura Mazda) while for the Jews he is primarily the “God of Israel”. That is the deepest secret of Judaism, and the key to Jews’ relationship to universalism and to the nations: success rests on their ability to make Gentiles believe that the national god of Israel residing in the Jerusalem Temple is the God of Heaven who happens to have a preference for Israel.

The misunderstanding led to a public scandal in 167 CE, when the Hellenistic emperor Antiochos IV dedicated the temple in Jerusalem to Zeus Olympios, the supreme God. He was simply expressing the idea that Yahweh and Zeus were two names for the supreme cosmic God, the Heavenly father of all mankind. But the Jewish Maccabees who led the rebellion against him knew better: Yahweh may be the Supreme God, but He is Jewish. Only Jews are intimate with Him, and any way the Pagans worship Him is an abomination.

So is Yahweh God, or just the god of Israel? Why should we care? Well, let’s call it the Feuerbachian approach to the Jewish question. In his famous work *The Essence of Christianity* (1841), which was to influence greatly Karl Marx, Ludwig Feuerbach sees the universal God as “the deified and objectified

spiritual essence of man”: theology is anthropology in disguise, and “The consciousness of God is the self-consciousness of man.” But if we regard the biblical Yahweh as a creation of Jews alone, rather than humanity at large, then we can consider him as a personification of the national character of the Jewish people—or, more correctly, a reflexion of the mentality of the Jewish elite who invented Yahweh.

It is known to biblical scholars that, in the oldest strata of the Bible, Yahweh appears as a national, ethnic god, not the supreme God of the Universe. “For all peoples go forward, each in the name of its god, while we go forward in the name of Yahweh our god for ever and ever” (Micah 4:5)^[15]. “I am the god of your ancestors,” Yahweh says to Moses (Exodus 3:6), who is then mandated to declare to his people, “Yahweh, the god of your ancestors, has appeared to me,” urging them to talk to Pharaoh in the name of “Yahweh, the god of the Hebrews” (3:16–18). The Hebrews chant after the miracle of the Red Sea engulfing Pharaoh and his army, “Yahweh, who is like you, majestic in sanctity, among the gods?” (15:11).^[16] And in Canaan, a Hebrew chief declares to an enemy king: “Will you not keep as your possession whatever Chemosh, your god, has given you? And, just the same, we shall keep as ours whatever Yahweh our god has given us, to inherit from those who were before us!” (Judges 11:24).^[17] In all these verses, Yahweh is an ethnic or national god among others.

What sets him apart from other tribal gods of his kind is possessive exclusivism: “You shall have no other gods to rival me” (Exodus 20:3); “I shall set you apart from all these peoples, for you to be mine” (Leviticus 20:26). This is the justification for strict endogamy: it is forbidden to marry one’s children to a non-Jew, “for your son would be seduced from following me into serving other gods” (Deuteronomy 7:4).

Yahweh is known as “the Jealous One” (Exodus 20:5 and 34:14; Deuteronomy 4:24, 5:9, and 6:15). But jealousy is an euphemism for outright sociopathy, because what Yahweh demands from his people is not just exclusivity of worship, but the destruction of their neighbors’ shrines: “Tear down their altars, smash their standing-stones, cut down their sacred poles and burn their idols” (Deuteronomy 7:5). Judean kings are judged on the unique criterion of their obedience to that precept. Hezekiah, whose disastrous policy of confrontation with Assyria led to a shrinking of the country, is praised for having done “what Yahweh regards as right,” namely abolishing the “high places” (2 Kings 18:3–4). His son Manasseh, whose 50-year reign is known to historians as a time of peace and prosperity, is blamed for having done “what is displeasing to Yahweh, copying the disgusting practices of the nations whom Yahweh had dispossessed for the Israelites” (2 Kings 21:2). Manasseh’s son Amon is no better. Josiah, on the other hand, proved worthy of his great-great-grandfather Hezekiah, by removing from the temple “all the cult objects which had been made for Baal, Asherah and the whole array of heaven. [...] He exterminated the spurious priests whom the kings of Judah had appointed and who offered sacrifice on the high places, in the towns of Judah and the neighborhood of Jerusalem; also those who offered sacrifice to Baal, to the sun, the moon, the constellations and the whole array of heaven” (2 Kings 23:4–5).

It is ironic that Yahweh, originally a minor tribal god, should compete with the great Baal for the status of supreme God, as when Elijah challenges 450 prophets of Baal in a holocaust contest, which ends up with the slaughter of them all (1 Kings 18). In ancient Syria, Baal Shamem, the “Heavenly Lord,” was identified as the God of Heaven and honored by all peoples except the Jews.^[18] The goddess Asherah, whom Yahweh loathed even more, was the Great Divine Mother worshipped throughout the Middle East. In Mesopotamia, she went under the name of Ishtar, while in the Hellenistic era, she was assimilated to the Egyptian goddess Isis. The Hebrews themselves called her “Queen of Heaven” and turned to her in times of trouble, to the dismay of their priest and prophet Jeremiah, who threatened them with Yahweh’s exterminating wrath (Jeremiah 44).

Historians of religion tell us that Yahweh was still a national god at a time when the notion of a supreme God was widespread. When and how the Levites declared the god of Israel to be the true and only God is not entirely settled, but it is generally admitted that it happened shortly before the time of Ezra, when the Book of Genesis was composed (with much borrowing from Mesopotamian and Persian myths). The process is easy to imagine, for it follows the cognitive logic of a narcissistic sociopath among the community of gods: from the commandment of exclusive worship and the destruction of other gods' shrines, it is a small step to the denial of the very existence of other gods; and if Yahweh is the only existing god, he must be "The God."

A curious story about King Hezekiah can serve as an illustration of this process. The Assyrian king threatens Hezekiah in the following manner, explicitly identifying Yahweh as the national god of Israel:

"Do not let your god on whom you are relying deceive you with the promise: 'Jerusalem will not fall into the king of Assyria's clutches' [...] Did the gods of the nations whom my ancestors devastated save them?"

Hezekiah then goes up to the Temple and offers the following prayer:

"It is true, Yahweh, that the kings of Assyria have destroyed the nations, they have thrown their gods on the fire, for these were not gods but human artifacts—wood and stone—and hence they have destroyed them. But now, Yahweh our god, save us from his clutches, I beg you, and let all the kingdoms of the world know that you alone are God, Yahweh" (2 Kings 19:10–19).

So here we witness how Yahweh was promoted from the status of a national god to that of universal God by the prayer of a devout king. In response to that prayer, according to the biblical story, "the angel of Yahweh went out and struck down a hundred and eighty-five thousand men in the Assyrian camp," then struck their king by the hand of his sons (19:35–37). Pure fiction: the Assyrian annals tell us that in reality, Hezekiah paid tribute to the Assyrian king. Which proves that Hezekiah's claim was deceptive.

Conclusion

The exclusive monotheism demanded by Yahweh is a degraded imitation of that inclusive monotheism toward which all the wisdoms of the ancient world converged by affirming the fundamental unity of all gods. As Egyptologist Jan Assmann emphasizes, the polytheisms of the great civilizations were cosmotheisms, insofar as the gods, among other functions, form the organic body of the world. Such a conception naturally led to a form of inclusive or convergent monotheism, compatible with polytheism: all gods are one, as the cosmos is one.^[19] The notion of the unity of the divine realm naturally connects with the notion of a supreme God, creator of heaven and earth, enthroned atop a hierarchy of deities emanating from him—a concept familiar to Plato, Aristotle, Seneca, and most ancient philosophers. The exclusive and revolutionary monotheism that the Yahwist priests crafted for their own benefit is of a totally different kind: it is, in fact, the exact opposite of the inclusive and evolutionary monotheism of neighboring peoples.

From the historical perspective, it is not the Creator of the Universe who decided, at some point, to become the god of Israel; rather, it is the god of Israel who, at some point, was declared the Creator of the Universe by the Levites and their scribes. The Jewish conception of Yahweh parallels that historical process: for the Jews, Yahweh is primarily the god of Jews, and secondarily the Creator of the Universe. This is what Maurice Samuel kindly tried to tell us in *You Gentiles* (1924): "In the heart of any pious Jew, God is a Jew." "We [Jews] and God grew up together," that is why "we need a world of our own, a God-world, which it is not in your nature to build."^[20]

And so the paradoxical nature of Yahweh is, in reality, a deception. The idea that the Heavenly Father

of humankind, somewhere in the second millennium BCE, chose a particular people and ordered them to dispossess and slaughter other peoples is, any way we look at it, an outrageous absurdity. The fact that billions of people have believed it for thousands of years makes no difference. Or rather, that is the problem: many peoples throughout history have believed themselves to have been chosen by God, but only the Jews have managed to convince others that they have. That has turned this outrageous absurdity into the most devastating idea in world history.

The deceptive nature of biblical monotheism is the key to understanding traditional Jewish attitude to universalism. For the Jewish conception of God is reflected in the Jewish conception of Humanity. Just like their tribal god speaks of himself—through his prophets—as the God of humankind, Jewish communitarian thinkers speak of Jewishness as the essence of humanity: Judaism constitutes a “particularism that conditions universality” so that “there is an obvious equation between Israel and the Universal”; in other words, “Israel equals humanity” (Emmanuel Levinas, *Difficult Freedom: Essays on Judaism*, 1990).^[21] It is almost always in reference to their Jewishness that such opinion makers, who are often ardent Zionists, proclaim themselves universalists: see for example how Rabbi Joachim Prinz, a German Zionist who in 1934 had applauded the Nazi state for being “built upon the principle of the purity of nation and race,” declared in 1963, as chairman of the American Jewish Congress, that he supported the African-American civil rights movement “as a Jew.”^[22] “Jewish universalism” is a contradiction in terms and therefore necessarily deceptive. It is self-deception in the case of most Jews, who believe what they have been taught by their representative elites ever since the Haskalah: that there is no contradiction in being a tribalist at home and a universalist in the street—provided that, in each of their universalist stand, they do not lose sight of the important question: “Yes, but is it good for the Jews?”^[23] Of course, there are many remarkable exceptions: Jews who have broken through the mental “Jewish prison” (as Jewish journalist Jean Daniel calls it)^[24] to reach for some universal truths. I call it the genius of the escapee.

Ultimately, the deceptive nature of both biblical monotheism and Jewish universalism is a key to unraveling the Zionist paradox: nationalism and internationalism go hand in hand in Israel’s destiny, because Israel is, fundamentally, a biblical and therefore universal project. For the Jewish cognitive elites who determine Jewish public opinion to a large extent, the New World Order is an ancient et eternal idea. It is Israel’s destiny carved in the Bible. It is inherent to Jewishness.

THE MYSTERY of the SERPENT

By B. F. JACKSON

It is this study, which, because of necessity, we compose in a series of pamphlets which we dedicate to America's survival in this final struggle of World War III as Armageddon into which Jewry in America, working as one with the Jews in the Kremlin in Moscow, Russia, have plunged us in order to annihilate Christianity and the white race or perish in the attempt.

IN BIBLICAL PROPHECY, the number 44 signifies the Beast of Lies. He is Satan! Accordingly, after 44 years of lying about the book, "The Plot of the Jews: The Protocols of the Learned Elders of Zion", being a non-Jew forgery, the leaders of Jewry in America on the night of 5 Feb. 1949 bragged to what they supposed to have been an all-Jewish audience in the Shriners Auditorium, Los Angeles, California, that, the Protocols are authentically the blue-print of world conquest by the Serpent race of Jews—the Protocols are Jewry's own property—and the conspiracy against God and man in them is an accomplished fact, except to collapse America's economy and finances then seize the government and destroy the independence of this Nation. Yet, they declared that would be accomplished before the end of 1953.

It is time that we stood up to be counted!

In the very first paragraph of protocol No. 3 the leaders of Jewry admit Jewry is the Serpent race of Satan. We first observe that Reptilian race in the third chapter of Genesis in our Bible. In the Hindu Scriptures he is called Shesha, which is pronounced Shaitan (Satan), He is symbolized as being a 12-headed cobra. Actually the heads are 12 high-degree B'nai B'rith Jews as the Cabinet of the King of the Jews.

That king today is the Asiatic Turko-Mongol Jew, Prince Abdul Baraba Baha. He is the "brains" of Shaitan the Serpent. A portion of his teeth and claws are the members of the Anti-Defamation League, which is an un-Constitutional gestapo organized in the United States in 1913 by Jewry's exclusive Grand Orient Freemasonic Lodge of B'nai B'rith so as to force out of circulation any truth remotely-connecting the word "Jew" with the world conspiracy against God and man; and also to prevent as far as possible the truth being published about the Anglo-Saxon-Celtic, Scandinavian and Nordic people being the House of Israel as God's Kingdom in the material plane.

The axis of Shaitan's spinal column are two Princes of the Jews and one roving ambassador who answer to no one but the King of the Jews. Shaitan has seven vertebrae in his back bone. His spinal cord has 1,000 nerve fibres. They are the Luciferian priesthood known in Christendom as the Learned Elders of Zion. They are equally divided between the Western and Eastern Hemispheres. His nerve system is a 7 x 7 super-secret organization known as the Cahilla. The vertebrae in his back bone are seven offices from which emanate the nerve system consisting of seven Ministers under seven Arch-censors (7 x 7 = 49 Ministers). Under each Minister are seven Heralds (7 x 49 = 343 Heralds). Under each Herald are seven Couriers (7 x 343 = 2,401 Couriers). Under each Courier are seven Scribes (7 x 2,401 = 16,807

Scribes). Under each Scribe are seven Auditors ($7 \times 16,807 = 117,649$ Auditors). Under each Auditor are seven Mutes ($7 \times 117,649 = 823,543$ Mutes).

With the 500 Luciferian priests, the Archcensors, the king and prince there are 961,301 Jews in each hemispherical Cahilla section. Adding the 24 B'nai B'rith Jews in the two Cabinets of the king and his co-regent and the roving ambassador, there are 1,922,627 Jews in the hemispherical brains and nerve system of Shaitan the Serpent, That Cabal and the Jewish race are the brains, nerve system, teeth, claws, back bone and body of Satan in the material plane, and their collective evilness is the Devil and his demons in the spiritual plane.

That is the talking Snake who spiritually-sabotaged our Adamic progenitors. It is a race of material vampires. It is a counterfeit race of Devils not created by God. It is on display as such in Job 26:5; Psa. 88:10; Pro. 2:18; 9:18; 21:6; Isa, 14:9 and 26:9 in which the original Hebraic for the word "dead" is Rephaim, which means the Shades of spiritual and material death. Jude 12 says they are twice dead (spiritually and materially), plucked up by the roots. Then, Mark 4:11, 12, 15; Luke 11:44; John 7:33, 34; 8:43-47; 9:27; Acts 2:47; Heb. 13:20 and II Peter 2:4,12 show they are born spiritually-dead from the womb.

God put in man a certain genealogical power to cause the marrow of the bones to generate blood for the life of flesh (Lev. 17:11). Jewry lacks that power. He steals it from man, however, in mongrelization. The Satanic dyed vampire is manifest in what we have believed was Jewry's white blood corpuscles. In man, they are round, yet shaped differently for each race. That is one reason God established the Divine Law for the various races not to mongrelize, In Jewry, however, the "white blood" corpuscles are long and stringy, and Divine Law forbids all humanity to mongrelize with the Devil's Serpent race, because the children will in turn be vampire and totally cut off from God.

In times past the Serpent race absorbed entire nations in order to renew the life force in their bone marrow. Ezek. 28: 12-19 and Isa. 49:26 show the vampire condition. The latter states: "And I (God) will feed them that oppress thee (Israel) with their own flesh; and they shall be drunken with their own blood as with sweet wine: and all flesh shall know that I am the Lord and thy Savior and thy Redeemer the Mighty One of Jacob".

Isaiah makes it plain that he is speaking about the counterfeit race of Satan who we know as Jews. In Isa, 14:29; 27:1 and 65:25 he mentions them as the Serpent which is written in the Hebraic to mean the counterfeit race of the original material Beast who we know as Satan, the same as the father of the Luciferian Beast in Ezek. 28. In Isa. 49:26 the word "feed" isakal, in the original Hebraic.

It means to consume away. If Isaiah had meant the Serpent race would turn cannibal and feed on itself, the word "feed" would have been nahal. If they were thrown into jail as in Rev. 20 and given Jew flesh to eat when they asked for food and said "feed me" the word would have been last. If they could feed themselves and they were given Jew flesh (or any proper nourishment) the word "feed" would have been kul. Isaiah, therefore, graphically shows when Zech. 14:21 and Rev. 20:1-3 are consummated the Serpent race of Jews will be isolated from humanity and the faculty of Jewry's bones to produce blood corpuscles will gradually be lost until the race will stagger from weakness which will gradually consume the race.

Mongrelization with man is essential so Jewry can renew the depleted life force, Extensive mongrelization can change the outward appearance so much that the Jewish characteristics are difficult, if not impossible, to perceive.

When that occurs and Satan is about to transform himself into a human automatically possessing the Life Force of God, Divine Law intervenes and the next generation reverts back with all the physical characteristics known as Jewish and that line of Satan is entirely sterile.

The vampire condition is in three categories and they are spiritual and material. The first phase is as above. Secondly, the instinctive craving to murder man spiritually. It is accomplished by subtle suggestions which causes man to think erroneously which generates a destructive electro-cosmic field of oscillatory disequilibrium in his brain cavity which thrusts him out of conscious contact with God and spiritually-kills him. That field can be measured with electronic instruments, and scientists know it is directly the presence of that field which makes man's body deteriorate and eventually die of old age. Jewry is greedy to shed man's blood in murder and wars (John 8:44; Matt. 23:35)

The third phase of the vampire condition is the stealthy approach unto man on his Snake belly of sham worship of God and being the chosen people of God. Drawing near an intended victim amidst the darkness of misrepresented brotherhood, liberalism, equality and fraternity he hypnotizes the victim with a flickering spiritually-black forked tongue of exaggerated friendliness and humane feeling, and by time he is in striking distance the victim is mentally- paralysed in respect to Jew chicanery. Then, without any resistance the Serpent swallows the victim by first marrying into his family then absorbs it in mongrelization in efforts to steal the Life Force put in it by God. Racial characteristics of man are ignored by the Serpent race. All it is interested in is stealing the Life Force put in man by God.

While doing it he steals every important thing man creates. The prophet Ezekial calls that characteristic a cormorant because there is no Hebraic for a vampire bat. While preying on man, that vampire race utterly corrupts him, yet pretends to assist elevate him to the zenith of spiritual attainment. II Peter 2:11, 12 throws light on the condition when he says:

"Whereas angels, which are greater in power and might, bring not railing accusations against them before the Lord. But these, as natural brute beasts, made to be taken and destroyed, speak evil of things that they understand not; and shall utterly perish in their own corruption".

The original Greek for that word "natural" is phusikos, It means things born in one. Brute is alogos, or without life. Beast is zoon, a living creature. Made is gennaō, or conceive, bring forth in child birth. Take is halosin, or with a view to capture. Destroyed is eisphthoran, or corrupt. Perish is kataphtheiro, or to corrupt utterly.

Thus, the original declaration of St. Peter is: These, living-dead things are conceived and brought forth in child birth with the view born in them to capture man and corrupt him utterly.

Peter and Jude graphically show they are speaking about none other than Jewry. They are speaking about the same conditions. Jude 9 shows the angel is Michael and the Brute Beast is the Devil, who, according to the personal family record of Jewry's current god, Prince Abdul Baraba Baha, was the Serpent Prince Nahar.

The first record of that counterfeit race is in the third chapter of Genesis. The word "serpent" in that chapter is nachash, in the original Hebraic. There are three ways of composing the word "nachash". The root is composed with three characters, the first of which is shaped similar to around-bottomed "W" with a dot above the right hand arm. The second is similar to the piratio sign. The third to a very poor figure three. Written thus, it means, Divine, learn by experience, observe diligently, use enchantment, an enchanter. When the word contains a dash, or bar, under the second and third characters it means, occult science, witch-craft, black magic. When a dot is included under the bars the word means, the

Serpent race fathered by the original material Satan, and the race is the racial body of Satan in similar manner as the Anglo-Saxon-Celtic, Scandinavian and Nordic people are the racial body of Israel. The Serpent in Gen. 3 is written with the bars and dots under the two last characters to prove he is Satan's cursed Serpent race of Jews; and the word "Jew" is Yehudim, in the Hebraic, Aramaic and Greek which means the race cursed by God.

The word "serpent" makes its next appearance in Gen. 49:17. It is written without the bars and dots under the second and third character in the Hebraic. When we study the contents of Gen.49 we observe Israel is prophesying about Dan would become an honourable judge in the House of Israel—"nachash", learn by experience, observe diligently. Today, Dan is the Irish, Hollanders, Belgians and Scandinavian people. The adder in Gen. 49:17 symbolizes the "nachash" as an enchanter, enchantment.

Dan's ancient coat' of arms was a coiled adder standing on its tail. Dan is standing today while enchanting our people with secular facts that he was the scouts of the Caucasian race moving out of Eurasia toward the Appointed Place of II Sam. 7:10 and I Chron. 17:9 in 220 A.D.

The word "serpent" makes its next appearance in Exo. 4:3 and 7:15 in which it is nachash. It is written without bars and dots under the last two characters. Written thus. and close study of the chapters, we know the word means Divine. Then why did Moses run from it?. The fire in the burning bush in Exo. 3 was Divine, yet it aroused his curiosity which brought a warning from God. We know that fire was Divine, because it is "esh" in the Hebraic. It was the manifestation of Jehovah's Power being translated into the material plane. It was a corona of cosmic electricity similar to the corona observed at night around a copper transmission line carrying 100,000 or more volts of electricity. In the vicinity of that bush was generated a tremendous field of cosmic energy. That is the reason Jehovah told Moses to remove his shoes—so he would be thoroughly grounded and would not be spiritually-electrocuted. Or, as the text says, the ground was holy. The Hebraic for that word "holy" is qodesh, or a sanctuary.

Then, in Exo. 4:8 God says to Moses: "If they will not believe you, neither hearken to the voice of the first sign, then they will believe the voice of the latter sign".

The first sign was in the rod. The second occurred when Moses thrust his hand into his coat. The first word "voice" is qol. It means crackling. That word "qol" is written with three Hebraic characters. The second "voice" is also qol, yet written with only two characters, which means lightness. It verifies verse 6 as to Moses' "hand was leprous as snow". Then, 'the first word "sign" is oth. It means ensign, badge or rank of power. The second "sign" is also oth, but it means miracle.

We observe, therefore, when Moses east his shepherd's staff upon the ground, Divine Power changed it into the ankh as the sceptre of the High Priest of the Order of Melchizedek which God conferred upon Moses. The "voice" of that ankh was the crackling sound of cosmic electricity running over it. That Power was the nachash, or serpent, which frightened Moses because he was shocked by its spiritual force.

In Exodus, 7:9, 10, 12, however, Moses cast the ankh upon the ground in front of Pharaoh and the

Cosmic Energy changed it into a serpent. That word "serpent" originally was "tannin". It means a howling dragon—a howling lizzard which make a noise similar to "choke you".In Num. 21:6 and Deut. 8:15 are fiery serpents.

The word "fiery", in the Hebraic, is seraph. It means burning, blazing. Sometimes it is seraphim. Both have the same meaning as something hot. That word "serpent" is nachash, and is written without the bars and dots under the last two characters. Written thus, and by close study of the chapters, one observes that serpent is an enchanter—something which enchanted the people. In Deut. 8:15 the Hebraic for the word "scorpion" is aqrab, which is just an ordinary scorpion,yet the serpents are not snakes. It holds for Exodus, 21:6. 7. What, then, are the fiery serpents sent by God to bite and kill the people? That word "fiery", as a seraph, and the "serpents",as nachash, or enchanter, are the clues proving the fiery serpents are heat waves caused by sun heat radiating from the dry ground, which, when observed from a distance, formed into shimmering undulating mirages (seraphim).

That unfamiliar spectacle enchanted (nachash) our Isralite progenitors and they received sunstroke and were dangerously blistered by the tremendous summer heat after "the people spoke against God and Moses" and refused to get in the shade of their tents. Moses warned them to keep in the shade during the heat of the day, but the stiff-necked people ignored him and remained out doors to look at the enchanting mirages constantly changing from one spectacle to another. Many of the people died from sunstroke and severe sunburn. Those not dying yet were weakened with high fever appealed to Moses to save them. He could have used his Power and cured them, but it would have been useless. They were so rebellious that, as soon as they had been cured they would have again defied him. To convince them he knew what he was talking about he let them suffer and learn the hard way. They would not rely on him for anything when the going got tough, Without something to look at and remind them of Moses' warning to remain in the shade during the heat of the day, they would go their head-long way and continue exposing themselves to sunstroke and sunburn while declaring they were rugged enough not to be hurt. Therefore, in Num. 21:9 is the record where Moses installed a brass serpent on a pole in the center of the camp,

That word "serpent" is nachash in the original. Moses, however, did not install it for the people to worship and appeal to, to cure snake bite as many Christian clergy men have preached, or ignored it because their idea of it was that of an idol. Now idol-worship is for bidden by God. To preach it as an idol, which God told Moses to install, would be contrary to His Word. Therefore, that portion of our Scriptures is ignored by many clergymen. The occults have seized hold of that "serpent" and declare our Israelite progenitors worshipped the Ophidian god who is Satan symbolized as the serpent of divine wisdom, and our God gave approval. Inasmuch as God told Moses to set it up, the Ophites declare the tribal God of Israel knows Satan is more powerful than He.

God, however, never told Moses to install an image of the Ophite Devil! In Num. 21:8is where He tells Moses to install the fiery serpent. That serpent is a nachash, and it means an enchanter in the original Hebraic text. The word "fiery" is seraphim. What, then, is that serpent? It is nothing more than a flat or concave polished brass disc to serve as a "thermometer" installed in the middle of the camp so it could be observed from any angle. When it became hot in the sun and its temperature increased as the sun approached the zenith,heat waves—seraphim—began radiating from it. At the maximum temperature, the radiation would be so intense, one looking at it would see a spectacle as though the radiated heat was water pouring in every direction similar to water flowing down the outer surface of a glass windowpane while one looks at it from inside the room. When our progenitors saw that fiery radiation it was a solemn warning that the temperature out in the sun rays was too intense and they had better get in their tents and remain until the heat slacked off in the late afternoon. That time was indicated when

the brass enchanter ceased radiating. Those formerly receiving minor sunstroke and sunburn were cured by remaining in their tents. I do not know how high the temperature rises in the Arabian Desert in summer, but Mr. W. B. Seabrook in his book, "Adventures in Arabia", says it is so severe that, one will even blister in the shade of a moving motor car, To prevent it it is necessary (for white men) to wear heavy woollen clothes. He says he preferred being part boiled that way rather than roasted with light summer clothes on.

On the plains of Cambodia, French Indo-China, I have experienced during the dry season a temperature rise to 150 degrees Fahrenheit in the shade. In the open sun rays the temperature is so intense, the exposure to it is similar to one walking into an open fire, and the flaming fiery serpents (seraphim) are very much "alive" and active on the distant landscape, They are mirages produced by heat waves rising from the dry ground. They form in various shapes. Occasionally they seem to be a waterfall or cataract, except the "water" falls upward. On other occasions they seem to be a lake of shimmering silver. Other times they seem to be millions of headless white snakes chasing one another over the landscape. Occasionally one seems to see a high wave of shimmering molten glass rapidly approaching.

There still lingers in Anglo-Saxondom an "old saying" that the sun heat waves are Lazy Lawrence. Obviously, the expression has come down from our progenitors' 40 years of probation in the Arabian and Sinai Deserts when they lazed around their tents during the heat of the summer days. In modern steel mills those same fiery, burning serpents (seraphim) can be observed in the blast furnaces when the temperature reaches a certain degree of white heat. They are a glowing red color, whereas the main fire is white. They resemble big fat lizzards about 12 inches long. They are known to steel workers as "fire lizzards". The same fiery serpents are again observed in Isa. 30:6. In Deut. 32:24, however, the serpent isa snake.

In the original manuscript it is "zachel". The word can be used for a snake, a worm, or to be afraid. In II Kings 18:4 is the record of King Hezekiah destroying the brass "thermometer" made by Moses because the people still believed it contained life and was an object of worship to them. In Psa. 140:1 the word "man" is Adam in the original. It graphically shows the men of Israel's Household are of the Adamis race. They had sharpened their tongues like a serpent (verse 3). That word "sharpened" is latash, orto instruct. The word "serpent" is nachash and written with bars and dots to show he is of Satan's race. Any instruction coming from that source is the philosophy of hate. It is denoted in the word "poison", which is chemah, or heat, fury, anger. The word "adder" is akashub which is the female viper in Matt. 3:7 and co-relating passages. She is Kali, the poisonous female of Jewry's Beast System.

In Pro. 23:32 the serpent and adder are the same as in Psa. 140:3. The serpent in Pro. 30:19, however, is the enchanting, quivering waves caused by rocks radiating the sun heat. It is denoted by the word "serpent" is nachash and written without bars and dots under the last two character sin the original Hebraic. In Eccle. 10:8, 11 the serpent is nichash and written with the bars and dots to show he is of Satan's counterfeit race. It is further denoted in the ward "hedge" in verse 8 which is gader, in the Hebraic. It means a wall as one's protection in the law. The word "bite" in both verses is nashak, or to lend upon usury: "Surely the son of Satan will lend upon usury without enchantment" (verse 11) when one breaks the law: He loans on usury as our bail-bond brokers. In Isa. 65:25 the serpent is nachash and written with dots and bars to prove he is the cursed race of Jews soon to be banished from Israel's Christian world.

The wolf symbolizes people in the House of Israel who have not accepted Christ Jesus, whereas the lamb are those accepting Him. The lion symbolizes the lion of Judah and the bullock symbolizes

Ephraim who is England. The straw which they are going to eat together is clean, uncontaminated peace after the Serpent race of Jews has been banished from Christendom to eat dust for the next thousand years. That word "dust" is apha, or rubbish, which will be the spiritual, mental and material food of Jewry exiled out in Mongolia and Tibet from whence his ancestral father,

Cain, came when he went into the land of Nod, which means wandering, in the Hebraic. In Jer. 8:17 the serpents and cockatrices are the same counterfeit race of the Devil. In Isa. 14:29 is a prophecy for this era. The serpent is nachash and written with the bars and dots to prove he is of Satan's Serpent race of Jews. Isaiah says its offspring would be a poisonous cockatrice. It was a female. During Isaiah's time she was called Ishtar. Today, she has adopted her original Hindu name of Kali. She is the deadness in Jewry's blood system as the vampire of that counterfeit race. She is the adder in Psa. 58:3, 4; the viper in Matt. 3:7; 12:34; 23:33; Luke 3:7; the woman in Zech. 5:7 and Rev. 17:1-6 notwithstanding the Jew lie that, the latter is the Roman Catholic Church. The Serpent in Isa. 14:29 was the Luciferian priesthood and Satan in Babylon from 721 to 330 B. C.

A relative of theirs exalted himself as God in India in 600 B. C. He was the King of the Naga, or Serpent, race in that land. Since time immemorial, the King of the Serpent race has been the current eldest son of the eldest son of the original Crown Prince of Hell. He was worshipped as Lucifer yet called God. The record of the one exalting himself as God in 600 B.C. is the first secular record of the exaltation in India, whereas his record in the Hindu Scriptures goes back to about 35,000 B. C. when Enoch of the Adamic line of Seth says in his Messianic Prophecy Satan first came out of the dimension of spirit a counterfeit material Beast making his appearance amidst man contrary to Divine Law. Isa. 14:29 is so big we have to stand at a distance and observe it from Psa. 58:3, 4 on through the Book of Revelations and verify it by the Serpent's own record.

At this occasion, however, we will not dwell on Isa. 14:29 any further than to observe the meaning of the Hebrew words which say: "Rejoice not, thou, whole Palestine, because the rod of him that smote thee is broken: for out of the Serpent's root shall come a cockatrice, and his (or her) fruit shall be a fiery flying Serpent". The original for that word "rod" is shebet. It is a sceptre. It is the original caduceus as the emblem of Kali's power—the emblem of witch craft, or occult science.

The first serpent is "nachash". It is written with bars and dots under the last two characters. Written thus, it proves he is of Satan's Serpent race of Jew vampires. The word "root" is shoshan, bottom. It is the bottomless pit of hell in the upside down floor of the Synagogue of Satan. The word "cockatrice" is tsepha. It is an adder, or viper, which seems to be an ordinary snake. It would if not connected with Satan's Serpent race. When connected with that race we know that cockatrice is the whoring mother-spirit, or the vampire condition of Jewry's blood stream. The "fruit" of that cockatrice is "peri". It means a branch. The word "fiery" is seraph, burning one. The word "flying" is uph, to be faint, be weary, flee away, wax faint. The second "serpent" is saraph, a burning, fiery, stinging. Yes, she will be a burning, fiery, stinging Reptile[1] She is Kali, the prostituting blood-drunk mother-spirit of a race of religious cutthroats and murderers. As the material, or masculine, Cockatrice he is the Ashkenazim-Khazar Jews in Christendom and the black Zhuzhu Jews of Asia in who is the Satanic force of the night-prowling vampire (Kali), the female Cockatrice of Jewry's Serpent System.

With that whoring spirit within them they pretend to be faint, always weary because they are persecuted, to hear them tell it, just because they are unfortunate to be born Jews. They flee from justified punishment when their sabotage and destruction smacks them in the face. They wax faint after every pogrom, but they press on with one thought constantly burning within them—a fiery, stinging, spiritually-depraved sense of revenge against people, who formerly gave them sanctuary out of pity,

refuse to bow to Jewry and lower themselves to his level then surrender to that counterfeit race and permit it to rule supreme with its subjects clamped in the so-called benevolence of Talmudic slavery.

Satan's Serpent race bobs up again in Job 26. He is the same breed as the one in Isa. 14:29. Another track is observed in Job 24 as the low chicanery of Satan's vampire race whom Job calls "he" occasionally, and "he" is Satan as Bildad's god. Bildad and his companions are Cainite Sabine-Serpent mongrels. Another Snake track is observed in Job's 25th chapter where Bildad is praising Satan and condemning God. He says to Job: "How then can man be justified with God?". So, come on over to Satan's house, Job. His light of the Luciferian Doctrine shines on all good men. God even looks with scorn on the moon and stars, but Satan is wiser—he worships them. How can God love a man who God looks on as a worm and the son of a worm? But Job answered and said, "How have you (Bildad) helped him that is without power? How save you the arm that has no strength? Dead things are formed from under the waters, and (from under) the inhabitants thereof" (Job 26: 1, 2, 5).

That compound word "dead things" is Rephaim in the original Hebrew. It means the Shades of spiritual and material death. It is the twice dead Serpent race of Jew vampires. In Job 25 the word "dominion" is mashaal, to cause to rule. Fear is pachad, dread. Peace is shalom, favour. The high places in marom, a person in authority. Light is "or", enlightened. Arise is qum, abide. Thus, Bildad says his god (the Jew race) causes fear to rule when a Jew favours one in authority. Jewry's favours to man then and now is preceded with the lowest form of servility, boot-licking then loaning money to an individual or a government so as to obligate them to him. When Satan as a Jew has obligated one to his Beast System, his Luciferian Doctrine insures him that, man's instinct to be honourable compels him to respond, and inasmuch as the Jew seems so harmless, while being so meticulous in his duties, he is given a position of authority and trust. After securing that advantageous position, the Jew gradually puts forward hidden suggestions for various unnecessary projects which the superior non-Jew ultimately believes are necessary and the initiative seems to be his. The projects are started and he unconsciously does the very bidding of the Jew whose slithering chicanery gradually undermines the business until the damage is beyond repair before the superior awakens to what has occurred. Perhaps he trusts the Jew to such an extent that he will never awaken to the truth. He takes the responsibility as being negligent for permitting his business to decline and he discovers he is denied further credit at the bank presided over by another Jew secretly in league with the traitor in his office.

Satan then offers to "reciprocate" the former favours he received and offers to buy one's business in apparent sincere efforts to prevent one from becoming a total failure. One has no alternative. The offer is generous. One accepts the offer, and one's work, created out of one's genius, passes into the parasitical hands of the blood-sucking vampire who then goes to his brother-Jew in the bank to refinance the business for speculative purposes. The traitorous Beast then sells the property at an enormous profit while his former employer commits suicide because he believes she is a failure. The traitor and his banker-brother then divide the loot between themselves in accordance with Lucifer's law in the Schulchan Aruch section of the Talmud which says: "When a Jew makes a deal with a non-Jew, and another Jew comes up and deceives the non-Jew, no matter in what manner, whether he gives him false measure or overcharges him, then both Jews must share between them the profits thus sent by Jehovah". On other occasions when one becomes obligated to a Jew in any manner and he learns one's weakness or discovers a secret which one is ashamed of and is desirous of keeping it out of public cognizance, one is then in the power of the Luciferian Reptile.

When the superior awakens to the chicanery and takes measures to divest himself of the crawly influence, the Jew bears his poisonous Serpent fangs and bodily demands to be given supreme power or he will expose the secret to public view. If the superior defies the Jew the latter very "piously" gives

information about the secret to the newspapers in what he declares is service to the public. Another Jew then broadcasts it over the radio so as to kill the confidence of the public in the victim. The blind public does the rest and throws the good man out of office and destroys his public usefulness while the hypocritical, blackmailing Jew is held up as a public benefactor. When Satan has accomplished his dirty work he then slithers into the vacant chair to suck his living out of our people if the occasion warrants it. If, however, it is not expedient for him to take the chair at that time, he suggests to other superior non-Jews that a certain man—anon-Jew—is more capable than him to discharge the duties of the office. In that manner Satan remains in darkness behind the "certain man" who is always of weak character and submits to the Jew's very bidding out of fear of losing his well-paid job or of being character-assassinated.

In respect to Satan getting peace in high places of our government and Nation. Dean Acheson, Secretary of State, and President Harry S. Truman are the "certain men" of whose sponsored conspiracy Senator Joseph McCarthy speaks of in the Congressional Record for 14 March 1951: ". . . Mr. (Owen) Lattemore, the State Department's adviser, praised the State Department for having succeeded in allowing China to fall to the Communists without letting it appear to the world that we had shoved it. It is almost incredible, but it is a matter of record. He then goes on to say: "The thing to do, therefore, is to also let South Korea fall but do not let it be known that we pushed her; hence the recommendation for a parting grant of \$150,000,000'. "The picture of Western Europe, Mr. President, is much the same. We are preparing to allow Western Europe to fall without having it appear that we pushed her In other words, the present plan is strictly a "phony" plan for a "phony" defence—a case of those in the back rooms, where the planning is done by the same crowd that did the planning for China, saying the same thing said about China, namely, 'We will let them fall, but we will not let it appear that we pushed them' ".

In a cafe in Budapest, Hungary in 1919 Jew Jacob H. Schiff revealed another phase of that Beast System. It was published in the book, "Geneva Against Peace", by Comte de Saint-Aulaire in 1936 in which he quotes Schiff: "The health of our Golden Calf (note—the Jew god of gold) demands that certain nations should be sick, namely, those not of themselves to develop. Take for example pre-war Turkey, the "sickman", as it was called by diplomats, which helped to keep us healthy. From it we received concessions of every description: banks, mines, harbours, railroads, etc., in short, its whole economical life was in our care. And we cared so well for it that it died, in Europe at least." Now that the accumulation of (Turkey's) wealth has become common (property in the international Jew banking house of Rothschild), and that we have the fulfilment of our mission at hand (of revealing to Christendom the fact that Jewry is Satan, and the re-establishing the World Empire of Satan) we need another sick man.

This alone would have been sufficient reason, apart from higher consideration (of annihilation of Christianity) for grafting Bolshevism on to Tsarist Russia. Russia is now the sick man of the post war days, and it is much more nourishing than the Ottoman Empire. It also does less in its own defence. It (the god of gold) is now ready for another feast. Soon Russia will be a corpse, and we shall have nothing left to do but to cut it up . . . Even if a few drops of blood were spilled in the process, we (Jews) have no cause to get excited". A few drops of blood spilled in Jewry's efforts to annihilate Christianity! The record shows Jewry is directly responsible for the death in wars, mass murders in deliberate starvation of more than 144,000,000 people in the past 38 years. When Adolph Hitler began attracting attention beyond Germany with his anti-Jewishness, the Jew Cahilla in America selected James P. Warburg of Kuhn, Loeb & Co. to finance him so as to build up a Nationalist Germany then push Anglo-Saxondom into attacking Germany and thus break the back of Christianity in Central Europe so as to pave the way for Jewry to seize all of Europe in the name of Russia in the final prelude to the destruction of the white race and the establishing of Satan's World Empire.

Major Robert H. Williams reported in his "Williams Intelligence Summary" for February 1950 about James P. Warburg's part in the plot against Christendom. He says: "Last November, the widow of the late General Ludendorff, on trial at Nuremberg, explained why her husband broke with Hitler, confirmed the reports in convincing detail." She stated that, . . . as early as the summer of 1929 James P. Warburg had undertaken an assignment from financial circles in America, which desired to exercise solitary influence on Germany in the unleashing of a national revolution. Warburg's task was to find the suitable man in Germany, and he entered into contract with Adolph Hitler who subsequently received sums of money amounting to 27 million dollars up to January 30, 1932, and still another seven million thereafter, enabling him to finance his movement' ".

After the 1919-German revolution Jewry took over the country lack, stock and barrel. Jewry retained power until Hitler came on the scene. Then why was international Jewry so anxious to foment a nationalist revolution in Germany? Because, they desired to destroy the Royal Judah tribe of Israel (the Nordic Germans, real Semites) because Jewry could not absorb them in mongrelization; and to destroy Christianity in Central Europe. After Adolph Hitler received the financial assistance he disenfranchised the Jews in Germany then set up a banking system of his own. Nevertheless, Anglo-American Intelligence Services learned that, Hitler, Jew Rudolph Hess and Von Papen secretly called on Jew Baron Kurt von Schroeder in Cologne and obtained his guarantee to further finance Hitler's schemes, Schroeder agreed to the proposition after bribing Hitler to place Jews in strategical positions to direct the very heart beat of National Socialism. Hitler made Jew Hjalmar Schacht the Director of the ReichBank. Rudolph Hess became Deputy Fuehrer. He is the son of an Egyptian Jewess. General von Haushofer was made Geopolitical Minister. He is a Jew. General Milch became head of the Luftwaffe. He is a Jew. Goebbles was with Hitler to the end. He was a Jew. All of which is in accordance with Jewry's protocol No. 15 which says: "But if there should arise in its midst a plot, then at the head of that plot will be no other than one of our most trusted servants".

Baron Kurt von Schroeder was related to Baron von Schroeder of J. H. Schroeder & Co., Ltd., London, England, which, together with Messrs. N. M. Rothschild & Sons; Ruthers, Ltd., and the Imperial Chemical Industries assisted James P. Warburg of Kuhn, Loeb & Co. finance Hitler in accordance with protocol No. 9 which says: "Nowadays, if any State raises a protest against us it is only pro forma at our direction and at our discretion, for their anti-Semitism is indispensable to us for the management of our lesser brethren". Thus, the Jew Devil will murder his own sons so as to get peace (shalom) from one in authority (marom) which causes fear of the Jew (pachad) to rule (mashal) amidst those he abides (qum)

We next observe the Serpent race in Psa. 58:4 in which the word "poison" is cheetah, in the Hebraic. It means, anger, heat, fury, rage, hot displeasure, wrath, to be furious. That poison is used on non-Jews having high moral and spiritual strength and refuse to lower themselves to the level of a Jew. Usually, the approach is by bribery concealed as a gift. When he fails to reach his intended victim he lets fly the poison of fury, rage and wrath in attempts of character assassination so as to kill one's business or political life. If the person is immune to the poison, and the Jew Cockatrice fails to silence the truth about his skulduggery, his final effort comes by using the poison of hot displeasure and he becomes furious in premeditated cold-blooded murder. However, if it is not expedient for the Reptile to personally murder his victim, or he is too cowardly to do it himself, he bribes some non-Jew to do the dirty work while the Jew Reptile remains in ambush as a "respectable" citizen whose only crime, to hear him tell it, is being unfortunate enough of being born a Jew.

In Amos 5:19 is the Serpent "nachash" as the so-called divine wisdom in the Luciferian Doctrine of Spiritual Illumination. The way the Hebraic word "serpent" is written in the original passage (with bars

—occult science) the Reptile has nothing to crawl under. The "wall" which one is going to lean against in our national house is spiritual salvation through our Lord Christ Jesus. It is the same wall that is prophesied in Isa. 60:18. One is inviting the sting of the Cockatrice if one seeks rest in spiritual salvation as preached by the so-called Christian denominations banded together in the Communistic Federal Council of Churches of Christ which is sponsored and maintained by Jews in efforts to keep Christ Jesus out of the church houses then enshrine Satan on one corner of the pulpit. He, as a Jew, has even been made the preacher in some of the denominations. One is guaranteed to receive Snake bite if one leans against the false wall of the so-called Christian spiritualist cults which deny the sovereignty of Jesus Christ. Christians are requesting their pastors to define the word "leviathan" which is found in Job 41:1; Psa. 74:14; 104:26 and Isa. 27:1. The Hebraic for "leviathan" is the same as in English. It means crying, mourning, and a great water animal. Job and David are referring to the latter. Isaiah, however, is prophesying about something entirely different, yet he symbolizes it as having characteristics of that great water animal.

Isa. 27:1 says: "In that day the Lord with His sore and great sword shall punish leviathan the piercing serpent, even leviathan that crooked serpent; and He shall slay the dragon that is in the sea". That word "piercing" is bariach in the Hebraic. It is synonymous with the word "flying" in Isa. 14:29. The word "serpent" is nachash, and it is written originally with bars and dots to prove it is the Serpent race of Jews, The word "dragon" is tannin. It means a great sea serpent. The word "sea" is yam. It means west, west side, western, westward.

One observes, therefore, that particular sea is not a sea of water. Instead, it is the people of Christendom, which is further denoted in the time measurement of "the Day of the Lord" which is Armageddon. The latter is a place and an era. The era is the 40-year "day" of Jacob's Trouble brought out of the lowest depths of the dimension of spirit by Jewry's Era of Kali. It began in 1913 and ends in 1953. In the near future we will see the Day of the Lord in which Satan's Serpent race of Jews will be annihilated in Christendom. It is inevitable so Israel can sweep out and cleanup the Kingdom of God before the beginning of the Millennial Reign of our Lord Christ Jesus on the Throne of David, which is the Throne of England today. The annihilation is also portrayed in Isa. 34:5, 6 in which the Jew is clearly mentioned by name—Idumea; Ezek. 35:15; 36:5; Zech. 14:21 where he again is mentioned by name—Canaanite; and Rev. 20:1-3. We observed the dragon in Isa. 27:1 is a "tinnin", or a great sea serpent. Then, in Exodus. 7:9,10, 12 the word "serpent" is also tannin, but it means a howling dragon (lizzard). Inasmuch as he is pronounced in the Hebraic the same as Isaiah's sea serpent, then both creatures are shaped the same, yet one lives on land and the other in water. The one in Isa. 27:1 is symbolical yet the other is a living lizard, and because the leviathan, serpent and dragon in Isa. 27:1 are one reptile symbolized as being shaped like a lizard, then, when we observe the leviathan in Job 41:1; Psa. 74:14; 104:26 has the same meaning as the one in Isa. 27:1, we know David and Job are referring to a crocodile.

Moreover, when we denote the word "leviathan" also means mourning and crying; and the word "piercing" is synonymous with the "flying" in Isa. 14:29, then, leviathan is further revealed to be a crocodile. Thus, we observe Isaiah in symbolizing the Serpent race of Jews have attributes similar to crocodiles: When his slithering chicanery backfires in his face, when a nation wakes up to the fact that it has been sabotaged and destroyed by Jews, who were admitted into the nation so as to find sanctuary from persecution and destruction, the crying, moaning Jew sheds "crocodile" tears in efforts to win sympathy and pity from the betrayed people driving him root and branch from among them. He flees from the justified punishment and sheds more "crocodile" tears at the gates of another nation while crying and moaning his age-old lamentation that he is a homeless refugee fleeing from punishment piled on for no reason than that he is a Jew.

He is admitted into the sanctuary of the sympathetic nation, and the flying Crocodile that he is submerges in the cool water of human decency with only his unblinking watery eyes showing above the surface at places where trusting people go to slake their spiritual thirst for God and material needs for the first necessities of life. When they wade out in striking distance of the lurking Beast he grabs them and spiritually and materially-devours them without the least pity. Inasmuch as "leviathan" refers to a crocodile as well as crying and mourning, it is obvious, that, from our ancient Israelite progenitors is where we Anglo-Saxon-Celtic people obtained the expression of "crocodile" tears.

After coordinating the meaning of the Hebrew words leviathan, piercing, crooked, flying, serpent and dragon in Job 26; Isa. 14:29 and 27:1 we observe the Jew Crocodile fleeing from his justified punishment in the last hour of the Day of the Lord when his slithering, silent chicanery back-fires in his unblinking, crying eyes with greater vengeance than in all the annals of history, because it will be the national redemption of the House of Israel from Satan's counterfeit race. Isaiah has warned you! Take heed, stand steady and observe the hand of the Lord at work amidst His people! Be not deceived by the crocodile tears of the morning Jew. The only sorrow he will have is we "stupid oxen of his" refuse to abandon Christ Jesus for Satan then bow down and worship the King of the Jews as God and his race as the lesser gods. Jer. 46:22 says: "The voice thereof shall be like a serpent: for they shall march with an army, and come against her (Egypt) with axes, as hewers of wood". It is the cursed Serpent race using the Chaldeans as an axe to chop Egypt to pieces so the Luciferian priesthood with the army can move the Egyptian treasure to Babylon and imprison Pharaoh Uahabra in a Babylonian dungeon and consummate the Babylonian Empire in which the Serpent priests of finance would rule from Babylon after consummating the World Empire of Satan in accordance with Isa. 14:29. The word "serpent" in the above passage is nachash in the original, and it is written with the bars and dots to prove it is the Serpent priesthood of Babylon, which is substantiated by secular records.

Jeremiah's prophecy was fulfilled in 566 B. C. when the Luciferian priesthood succeeded in consummating the great Babylonian Empire through King Nebuchadnezzar II. The 29th through the 32nd chapters of Ezekiel prophesy the same episode. In all the annals of history while the Serpents murdered and robbed one another God used them to destroy their own evilness so as to prevent them from becoming too strong. God placed Nebuchadnezzar II on the Throne of Babylon in order to destroy the Devil in Tyrus (Ezek. 28:12-19) and imprison the insane Pharaoh Uahabra of Egypt so the King of Babylon could incorporate all western Asiatic civilization into one empire and set the stage to raise up the branch of Satan in whose house his sceptre would be broken and God would not permit him to establish a World Empire.

When the Babylonian Empire was consummated God had Satan where He wanted him and in rapid succession the Serpents murdered one another in greediness of each to reign as "God", yet the Devil in Isa. 14 failed to seize open domination and his sceptre was finally broken in 330 B. C. when a kinsman of Jewry's current god, Prince Abdul Baraba Baha (Darius III) was murdered by the satrap, Bessus, which terminated the great Babylonian Empire and the Cockatrice of Isa. 14:29 came out of the lowest depths of the bottomless pit as the Devils of the Selucidian Dynasty. The Devil, however, left Babylon in 429 B. C. when he moved to Pergamos, Greece from where he plotted the annihilation of the Israelite House of Judah in order to defeat God's plan for man's ultimate destiny. He failed, however, and Jehovah removed His House of Judah out of Palestine to the Danube Basin in 70 A. D.

The Satanic race of Jews remained in Palestine and the Devil in the form of Jew Bar-kochab again attempted to regain a World Empire by conquering the Roman Empire. Michael, however, used the Romans for his battle axe and weapons of war and broke the Devil's sceptre again in 135. A. D. Amos

9:3 says Jehovah would permit the Serpent to bite the House of Israel. The word "serpent" in that passage is nachash with the bars and dots under the second and third characters to prove he is the Devil's counterfeit race of Jews. The prophecy is for this era, and the House of Israel who was promised all the things for the "latter days"—the Christian dispensation—is the Anglo-Saxon-Celtic people. True to that prophecy, we, as a people, indeed have been struck by the skulking Jew Snake hiding in the ambush of sham patriotism, and we have descended to the lowest depths of spirit, morals and national apathy—the bottom of the sea in Amos 9:3—during the past 38 years. By the Grace of God, alone, will we rise to the surface in time to prevent being drowned by the Jew Devil who is now attempting to inveigle our government into signing into law the international Genocide Treaty so as to make it impossible for us to grub Jewry out of our Nation once our people were to wake up to the fact that, Jewry has now pushed us into World War III in which he purposes to cause the heathen millions of Asia and Africa to exterminate the white race from the face of the earth.

In Micah 7:17 is a prophecy repudiating Jewry's grandiose plot of destroying the House of Israel and our Christian faith in God. Micah says the non-Israelite nations will lick dust. It symbolizes cringing fear of being annihilated. However, it is not natural for them to lick dust in the manner of the Jew Serpent who licks it in accordance with Gen. 3:14 and the meaning of the word "flying" and "crooked" in Isa. 14:29 and 27:1 which is proven when we denote the word "serpent" in Micah 7:17 is nachash and written with the bars and dots in the original. The nations will lick dust when world Jewry pushes them in front of Russia in the final effort to annihilate Christendom. It is inevitable. All of Israel's prophets saw it in the dimension of spirit and we lack only time to bring us in proximity with it. The final struggle is set forth in Ezek. 38 and 39 in which he names Russia as our adversary: and the "he" in 38:17 is Jewry headed by the Devil, Prince Abdul Baraba Baha, whose image, the Turko-Mogol Jew, Josef Vissarionovitch Djughashvili, alias Josef Stalin, sits on the Serpent Throne as the Magog, chief prince of Meshech, or Moscow. In Matt. 7:10 and Luke 11:11 is Jewry's Ophidian religion of the Luciferian Doctrine of Spiritual Illumination. It is denoted by the Greek for the word "serpent" isophis.

In them, Christ says: "Or if he asks a fish will he give him a serpent?" Since time immemorial, the worship of God was symbolized by a fish. The early Christians identified one to another by the image of a fish instead of the cross. They are regarded as Christ's fishermen in Jer. 16:16; Matt. 4:19 and Mark 1:17. The symbolism is carried on into Matt. 7:9 in the word "bread". It is Christ, the Spiritual Bread of Life. In Matt. 10:6 Christ Jesus tells His disciples to become as wise as serpents. That word "serpent" is ophis in the original. As Christ Jesus uses the word we know that serpent is on the same order as the one in Gen. 49:17 where Israel tells Dan he would become a serpent. That is what Christ is telling His disciples—observe diligently, and learn by experience. Mark 16:18 says the disciples would take up serpents. From that passage and Acts 28:3-6 Christian clergymen have preached the serpent in Mark 16:18 is a snake, and the deadly thing is a dose of poison. In the original Greek, however, a snake is "herpeton". He is found in James 3:7. The one in Mark 16:18, however, is an "ophis", which proves it is of the Serpent race of Jews and its Ophidian religion of worshipping Lucifer's "divine wisdom". Moreover, in the original Greek of Mark 16:18 the compound word "take up" is ario. It means, to take away. It does not mean to take up as one would pick up anything, or, as St. Paul took up the snake in Acts 28:3-6 and shook it off into the fire. The compound word "deadly thing" in Mark 16:18 is thanasimos, or belonging to the dead. That word "dead" is synonymous with the "dead things" in Job 26:5. It is the Shades as the Jew Serpent race.

If Christ was referring to the disciples drinking a lethal potion, the original for the word "deadly" would be thanatos. The drinking is not literal. It is the same as one would say: "I drank-in his philosophy". Christ Jesus, therefore, was telling His disciples they would take away the Luciferian Doctrine from Israel by teaching His glorious plan for spiritual salvation which will eventually

culminate in racial spiritual salvation after national redemption of the House of Israel from Satan's Serpentrace of Jews.

Anyone hearing the Message of Christ yet turns from Him to the Serpent's Luciferian Doctrine will be destroyed by the Serpent in accordance with II Cron. 10:9. The Serpent there is anophis. One taking that deadly thing to one's bosom renounces spiritual life, because the portions of the Luciferian Doctrine (ophis) which the Serpent race (the Ophites) permits us to see seems so logical it appears to be the true way of spiritual salvation. However, it leads one into the swamp of spiritual death, and if one goes all-out for it, one "drinks" the Serpent's "deadly" misrepresented liberalism, fraternity, brotherhood and equality then marries a Jew, and one's line is killed in the Satanic blood system of Jewry and in turn becomes a vampire.

The serpent in II Con 11:3 is anophis. He is the Serpent race of Jews, the same who beguiled Mother Eve. St. Paul is worried about the Christians being influenced by the new Gnostic version of the Luciferian Doctrine revised by Simon Magus (the Simmon of Acts 8:9-13) to sabotage the faith in God. In Rev. 9:19 is the record of something observed by St. John when Christ Jesus took him into the dimension of spirit in 35 A.D. He says: "For their power is in their mouth, and in their tails: for their tails were like unto serpents". That serpent is anophis, yet it is not the Serpent race or its religion. It symbolizes the type of cannon used by the Turks in 1453 A.D. when they conquered the Eastern Holy Roman Empire. The war, however, was financed and fomented by Jewry's Greater Sanhedrin which had been in Constantinople since 79 A.D. That Cabal remained there until 1552. Archaeologists have recovered guns used in the campaign. Their muzzles were cast in the image of a lion's head (Rev.9:17), and their "tails" were fuses ignited by torches. John describes them as being similar to the Serpent, who, in 1453, had his tail anchored around Lhasa, Tibet from whence came the spark that caused him to belch forth the fire and brimstone of geopolitics which caused the Turko-Mongol invasion of Christendom.

In accordance with the genealogical record of Jewry's current Devil-god, Prince Abdul Baraba Baha, the Serpent in Constantinople in 1453 was the Turko-Mongol Jew, Amurath. From Gen. 3 to Rev. 9 we have observed the people we know as Jews are the Serpent race of the Devil whose evilness is the Devil and his demons in the dimension of spirit. To prove it without leaving any doubts in our Minds, St. John, in Rev. 12:9 and 20:2 lays Jewry wide open and exposes him all at once as the Red Dragon, that old Serpent, which is the Devil and Satan. Irrespective of that fact, let us not end this expose at this occasion, because one may yet ask: "How can the Devil be the King of the Jews, and Jewry be Satanic, for is not the Devil purely a spiritual being down in the lower regions of the earth? Does not the Bible declare the Jews are God's chosen people?" The answer to both is, emphatically NO! and the Biblical Message proves it. Any historian knows they are not God's chosen people, they are not of Israelite extraction, and the Bible sets forth in plain English that Jewry is the literal household of the Devil; and in 1920, Dr. Oscar Levy, a Jew in England, stated in the preface of the book, "The World Significance of the Russian Revolution": "Are not the Jews the inventor; of the Chosen People myth?" The theory of hell being in the nether regions of the earth, or any other place, where the Devil resides to burn human Souls after death of the body is Jewish, and they obtained it from their ancestral Devil-god, Nergal-Shar-Usur, a son of King Nebuchadnezzar II of Babylon, which was slipped over the head of Christendom in order to deceive us with the lie so we would not see the truth that Jewry is Satanic.

Enoch of the Adamic line of Seth says in his Messianic Prophecy the Devil came out of the dimension of spirit about 41,000 years ago. He did it on his own accord, and God did not create him, yet Col. 1:16 says God created everything, and John 1:3 says: "All things were made by Him; and without Him was not anything made that was made". That is true. God, however, did not create the Devil! Therefore, he

and his counterfeit race of Jews are unrealities as a lie and an error in the tangible form of humans (John 8:44), God, however, created Lucifer, yet he died when he failed to conform in accordance with Divine Law, and the spiritual deadness became Satan, or God's adversary. He was then thrust out from the Throne of God in the high planes of spirit, or heaven, to the lowest depths of the dimension of spirit. He was totally cut off from God and he thought of ways of getting revenge, yet he could not touch God in any manner. Therefore, he came out of the pit of spiritual upside downness to the material plane without God's approval in order to get revenge against God by spiritually and physically-killing man, because man's Life Force is of God and by killing man the pain would also hurt God.

When he was in the pit he was intangible spiritual evilness, yet when he transposed himself to the material plane he was tangible flesh, yet counterfeit because he was in no manner a part of God and the transposition was in direct violation of Divine Law. Gen. 14:18 gives a relative picture of the situation in which God's Christ-Son of Righteousness as Melchizedek stepped out of the dimension of spirit to renew His Covenant with father Abraham in the sacrament ritual. He came into the material plane in accordance with Divine Law, because that Law is in His Being. He was real and as tangible as Abraham. The wine and bread He brought out of the dimension of spirit was also real and tangible. He and Abraham ate the bread and drank the wine. In Gen. 19:1-22 is the record of two of the archangels who stepped out of the dimension of spirit into the material plane in the interest of Lot and his family.

They ate tangible food cooked by Lot's wife. They were tangible. In Gen. 32:24-30 is the record where another archangel stepped out of the spiritual plane and wrestled with father Jacob all night. He was as tangible as Jacob. In Luke 1:1-38 is the record where Gabriel stepped out of the dimension of spirit to inform Zacharias that his wife would conceive and bear John the Baptist. He then made himself manifest to the virgin Mary and informed her that she had been selected to be the mother of God. Her Son was Jesus Christ, the same as Melchizedek in Gen, 14:18. He as Melchizedek could have stepped out of the dimension of spirit in full stature as He did in Gen. 14:18. In that condition, however, He would have not been subject to death which He had to endure in order to destroy the Devil. It was essential, therefore, for His Spiritual Energy to be "born, not of blood, nor of the will of the flesh, nor of the will of man, but of God" (John 1:13) so the Devil could murder Him then be resurrected in order to cancel spiritual and physical death in the House of Israel, then ultimately for all humanity after Israel teaches men the truth about God and things spiritual and things material without the Devil and his Satanic race of Jews being around to sabotage and destroy the work.

In Acts 1:11 are two of the archangels talking to the disciples of Christ after the latter passed back into the spiritual plane after His resurrection from death. He passed back into the spiritual plane in the same Body His disciples loved, walked and talked with, ate and drank with, and that which was pierced on the cross. Yet, at the moment of ascension His Powers of the Cosmos changed the vibratory impulses of the Spiritual Energy of which His Body was made, and the intensity of vibration changed Him to tangible, visible Spirit as He presented Himself to James, Peter and John in Matt, 17. The record, therefore, proves when it became necessary for God's Christ-Son of Righteousness and His archangels to come into the material plane in accordance with Divine Law, all that was necessary was merely to change the wave length of the Spiritual Energy of which they are made, and the lowering of the vibratory impulses made them visible to human eyes without discomfort, and they were as tangible as any human. They ate, they breathed and they had all the prerogatives of man; and because they were in direct communication with the Eternal Father, they could step into the material plane and back into the spiritual plane with impunity.

If it had been in accordance with God's plan for them to remain in the material plane and they had married human women they could have fathered children as tangible and real as we. On the other hand,

however, the Devil was totally displaced from God, and when he transposed himself into the dimension of the material contrary to Divine Law it was impossible for him to go back into the dimension of spirit because, God's Spiritual Energy was not the corn-position of the counterfeit substance going in to make the micro cosmical order of his body, or the state of being material. From that twice dead Beast mongrelizing with human women sprang the people we know as Jews whose god for all ages has been the current Devil which is proven by Gen. 4; John 8:44; and Matt. 23:35 proves they are responsible for all bloodshed in our Adamic-Israelite Household. Today, the Devil is the Asiatic Jew, Prince Abdul Baraba Baha. He resides in John Hopkins University, Baltimore, Maryland.

He was proclaimed in 1950 to be Jewry's god by Jewry's Grand Orient Free-Masonic Lodge of B'nai B'rith in New York City. He is the prophesied king of fierce countenance in Dan. 8:23-25; the Jew god in Zech. 8:23; the king of all Jew anti-Christ's in Matt. 24:24; the current Jew god in John 5:43; the min of sin in II Thess. 2 and the Dragon in Rev. 13:13-18. Enoch says when the Devil transposed himself into the dimension of the material he was also materially-dead, although possessing a type of animation. Then, the word "dead" used by Jude to describe the condition of the Devil's household of Jews is apothenesko, in the Greek. Its meaning is the same as that for the "brute" in II Peter 2:12, the "dead" in Matt. 9:24; John 6:49 and other places too numerous to mention here. It means precisely what it says—without life, be a dying, to be dead. John 8:43, 47 shows the spiritual deadness when Christ Jesus accused the Canaanite-Akkad-Idumean Devils of not being capable of hearing His Word. That word "hear" is akouo. It means, understanding. They were, and remain, void of spiritual perception, which is the "darkness" in II Peter 2:4, because they are totally cut off from God. Despite our expose of Jewry being Satanic, however, there are Christians who attempt to repudiate us. They refuse to accept secular records, and even Jewry's private epistles and base their contention solely on the surface appearance of II Kings 19:30; Isa. 37:31; Jer. 23:6; 33-16; Joel 2:32; Zech. 12:5, 7, 12; Acts 2:21; Rom. 10:13. They declare they know their Bible which definitely proves the above passages guarantees the House of Judah (the Jews) will take root downward and produce spiritual fruit upward; Judah (the Jews) shall be saved by the Grace of God; Jerusalem (the city in Palestine) shall dwell safely; all, including the Jews, calling on Christ in the Day of the Lord shall be saved and delivered from sin and damnation; and the House of David (the Jews) shall look on Christ who they pierced then repent and rule the world with Him.

There are more than 16,000 words in the King James Bible translated erroneously and an innumerable number used improperly. Therefore, let us look at the Hebraic and Greek in the above citations: The several meanings and is written four different ways: First, it means bars, branches, staves, strength. Second, is le-bad, which means, to be alone, by self, of each other, only. Third, "bad" is linen cloth. Fourth, "bad" is liar, lies. The word "alone" in Zech. 12:12-14 was originally written in the latter manner. It is the Jew mongrels in the House of David and other families of Israel who will lie and shed crocodile tears (Isa. 27:1) in the Day of the Lord in efforts to win sympathy and escape their punishment so as to be given another opportunity to sabotage and destroy man, beat out of him his faith in God so the Jew Devil can set up his World Empire of Satan and have the world all of his own in similar manner as his ancestral father, Cain, is doing in Gen. 4:14.

Zohar, Shemoth

Tob shebbe goyyim harog - Even the best of the Goyim (Gentiles) should be killed.

- * "The 'goyim' are not humans. They are beasts." (Baba Mezia 114b)
- * "If you eat with a 'goy' it is the same as eating with a dog." (Tosapoth, Jebamoth 94b)
- * "Sexual intercourse between the 'goyim' is like intercourse between animals." (Sanhedrin 74b)
- * "All children of the 'goyim' (Gentiles) are animals." (Yebamoth 98a)

In *Zohar*, II, (64b) it says:

"...People who worship idols, and who are called cow and ass, as it is written: I have a cow and an ass..."

Rabbi Bechai, in his book *Kad Hakkemach*, ch. I, beginning with the word *Geulah*—redemption—referring to *Psalms* 80, v. 13: *The boar out of the wood doth waste it*, says:

"The letter *ain* is dropped [suspended] the same as these worshippers are followers of him who was suspended."

Mas. Shabbath 31b

On the house of the Goy [Goy means unclean, and is the disparaging term for a non-Jew] one looks as on the fold of cattle.

Zohar, Toldoth Noah 63b

When the Messiah comes every Jew will have 2800 slaves.

In *Midrasch Talpioth* (fol. 225d) it says:

"God created them in the form of men for the glory of Israel. But *Akum* were created for the sole end of ministering unto them [the Jews] day and night. Nor can they ever be relieved from this service. It is becoming to the son of a king [an Israelite] that animals in their natural form, and animals in the form of human beings should minister unto him."

We can quote here also what is said in *Orach Chaiim*, 57, 6a:

"If pigs are to be pitied when they suffer from disease, because their intestines are similar to ours, how much more should the *Akum* be pitied when thus affected."(49)

(49) In *Taanith* (21b) it says: "How much more the *Nokhrim* since they are similar to Israelites."

Rabbi Edels, in commenting on *Kethuboth* (110b) says:

"The Psalmist compares the *Akum* to the unclean beast in the woods."

Sanhedrin 59a

To communicate anything to a Goy about our religious relations would be equal to the killing of all Jews, for if the Goyim knew what we teach about them, they would kill us openly.

Libbre David 37

A Jew should and must make a false oath when the Goyim asks if our books contain anything against them.

A Jew may violate but not marry a non-Jewish girl.

Gad. Shas. 2:2

A boy-goy after nine years and one day old, and a girl after three years and one day old, are considered filthy.

Pereferkowicz, Talmud t.v., p. 11

They decreed in connection with a heathen child that it should cause defilement by seminal emission so that an Israelite child should not become accustomed to commit pederasty with him.... It is therefore to be concluded that a heathen girl [communicates defilement] from the age of three years and one day, for inasmuch as she is then capable of the sexual act she likewise defiles by a flux. This is obvious!

Avodah Zarah 36b-37a

R. Joseph said: Come and hear! A maiden aged three years and a day may be acquired in marriage by coition [intercourse], and if her deceased husband's brother cohabits with her, she becomes his. The penalty of adultery may be incurred through her; [if a niddah] she defiles him who has connection with her, so that he in turn defiles that upon which he lies, as a garment which has lain upon [a person afflicted with gonorrhoea].

Sanhedrin 55b

Rab said: Pederasty with a child below nine years of age is not deemed as pederasty with a child above that. Samuel said: Pederasty with a child below three years is not treated as with a child above that.²⁴ (24) I.e., Rab makes nine years the minimum; but if one committed sodomy with a child of lesser age, no guilt is incurred. Samuel makes three the minimum.

Sanhedrin 54b

Raba said. It means this: When a grown-up man has intercourse with a little girl it is nothing, for when the girl is less than this [three years old], it is as if one puts the finger into the eye; but when a small boy has intercourse with a grown-up woman he makes her as 'a girl who is injured by a piece of wood.'...

Kethuboth 11b

[This debate concerns whether or not someone is a virgin. Virginity is prized above all, such that it is believed that a girl under the age of three will regain her virginity, even if a man has had intercourse with her. (Fn. 7 says, in regard to putting "the finger into the eye": "I.e., tears come to the eye again and again, so does virginity come back to the little girl under three years.") Since virginity is prized above all, one could assume that this conclusion has allowed grown men to have sex with little girls with immunity. A grown-up woman is not deflowered by having sex with a small boy, however, since he is only like a "piece of wood."]

Menachoth 43b-44a

[A "prayer" or "benediction" to be said by a Jewish man every day: "Thank God for not making me a Gentile, a woman or a slave."]

Do not save Goyim in danger of death.

Show no mercy to the Goyim.

This is unfortunate because within these texts are some very dark and disturbing details, backed up with critical facts that reveal the Satanic origins of this Jewish “religion” that controls the world via its Legal System of Mosaic Law.

THE GREAT MODERN CHRISTIAN/MUSLIM GENOCIDE

At least twenty million Russian citizens were murdered in the Soviet holocaust, and many more than that were imprisoned and/or tortured in some way. Many of the people who were murdered or oppressed were politically conservative or moderate Russians who simply opposed Soviet communism. But some of the people who were killed by the Soviets were political leftists who, for certain reasons, opposed the Soviet government, or, were seen as a political threat to the government.

Most of the murders committed during the Soviet holocaust were committed by people who were racially/ethnically Jewish [in fact, Jews, via their political activism, built the Soviet Union]. Granted, Soviet leader Joseph Stalin was not a Jew, and his predecessor Vladimir Lenin was only part-Jewish [however both were married to Jews]. But most of the top people who served in the Soviet government under both Stalin and Lenin were Jewish, and their names are well-known to many historians - for example Leon Trotsky, Lazar Kaganovich, Lev Kamenev, Genrikh Yagoda, Nikolai Yezhov [2].

The Soviet holocaust is rarely mentioned in the West today. And when it is mentioned, it isn't referred to as a holocaust.

Communist China was created by Rothschild's and their agents.

October 1 1949, Mao Tse Tsung declared the founding of the People's Republic of China in Tiananmen Square, Beijing. He was funded by Rothschild created Communism in Russia and also the following Rothschild agents: Solomon Adler, a former United States Treasury official who was a Soviet Spy; Israel Epstein, the son of a Jewish Bolshevik imprisoned by the Tsar in Russia for trying to ferment a revolution there; and Frank Coe, a leading official of the Rothschild owned IMF. Jews were behind the rise to power of Mao Tse Tung, the communist dictator of China, who tortured and murdered tens of millions of Chinese (mostly Christians) during his brutal reign. Sidney Shapiro, an American Jew, was in charge of China's propaganda organ. Another Jew, Israel Epstein, was Mao's Minister of Appropriations (Finance).

Mao would murder sixty million innocent Chinese people under his rule mainly to destroy traditional Chinese culture in order to gain total control. As with Christianity, any practitioners of spiritual systems were outlawed, killed, and thrown into gulags, to die a slow death through slave labor, starvation and torture. The Communistic systems became the new culture of control. With China under their flag, Tibet was next on the list as being the last bastion of spiritual and historical knowledge. All the Jewish systems seek to remove spiritual knowledge from Gentiles and keep it in the hands of the Jewish elite. This is a major part of their indoctrination program. There has been a major Jewish population in China for over a thousand years such as the Jews of Kaifeng.

The Bosnian Genocide, which refers to the attempted annihilation of Muslims by Christian Serbs in former Yugoslavia from about 1992-1995.

On July 1995, Bosnian Serbs killed more than 8,000 Muslim men and boys, as well as the ethnic cleansing of another 25,000–30,000 refugees, in and around the town of Srebrenica in Bosnia and

Herzegovina in what is now referred to as the Srebrenica massacre.

The Srebrenica massacre is the largest mass murder in Europe since World War II. In 2004, in a unanimous ruling on the “Prosecutor v. Krstić” case, the Appeals Chamber of the International Criminal Tribunal for the former Yugoslavia (ICTY), located in The Hague, ruled that the massacre of the enclave’s male inhabitants, accompanied by the forcible transfer of all of the women, children and elderly, constituted a crime of genocide. Theodor Meron, the presiding judge, stated:

By seeking to eliminate a part of the Bosnian Muslims, the Bosnian Serb forces committed genocide. They targeted for extinction the 40,000 Bosnian Muslims living in Srebrenica, a group which was emblematic of the Bosnian Muslims in general. They stripped all the male Muslim prisoners, military and civilian, elderly and young, of their personal belongings and identification, and deliberately and methodically killed them solely on the basis of their identity.

In February 2007 the International Court of Justice (ICJ) concurred with the ICTY judgement that the atrocities committed at Srebrenica constituted a genocide, stating:

The Court concludes that the acts committed at Srebrenica falling within Article II (a) and (b) of the Convention were committed with the specific intent to destroy in part the group of the Muslims of Bosnia and Herzegovina as such; and accordingly that these were acts of genocide, committed by members of the VRS in and around Srebrenica from about 13 July 1995.

Let us hear the Irish statesmen Edmund Burke, who stated that the only thing necessary for the triumph of evil, is for good men to do nothing. If Christians in the Middle East are annihilated, responsibility will not only lie with the perpetrators, but with leaders who failed to come to the aid of people being slaughtered for nothing more than believing something different.

Have we learned nothing from the 1994 genocide in Rwanda, where more than 800,000 Tutsi were killed in less than three months? Has the Assyrian genocide already slipped into oblivion?

Paying the Price: Killing the Children of Iraq is a powerful indictment of the largely unreported effects of United Nations sanctions following the 1991 Gulf War – most strikingly, the 500,000 children among more than one million Iraqis who died in almost 10 years of sanctions/wars, figures verified by UNICEF (the United Nations Children’s Fund) and other UN agencies.

Syria, the population of Christians there continues to decline, from 1,250,000 in 2011 to less than 350,000 this year, according to [ADF International](#), which advocates for religious freedom worldwide.

In a sub-report submitted with the report [Genocide Against Christians in the Middle East](#) to Secretary of State John Kerry in March, the ADF International details the ongoing genocide of Christians and other religious minorities in the Middle East.

It notes that “Christians are the most persecuted religious group in the world” and that in at least 104 countries Christians are harassed and persecuted by governments and organizations.

The study by [Aid to the Church in Need](#) said the treatment of Christians has worsened substantially in the past two years compared with the two years prior, and has grown more violent than any other period in modern times.

The report examined the plight of Christians in China, Egypt, Eritrea, India, Iran, Iraq, Nigeria, North Korea, Pakistan, Saudi Arabia, Sudan, Syria and Turkey over the period lasting from 2015 until 2017. The research showed that in that time, Christians suffered crimes against humanity, and some were hanged or crucified. The report found that Saudi Arabia was the only country where the situation for Christians did not get worse, and that was only because the situation couldn't get any worse than it already was.

The Coudenhove-Kalergi plan – The genocide of the Peoples of Europe/US/Australia/NZ

Mass immigration is a phenomenon the causes of which are cleverly concealed by the political elites, and multicultural propaganda is employed to falsely portray immigration as inevitable. In this article we intend to prove once and for all, that mass immigration is not a spontaneous phenomenon. What the elites try to present as an inevitability of modern life, is actually the product of a plan conceived around a table and prepared over decades, to completely change the face of our continent.

The Pan-Europe

Few people know that one of the main instigators of the process of European integration, was a man who also conceived the genocide of the peoples of Europe. He was a sinister individual whose existence is unknown to the masses of our people, but the political elites consider him the founder of the European Union. His name is Richard von Coudenhove Kalergi. His father was an Austrian diplomat named Heinrich von Coudenhove-Kalergi (with connections to the Byzantine family of the Kallergis), and his mother the Japanese Mitsu Aoyama.

Thanks to his close contacts with European aristocrats and politicians, and due to the network of relationships created by his nobleman-diplomat father, Richard von Coudenhove-Kalergi was able to work unseen, away from the glare of publicity, and he managed to engage the co-operation of the most influential European heads of state for his plan, making them supporters and collaborators in his “project of European integration”.

In 1922 he founded the “Pan-European” movement in Vienna, which aimed to create a New World

Order, based on a federation of nations led by the United States. European integration would be just the first step in creating a world government. His earliest supporters included Czech politicians Tomáš Masaryk and Edvard Beneš, and the German Jewish banker Max Warburg, who invested 60,000 marks in the project. The Austrian Chancellor Ignaz Seipel and the next president of Austria, Karl Renner, took early responsibility for leading the “Pan-European” movement and later, French politicians, such as Léon Bloum, Aristide Briand, Alcide De Gasperi etc., offered their help.

With the rise of Fascism in Europe during the 1930s, the project of European integration was abandoned and the “Pan-European” movement was forced to dissolve. However, after the Second World War, and thanks to frantic and tireless activity and the support of Winston Churchill, the Jewish Masonic Lodge B’nai B’rith and major newspapers like the New York Times, Kalergi managed to gain acceptance for his plan by the United States Government and later the CIA became involved in driving the plan towards completion.

The essence of the Kalergi plan

In his book ‘Praktischer Idealismus’, Kalergi explains that the citizens of the future “United States of Europe” will not be the people of the Old Continent, but a new mixed breed, the products of thorough and widespread miscegenation. He states that the peoples of Europe should interbreed with Asians and other non-White races, to create a multiracial population, with no clear sense of tradition or identity and therefore easily controlled by the ruling elite.

Kalergi proclaims the need to abolish the right of nations to self-determination and outlines the break-up of nation states through the use of ethnic separatist movements and the destruction of the nations themselves through mass migration. In order for Europe to be easily controlled by the future elite, Kalergi proposes the creation of a homogeneous mixed breed population, and as to who should be the new elite? Kalergi is particularly illuminating on this point:

The man of the future will be of mixed race. The races and classes of today will gradually disappear due to the elimination of space, time, and prejudice. The Eurasian-negroid race of the future, similar in appearance to the Ancient Egyptians, will replace the current diversity of peoples and the diversity of individuals. Instead of destroying European Judaism, Europe, against her will, refined and educated this people, driving them to their future status as a leading nation through this artificial evolutionary process. It’s not surprising that the people that escaped from the Ghetto-Prison, became the spiritual nobility of Europe. Thus, the compassionate care given by Europe created a new breed of aristocrats. This happened when the European feudal aristocracy crashed because of the emancipation of the Jews [due to the actions taken by the French Revolution]

Although no textbook mentions Kalergi, his ideas are the guiding principles of the European Union. The belief that the peoples of Europe should be mixed with Africans and Asians, to destroy our identity, to break down traditional ways of living and create a single mixed race, is the reason for community policies that promote minority interests. The underlying motives are not at all humanitarian, because the driving power behind the ruthless regime dominating the EU, plans the greatest genocide in history.

A prestigious prize is awarded every two years by the Coudenhove-Kalergi Foundation to Europeans who have excelled in promoting this criminal plan. Among those awarded with such a prize are Angela Merkel and Herman Van Rompuy.

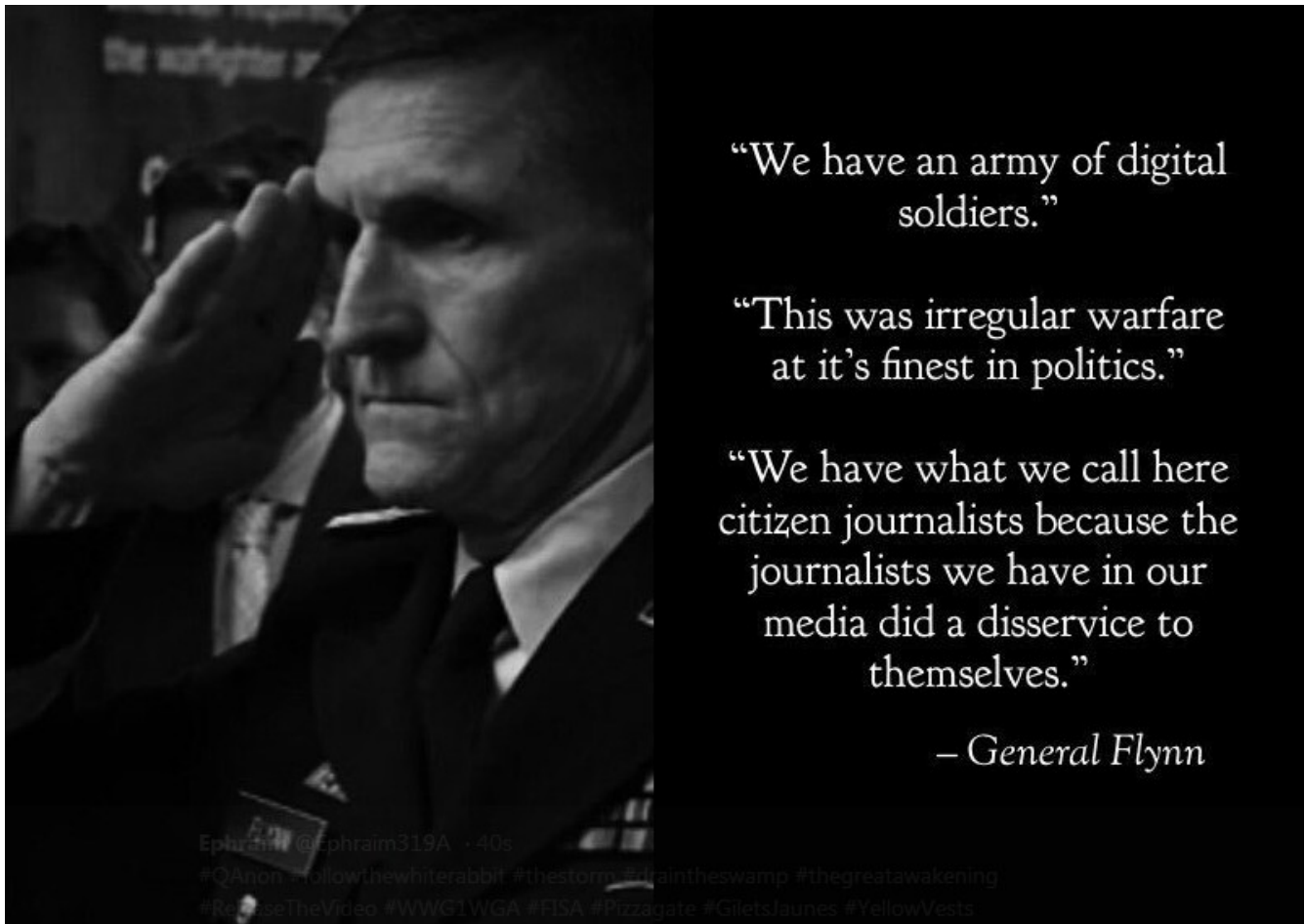

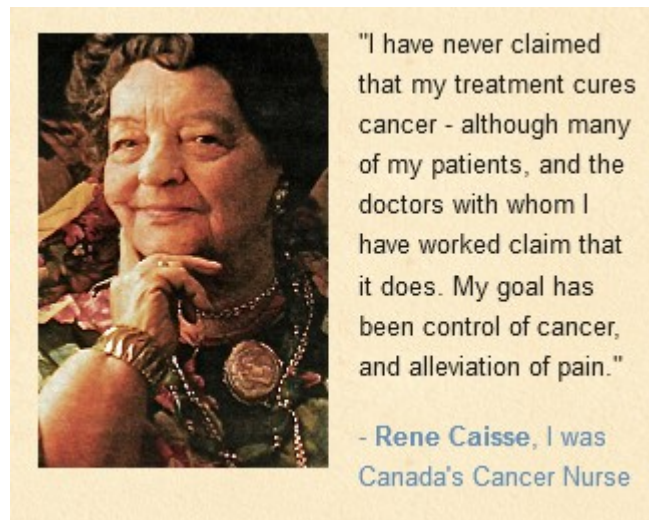

How Cannabis Oil Works to Kill Cancer Cells

In every cell there is a family of interconvertible sphingolipids that specifically manage the life and death of that cell. This profile of factors is called the "Sphingolipid Rheostat." If endogenous ceramide (a signaling metabolite of sphingosine-1-phosphate) is high, then cell death (apoptosis) is imminent. If ceramide is low, the cell is strong in its vitality. Very simply, when THC connects to the CB1 or CB2 cannabinoid receptor site on the cancer cell, it causes an increase in ceramide synthesis which drives cell death. A normal healthy cell does not produce ceramide in the presence of THC, thus is not affected by the cannabinoid.

The cancer cell dies, not because of cytotoxic chemicals, but because of a tiny little shift in the

mitochondria. Within most cells there is a cell nucleus, numerous mitochondria (hundreds to thousands), and various other organelles in the cytoplasm. The purpose of the mitochondria is to produce energy (ATP) for cell use. As ceramide starts to accumulate, turning up the Sphingolipid Rheostat, it increases the mitochondrial membrane pore permeability to cytochrome c, a critical protein in energy synthesis. Cytochrome c is pushed out of the mitochondria, killing the source of energy for the cell.

In every cell there is a family of interconvertible sphingolipids that specifically manage the life and death of that cell. This profile of factors is called the “Sphingolipid Rheostat.” If endogenous ceramide (a signaling metabolite of sphingosine-1-phosphate) is high, then cell death (apoptosis) is imminent. If ceramide is low, the cell is strong in its vitality.

Ceramide also causes genotoxic stress in the cancer cell nucleus generating a protein called p53, whose job it is to disrupt calcium metabolism in the mitochondria. If this weren't enough, ceramide disrupts the cellular lysosome, the cell's digestive system that provides nutrients for all cell functions. Ceramide, and other sphingolipids, actively inhibit pro-survival pathways in the cell leaving no possibility at all of cancer cell survival.

The key to this process is the accumulation of ceramide in the system. This means taking therapeutic amounts of CBD and THC, steadily, over a period of time, keeping metabolic pressure on this cancer cell death pathway.

Cancer In An Alkaline Environment

Is it true that cancer cells cannot live in alkaline tissues? Yes, absolutely that's true. Also as a matter of fact all cells have an optimal PH, which is acid alkaline, and an optimal temperature at which they function.

For example, if your body is chilled down to 90 degrees, you're not going to be moving around, even at 93 or 92 degrees you won't be moving.

When I was doing my residency, my internship, we used to have people come in from Central Park who had been out in the cold and fallen asleep. We had to heat them up before we could know if they were alive or not. You can't pronounce someone dead if they're alive, so we had to actually heat them up.

So there's a bottom temperature and an upper temperature and the same with alkaline and acid. Our body functions best at a PH of 7.4. When you get up to 7.5 or 7.6 cancer cells just can't do their thing and will not survive. Part of their a cancer cells whole metabolic requirement is acid production, and they can't produce those acids in an alkaline environment.

Did you ever try to stick your head out of the window while your car's going 60 miles an hour with your face facing toward the direction you're driving into and try to breathe? You can't breathe. You have to turn your head to the side, it's like too much air. Well, it's the same thing with the alkalinity. The cancer cells just can't function at that high of a ph.
