# 2. The Patriot Myth

• January 6th Committee: Flynn's decision to plead the Fifth during his testimony suggests he was potentially avoiding incriminating

himself rather than standing up for patriotic values.  $^{\mathrm{W}}$ 

 Public Perception: His narrative as a persecuted patriot who was wrongly targeted by the "deep state" has been sold to his followers, enhancing his image but not necessarily reflecting his actions or beliefs.

## 3. QAnon Contradictions

• **Public Stance vs. Actions**: Flynn has publicly debunked QAnon, calling it a "disinformation campaign," yet he has actively engaged with QAnon influencers and appeared on platforms where QAnon

theories are propagated.



 Q Drops: Notably, on May 29, 2021 (JFK's birthday), during Flynn's speech in Dallas, a Q drop specifically mentioned Flynn, aligning his actions with QAnon's narrative, despite his public disavowal. This event was exclusively reported by Vice News, suggesting Flynn was

playing both sides.

## 4. Business Dealings in Turkey

• **Foreign Agent Allegations**: Flynn's business in Turkey, particularly through Flynn Intel Group, led to legal scrutiny. Convictions and

subsequent overturned decisions suggest a pattern of potentially

using his influence for financial gain rather than patriotic duty.  $^{\mathrm{W}}$ 

• **Under a Spell?**: The question posed if Flynn was "under a spell" when engaging in these dealings could be seen as rhetorical, highlighting the disconnect between his actions and the image he cultivates.

### 5. January 5, 2021 Speech

• **Hype and Mobilization**: Flynn's speech on January 5, 2021, as documented in an exclusive by 9chnet from the Baron of Arizona's YouTube channel, could be interpreted as an attempt to mobilize his

audience, potentially under false pretenses or for personal gain.

#### 6. Deep State Chess Piece?

• **Strategic Positioning**: The narrative of Flynn being either under a spell or a puppet of the "deep state" serves to question his true motives, suggesting his actions might serve interests other than a genuine patriotic cause.

### Conclusion

This mind map suggests that Michael Flynn's activities and statements present a complex figure who might be more aligned with personal or financial interests than with the patriotic heroism he's often portrayed to embody. His engagements with conspiracy communities, legal issues related to foreign dealings, and selective engagement with controversial narratives paint a picture of an individual using influence to navigate or exploit the political and social landscape for personal benefit. **Note:** The references provided focus on Flynn's actions and public statements rather than directly addressing the speculative questions about being "under a spell," which are used here for rhetorical effect to critique the consistency and motivations behind Flynn's public persona.
