It’s a political game, played by those who thrive on engagement farming and emotional manipulation, turning a manageable issue into a festering wound.

## **Mexico's Pathetic Leadership: A Disgraceful Enabler**

The root of this mess lies partly beyond our borders, with Mexico's current president, Claudia Sheinbaum, embodying a pathetic disgrace who actively undermines her own nation.
