I. Program Narrative

Overview

The Training Internship Program will provide three months of on-the-job and academic training in the priority areas of public administration, business management, telecommunications, environmental management and banking & finance for 30 professionals from Bulgaria, Estonia, Poland, Romania, and Slovakia.

The Soros Foundations Management Training Program ("SFMTP") received and signed Cooperative Agreement #EUR 0045 A 00 4007 00 from the United States Agency for International Development ("USAID") on November 19, 1993.

In the first quarter, SFMTP staff in each of the five countries began open advertisement to professionals for the training available. In the US, SFMTP staff were introduced to USAID procedures and began recruitment of host companies.

Field activities: Participant Selection

Before opening the competition, an SFMTP Coordinator in each country met with the respective USAID representative to introduce the program and SFMTP's open selection procedures and to invite the representative's participation in the selection process.

In all five countries, advertisement and recruitment began immediately. Ads were placed in the newspaper in Poland, Romania and Slovakia. In all five countries, Coordinators distributed application packets to other organizations that included other development agencies, USAID-funded projects, banks, companies, branch offices of the Foundations themselves, small business associations, chambers of commerce and more. In Bulgaria, Estonia, Romania and Slovakia, SFMTP coordinators drew on a database of pre-screened applications that had been gathered in earlier advertising campaigns for the other opportunities for training abroad that SFMTP offers.

By the end of the contract's first quarter, several hundred applications had been received by the SFMTP field offices and close to 50 interviews completed with more scheduled for the next month. SFMTP staff in Estonia and Slovakia had mailed their slates of applications to SFMTP New York before the end of the quarter. In Poland, Bulgaria and Romania, applications were still under review.

US Activities: Recruitment of host companies and introduction to USAID procedures

The SFMTP New York Coordinator (i) met with the USAID program officer for an introduction to the grant-management procedures, (ii) monitored the progress of the selection procedures, and (iii) began establishing internal systems to meet AID reporting and funds management requirements. BHEF began to recruit host companies and universities from its membership.
