FOLDER 0 - ID & CREDENTIALS - PRIEST

This folder contains the IsigniaGate Mandate from myself to those who I have authorised to drop this information on 8 Chan on 24.8.2018. It also contains my credentials as Designate Honorary Consul (Ambassador) for the Democratic Republic of Congo to Australia, my World Peace Congress pics and thank you letter and also my Australian Passport & Queensland Drivers license for World Transparency that I am putting all my chips on the table and my money where my mouth is.

FOLDER 1. CIA ASSETS

This folder hosts several conversations between myself and known CIA Agents which substantiate the Five Star Trust. It also holds the US VISA of Agent Marlon McCall who was Lord David James of Blackheaths CIA Contact during the foundation X UK saga in 2011. Of course the most interesting file is the CIA Kill order with a sanctioned hit on an asset called "WhiteCat" authorised by the DCI (Director of Central Intelligence <The CIA>) whom at the time was Leon Panetta. I stole this recording off the encrypted COMS device that Panetta's down-line "M" invited me into.

FOLDER 2. DEA

Contains an MP4 of extracts from Oliver North's Notebook as reported by DEA Agent Mike Levine. This folder will also act as a place-marker for all future DEA intelligence on the subject or connected.

FOLDER 3. KEY DOCUMENTS -

After years of research on the subject this remains the most important document with as yet unclassified FBI Investigation for then Senator Edward Kennedy, including the SWIFT notes in the ACCOUNTS folder which substantiate the \$15 Trillion Swifted from the Federal Reserve Bank through JP Morgan & onto RBS Global in 2009. The rest of the information cross references and cross correlates the FBI document. It is worthy to note that this FBI document has been verified by various Government Sources.

FOLDER 4. INDONESIA, ASIO & MR HAMOD

These are unedited recordings taken of an interview I conducted in 2015 between myself and Mr Tony Hamod of Sydney Australia at the time. Mr Hamod had an original \$150 Billion Platinum Certificate that was part of the plunder when Suharto took power and stole from the Indonesian Central Bank. (I viewed the original in 2008 and witnessed ASIO asking questions of Mr Hamod in the Sydney Sheraton) This type of "Collateral finance" further substantiated the banking black market used to channel the CIA's dirty money. Mr Hamod's last known location as of 2017 is Lebanon where he alleged to be spending proceeds from the Certificate on Prostitutes, instead of the Humanitarian Initiatives he pledged to.

FOLDER 5. INTERNATIONAL ENFORCEMENT

Various documents on international law surrounding drug trafficking from Interpol & the United Nations as well as the Vienna Convention which I have invoked for my own political protection as a result of this Drop.

FOLDER 6. INTERNATIONAL SUPPORT

This folder includes the digital response/footprint from other countries that have been sent the InsigniaGate Drop.

FOLDER 7. NUGAN HAND BACKGROUND

All information pursuant to the Nugan Hand Merchant Bank of Australia & the CIA Connection. The Nugan Hand Bank was accused of laundering the drug money for the CIA and Frank Nugan was found dead with CIA Director William Colby's business card in his top jacket pocket. The subsequent Royal Commission by the Australian Government into the Nugan Hand Bank could find no connection between the CIA and Drug trafficking. Subsequent requests to reinstate the Royal Commission have been stonewalled by every level of the Australian Government.

FOLDER 8. PARLIAMENTARY PETITIONS 2018.

Part of my ongoing strategy to ensure that every level of the Australian Government had been given the lawful opportunity and oversight at every level of the Australian Government apparatus to make comment on these heinous crimes. For responsible officers of Government to continue to deny engagement on the issue places the Australian Government in further collusion and jeopardy.

FOLDER 9. PROSECUTION FOLDER

I see this as the second most important folder in the InsigniaGate Drop. It includes a huge amount of correspondence, dialouge and recorded phone calls with most every relevant department and agency in the Australian Government who under the Australian Rule of Law must be held accountable for directing and investigation into the CIA involvement in Nugan Hand, given this new information contradicts the findings of the Royal Commission of the 1980's.

The reader will note that I have conducted a high level of forensic due diligence on the Australian Government from the local Police (who kidnapped me over this issue without charge) all the way up through the Australian Federal Police, the Australian Security Intelligence Organisation (ASIO), The Inspector General for Intelligence & Security, the Foreign Minister Julie Bishop and Prime Minister Malcolm Turnbull - Through to Attorney General Christian Porter and Governor General Peter Cosgrove. Most all confirmed receipt of the information and I collected digital IP Fingerprints on their engagement with the intelligence. As a result of the Australian Governments breach of their own Rule of law across their entire apparatus, I now hold the entire Corpus of the Australian Government in Treason Against the Australian People & the Australian Consitution under the Crown.

FOLDER 12. RESOURCES & REFERENCE

Miscellaneous files that I find interesting, including the speech by Former President Kennedy where I believe he was making direct reference to the Five Star Trust, the Men that potentially lead to his assassination.

FOLDER 13. THE DRUG FILES

An as yet not vetted or verified folder full of intel that links back to CIA drug trafficking, this was provided to me "As is" from an anonymous journalist linked to WikiLeaks. Huge amount of information in here which will be a veritable gold mine to substantiate the key drop points.
