EXECUTE INITIAL SEARCH WARRANT:

Original intelligence suggested the sole suite involved was Suite Trooper Kieffer and I entered that suite and found it to be unoccupied. It was aesthetically obvious that the purpose of the room was having to do with the voting process. There were many posters and pictures on the walls suggesting the importance of voting and showing scenes of people voting or experiencing resistance while voting in the past. While I looked around the room I heard a door open from across the hallway and a black female emerged. She asked if she could help me and I informed her of the reason for my visit today. This female was later verbally as Manager Two more individuals emerged from the suites across the hall as well, and told me she and work for and they rent the suites across the hall and the room we were standing in which was the training room. I clarified, asking if she was talking about the rooms directly across the hall. She confirmed this to be true. I asked all three individuals to stay in the training room while the search warrant was being conducted. All of them complied without incident.

At this point I knew the search warrant did not cover the suites across the hall where they had emerged from but stated did legally rent those suites. 

this time and recorded three segments of conversation. These three files were added to property in this case. For the full contents of the files, review the files.

I observed a middle-aged black male with a medium build on phone/video chat screen. I asked him what was. He stated is an operations firm that helps out around campaigns. We are an operations team and we go out in the field and we knock on doors during campaigns. We send people into the community and they knock on doors uh to engage educate and mobilize the community around different elections." I went on to ask our if he was currently in Michigan and he stated he is not, he is in lowa. I asked to see a copy of the search warrant and I told her I would give her a copy when I get her name and her role in the company. As soon as I obtained her name I provided her a copy of the initial search warrant. This occurred soon after the first conversation with ended. I also heard telling that she needed to make sure she declared the personal tems he left behind before leaving the state. It should be noted it was later found that he was referring to multiple firearms and ammunition within one of their suites as noted in D/F/Lt. Anderson's report.
While waiting for the updated search warrant a few more employees from arrived on scene and were asked to come into the training room to avoid going into the secured area we had cleared. All of them were cooperative with this request. Also during that time 2 nd District SIS MSP employees D/Lt. Richard Sanchez, along with Detective Troopers Chang, Pirvu, and Terrill arrived to assist. They interviewed those present who were willing to be interviewed. See their reports for content of the interviews. D/Tpr. Pirvu interviewed employee completed a written statement which was placed in external documents. D/Tpr. Chang interviewed employee and documented the interview in her original report. D/Tpr. Terrill nterviewed and documented the interview in a supplemental report to D/Tpr. Chang's original report. I asked if she was willing to be interviewed and she declined stating she did not want to talk further without consulting with a lawyer.
Also, while waiting for the amended search warrant approached me and stated the attorney for wanted to speak with me. His name was Brian Lennon and he was with the law firm Warner Norcross & Judd. 

3. In reviewing Muskegon PD Report 2020-19124 your affiant learned the following: On 10/16/20 Muskegon City Clerk Ann Meisch and Deputy Clerk Kimberly Young contacted the Muskegon Police Department after receiving multiple "State of Michigan Voter Registration Application" forms which in their opinion appeared to be fraudulent. Meisch based this opinion on the fact that some of the addresses on the applications appeared to be invalid or non-existent, some of the phone numbers were invalid and some of the signatures on the forms did not match the signatures on file with Secretary of State. 13. On 10/26/20 Your affiant had contact with Michigan Secretary of State Analyst Corey Ames. Ames prepared a spreadsheet with information supplied by the Muskegon City Clerk's Office and Muskegon Police Department from each sampling of suspicious voter registration form. The spreadsheet tracked information provided on the voter registration form and information contained in the MDOS Qualified Voter File and the Driver Information Database. The spreadsheet was then sent to Muskegon PD for follow up investigation and comparison.
14. On 10/27/20 Detective Luker from Muskegon PD conducted follow up investigation on the spreadsheet completed by analyst Corey Ames. Detective Luker advised your affiant of the following in that regard:

The form had the following errors: fictitious last four numbers of social security number, fictitious phone number and invalid address  Your affiant knows McLaughlin and Terrace to be an intersection and not a residence.
B. Detective Luker examined (2) voter registration applications to conduct follow up and found the following issues. Detective Luker found the address on both forms does not exist.
