The following violations of the Nuremberg Code is as follows

Nuremberg Code #1: Voluntary Consent is Essential

No person should be forced to take a medical experiment without informed consent. Many media, political and non-medical persons are telling people to take the shot, it's safe and offer no information as to the adverse effects or dangers of this gene-therapy. Countries are using lockdowns, duress and threats to force people to take this vaccine or be prohibited to participate in free society under the mandate of a Vaccine Passport or Green Pass. During the Nuremberg trail, even the media was prosecuted and members were put to death for lying to the public amongst many of the doctors and Nazis found guilty of Crimes Against Humanity.

Nuremberg Code #2: Yield Fruitful Results Unprocurable By Other Means

As listed above, the gene-therapy does not meet the criteria of a vaccine and does not offer immunity to the virus. There are other medical treatments that yield fruitful results against Covid such as Ivermectin, Vitamin D, Vitamin C, Zinc and boosted immune systems for flu and colds.

Nuremberg Code #3: Base Experiments on Results of Animal Experimentation and Natural History of Disease

This gene-therapy skipped Animal testing and went straight to human trials. In mRNA research that Phizer used a candidate study on mRNA with rhesus macaques monkeys using BNT162b2 mRNA and in that study all the monkeys developed pulmonary inflammation but the researchers considered the risk low as these were young healthy monkeys from the age of 2-4. Israel has used Phizer and the International Court of Law has accepted a claim for 80% of the recipients having pulmonary inflammation from being injected with this gene-therapy. Nuremberg Code #4: Avoid All Unnecessary Suffering and Injury

To understand the net effects of SIP policies, we measure the change in excess deaths following the implementation of SIP policies in 43 countries and all U.S. states. We use an event study framework to quantify changes in the number of excess deaths after the implementation of a SIP policy. We find that following the implementation of SIP policies, excess mortality increases. The increase in excess mortality is statistically significant in the immediate weeks following SIP implementation for the international comparison only and occurs despite the fact that there was a decline in the number of excess deaths prior to the implementation of the policy. At the U.S. state-level, excess mortality increases in the immediate weeks following SIP introduction and then trends below zero following 20 weeks of SIP implementation. We failed to find that countries or U.S. states that implemented SIP policies earlier, and in which SIP policies had longer to operate, had lower excess deaths than countries/U.S. states that were slower to implement SIP policies. We also failed to observe differences in excess death trends before and after the implementation of SIP policies based on pre-SIP COVID-19 death rates.

Additionally, *in vivo* experiments demonstrate replication of the chimeric virus in mouse lung with notable pathogenesis. 

In its report released earlier this year, the WHO-China team said it was "very unlikely" that the virus, officially named SARS-CoV-2, could have accidentally leaked from the Wuhan Institute of Virology or another facility in the Chinese city where infections were first found. The joint team of researchers said it would not recommend further investigation into the issue.

A discussion of whether to include the lab-leak theory at all lasted until 48 hours before the conclusion of the mission, Ben Embarek told the Danish reporters. In the end, Ben Embarek's Chinese counterpart eventually agreed to discuss the lab-leak theory in the report "on the condition we didn't recommend any specific studies to further that hypothesis." Also, the WHO team lead considers researcher getting infected in the field in the "likely" category —as a mix of "lab-leak" and direct infection— and also says there could have been human error but "the Chinese political system does not allow authorities to acknowledge that."

Ben Embarek said one similar scenario, in which a lab employee inadvertently could have brought the virus to Wuhan after collecting samples in the field, could be considered both a lab-leak theory and a hypothesis of direct infection from a bat, which was described as "likely" in the report.

"A lab employee infected in the field while collecting samples in a bat cave such a scenario belongs both as a lab-leak hypothesis and as our first hypothesis of direct infection from bat to human. We've seen that hypothesis as a likely hypothesis," Ben Embarek said.

In further comments during the interview that were not included in the documentary but were incorporated in an account by the Danish channel TV2 on its website, Ben Embarek suggested that there could have been "human error" but that the Chinese political system does not allow authorities to acknowledge that.

"It probably means there's a human error behind such an event, and they're not very happy to admit that," Ben Embarek was quoted as saying. "The whole system focuses a lot on being infallible, and everything must be perfect," he added. "Somebody could also wish to hide something. Who knows?"



Generally described, the present application relates to a system and method for processing input to control a set of functions and features. 

11.3.1 End of Occupation. Belligerent occupation ceases when the conditions for its application are no longer met.⁸¹ In particular, as discussed below, the status of belligerent occupation ceases when the invader no longer factually governs the occupied territory or when a hostile relationship no longer exists between the State of the occupied territory and the Occupying Power.⁸²

Belligerent occupation ends when the Occupying Power no longer has effectively placed the occupied territory under its control.⁸³ For example, an uprising by the local population may prevent the Occupying Power from actually enforcing its authority over occupied territory. Similarly, the Occupying Power's expulsion or complete withdrawal from the territory would also suffice because the former Occupying Power generally would not be able to control sufficiently the occupied territory.

11.4 LEGAL POSITION OF THE OCCUPYING POWER

Military occupation of enemy territory involves a complicated, trilateral set of legal relations between the Occupying Power, the temporarily ousted sovereign authority, and the inhabitants of occupied territory.⁹² The fact of occupation gives the Occupying Power the right to govern enemy territory temporarily, but does not transfer sovereignty over occupied territory

11.5 DUTY OF THE OCCUPYING POWER TO ENSURE PUBLIC ORDER AND SAFETY

The authority of the legitimate power having in fact passed into the hands of the Occupying Power, the latter shall take all the measures in its power to restore, and ensure, as far as possible, public order and safety, while respecting, unless absolutely prevented, the laws in force in the country.¹⁰¹ This principle has been recognized as customary international law.¹⁰²

11.6 PROTECTION OF THE POPULATION OF AN OCCUPIED TERRITORY

Under the law of belligerent occupation, the Occupying Power has certain duties with respect to the population of an occupied territory, including protected persons under the GC.

11.6.1 General Protections, Including Humane Treatment, of the Population of an

Occupied Territory. The population of an occupied territory, like other protected persons under the GC, are entitled, in all circumstances, to respect for their persons, their honor, their family rights, their religious convictions and practices, and their manners and customs.¹⁰⁷ They shall at all times be humanely treated, and shall be protected especially against all acts of violence or threats of violence, and against insults and public curiosity.

Other provisions for the humane treatment of protected persons set forth in Articles 27 through 34 of the GC apply to the population of an occupied territory. For example, women must be especially protected against any attack on their honor, in particular against rape, enforced prostitution, or any form of indecent assault.¹⁰⁸ Reprisals against protected persons and their property are prohibited.¹⁰⁹ The taking of hostages is prohibited.¹¹⁰

In addition, protected persons in occupied territory shall have every facility for making application to the Protecting Powers, the ICRC, the National Red Cross (Red Crescent, Red Lion and Sun) Society of the country where they may be, as well as to any organization that might assist them.¹¹¹

11.6.2 Overview of Additional Protections for the Population That Are Specific to Occupation. There are a number of protections for the population of occupied territory that are specific to occupation. For example, specific provision exists for the protection of children in occupied territory.¹¹² Specific constraints exist on the authority of the Occupying Power to punish protected persons, direct their movement, or compel them to perform labor.¹¹³ Provision also is made with respect to: (1) food and medical supplies of the population; (2) public health and hygiene; (3) spiritual assistance; and (4) relief efforts and consignments.¹¹⁴

11.7.1.1 <u>Enforcement of Obedience</u>. The Occupying Power's enforcement of obedience must comply with the law of war. For example, measures prohibited by the law of war, such as collective punishments, acts of torture, or reprisals, may not be used.

Insurgency is the organized use of subversion and violence to seize, nullify or challenge political control of a region. As such, it is primarily a political struggle, in which both sides use armed force to create space for their political, economic and influence activities to be effective. Insurgency is not always conducted by a single group with a centralized, military-style command structure, but may involve a complex matrix of different actors with various aims, loosely connected in dynamic and non-hierarchical networks. To be successful, insurgencies require charismatic leadership, supporters, recruits, supplies, safe havens and funding (often from illicit activities). They only need the active support of a few enabling individuals, but the passive acquiescence of a large proportion of the contested population will give a higher probability of success. This is best achieved when the political cause of the insurgency has strong appeal, manipulating religious, tribal or local identity to exploit common societal grievances or needs. Insurgents seek to gain control of populations through a combination of persuasion, subversion and coercion while using guerrilla tactics to offset the strengths of government security forces. Their intent is usually to protract the struggle, exhaust the government and win sufficient popular support to force capitulation or political accommodation. Consequently, insurgencies evolve through a series of stages, though the progression and outcome will be different in almost every case.

Counterinsurgency (COIN) is the blend of comprehensive civilian and military efforts designed to simultaneously contain insurgency and address its root causes. Unlike conventional warfare, non-military means are often the most effective elements, with military forces playing an enabling role. COIN is an extremely complex undertaking, which demands of policy makers a detailed understanding of their own specialist field, but also a broad knowledge of a wide variety of related disciplines. COIN approaches must be adaptable and agile. Strategies will usually be focused primarily on the population rather than the enemy and will seek to reinforce the legitimacy of the affected government while reducing insurgent influence. This can often only be achieved in concert with political reform to improve the quality of governance and address underlying grievances, many of which may be legiti-





Frank Lowy

Fifty days before 9/11, Larry Silverstein's <u>Silverstein Properties</u> and Frank Lowy's <u>Westfield America</u> secured a 99-year lease on World Trade Center Buildings One, Two, Four and Five. Silverstein already owned <u>Building</u> <u>Seven</u>, aka the Salomon building. The Port Authority of New York and New Jersey handed over control of the World Trade Center to Silverstein and Lowy on July 24, 2001, <u>an "historic" agreement</u> and "one of the largest privatization initiatives in history."

Lowy leased the shopping concourse area called the Mall at the World Trade Center, made up of approximately 427,000 square feet of retail floor space. Silverstein<u>and Westfield America</u> insured the complex for \$3.55 billion, but after the attacks of September 11 lodged a claim for \$7.1 billion on the premise that each plane collision constituted a separate act of terrorism, doubling the payout. Most people know about "Lucky"<u>Larry Silverstein's part in 9/11</u> and his dubious<u>connections</u> to Binyamin Netanyahu et al, but not much has been reported on Lowy, so let's have a look.

Lowy's fondness for banking is not limited to the U.S. He's a board member of the <u>Reserve Bank of Australia</u>, Australia's central bank, which is the Australian version of the American<u>Federal Reserve</u> system and <u>issuer of</u> <u>Australian banknotes</u>. Lowy served a ten year term as director of the RBA.

In 2001 he was the Associate International Chairman of the <u>Israel Democracy Institute</u>, and in 2003 he set up the <u>Lowy Institute for International Policy</u>, an international think tank devoted to foreign affairs, a meddlesome endeavor which won him the Woodrow Wilson Award for Corporate Citizenship in 2005 (aptly enough it was <u>Wilson who signed the Federal Reserve Act</u>). That same year, the Institute moved into its permanent home in Sydney's CBD which was formally opened by Australia's

Prime Minister and Lowy's good mate, John Howard. Lowy joined Howard and Bill Clinton on a romantic "evening Sydney Harbour cruise" when Clinton visited Australia in 1996 (<u>source</u>), and is the "<u>dubious donor</u>" of approximately \$100,000 to Bill's William J. Clinton Foundation. One of Lowy's many lawyers is Robert Bennett, who defended Clinton during the Monica Lewinsky fiasco.

Other good friends of his include Israeli prime minister<u>Ehud Olmert</u> and<u>media mogul_Rupert</u> <u>Murdoch</u>, who has<u>his own murky connections to 9/11</u> and who provides ideological support and political cover to the genocidal Likud Party of Israel in his broader role as one of the high overseers of the global mega-campaign of trans-corporate post-9/11 perception management. With a centralised mass media monopoly engineering a psycho-social zeitgeist favourable to the ongoing "war on terror" agenda, the status quo continues unabated in the absence of effective public resistance.

Furthermore, Lowy is a founding member of the International Advisory Council of the pro-Israel<u>Brookings</u> <u>Institution</u> in Washington. According to<u>Wikipedia</u>, "Brookings is generally considered one of the three most influential policy institutes in the U.S." The aforementioned Martin Indyk, former vice chairman of Lowy's Institute for National Strategy and Policy and former U.S. ambassador to Israel, is also a<u>Director at Brookings</u>. You can read about Indyk<u>here</u>.

But Lowy's penchant for meddling in world affairs doesn't stop there. Lowy was vice president of a publication called the <u>Australia/Israel Review</u> (AIR), whose parent body is the <u>Australia Israel Jewish</u>. <u>Affairs Council</u> (AIJAC), the <u>Australian equivalent</u> of its U.S. counterpart, <u>AIPAC</u>. The AIR is a rightwing Zionist publication whose editor, Michael Kapel, was <u>forced to quit in '98</u> after the magazine published stolen membership lists of the <u>One Nation party</u>, an Australian nationalist political group. And in 2004, during a parliamentary inquest into the closing of an illegally built shopping centre, Lowy was <u>very open about using his influence</u> to sway New South Wales premier Bob Carr on Middle East policy while denying that he'd used it to his advantage on the matter of the shopping centre:

His three sons: Peter Lowy, <u>co-CEO of Westfield Corp with his brother</u> Stephen, <u>sits on the board</u> of the <u>Simon Wiesenthal Center</u> and is chairman of the board of the <u>University of Judaism</u>, which has

been renamed the American Jewish University after its merger with the Brandeis-Bardin Institute. Peter publishes the *Jewish Journal* which <u>glorifies him</u> in return:

Last Thursday night, at a banquet at the Beverly Hilton Hotel, the [University of Judaism] celebrated its 60th anniversary by honoring [Peter] Lowy. Mayor Antonio Villaraigosa was there, and President Bill Clinton and Gov. Arnold Schwarzenegger sent their best by video.

Peter is an important man in the U.S.: he<u>chairs the Homeland Security Advisory Council</u>, serves on the <u>RAND Corporation Executive Committee and Board of Trustees</u> and still finds time to serve Israel through the Washington Institute for Near East Policy (WINEP) as a<u>member of the Executive</u> <u>Committee</u>. He's<u>described</u> as a "deep-pocket contributor" to both the Democrat and Republican parties.

David Lowy is manager of the Tel Aviv-based<u>lon Asset Management</u> and CEO of the family's LFG Holdings which has<u>millions of dollars of investments in Israel</u>, and Stephen Lowy, co-CEO of Westfield, is<u>chairman</u> of the<u>United Israel Appeal</u>.

Frank Lowy has a <u>long history</u> of tax evasion. In 2008 it was revealed that he and his three sons had_<u>hidden \$US68 million</u> from the Australian Tax Office (ATO) and the IRS in a secretive Liechtenstein bank (Liechtenstein Global Trust, or LGT) through a complex network of shell companies and offshore trusts. The money was channeled via various_dodgy transfers into the Luperla Foundation's account at LGT set up in May 1997 by the Lowys and Israeli lawyer Joshua Gelbard. Luperla was dissolved for "undisclosed reasons" by Frank Lowy in late 2001, around the time of 9/11, with Lowy claiming that the funds were "distributed for charitable purposes in Israel". He refused to reveal details of the supposed charities, and internal LGT documents showed that in fact the <u>funds were transferred</u> to Bank Jacob Safra in Switzerland.
