Fun and sexy. Text me to set up an appointment ??????? 301-259-5664 Poster's age: 23

Location: College Park, District Of Columbia Post ID: 22802932 washingtondc."

The Undercover Detective asked the Female if she was available. The Female stated, "Yes I am". The Undercover Detective stated that he was looking for a half hour. The Female stated, "100 love". The Undercover Detective agreed to that price and responded, "I can do \$100". The Undercover Detective stated, "Where are you?" The Female stated, "College Park" and then instructed the Undercover Detective to let her know when he was 15 minutes away. At 2021 hours the Undercover Detective stated, "I'm about 15 mins away from College Park. Where am I going?" The Female stated, "9113 Baltimore Ave." The Female soon texted, "okay your not a cop or pimp right". The Undercover Detective stated, "Hell no. I just like nice boobs". The Undercover Detective arrived in the parking lot of 9113 Baltimore Avenue College Park, Prince George's County, Maryland at 2040 hours and texted the Female. The Female texted, "Howard Johnson give me a min n I will give u room number just finishing freshening up for u love". At 2047 hours, the Female texted, "412 love". I know from my training and experience that money in exchange for sex is prostitution and the meeting thereof is assignation.

The Undercover Detective arrived to room 412 and knocked on the door. A white female later identified as Victim (M.A.S.-17 years old) invited the Undercover Detective inside the room. The Victim (M.A.S.-17 years old) was wearing only a towel. Once inside the room, the Victim (M.A.S.-17 years old) instructed the Undercover Detective to have a seat; she then sat next to him and attempted to grab the

Undercover Detective's genitals. The Undercover Detective stood up to take his jacket off and then stated, "How much was it again?" The Victim (M.A.S.-17 years old) stated, "you wanted a half hour, that's \$100". The Undercover Detective then handed the Victim (M.A.S.-17 years old) \$100. The Victim (M.A.S.-17 years old) dropped her towel, walked around the second bed and placed the money under a pillow. The Victim (M.A.S.-17 years old) then stated, "Let me get a condom". The Undercover Detective asked if there was anything they couldn't do. The Victim (M.A.S.-17 years old) replied, "I don't do anal". The Undercover Detective then identified himself as a Prince George's County police officer; the Victim (M.A.S.-17 years old) fled the room and ran down the hallway where she was stopped by the arrest squad.

Members of the Vice Intelligence Unit described a male that was watching the Undercover Detective as he entered 412. Members described him as a chubby, light complexioned African American male with a beard. The Victim (M.A.S.-17 years old) stated, "Oh that's my manager, CJ...and I'm 17 years old". Members of the Vice Intelligence Unit stopped and detained the described male who was identified as the Defendant (WADE, Charles Curtis). Investigation revealed that the Defendant rented room 412 with his passport. Paper articles found inside room 412 also had the Defendant's name on them. The Defendant was placed under arrest for Human Trafficking of a Minor and transported to the Hyattsville Department of Corrections for processing. 3 cell phones were recovered from the Defendant's possession. Detectives believe these phones were all used in furthering the criminal activity. The Victim (M.A.S.-17 years old) was recovered.

During the interview of the Victim (M.A.S.-17 years old), the Victim (M.A.S.-17 years old) identified the Defendant (WADE, Charles) as "CJ". The Victim (M.A.S.-17 years old) stated that the Defendant was aware that she was 17 years old and the Defendant even stated, "you only have 5 months left until you're 18 so I'm not worried". The Victim (M.A.S.-17 years old) stated that after all of her dates, she gives the proceeds to the Defendant. The Defendant posted the backpage ads and responded to the clients himself. It was revealed that the Undercover Detective was texting the Defendant when he responded to the backpage ad. When there were clients/johns, the Defendant would leave the room. The Victim (M.A.S.-17 years old) stated that she had vaginal and oral sex with "clients" and after the date was over, the Defendant would return. The Victim stated that the Defendant does not drive but he would call an uber and they'd move to different hotels within the county. I know through knowledge, training, and experience that individuals who rent hotel rooms, screen clients, conduct counter surveillance, collect the earnings from prostitution and provide security are participating in Human Trafficking.
