Hi Dave Huber,

Thanks for your email and yes I'd be happy to share proof of threats and sabotage plans against my poster campaign by antifa and other leftist groups, including threats to put up fake posters. I have included 16 examples, examples 1-7 deal with sabotage via fake posters and examples 8-16 deal with other things including threats of violence (and more disturbingly, plans for violence which were never issued as threats). They are organized mostly in order of relevance, not necessarily chronological order. I'm extremely grateful that this is being covered. Please bear with me as there is a lot of evidence and things could get a little bit complicated. I'll try my best to keep it concise and clear.

USEFUL CONTEXT:

Sabotage plans were coordinated in several places, notably "itsgoingdown.org" (an official antifa terrorist website), Discord servers and "Leftypol" which is part of the website 8chan (similar to 4chan). Antifa and other alt left / far left extremists are very active in these places. Leftypol had two pages dedicated to sabotaging the poster campaign, I will point out specific examples but first here are links to the sabotage pages:

Threats and sabotage attempts were issued to the campaign in areas where planning and organization took place, namely 4chan and Voat (an alternative to Reddit with less censorship). A lot of campaign promotion also took place on Reddit on r/The_Donald (it reached the front page five times and was stickied by mods twice) but threats and sabotage attempts were unsuccessful there as it is strictly moderated relative to the other places.

EXAMPLE #1:

On January 16th 2018, antifa & left wing extremists on Leftypol discussed plans to sabotage the campaign with fake posters. Unsuccessful at tricking campaign participants into putting up fake posters, they began instructing leftists to print off fake racist versions of the poster and put them on campuses to frame the campaign, specifically to put them near a CCTV camera. They went further and instructed leftists to work with the school administration to get the CCTV footage and substantiate police complaints.

"Print off one of these posters and place it next to a CCTV camera."

"Also consider working with uni administration or the student union to get CCTV footage asap in order to substantiate the police complaint."

EXAMPLE #2:

On December 9th 2017, left wing extremists who had discovered plans for the poster campaign began plotting to sabotage it. They discussed sabotage plans in a Discord server associated with Leftypol. Specifically they wanted to frame the campaign by creating fake racist versions of the poster.

"Maybe we can edit it so that the hand is brown that way, they're racist?"

EXAMPLE #3:

On December 20th 2017, leftists created a fake racist version of the poster, which they proceeded to spam incessantly on 4chan in an attempt to get legitimate participants in the poster campaign to use the fake version (though these attempts were unsuccessful as campaign participants did not want to spread a racist message):

EXAMPLE #4:

On December 17th 2017, a saboteur identifying themselves as a paid employee of Shareblue arrived on 4chan to disrupt campaign planning by threatening to frame the campaign with fake racist posters. This individual also threatened that if any legitimate participants attempted to remove fake posters, they would get their hands chopped up as leftists would be placing razorblades behind their fake posters to harm anyone who might try to remove the fake posters.

EXAMPLE #5:

On December 21st 2017, a leftist saboteur posing as a legitimate participant arrived on 4chan and unsuccessfully attempted to trick legitimate participants into using the fake racist version of the poster. This individual then revealed that they were a saboteur and claimed that many fake racist posters had already been printed and would be put up by leftists to frame the campaign, and even claimed that a "pre-packaged story" to frame the campaign had already been given to the media.

EXAMPLE #6:

On January 26th 2018, a Voat user called "BoraxTheFungarian" participated in a brigade / raid along with many other users, attacking the official #MyBordersMyChoice website on Voat (https://voat.co/v/mybordersmychoice) which I moderate. I banned him for the following post, which encouraged people to use fake versions of the poster in order to sabotage the campaign:

"Btw, you have the hand colored wrong." (implying the hand should be given a color)

EXAMPLE #7:

This example does not pertain strictly to #MyBordersMyChoice but is provided to show that antifa / left wing extremists have a history of sabotaging messages they disagree with by framing their political opponents with false flags. The "It's Okay To Be White" poster campaign, which was planned in a similar way to #MyBordersMyChoice and by largely the same people, was also targeted by leftists for framing and sabotage. A media outlet reported on a fake "It's Okay To Be White" poster (containing links to websites) here, which was almost certainly put up by a leftist trying to sabotage the campaign:

Just like with #MyBordersMyChoice, the "It's Okay To Be White" official posters contained no links to any websites, no association with any group or organization, no threats, no racism, no obscenity, etc. The message stood alone. I know this because I was one of the main organizers behind the "It's Okay To Be White" poster campaign and I dealt with a similar non-stop barrage of leftist sabotage attempts and false flags.

EXAMPLE #8:

On January 21st 2018 (the official night when posters were put up around the world), a self-identified communist posted a violent threat on 4chan:

"We know what you're up to retards. It's a public forum. If i see any of you out and about putting these dogwhistles up, get running."

"The revolution will not be televised."

On December 21st 2017, a left wing saboteur began spreading fabricated lies and slander about the organizers of the campaign to demoralize people from participating, baselessly asserting accusations of drug dealing and financial fraud:

EXAMPLE #10:

On January 18th 2018 (three days before the January 21st poster date), a left wing extremist posted a call to violence on Leftypol for antifa and other extremists to see. Critically this was not issued as a threat but rather was posted quietly on a leftist site – making it far more serious. Threats are often issued as a bluff to discourage someone from doing something. The fact that these comments were not directed at the poster campaign as threats means they had no usefulness as bluffs and were more likely a sincere call to violence and physical assault against political opponents.

"Does anyone think it would be a good idea to go there and actually beat the fuck of them? I'm getting really, really sick of these stupid retards and the damage they're doing. They're dragging us into idiocracy and a post-truth world with how they openly embrace cognitive dissonance, lies and hypocrisy and the world just stands buy and lets them because "muh free speech".

Fuck these retards. They deserve to hang."

EXAMPLE #11:

On January 18th 2018 (three days before the January 21st poster date), an antifa member apparently named Alex Gettler (whose facebook page https://www.facebook.com/bootblack3000 has since been removed) posted a call to violence on the facebook page of "It's Going Down", a major antifa website that was banned from Patreon (https://www.patreon.com/igdnews) for violating their Terms of Service, for promoting violence and terrorism.

"Wait for them to come to put posters up and ambush the fuckers". (this comment was liked several times and nobody replied to it with any disagreement)

EXAMPLE #12:

On January 11th 2018, antifa and left wing extremists began an effort to doxx someone for sharing #MyBordersMyChoice pictures online. Specifically they targeted the user Pennsylvanian Patriot on Tumblr for this post made on December 10th 2017:

The purpose of doing this was to follow up with a campaign of personal harassment and intimidation against this individual, attempting to get them expelled from school, fired from their job, socially ostracized and physically threatened. Here are the comments on Leftypol related to the doxxing attempt:

"Oh my fucking god I know that guy, he's a massive fucking twat on Google+ and i actually live 5 miles away from the fucker."

EXAMPLE #13:

On January 16th 2018 (five days before the January 21st poster date), antifa and left wing extremists coordinated on Leftypol and planned to stake out campuses while wearing masks, armed with cameras, to follow around anyone putting up posters and take pictures of their face to doxx them (potentially escalating to violence as well). The purpose of doing this was to follow up with a campaign of personal harassment and intimidation against participants, attempting to get them expelled from school, fired from their jobs, socially ostracized and physically threatened.

"Wear a mask (a horse head mask would be best) and stake out the local women's studies department with a DSLR camera on Sunday night."

"Remember that since you are in a public place, they have zero expectation of privacy and you are permitted to take any pictures of them you want. If they tell you to stop following them then comply to avoid an arrest. Be aware they might phone in a complaint anyway so leave after getting a good shot of their face."

EXAMPLE #14:

On January 17th 2018 (four days before the January 21st poster date), the official antifa terrorist website "It's Going Down" posted an article about the #MyBordersMyChoice poster campaign, baselessly slandering all participants as "nazis" as is their standard operating procedure to delusionally justify using violence and terrorism against anyone they disagree with.

Astonishingly, Newsweek.com cited this terrorist website in their own article about the poster campaign, repeating the slander against participants by baselessly labeling them "nazis" and euphemizing the antifa terrorists as "activists" to provide PR assistance to the terrorist organization.

EXAMPLE #15:

On January 24th 2018, the antifa terrorist website "itsgoingdown.org" posted an article bragging about ripping down a small number of #MyBordersMyChoice posters and Kate Steinle posters at Arizona State University and burning them while giving the burning pile of posters the middle finger (picture shown at the beginning of the article).

"At around 9:00 PM (on the poster date January 21st 2018), a large group of antifascists met on the campus and organized themselves into patrols with the goal of cleaning the campus and potentially identifying those responsible. The area was swept and a large amount of #MyBordersMyChoice posters (a perversion of "My Body, My Choice", a slogan picked to specifically coincide with the Women's March) and posters politicizing the death of Kate Steinle, a woman killed in San Francisco, of which an undocumented migrant went to trial for and was acquitted, were found."

Cassandra Fairbanks wrote an article for The Gateway Pundit about antifa's depraved act of burning posters of a murdered girl and giving her the middle finger (along with #MyBordersMyChoice posters):

"Antifa in Phoenix have torched memorial photos of Kate Steinle that were posted on the Arizona State University campus on Monday evening."

"The masked far-left terrorists posted photos of themselves burning the posters of the 32-year-old shooting victim while sticking their middle fingers up at the flames."

EXAMPLE #16:

On January 21st 2018 (the official night when posters were put up around the world), a self-identified anarcho-communist (likely antifa) posted disturbing anime pornography known as "loli hentai" (depicting characters that look questionably young) on 4chan to disrupt and attack planning efforts for the poster campaign. This was not the first time a leftist had posted this image to disrupt the campaign. Even though this obscene material was a hand drawn cartoon and did not show abuse that actually took place in reality, it still depicted fictional abuse in graphic, disturbing detail. 4chan mods removed the image very quickly and banned the user who posted it. One user managed to screencap the post, blurring out the sexual detail but leaving the post number visible so anyone could still verify that a leftist saboteur actually posted it.

CONCLUSION:

Antifa and left wing extremists engaged in seemingly every possible tactic to sabotage the poster campaign, except presenting a logical counter-argument to the message of the posters. Lying, censorship, crime and violence were their first resorts.
