I was requested to supervise the perimeter while K-9 conducted a track. It should be noted Ramsey County assisted with deploying a drone into the area, and the State Patrol helicopter assisted with the search as well.

While the track was being conducted Ramsey County Sheriff Deputies advised that they had the suspect in custody over in the Eastern District. They also advised that they recovered a handgun as well. At this time the K-9 Track was ended and the perimeter was taken down.

On 01/18/2023 at approximately 1612 hours squad 382 (DeJong/ A. Cruz) responded to Jimmy Lee Recreation center at 270 Lexington Pkwy for a report of an assault. A male victim was reported to be shot in the parking lot. Prior to our arrival responding officers aired suspect information and responded to the victim who was transported from the scene by ambulance. See supplement reports for further details.

Upon arrival we assisted in speaking with possible witnesses at the scene as well as staff and patrons of the rec center. I spoke with a female, later identified by name and date of birth as Alisa Jae Logan (DOB/2002), who was sitting at a table inside the building. Logan stated she works at the center and did not witness the incident. Logan stated she was in her officer and walked into the main lobby shortly after the assault. Logan saw a group of kids in the entry way but could not provide suspect information. Logan stated her mothers vehicle was outside in the parking lot and she was waiting to leave the scene. Logan was advised of the severity of the incident and advised to call for a ride out of the scene.

I spoke with a male, Later identified as Chevy David Midas (DOB/1979), who was standing in the lobby and stated he arrived on scene shortly after the assault took place. Midas stated he was driving west bound on Marshall Ave prior to turning into the parking lot. When Midas parked his vehicle, MN Lic/ NJY009 a 2013 Volkswagen Passat dark blue in color, in the parking lot he observed a male laying on the ground and two groups of kid standing on the east side of the parking lot and near the entry of the building. Midas did not know what was going on so he got out of his vehicle and walked into the address. Midas was not able to provide suspect information at this time. Midas was advised of the severity of the incident and agreed to call for ride.

We then assisted in maintaining scene security until we were relieved by west officers and Squad 108 (Sgt. Shead)

Barnes advised that she has possible video footage of the incident from her Brinks security Camera. The camera is located at her front doorway facing Northbound towards the Jimmy Lee Rec Parking Lot.

Barnes was not able to access the footage at this time and that she would contact police again when she was able to.

We advised SGT SHEAD of the information from Barnes.

We held the Jimmy Lee Rec Parking lot securing the scene of the crime from our area until we were relived of our duty. We did not make any contact with any other witnesses of the incident.

When we arrived I (Larkin) observed the victim on the ground in the parking lot with two other people (unidentified) that were rendering aid. People were saying that the victim had been shot in the head. There was also other people around in the parking lot. One of the individuals there had a sweatshirt placed on the victims head. I took over with pressure to the victims head to stop the bleeding while OFC Tschida started gathering information. The victim was breathing and seemed to be semi-conscious. There was a lot of dark red blood coming from the victims head.

Officer Tschida was told that the shooter was an "Xavier," BM wearing a "Jimmy Lee" shirt. It was reported that XAVIER was an employee.

Medics arrived and placed the victim into the back of the ambulance. After stabilizing the victim squad 138T followed the medics to the hospital were the victim was treated by hospital staff.

I, Officer Bragg (Squad 828) assisted western district officers on a shots fired complaint located at 270 Lexington Parkway North (Jimmy Lee Rec Center) at 1612 hours. While heading to Jimmy Lee Rec Center, the call was updated to one person shot in the head. Additional information came out that the shooter was possibly inside Central High School. Due to multiple squads at the shooting scene, I traveled to Central High School where two teams of officers were wanted to search the high school for the suspect. Once on scene, this request was cancelled as the suspected shooter was not seen entering into the school.

At this time squads were needed to form a perimeter. I floated outside of the perimeter in an unmarked squad equipped with emergency lights and siren. Suspect was later arrested on the eastside.

#### Narrative:

On 01/18/2023 at approximately 1636 hours, We, Squad 384 (OFC.E.HIGGINS/OFC.C.XIONG) responded to the area of 1663 Stillwater Ave E to canvas the area for the suspect from the incident that occurred at 270 Lexington Parkway.

Upon arrival, we parked our squad car (2179) at Germain St and Stillwater Ave to watch for the suspect, Exavir Dwayne Binford (DOB/1996-04-11), and any vehicles he was registered to.

At approximately 1705 hours, we noticed Ramsey County Sherriff Office (RCSO) Deputy squads activate their emergency lights near 1663 Stillwater Ave E. One of the Deputies aired out over the radio that they had the suspect in custody and recovered a firearm.

We drove to where the Deputies were, I got out of the squad and as I was walking, I saw a Deputy holding a firearm and he handed it to a St. Paul Police Gang Officer. I continued walking and saw Exavir in custody with RCSO Deputies. We decided to put Exavir in the rear of our squad car (2179), I escorted Exavir to the front of our squad and searched him incident to arrest. A female RSCO Deputy took out Exavir's cell phone and other belongings when she was standing on his right side. I re-searched Exavir after the RSCO Deputy searched him. While I was searching Exavir, I noticed his jacket was ripped and I pointed it out to him. Exavir stated something along the lines of "yeah because I was attacked". I handcuffed Exavir, checked tightness and double locked, and took off the Deputy's handcuffs. I placed Exavir in the rear of our squad car.

Without asking Exavir any questions, he mentioned that he couldn't wait to get this all off his chest and that he couldn't believe this happened. After Exavir was in the rear of our squad and the door was shut, his mother walked close to the squad and yelled out that she loved him, and he did nothing wrong.

We transported Exavir to the St. Paul Police Headquarters (367 Grove St) without incident. Exavir was escorted to the second floor and was placed in a secure interview room. I removed the handcuffs off of Exavir and closed the door to the room. I monitored Exavir through video surveillance.

At approximately 2121 hours, I placed handcuffs on Exavir, I checked the tightness and double locked. We transported Exavir from the second floor of St. Paul Police Headquarters to the Ramsey County Law Enforcement Center without incident.

Exavir was booked for assault- great bodily harm, first degree, felony.

## Narrative:

On 01/18/2023, at approximately 1612 hours, I, OFF. K. BESAW (366) heard radio traffic of a shooting that occurred in the area of 270 Lexington Parkway N. Eventually suspect information was aired of a possible suspect of EXAVIR DWAYNE BINFORD (DOB: 04/11/1996, 1663 Stillwater Ave.,) which is an east district address. Using MyBCA I noticed that BINFORD had several vehicles currently registered to him. I waited in the area of White Bear Ave. N., and Stillwater Ave., to see if any of his vehicles turned onto Stillwater Ave.

Eventually squads took BINFORD into custody. While on scene I was asked to standby with a vehicle, MN LIC KAF 634, a gray 2007 Chevrolet Equinox. I was later asked to photograph the exterior of the vehicle and not the interior as it would be towed and held. I photographed the exterior of the vehicle and uploaded the photographs to MediaVault.

I also assisted by having the vehicle towed to the impound lot and informed the tow truck driver that I would be following the vehicle to the garage at the impound lot and to not touch the interior of the vehicle as it was going to be processed. As soon as I received notification that the address had been released, I drove HICKS and Ross back to the address. I provided HICKS with my business card with the case number and a business card from the homicide investigator who would be in contact with her about her vehicle at the impound lot.

Some how the brother was able to get into the building without Exavier knowing.
- Exavier found out and she stated, "he wasn't mad, but he was mad". She said the girl told Exavier to let her brother in and he can come in. Exavier told the girl, "No, get the fuck back bitch, he not coming in. Y'all can move around and y'all don't need to be here". The girl said, "Fuck, I can move around, and I can call my peoples". Exavier said, "Good, call your peoples".
- She stated that the girl and her brother were leaving the building and walking out. As the girl was walking out, she told Exavier, that the other female employee (Furo Ejero) was the one who said they could be in there. This irritated Exavier and he told the girl, "Fuck Furo, I don't know why that bitch try to go over my authority". said, "I guess he is the boss, because he said he is the boss".
- . Exavier went back inside building of Jimmy Lee for approximately five minutes, and she stated, "I guess he clocked out, and I guess he went to get his gun. I don't know if he (Exavier) had it on him already or not. He walked out with a ski mask; he had to walk past the girl and was getting disrespectful with her, so that is why she was arguing with him because he was saying rude things to her". The girl told Exavier, "I can call my brother". Exavier then showed his gun.

- While this was going on, Exavier, and and were still outside in front of Jimmy Lee. was sitting down, was standing by the door, and Exavier was near the door. Exavier was talking to them "reckless" and pacing back and forth with his hands in his pockets. Exavier was telling them to open the door several times, however they all refused to let him into the building.

On 01/18/2023 at about 1710 hours, I (Sgt P. Lee) was notified by Cmdr S. Lohse Johnson to respond to an aggravated assault call at 270 Lexington Pkwy N (JIMMY LEE REC CENTER). The information provided was the suspect (later identified as EXAVIR DWAYNE BINFORD DOB 04/11/96) is an employee of the Rec Center who shot a juvenile victim (DOB 06).

Additional details I knew up to that point was a fight occurred at the Rec Center. There was a dispute between the suspect and victim. The suspect shot the victim and fled the scene. The victim was transported to the hospital. The suspect was located by assisting squads and taken into custody outside of 1663 Stillwater Ave E. The suspect was currently at SPPD HQ.

At about 1839 hours, Sgt M. Onnen and I conducted an in-custody Miranda Rights interview with BINFORD at the SPPD HQ Homicide/Robbery interview room. The interview was audio recorded and later uploaded to the media vault. I read the SPPD Miranda Rights form that included the Miranda Warning to him. He acknowledged he understood his rights by writing his initials and signing his name on the form. He was given his copy of the form. My copy of the form was later uploaded to the media vault.

It should be noted that when I was asking BINFORD for his personal information such as name, date of birth and address, I also asked him for his phone number. He gave his cell phone number as 651-529-6818. I asked for an alternate contact phone number. He responded, 'My my work phone but I probably won't had that job no more.' I told him that I would take his work cell phone number which he gave as 763-354-0823. There was a section to ask about employer information which I did. He responded it was 'the City' and acknowledged it was the City of St Paul. I asked him to confirm that he works at the Rec Center referring to the JIMMY LEE REC CENTER, and he responded, 'I was.'

I advised BINFORD that his rights were read to him, and he acknowledged he understood them. I asked if he wanted talk and he responded 'I mean where do we startin from like the earlier in the day or...when the incident just happened or...' I told to start from what led up to it referring to the shooting.

The following summarized what we talked about.

He said what led up to it was he just started this position at 'Jimmy Lee CRS' and was previously at the Arlington Rec Center for four years. He got moved to the Jimmy Lee Rec Center in August 2022.

For today's incident, he said 'So I think whoever I harm I want to say he goes to...I don't even know how old he is, I just know I always had a problem with him since I started working up there.'

He explained the Rec Center would get calls from 'Central' which he verified is Central High School. The high school would call the Rec Center's front desk to tell them 'Yeah it's one of days.' and 'Lock the doors so that's how it really started.' He added it was always the same thing with that group referring to the victim and the victim's group. He also added it was the victim and the victim's group who were always involved with fights at the high school and at the Rec Center.

Today he acknowledged the Rec Center received a phone call from Central High School, so his front desk staff locked the doors. The high school did not tell them much other than 'today is one of them days.' and he and his staff new what that meant. The call time from the high school would have been around 3 PM because that was around the time the high school let out and the time their gym open.

When they get notified by the high school, what they do at the Rec Center is to lock the doors. They do not allow anyone in and if a guest leaves the Rec Center, then the guest would not be allowed back inside.

He described himself as 'I was fed up that day.' and he clocked out early. He started to mention something about 'some little girl' but stopped himself. He then stated 'I don't know, I got, how should I say this. I'm not. I know right from wrong. I just know my temper where it can go, you know what I'm saying.'

He explained what made him leave the building was 'some young lady' had a problem with him telling them (guests) no one could be in the building because a fight was going on. He stated the police came to the Rec Center and left so he was trying to make sure his building was secured.

I noted he stated, 'We had words with the female some young lady I don't even know her name.' He stated she was trying to be loud. He tried to explain to her this was his building and he wanted to run it smoothly because if something happened then he would be in trouble.

I noted he stated, 'So we had words in the building, me and the young lady.' He went on to say it was more so because she let her brother into the building. He told 'him' referring to the young lady's brother not to come into the building because he was part of the group causing trouble and he should stay with that group.

I asked and he clarified his dispute with the young lady happened after the Rec Center went into lockdown and before the shooting incident. He had already clocked out because he was upset and recalled punching out of work at 'like 4:30.'

He talked about not liking to get into argument because his first month on this job was 'bullshit bro, the kids be fighting, they be coming up there to do what they want to do...'

He stated because this young lady did not do what the Rec Center had asked regarding the Rec Center's lockdown rules that she became upset with him. He told her that he was not going to put her out, but she needed to understand the Rec Center's rules. He then clocked out and was leaving the building. There were still 'kids' outside of the Rec Center arguing and fighting under the vestibule area.

He was walking and the same girl referring to the young lady he had gotten into an argument with inside the building ended up leaving as well. He reminded her about all the 'extra stuff' she had done inside and now was leaving as well.

He got into an argument with her, was getting ready to leave and she was talking about him to her friends. He stated he was already upset so he responded with 'Shut the fuck up.' to her. He continued by saying 'the victim' stepped up and told him not to talk to her like that. He noted leading up to that point 'the victim' had been arguing with another girl as well. I noted him to say, 'Now that's when me and him had words.' He stuttered and stated, 'Me and the victim had words.' He recalled this was the same guy that he had problems with on his first week on the job at this Rec Center. He described the victim as someone who always will make everything about himself.

He went on to say again he left and walked pass the young lady had argued with and who was still talking to her friends about him. He said something back to her and said it in front of the 'victim' as he walked away.

At this point, Sgt Onnen asked him to clarify the identity of the 'victim.' He responded by saying 'I don't even know his name for real.' Sgt Onnen asked him to clarify who the 'victim' was, and he responded 'Whoever yall found at Jimmy Lee on the ground. That's the victim who I'm talking about.' He described the victim wearing a red coat, red hooded sweatshirt under the red coat, gray jogging pants and black crocs.

I asked what race the victim was and he responded the victim is Black and could be more White, biracial.

He talked about having an argument with the victim who also had a friend with him. He realized he was 'kinda talking to both these guys, whoever his friend's doing he doing.' He described at that point they were 'talking shit' and he was still going to leave but 'came back.' He thought he forgot something in his office such as his work key or work phone and did not want to lose them. He continued to argue with the victim and the victim's friend. He stated 'I ain't gonna lie, I felt threatened.' even though they were teens.

I asked him to explain how it was that he felt threatened. He stated the victim thought he (suspect) was trying to brandish or reach for his (suspect's) gun when he was reaching into the exterior left front upper jacket pocket. He was digging into that jacket pocket because he was looking for his bus pass. He and the victim were still arguing, and the victim thought he (suspect) was reaching for his (suspect's) gun which caused the victim to assume 'Oh you clutching your gun.' towards the victim. He said the victim would not know he (suspect) had a gun and even if he did, it was legal.

I asked if he had his gun on him. He responded first about having his gun on him and an incident involving his vehicle which did not make sense. I cut him off because he was not answering if he had his gun on him or not. I asked him where his gun was at during his argument with the victim. He gestured by reaching into his left interior jacket pocket with his right and said he only took out his gun 'after they fucked me up.'

I went back to talk about him reaching into his exterior left upper jacket pocket and what the victim assumed he was doing. He said the victim told the victim's friend to 'call what's his name and tell him to bring all the sticks.' I asked what sticks meant and he did not know but though it probably meant to bring all the weapons.

He said up to that point he was still going to walk away to catch the bus. He told the victim and the victim's friend if they wanted to do something to him that he would be at the bus stop.

One of his co-workers came outside and got in the middle of the argument between him, the victim and the victim's friend.

He was walking towards Marshall Ave because his bus stop is at Oxford St/Selby Ave. The victim continued to talk 'shit' to him as his co-worker got in the middle between them. He continued to walk off and told that he felt threatened because of the past behaviors of the victim and the victim's friend.

He went on quick rant about not really talking to those kids referring to the victim and his group of friends. He mentioned almost fighting with them on his first week on the job at this Rec Center.

I directed his attention back to talk about him saying he was walking away from the argument with the victim. He explained stood nearby as well as the victim and the victim's friend as he walked away. He added there as a vehicle parked near them which he could have walked around but he decided not to. He walked pass the victim's friend who got in his way. He responded by extending his arm and pushed the victim's friend to get back which he described as a 'baby shove' to create space. It should be

noted he described the victim's friend as someone who wore a blue coat, and the altercation was still on the Rec Center property (parking lot).

After he shoved the victim's friend, the victim and the victim's friend ran up on him. He admitted to shoving the victim's friend, however he did not ball up his fists. He believed the victim's friend had blocked his path on purpose as well.

The victim and the victim's friend were ready to fight him after the shove. He started to back away and they got up on him. He described wearing his jacket unzipped with the hood up over his head during this time. I noted he said 'I ain't gonna lie. They they jumped me, they jumped me.'

I asked him to describe how the victim and the victim's friend rushed him. I observed him getting up from his chair, walk a couple of feet away from the interview table and stood facing Sgt Onnen and me from about five feet away. He clenched his fists and brought them up near his chest and stated that was how they rushed, grabbed, and hit him.

He ended up on the ground and on his back but was able to 'flip him' referring to the victim. He was able to throw a couple of punches as the victim's friend ran up on him. He was able to throw punches at the victim's friend as well.

He was able to get off the ground and covered up his face/head by using his hands/arms to shield himself as they were beating on him. Immediately after giving those details, I heard and noted him say 'I ain't gonna lie...I pulled out my pistol and shit.' and 'That's really it though...' He added that 'I just felt like if you wouldn't put your hands on me this wouldn't happen you know what I'm saying but.'

He explained when he was getting jumped that everything was getting pulled off of him. He demonstrated by pulling his jacket over his head with his upper torso bending over forward. He pointed out to large tear on the right rear of his jacket which happened when he was getting jumped.

He mentioned before they fought that 'he' possibly referring to the victim was on the phone saying, 'Call what's man, we'll smoke you.'

I asked him when did he pull out his gun. He said he pulled out his gun after they beat him and 'like literally a second after they beat me and they kinda...' He acknowledged he was on his feet and did not chase them. I asked what they (referring to the victim and the victim's friend) were doing. He responded, 'Looking stupid just sittin there.' and stood there without backing away. He also did not back away. I asked how far apart he was from the victim and the victim's friend. He responded with a 'Good question.' He said there was a red car parked near where the victim was at. He described being 'like ten yards piece' regarding the distance between him, the victim and the victim's friend. He followed that statement up by saying 'maybe 10, 15 yards.' I asked if that was distance between him and the victim when he shot the victim and he responded, 'Um hmmm.'

I asked if he felt he had no choice at that time referring to shooting the victim. He responded he was not going to lie and could have done something different. He said now that he has reflected on it that he is not a dumbass, not mentally unstable and very logical that he felt 'if they wouldn't put they hands on me, I wouldn't have shot that boy and he know that.' He followed that up by saying they made his job hard, and he just wanted to come to work every day.

I asked him how big the victim was. He stood up and put one of his hands to about his eyes to demonstrate how tall the victim was compared to him. It should be noted the suspect is listed at 6-03 and 200 lbs on his MN DVS driver's license. He said the victim was six feet tall and about 170 lbs or 180 lbs. He said the victim was not big but talked big. He said the victim's friend was 'not that big though.'

I asked when he was rushed by the victim and the victim's friend and being beaten by them, if he saw them with any weapons and he responded no. He repeated himself by saying he did not see them with any weapons just like they did not see him with a gun until 'the point.'

He said the victim and victim's friend talked like they 'gun toters' which but him on defense. He was not going to let these 'kids' do anything to him although it was not intentional on his part.

He said he did not know the defense law here, but he was rushed and jumped. He suffered a busted lip.

I noted he grabbed and lifted his upper lip to show what looked to be a small fresh cut underneath the top portion of his lip. It should be noted he had visible injuries to his right upper eyebrow area and outer lips area near his mouth which he later said was caused by the victim and the victim's friend.

I asked if there was anything that obstructed him from behind that would have prevent him from running away in referring to why he did not de escalate the situation by retreating during the argument and fight.

He responded his intention at first was to run but the victim and the victim's friend put their hands on him first. He said he does not go around hitting people. He said he knew they did not like him because he is the new guy around town. He started to talk about when he first started the job at this Rec Center that they were asking who the new guy was referring to him and why he was hired.

I heard and noted he said this incident was not intentional because he did not plan to come to work with the intent to harm someone.

I asked him why did he have to shoot the victim after the fight because they all just stood there. He said he was not going to lie, it was just in the moment, he did not have an explanation and he was sorry.

I heard and noted him say 'I'm fucked right now but when shit happens bro it happens bro like.'

I asked how many times did he shoot and he responded 'one time.' I asked if he knew that he hit the victim referring to the gunshot.

He took a deep breath and said he initially did not know the victim was shot. After the gunshot the victim fell, and he peaked around the vehicle (parked vehicle) where the victim had been standing by. He said he looked, saw the victim and 'I'm like fuck.'

I asked where the victim's friend was at that point.

He responded the victim's friend was probably screaming and yelling.

I went back to ask him what he did after he saw the victim on the ground and he said 'I ain't gonna lie, I fled bro.'

He said this was the first time he experienced something like this happening to him. He again repeated himself by saying he is a nice guy and did not just wake up today to kill this dude.

He admitted everything happened fast and the victim fell down. He then said he thought the victim was playing dead when the victim fell but as soon as he peaked and saw the victim he knew 'I'm fucked.' He said at the same time he felt what happened was because the victim and the victim's friend jumped him.

I asked him where his co-worker was at that point.

He responded by saying was probably still trying to get the victim and victim's friend off him. He said when he shot his gun, he heard say 'Oh fuck.' and 'Oh my God.' and that ran away. He said whoever was out there would have seen what he did. He again said he did it, but it was not intentional.

I noted he talked again about getting jumped by these kids and got his jacket pulled over him. He said it was not on his mind, but he got his gun license for a reason.

I wanted to talk to him again about what happened after he shot the victim. I asked why he did not offer help to the victim and or helped himself. He was not able to give an exact answer and said, 'That's a good question.' and 'Nah, you definitely valid for that. That's a good question for sure.' He said the shooting was not intentional. He acknowledged he had his personal cell phone on him at that time and admitted he could have called 911 even if he had moved a safe distance away.

I told him he could have called the police. He said he was scared and 'I know better now.'

I asked him where he ran to after the shooting.

He said he ran to Oxford St/Selby Ave. He called his mother and told her 'That I fucked up. I did some dumb shit.' His mother wanted to see him before 'they' got to him referring to the police. He and his mother agreed to meet downtown St Paul. He took the bus #21 to downtown St Paul at 5th/Minnesota where his mother was waiting for him.

He clarified it was just his mother who came to pick him up. He and his mother left downtown and drove straight home to their address of 1663 Stillwater Ave E. He said when they got home the police were already on them. He said as he and his mother were getting out of her vehicle the police pulled up on them.

I went back to ask him about additional details regarding his argument with the victim and victim's friend. I asked why he did not remove himself from the situation and why he did not just go back into the Rec Center.

He responded he knew he fucked up and did not need to be lectured. He said he knew he could have left 'My thing is don't put your hands on somebody you don't know repercussion don't do that because I don't go around beating up on people and expect them to not do shit.'

He said the injuries on his face were not self-inflicted and caused by the victim and the victim's friend.

Sqt Onnen asked him some follow up questions.

Sgt Onnen asked how he clocked out of work. He said the work clock machine was mounted on the wall where one would enter their employee code and do a fingerprint scan.

Sgt Onnen asked about the girl who got into the building during the lockdown. He said the building was already locked down and he did not know how the girl got in because he was outside telling everyone who was with 'that group' to not go in. He said they had an open gym hosted by a group called 'JK' and the girl may already have been inside.

Sgt Onnen asked about him having said 'the other victim' which he clarified is the victim's friend who jumped him and who also was wearing the blue coat.

Sgt Onnen asked him about 'talking shit' and what it meant. He explained it was whatever they were saying to him that he was saying it back to them. He said they said, 'fuck my mom' and he responded back to them 'fuck your mom.'

He never told the victim and the victim's friend that he had a gun and did not brandish his gun at them during their argument.

He acknowledged he keeps his gun in his left front upper interior jacket pocket. He said when he pulled out his gun that he did not say anything. They did not say anything to him, but they saw him pull out his gun. He said they could have run away just like he could have as well. He acknowledged they did not react to him other than 'look stupid.'

He recalled the victim had earlier dare him to shoot the victim when he was reaching into his front jacket pocket to look for his bus pass.

He was asked how long it took when he pulled out his gun to when he shot his gun, and he responded with snapping his fingers.

He did not say anything after the shooting, and they did not say anything to him. He heard a lot of screaming as he ran away.

Regarding his co worker full name, he spelled it as ,' and who is a White male.

He described his mother' vehicle that picked him up as a Chevy SUV.

He described his gun as a 9 mm Taurus U2C with upgrades on it and it was the gun he shot the victim. He added his gun has a extended magazine and there were a total of 17 rounds. He also added he carries his gun loaded in his inside jacket pocket.

He was asked if he was familiar with the City of St Paul's policy regarding employee having gun(s) at work in relation him being a permit to carry person. He said he never asked his employer about the City's policy and procedures for carrying a gun on duty at work. He said he normally does not carry his gun with him at work. He said he would keep his gun in his car while at work however he has not driven his car to work because the catalytic converter got stolen. He said he knew that St Paul employees could have their gun(s) in their car at work but not on their person at work. He said if he was at the Rec Center with his family that he could have his gun with him because it is public property. He said he knew there was not a ban of firearms because Arlington Rec Center has given out gun locks.

Regarding him carrying his gun at work, he said he did not tell anyone about it and they referring to his employer did not know he carried his gun at work.

He acknowledged Kia vehicles gets stolen a lot and was asked why he would keep his gun inside his car since he said he had earlier stated he owned a Kia. He said he was not worried about his vehicle getting stolen. He said he was concern if his gun got found in the Rec Center that he would have some explanation to do. He said he just recently started carrying his gun in his jacket pocket. He said he got robbed when he was 14 years old and that messed him up.

He acknowledged looking back at this incident that he would have handled it different. He explained in the moment of things related to this incident that 'my mind just clicked bro.' while snapping his fingers and 'shit happen bro.'

He was asked what he recalled about his permit to carry training in relating to after shooting his gun. He said he did not know because it has been over a year since he took that training class. He was asked based on his training what he was supposed to do if he shot someone. He responded, 'You really supposed to call them peoples.' referring to calling the police.

He said he is not a threat. He said he felt threatened by those kids referring to the victim and the victim's friend.

As we talked to him about the trouble the kids caused at the Rec Center, he said he could not get the image of the victim out of his head. He said it was the image of him peaking over to see the victim laying on the ground before he ran away. He said he was 'going to be fucked up forever.' and 'I can't take it back; he can't get his life back...' He continued to repeat himself from earlier about being beaten up by the victim and the victim's friend.

I asked if he remembered when he was getting assaulted if there were other people around.

He said he remembered 'these two dudes' being in front of him. He again said he remembered being there as he tried to walk away. He talked about the dude in blue referring to the victim's friend who blocked his path and he responded by shoving the victim's friend to move away.

I asked if he remembered anyone else being in the background of the victim when he pulled the trigger.

He said it was after the shot that everyone came up. He said the shot came after the fight.

I asked if he pointed his gun at anyone else and he responded no.

I asked what he had to say about other people saying he pointed his gun at them as well.

He said there was probably no truth to and however he did cuss them out.

I asked about his employment history with the City of St Paul, and he said has been an employee for about 10 years. He worked at the ARLINGTON Rec Center and got moved to the JIMMY LEE Rec Center in Oct0ber 2022 based on a promotion. He said his title at the Rec Center is 'CRS' which is a Community Rec Specialist. His job duties have him overseeing majority of the programming on the recreation side.

I asked if he is a full-time employee.

He responded, 'I was a full-time employee.' He said he was not going to work for them referring to the Rec Center and 'I'm finna go down for the longest.'

He gave his work hours as 10:30 am to 7 pm before his vehicle got stolen. After his car got stolen, his work hours were 12:00 pm to closing which would be about 9 pm. He called it the graveyard shift and that was why he carried his gun on him.

He took the city but to work today and showed up at about 12 pm. He admitted he had his gun on him while he was at work today.

Regarding his permit to carry, he said he obtained it in October 2022.

He purchased his gun 'the gun yall got' from DK MAGS in New Brighton, MN.

He said he has a second gun which is also loaded, and it is kept in a bag somewhere in his room. He said his second gun is the same make as the gun we recovered.

He said he lives at home with his mother and his 12 years old sister.

The interview was ended at 1928 hours.

Squad 384 (Ofcs C. Xiong/E. Higgins) assisted with booking BINFORD at the LEC for 1st degree assault (Felony).

This case will be submitted to the RCAO for an in-custody review for charging considerations.

It should be noted that I was advised via secondhand information that St Paul Parks and Rec Supervisor Randy Graff expressed safety concerns for employees at the JIMMY LEE REC CENTER. The supervisor expressed a request for a court order restriction to not allow BINFORD to return to the Rec Center and to prohibit him from contacting employees.

### SAINT PAUL POLICE DEPARTMENT

- Is a Community Rec Director at Jimmy Lee, Merriam Park, and Martin Luther King Recreation Centers. He doesn't have any staff on his payroll. Exavir is underneath him, however, doesn't report to him. Exavir's direct supervisor is Eric Thompson. His role is program and outreach, and doesn't necessarily need to be onsite, however likes to be onsite for outreach. He stated one of the coordinator's is out for FMLA, so he has been stepping in to fill those shoes right now.
- He stated when the teens come after school, he usually will direct them to where they go. Today they were short on staff, so usually Exavir has his staff helps out. This evening it was him, Exavir, India Woods, and Furo Ejero.
- He stated today the kids were being directed to go down the gym at "JK Movements-Johnny Allen" to have open gym.
- At 310PM they got a call from Central High School to lock the doors at Jimmy Lee, because "kids were doing a lot". He
  wasn't positive who called, because India took the call. He stated it was somebody from their front desk and thought it may
  have been "Cindy".
- He stated he and Exavir went outside and observed a large group of kids at the parking lot entrance near Marshall Ave. He stated they stood near the door, and they try to not get involved. They had locked the doors and approximately five minutes later, it slowed down. They unlocked the doors. Exavir went downstairs to check on open gym.
- At approximately 320-325PM, the unruly group was "mobbing again" so they locked the doors again. Exavir came back upstairs.
- At approximately 330PM, Exavir and India walked down there, and the kids were not listening. They came back up towards the entrance, and stated he called the police at approximately 335PM. He estimated the group to be approximately 20-25 kids. He said only a few were fighting, but the group was loud, messing around, and not listening to staff.
- stated the police came, they didn't get out, however drove through the parking lot, which calmed them down for a minute, but not long. He described the group as "tense".
- Exavir was "escalating, he didn't really do anything, you could tell he was agitated". stated Exavir generally has a good relationship with the teens, that tough love stuff, and it worked for the most part to my opinion". The kids for the most part knew the rules and what was expected of them.
- stated at approximately 345PM Rec check has to go the pool at 4PM. The staff was not there, so he brought the kids to the pool. came out at approximately 352PM.
- He and Exavir were outside. The doors were locked, and a boy came up. A girl was inside the building, pushed the door
  open, and let the boy in. Exavir and the girl get into a heat verbal back and forth. He was telling her that she couldn't do that.
  He was "jawing" back at Exavir and mentioned she would "take it there". Exavir challenged her "Oh you going to take it
  there?".
- A couple minutes had passed, and he went in. above him. went over to the group who was in the corner and told them they should leave. They were not listening telling they were told they could stay by other staff. told them they needed to leave because Exavir was "tripping" out and talking reckless.
- Exavir was agitated and said something similar to, "Its all good, but you can't be here, I make the rules, I run it". The female told Exavir, "India said I could be in here". Exavir said, "What the fuck does that mean, I am the one who runs the building type shit". At this point, Exavir and India get into a small verbal altercation about this incident. Exavir was heated, goes in and clocks out. didn't recall at what time he clocked out and thought Exavir was supposed to close that evening. India was frustrated then. Exavir left the building. India went to the party room.
- was trying to figure out staffing since he left. While doing that the kids started banging on the door. He didn't know what was going on, however the kids told Furo that Exavir was talking reckless and "showed something". He stated, "They used a slang word, and he didn't recall, however thought they were referring to a firearm, maybe a burner". told Furo to let them into the building and he would bring them into the back gym. said, "I want to be honest with you, I didn't think he had a gun, I thought they just thought they saw something". He stated he called his supervisor (Eric Thompson) and told him that he needed to get down there.
- walked the kids to the back gym, and he came back out. Exavir came back to the building pretty quickly and began banging on the doors. told the others, "Don't he have a key?" Furo told him he wasn't going to let him in. stated he ignored him and was trying to wait for Eric to come. was thinking, "What is he doing, he is going to get us in trouble".
- India came back, and the doors were locked so other teens couldn't come in. India told the thought that Exavir was arguing with the kids outside. stated there were a few kids near the front steps, including the kid that was shot. walked outside and they were verbally arguing with one another.

He stated that where the juvenile was shot is where he dropped which was near the front driver's side tire of a sedan.
- wasn't sure if the parking lot view from the cameras caught the incident. He stated it was in the parking lot where the
  cars were and progressively moved further S/E into the lot.
- thought the juvenile was shot in the chest area and was bleeding heavy.
- wasn't sure what hand Exavir had the gun in but described the gun as black in color.
- wasn't certain if Exavir left his jacket, however he stated he did, and it was near the shooting. described his jacket as light blue in color and wanted to get it back as soon as possible.

She came upon a Facebook profile of "Seven Anderson" who posted a video of the aftermath of the shooting. The video showed a person laying on the ground of the parking lot with several people people standing around. There was a person talking on his or her cell phone among the people standing around the person on the ground. It appeared to her the video was recorded on the balcony of the same apartment building where her sister lives.

She saw that there were some disrespectful comments on the Facebook profile Seven Anderson about the video being posted. The video was eventually taken down.

She later searched Facebook and saw under profile "Quanny Quanny" the same video had been posted there as well. She noted the profile "Quanny Quanny" had been vocal towards the profile "Seven Anderson" about the video being posted on Seven Anderson's page.

She wanted to bring the video to the police's attention. She was concern the video may set off threats.

She later added there was a second video that showed the police in the parking lot.

I advised her that I would look into both Facebook profiles and look for the video. I also advised her that she could contact Facebook to report the videos.

Sgt Onnen assisted with locating the Facebook profile "Seven Anderson" which had the video posted of the aftermath of the shooting. The video was originally posted by Facebook profile "King Lamond." The video was about 35 seconds long. The video played in two parts. The first part captured a person laying on ground in the parking next to a parked vehicle. There were several people pacing around near the person on the ground. The video looked to be recorded from an apartment balcony that faced the Rec Center parking lot. The second part captured squads with their emergency lights flashing in the same parking lot.

A Snag It video copy was made of the aftermath of the shooting video and later uploaded to the media vault.

The Facebook profile "Quanny" was located and no videos related to the shooting was found. The other Facebook profile "King Lamond" was located and no videos related to the shooting was found.

A Facebook preservation was done on Facebook profile "Seven Anderson." Reference Facebook case number 7504703.

- I, Sgt M Onnen, along with Sgt P Lee, met with a state of at SPPD Headquarters to ask follow up questions. The interview was recorded audio and visual from the Homicide Conference Room. The interview was uploaded to Evidence.com.
- provided much of the same details but added the following new or further detailed information (See original interview report for further details):
  - · Exavir is sometimes referred to as "X".
  - Exavir is one of the onsite supervisors of Jimmy Lee with one other person.
  - had not seen any of the allegations made against Exavir (treated kids poorly) but said he knew Exavir would swear. The swearing was not in a derogatory manner.
  - Exavir had a good rapport with kids and youth work was something that he was decent at but had a few kids he did not know how to handle. Since Exavir was there they saw a decline in problems with the kids.
  - · Jimmy Lee Rec was short staffed so "JK Movements" was running the open gym to assist.
  - Exavir usually "takes the lead" on telling problem kids that they can't enter the building because he has the rapport with the kids.
  - Exavir might have swore at the female that got inside but did not know what was said.
  - · Kids being a problem at the building happens "a lot".
  - India is front desk staff for Jimmy Lee Rec. did not think India "overstepped" her role by saying the female could be inside.

  - · India and Exavir are both hardheaded and strong willed.

I told him that "we" were trying to track his his son down and time was of the essence in this case.

His voice started to go higher in yelling at me. I advised him that I did not want to get into an argument with him because he already yelled at me and my partner. He responded "Yeah you know why?" and I cut him off. We started to talk over each other. He accused me of talking over him and I told him it was he was talking over me.

I told him to set up a time so we could do the interview with his son at the SPPD HQ. He responded it would not be today because they have something going on.

I told him to tell me what day/time of this week his son will be available to speak with us. He wanted to see how long the conference at school last and would call me in the morning. I gave him my work cell phone number to call me. I also gave him Sgt Onnen's direct office phone number to call as well. I asked if his son mothers (and who he identified as his wife) would be coming as well and he responded "more than likely."

A hysterical female caller requested help to include an ambulance to the Jimmy Lee Rec Center/Oxford Community Center because "somebody got shot." The female caller was cry and screaming as she gave information to the 911 dispatcher. The 911 dispatcher tried to calm the female caller down and ask pertinent questions as to what happened. The female caller responded with calling the 911 caller a bitch, used the fuck or fucken profanity word as she screamed and stated "somebody got shot bitch.'

The 911 dispatcher got the fire/medic dispatcher on the line with them and requested medics to respond to 270 Lexington Pkwy. In the background the female caller who was still crying and screaming was heard saying the victim's name as Juvaughn.

The fire dispatcher asked the female caller about the rec center address which she confirmed. The female caller also confirmed her phone number as and who also confirm she was with the patient referring toe victim. The female caller continued to scream at the fire dispatcher and only answered some questions that were being asked. The fire dispatcher advised the female caller that help was on the way.

The fire dispatcher asked the female caller if the person who shot the patient was still there. She responded the shooter ran away and "he fucken ran."

The female caller did not know what part of the body the patient got shot but there was a lot of bleeding. She was asked and responded the patient was alert, his head was injured, and it was just one wound.

The fire dispatcher advised help was on the way.

The fire dispatcher gave first aid instructions to the female caller who did not verbally respond and sobbed loudly back.

The 911 dispatcher got back on the line and asked questions about the shooting to the female caller who did not answer and continued to sob. The female caller eventually answered and stated she saw the shooter.

The female caller identified the shooter by name as "Exavier" and who wore all black clothing. The female caller stopped answering questions again and yelled out some inaudible words to include profanity at apparently someone around her.

Towards the end of the call and at about the four-minute mark, the female caller acknowledged she was with the police and the 911 dispatcher advised the dispatcher would be disconnecting the call.

The audio for this 911 call is about 06:21 in duration. The first four minutes of the audio is related to this case. At about the 04:41, the 911 dispatcher spoke to a male caller who called in about wanting to report a criminal damage to property incident that was not related to this shooting incident. At about 06:11, the female caller from earlier called back and stated there were multiple people there and she was trying to get them evacuated. It appeared she did not need further assistance at the rec center and the call was disconnected.

This 911 audio was uploaded to the SPPD media vault and I titled it as the first 911 audio call with phone number

The second 911 call will be summarized as followed:

The male caller stated to the 911 dispatcher 'we' were at the Jimmy Lee Rec Center and 'This dude just shot a kid.' and 'He just killed a kid.' The caller said 'he' referring to the shooter was fighting them and then shot them.

The 911 dispatcher advised that help was on the way. The dispatcher asked for the caller's phone number and the caller responded that 'he' ran off referring to the shooter.

Louds screaming was heard in the background.

The 911 dispatcher appeared to try to connect the call with a fire/medic dispatcher however the caller could be heard saying 'He's dead.' a couple of times.

The 911 dispatcher asked what was going on and the caller responded a worker was involved who was picking fights with the kids. The caller added the worker argued with the kids and then shot him. The caller gave additional details by saying there were two kids the worker was arguing with.

The 911 dispatcher asked the caller if he was with the person who got shot. The caller responded he was not and he was inside the building. The caller added he was inside and watched the shooting happen outside. The caller was asked and responded there were four or five people with the person who was shot.

The 911 dispatcher asked how old the person was that got shot. The caller responded someone stated the person shot is breathing. The caller was asked for the age and gender of the person shot. The caller responded 'it was a boy, a sophomore in school and about 15 years old. The caller continued to answer questions by saying the shooting just happened, they were in the streets with the person shot and who was not moving.

The 911 dispatcher asked where the shooter was at the caller stated the shooter shot 'him' referring to the victim and ran away. The caller added he knew what kind of vehicle the shooter drove and was asked for details regarding it. The caller then stated he was handing the phone on his end to one of the workers.

A hysterical female got on the phone and stated she was inside the building. She was asked for details by the dispatcher and had difficulty giving full answers as she remained hysterical. She screamed out something to the effect of 'He ran off.' She was reminded help was on the way and responded with a couple of 'Oh my God.' She was asked additional questions and responded the shooter was a 'CRS' and a director at this rec center. She went on to say an altercation happened, he got upset, they 'got off with each other' and pulled out a gun. She added she was with the person who was shot (police sirens could be heard in the background).

The dispatcher asked if anyone was putting pressure on the wound and the female screamed it out to ask on her end of the phone. The female started sobbing, stated she was with the police and the call disconnected.

The second 911 call audio was about 04:09, uploaded and labeled as second 911 call audio into the media vault. I was not able to locate the caller's phone number for this second 911 call at this time.

The SPPD radio traffic audio was uploaded to the media vault.

The ECC Incident Detail Report was uploaded to the media vault.

On 01.18.23 at approximately 1612hrs, multiple officers from the western district responded to the address of 270 Lexington Parkway N (Jimmy Lee Recreation Center) in response to an aggravated assault complaint. Officers quickly arrived on-scene and located a male subject in the parking lot who sustained a gunshot would to the head.

Upon my arrival on-scene, I assisted Sgt. Shead with securing the scene and assigning on-duty personnel to witnesses and designating officers to assist with the K9 track. The victim was quickly transported to Regions Hospital and was followed by officers Tschida and Peterson, along with probationary officers Kreimer & Larkin.

As officers held the scene and located witnesses, other officers by working with Recreational Center staff were able to identify the suspect and obtain home address and cellular phone information. That information was later used to locate the suspect as he arrived back at his address in the eastern district. I later responded to Regions Hospital and it was determined the victim was in critical condition and had been admitted for surgery.

On 06/13/2023, I (Sgt P. Lee) received an email from Sue Wegwert from the City of St Paul HR that contained an attachment to three videos which I uploaded to the media vault. The videos are part of the search warrant signed by the Honorable Ramsey County Judge T. Carey on 04/21/2023 and executed on the same date at the City of St Paul HR and St Paul Parks and Rec HR in relation to the suspect Exavier Bindford's work file. I previously received some documents via email from the City of St Paul HR and these videos were not provided at that time. See other supplemental reports.

I will describe and note the three videos received as follow.

Video #1, Arlington Hills 12.3.19-Front Lobby Doors:

- -The video is about 5:23 in duration.
- No date and times on the video.
- -The visitor (male wearing a light color hooded sweatshirt and black pants) exited the first set of doors with Exavier Binford (all dark clothing) following a few steps behind. Both exited out the second set of doors and goes outside.
- -Moments later, Binford came back inside, and the visitor eventually comes back inside as well. Both walked out of view of this camera.
- -At about 1:07, BINFORD was seen in view of the camera being physically restrained by an unidentified rec center employee. Both moved out of view.
- -At about 1:14, BINFORD and the visitor were seen coming back into view grabbing each other with BINFORD seen swinging what looked to be a punch. Both are struggle with each other as the unidentified employee paced around and who tried to intervene. All three moved out of view of the camera.
- -At about 1:23, two unidentified males were able to separate BINFORD and the visitor as they came back into view of the camera.
- -At about 1:58, the unidentified employee and the two unidentified males escorted the visitor out of the building.
- -At about 4:26, the visitor came back into the building.

Video #2, Arlington Hills 12.3.19-Front Parking Lot:

- -The video is about 7:03 in duration.
- -No date and times on the video.
- -The camera covers the exterior front doors and overview of the front parking lot.
- -At about 42 seconds into the video, the visitor was seen walking out of the rec center building with BINFORD following on foot a few steps behind him.
- -BINFORD turned back around and walked back into the building. The visitor turned around and started walking back to the building.

- -The video is about 6:42 in duration.

- -The camera covers the interior entrance of the front doors.
- -The visitor was seen walking by the front desk about 16 seconds into the video.
- -The visitor paced around and heads for the front doors and he was followed by BINFORD. Both walked outside and out of view of this camera.
- -At about 1:00, BINFORD came back into the rec center building.
- -At about 1:13, the visitor came back into the building as well and his attention appeared to be directed to the unidentified employees at the front desk.
- -At about 1:20, BINFORD approached the visitor with an unidentified employee standing in between them. It should be noted that as BINFORD approached the visitor, he was seen grabbing the waist area of his pants to adjust his pants. From my training and experience, I know this body language and action to be a pre assault/fight indicator.
- -At about 1:22, BINFORD started to go after the visitor with the unidentified employee trying to stop him. BINFORD then threw a closed fist punch with his right hand at the visitor which connected. The visitor tried to duck with BINFORD throwing another punch with his left hand that connected on the visitor. The visitor tried to fight back and was pulled back by the unidentified employee who tried to break up the altercation. BINFORD had ended up on the ground, got back up on his feet and threw another punch at the visitor which connected. Two unidentified males and the unidentified employee were able to interview and stop BINFORD from assaulting the visitor. BINFORD still struggled to break free from their hold to try to go after the visitor before stopping and walking away. The visitor was escorted outside by the unidentified males.
- -At about 5:56, the visitor reentered the building.

- -St Paul Parks & Rec letter dated 02/18/2020 to BINFORD to advise him that he was suspended five working days. The reason for the suspension stated on 12/03/2019 while working at the Arlington Hill Community Center, he became involved in a physical altercation with a participant in the front lobby, 'you threw punches at the participant and had to be restrained by Recreation staff.' Additionally, it was expected of him when returning from his suspension that he refrains from any physical altercations while on duty.
- -Work Place Incident Investigation at Arlington Hills Community Center. Date of incident as 12/03/02019, date of investigation 01/29/2020. The complainant was Office Assistant Zachry Gilman and the respondents were Community Recreation Specialist Thao Vue and Community Rec Director Kate Ross. GILMAN submitted his resignation and one of his reasons included was the incident where BINFORD was involved in a physical altercation with a visitor. It was described as management attempted to 'sweep the incident under the rug.' The physical altercation involving BINFORD was not reported to higher up for more than a week.
