## Common Ground

Oh Imperial Wizard

*"Ladies and gentlemen, it is my humble duty tonight to introduce you, to THE GRAND and imperial wizard..."* The folks that come on television to present or defend their own beliefs in their person, with their real name are the least kind of a problem for society. It was in an episode of Crossfire in 1982 where Bill Wilkinson shared his views on segregation at the cost of being laughed at. Whatever his views were at the time, at least he said what he honestly believed in. If someone like him isn't a problem, then who is? Maybe those who appear to be honest, but are not really. Those who talk a lot, but not much truth. Those who express beliefs, but not their own. The concerned and of high moral standards deemed individuals.

Maybe those who have established themselves to be, one could say, racially uncorrupted before everyone. Whose reputation stems solely from their public actions. As if it was an impossible task to put up a character and keep a healthy public image. To show the good crust and conceal anything underneath. What does it show when a product advertisement contains every human race, like god forbid if they forgot to include one ethnicity, if not the fear of a company to be called racist and their awareness of the artificially induced and kept alive racial divide. Maybe the effort to be immune to the accusations. It seems forced, like the idea what choices people in the process of making an advertisement make, just to be whatever, appealing, correct or publicly acceptable. Things done with great caution aren't done naturally, but with mind governed intent.

It seems like accusations are taken advantage of, out of any controversy. As they still seem to work for the accusers, like every accusation creates this bubble of righteousness for its author not enough people strike with questioning. Almost anybody can be the good person these days, one just needs an apparent villain or proof someone's unjust nature to create a moral high ground for oneself.

Accusing someone in a vigilant society is a sure way to have your real character questioned. As everyone is aware of the possibility of appearing persons of morals to stir great trouble while being left unnoticed in plain sight. So everyone questions things themselves, even if culprits are pointed out to them by others. Obviously allegations aren't proclaimed just on account of racism and are not always used to destroy someone's reputation or get one out of the way. Is accusing is a good virtue. The idea that a public allegation is raised in honesty is often too sweet and comfortable to be true.

There isn't a person to feel contempt based on an outside appearance and be the one's only imperfection. One does not simply become racist. Views are developed throughout time. Who is born with prejudice. How do these accusers get away with calling people racist while race is all they talk about. Who of the accusers care to know the causes. Why is it called to be a race. The curious enough care to know about the characteristics, including those of ethnicity, even if they are not crucial in opinion making. Some even believe Jesus was black, who cares, rather interesting would be to know why he is known the way he is today. What was important was what he said. The truth is most people don't care much about skin tone

and all that above inner character. And the rest is like, appropriate to observe, but not to take seriously. Beside discrimination having its origins in strong beliefs, similar views could arise out of fear, like becoming a minority.

### The Seat

We know Hitler's Germany held racist ideology, but where were its roots. What the vision of developing a superior and riddance of inferior human races stemmed from. Hitler wrote at least two books and he mentioned the term Aryan at least in one of them. Our human culture and civilization is bound up with the presence of the Aryan and if he were to be exterminated or subjugated, the dark shroud of new barbarian era would enfold the earth. Did he ever write something along those lines? Why would he refer to the Aryan, which may imply a race or species, as he? There was supposedly a book made public in 1871 entitled "The Coming Race" written by Edward Bulwer-Lytton, who lived from 1803 to 1873 and was an alleged member of a society called the "Golden Dawn". And by supposedly I mean I have no idea.

In 1917, individuals of various backgrounds met in Wien to find out more about the matter, the knowledge of Golden Dawn, Templars und Die Herren vom Schwarzen Stein, possessors of a stone of deep black, purple color. The individuals may have been Karl Haushofer, Maria Orsic, Baron Rudolf von Sebottendorff, ace pilot Lothar Waiz and prelate of Societas Templi Marconi. Later in December of 1919, reportedly in Berchtesgaden, gathered the possessors of the stone along with Maria Orsic and one other transcendental medium to form an effort in contacting the Aryan or their ancestors. In Sumerian language was given some knowledge and an ethnical doctrine mentioning certain races to be in lower levels of development and their further cross breeding resulting in even greater spiritual descent. Then cooperation of various societies with similar interests including one called Thule enfolded, while individuals like Heinrich Himmler, Adolf Hitler or Winfried Otto Schumann became, among others, also involved and familiar with the teachings.

Maria Orsic along with other women created own, strictly female society Vrtil-Gesellschaft officially entitled; "Alldeutsche Gesellschaft für Methaphysik" and in cooperation with Thule society used the forementioned knowledge consisting of instructions and laws, to build an advanced system of propulsion, whatever its ethereal energy source was meant to be. One of the first alleged endeavors was JFM or Jenseitsflugmaschine, a drum cabin with engine in a middle of three discs. The upper one rotated in opposite direction to the lowest one and together with the disc in-between of them were meant to generate electromagnetic field. It was completed after financial difficulties in summer of 1922 and dedicated to two years of testing for a new type of propulsion called SM-Levigator, later disassembled and stored in an aircraft factory in Augsburg.

If there were to be intelligent beings somewhere in the Earth, one would expect to be quite critical to any received information, especially if they had strong beliefs in the survival of the fittest and their opinions about humans weren't way too far away from clumsy, primitive and a disgrace, not to mention if they despised democracy in its real form. No matter what races believably came out of the double helix, it may have not happened with their consent or control over it, nor it seems they have been somewhere down here with us just out of their own will. Chances are the idea of supremacy or race superiority hasn't been conceived by a human mind, but rather handed over to some of the minds, already preconceived.

After the Nazi Party took over, expeditions were to take place to a set of places and further development succeeding the Jenseitsflugmaschine was to be marked after a significant time gap in the beginning of 1937 with construction of Rundflugzeug 1 (RFZ-1) in Brandenburg. In a test flight, the flying machine along with Lothar Waiz reached a certain height after lifting off a customized ramp, but eventually came down and hard landing ensued. Its control mechanism turned out to be completely insufficient. RFZ-2 and 3 were built by the end of 1937 and used some kind of impulses of magnetic field to change direction of flight. RFZ-2 had diameter of 5 meters and an MG-34 machine gun. But as it could only turn in certain angles, it was only deployed as a scout vehicle. These and the other subsequent projects of the Vril and Thule along with conjectures about them, may be even more likely reviewed with scepticism. RFZ-4 was completed in 1938 and just as RFZ-3, it served to improve the flying capabilities. In 1939, Thule Triebwerk, an advanced propulsion unit was used within RFZ-5, of which two were built and in a new type of saucer titled H-Gerät, consequently renamed to Haunebu I, which was under scientific SS E-IV compartmentalization.

The task of the Thule and SS Entwicklungsstelle IV was to develop an advanced craft suitable in combat, while Vril pursued to build an interstellar transportation vehicle in the first place. Interstellar flying saucer, isn't that bit farfetched? It is, but at the same time it is not, if they had contacted and received a guidance from some elder life form. There is probably no publicly available proof the projects ever existed, but it may be a story worth mentioning. Whether they were successful in their endeavors, in what extend or even if the projects were real at all and if so, which ones, is questionable and rather increasingly less likely as the projects develop and profess greater results. In 1941, Adolf Hitler allegedly prohibited all occult and secret societies, which simply just outlawed any of their activities outside of the governmental supervision, even though different source stated Illuminati Germanae was prohibited as soon in 1933, after being restored in 1896.

RFZ-6 was used from 1940 to 1942 to test advanced versions of the SM-Levigator. In winter of 1942 began construction of RFZ-7 which was soon renamed to Vril 1 Jäger. Its attributes were quite incredible, achieving speeds of thousands of kilometers per hour while being armed with MK 108 cannons and two MG 17 machine guns. Its body was built from some kind of special alloy which was supposed to withstand flights with resistance. 17 of them were built by 1944 and tested in many flights. Vril 2 Zerstörer was planned to be build in 1945 or during the year after, and was to be followed by Vril 3, 4, 5 and so on.

Claims are also the Vril 7 "Geist" was engineered already in 1944, in Brandenburg factory and had to be repaired after its crash. Why would they skip or plan the preceding Vril versions for later? Vril 8 Odin was tested in spring of 1945 and armed with a cannon titled "Oberon". Then, as long it just wasn't also made up, there were to be other Vril vehicles; Vril 9 Abjäger, Vril 10 Fledermaus and Vril 11 Teufel, which allegedly remained, along with some other projects, only as plans.

The concluding project of the Vril was Andromeda-Gerät, 139 meters long spaceship thing that was able to store several flying saucers. Two of them were supposedly built by the end of the war and given names after Norse gods, from which "Freyr" was allegedly discovered by American army and the fate of the other "Freya" is unknown. If that's how the names are meant to be written. Rumor is Maria Orsic and other women of the Vril disappeared before

the war was over, but does that mean they had flown away in a flying saucer or some kind of a mothership.

SS E-IV and Thule were developing the forementioned Thule triebwerk as soon since 1935, in a secret facility in northwest Germany, alternatively just called the "Hauneburg", while a flying saucer was formally referred to as H-Gerät or Haunebu. None of this has been publicly confirmed. Built were two prototypes of Haunebu I, three prototypes of Haunebu II tested around 1943, there was also other version of 1944 called Haunebu II Do-Stra (Dornier-Stratosphären Flugzeug), which was meant to be used in combat, if it ever was, and one prototype of Haunebu III was built by the end of the war. Haunebu IV wasn't built, but was supposed to be 120 meters long in diameter. Haunebu I had a mounted cannon named after the Teutonic god of thunder; Donar, but its use was dropped after it'd caused stability issues during test flights in 1939. Its hull consisted of two layers and was made out of some kind of special alloy, presumably enclosing a vacuum. Haunebu II had three of these layers. They were able to achieve speeds of thousands of kilometers per hour and some even higher.

Even if some of it is true, any piece of information could easily vary from reality. There isn't whole lot of things to subsidize any of the claims. There are some images of documents that could have been inspired by the real things, but also made by anyone in an afternoon or few. Most of or probably all supposed photographs of flying saucers in Nazi possession that are publicly available rather discourage anyone who would be willing to reserve this subject some of their time. A lot of information, possibly including also here mentioned, is burying what could be true under layers of lies and discrediting this whole branch of unconfirmed, theoretical history of the World War II era. It is difficult to recognize what is potentially real or based on reality from what is made up, unless the thing isn't making it glaringly obvious.

Although they are not as extraordinary, Horten Parabel, Sack AS-6 and Omega Diskus are also some of the worthy projects which existence was at least partially confirmed. Brothers Reimar and Walter Horten built the glider in 1938. Its exceptional shape was inspired by a seed of *Zanonia Macrocarpia* and meant to have minimal air resistance. Sack AS-6 was made by German farmer, Arthur Sack who had also built propelled plane models. In 1939 at an exhibition in Leipzig-Mockau, he presented Sack AS-1, a model with circular wings and ended up accepting an offer to continue to develop this type of aircraft with official support. The government wanted new STOL plane capable to lift and land on a short runway. After he built a bigger AS-5 model, he was ready to make his first piloted version AS-6 V1, which test flights started in 1944. The plane was difficult to control and required improvements. Even though Arthur Sack wanted to solve the issues alone, AS-6 was sent to Messerschmitt for a rework. There it was also allegedly destroyed by allied forces and Sack AS-7 or Me 600 Bussard remained on papers.

Omega Diskus was imagined by German engineer Josef Andreas Epp around 1943. It was disk shaped, conventionally propelled vehicle designated for scouting and transportation while being capable of vertical takeoff as well as landing. A smaller model was built. With cockpit in its center surrounded by eight propellers and an arm with engines spanning through its whole diameter, it may had been rather way too difficult to build it in real scale. After the war, he was hired by Soviets and revamped the idea which may or may not have been built.

Other notable individuals were Henri Coanda and Viktor Schauberger. Henri Coanda was

Romanian engineer and beside his other work, also author of Coanda effect. He discovered and described the tendency of fluids flowing at high speeds to bend and replicate shape of a curved surface along which they move. The same happens with gases, just at higher speeds. He resided in Paris and after 1940 worked for the Nazi regime. During the time he also made a concept of a flying disc, but it required many jet engines which could be otherwise used in serially constructed planes. A model for tests in a wind tunnel was made by the end of the war. US Army received the documentation of his work and tested it with positive results.

Austrian constructor Viktor Schauberger also searched for new ways to use Coanda effect in propulsion systems. In 1940, he worked on a testing unit called Repulsin, but was after intrigues by association of Vienna engineers sent to a sanatorium in Mauer-Öhling, where he was under SS supervision and later to concentration camp in Mathausen. There he was meant with a group of technically educated prisoners continue to develop the Repulsin project, thus "Repulsin A" with diameter of 80 centimeters was created. Its first test didn't go as expected, the motor crashed straight into the ceiling after it had been activated. Such event almost meant for Schauberger death as the SS suspected him of sabotage. He built new units including an advanced version "Repulsin B". Its development continued in Vienna.

Repulsin plans and prototypes ended up both in the hands of Americans and Soviets. Schauberger was interrogated by American services for 9 months and had to give them his sketches and documents. Then he worked on agricultural machinery and water turbines. In 1958, he was invited to further develop his ideas for the US military. He agreed, came to the United States, spent few months writing articles and working under stress, but eventually came back to Linz, Austria. There he few months later died, on 25th of September 1958.

A company, different from the one Schauberger worked with in Vienna, knew about the Repulsin project and a plan for an aircraft based on its propulsion system was created, but the work did not advance further. In 1941, Rudolf Schriever, one of the engineers working for the company made a plan of a disc with pilot's cabin surrounded by many blades titled Flugkreisel. The blades propelled by jet engines controlled vertical movement as the rotor does on a helicopter, while two other jet engines were used for horizontal flight. At least one similar concept was supposedly conceived before the Second World War. Whether the Flugkreisel as it was imagined was ever built or tested is unknown, but it could have inspired similar aircraft called Flügelrad.

Existence of these vehicles, in basis propelled by conventional technology of that time, just in an unconventional way, is unconfirmed. It would be quite difficult to construct them just for the benefit of vertical take off and landing. Conjectures say all kinds of things, even that the Flugkreisel was already tested in June of 1942, when enough powerful engines weren't yet available, at least not for the regular planes of the Reich. The names are easy to change for one another. Development of the first prototype called Flügelrad V1 started in 1943, yet by another company. Flügelrad V1 was smaller than Flugkreisel, but less impossible to be build. It was supposedly tested in September of 1943 on an airfield near Prague, but with insufficient results. Flügelrad V2 was built and tested in 1944, but suffered stability issues, therefore a greater reworked version Flügelrad II V1 was made and tested in February 1945. The vehicle did only a jump into the air and was soon followed by Flügelrad II V2 with higher amount of 24 blades, greater diameter and two engines instead of a single one. It was also allegedly tested, but if it was successful, its performance was not to be drastically different

from any other aircraft of that time.

Plans were also for Flügelrad II V3 with total of 21 blades and larger Flügelrad III with two engines of a type which was still in development by the end of the war. Some of those who were allegedly working on Flügelrad prototypes or contributing to them were Heinrich Richard Miethe, Klaus Otto Habermohl, Giuseppe Belluzzo, but also Rudolf Schriever and Josef Andreas Epp. Projects were initially under Luftwaffe, later directed by Speer's Ministry of Armament while responsible for them was Georg Klein and at last under Hans Kammler's SS supervision. Documents and prototypes were destroyed before the enemy armies had a chance to get to them. Some speculations say there could be remains. Habermohl was captured by Soviets. Miethe, Schriever, Klein were captured by Allied forces and Belluzzo returned to Italy. Miethe became involved in another project. He also tried to convince Schauburger to come to work in America. Schriever left to work for American military, but later returned to Germany.

An article appeared presumably in March 1950, quoting Giuseppe Belluzzo in newspaper Il Giornale d'Italia. *"There is nothing supernatural or Martian about flying discs,"* he said, *"but they are simply rational application of recent technique."* Italian scientist said that types of flying discs were designed and studied in Germany and Italy as early as 1942. Adolph Hitler and Benito Mussolini, he added, were interested in the instruments, and the idea was developed concurrently, both in Italy and Germany. Later in the same year published magazine Der Spiegel Schriever's article. In 1952 came out in France-Soir interview with Richard Miethe describing something called V-7, which parts were supposedly acquired by Soviets. If that wasn't simply an attempt to direct attention to Russians. In 1953 came out an article in German newspapers Welt am Sonntag titled "Erste 'Flugscheibe' flog 1945 in Prag", which included interview with Georg Klein describing Flügelrad, but also another projects of saucers to which he attributed great performance. Constructor Roy Fedden also stated that Germans were by the end of the war developing aircrafts that could correspond with the saucers meantime observed in Europe and America. Similar attitude expressed Edward J. Rupert, leading director of Project Blue Book, an analysis of unidentified flying objects which went on from 1952 to 1969 or 1970, officially. So there seem to had been something to study. The UFO term had been created, the question is with what purpose. Josef Andreas Epp released book titled "Die Realität der Flugscheiben", in which he stated that all of the saucer objects seen after the war were man built.

There were also reports of pilots and crews of allied army about fiery orbs by which they were often accompanied or followed, even if their direction of flight changed. Occurrences happened in 1942 and continued abundantly throughout years and after the war, above the German territory and elsewhere. There were supposedly hundreds of such incidents, but not all of them were reported. The objects were seen as orange, white, red, yellow or gold spheres. They did not engage with aircrafts in any way other than causing their engines and electronics to malfunction. Planes were also outrun by them. Crews pointed to them as the thing, the light or lights when they had seen them in clusters. Some pilots referred to them in their reports as rockets. The phenomenon was later named Foo Fighters.

There was also report describing something of different shape which could intentionally point to the Andromeda Gerät. Or another report which stated crew member recognized features as wings of one of the spheres during an encounter. Chance is not all of the reports

are plain truth or remained unaltered. Did the individuals who come up with the name know something more than anybody else. Could be the research of atomic bomb related. If one can get through information about the band, there are also theories explaining origins of the name. Projects Feuerkugel and Kugelblitz as well as last century statements of individuals like Renato Vesco claim the Reich was responsible for the existence of Foo Fighters. There was also a document made public for some reason, whether it is real, titled "An Evaluation of German Capabilities in 1945", which also mentions a weapon called "Phoo Bomb".

American newspapers wrote articles during the war about floating in air silvery, sometimes semi-translucent balls seen alone and in clusters. Unknown objects appeared also above Los Angeles in 1942. Some images of documents depict aircrafts Haunebu I and II with spherical centers as well possible effort to link military industry of the Third Reich to the encounters. Why would Germans try to build a flying saucer. Maybe they knew their history that can be seen under a dome. Have the Vril 1, 7 and 8 or the Haunebu aircrafts ever been used in an air battle? Somebody may have noticed them. Or what happened with them after the war.

Die Glocke was main component of a secret project directed by one of the SS departments to the end of the war. Igor Witkowski, Mick Cook and other authors characterized it in their works in some detail. As its existence remains unknown to the public, all the information is matter of speculations. Priority of the project was defined as decisive for the outcome of the war, while term essential for war nullified any formal restrictions. The device consisted of two hollow rotary cylinders spinning in opposing directions and around shared axis at high speeds during an experiment. Between of them was placed tall capsule or container and the core with base was concealed by a heavy cover making it look like a bell. Alleged individuals involved in the project were Walter Gerlach, Kurt Debus, Hermann Oberth, Otto Ambros, Richard Crämer beside many people specialized in different fields and prisoners.

Wars end, but are the incentives and visions behind them gone. Albert Speer said after the war was over; *"It's hard to recognize the devil, when he has his hand on your shoulder."*, yet he'd recognized importance of the Pergamon Altar in the construction of parade grounds for the party rallies in Nuremberg. The grand stand became also known as the Zeppelin tribune. With hundred and fifty searchlights surrounding the grand stand and most rallies being held at night was created experience rather unseen before. After the war, only a small part of it was left standing and the swastika symbol atop the tribune was also destroyed. Which is a reason why people have to reside to old pictures to see it standing in its full shape as it was. The ends at both of its sides were so to speak, "coming out", as if the tribune wanted to embrace the crowds standing in front of it. The grand stand was only oriented in one way. A building resembling the Altar of Zeus, oriented in two opposite ways, would look like capital "H" (or "I" with the top and bottom horizontal lines), from an aerial view right above it.

The searchlights were even used in the closing ceremonies of the 1936 Olympics in Berlin. The year before on the evening of September 15th, Hitler announced the Nuremberg laws. Laws that took away German citizenship from Jews. Or said otherwise, made others believe they had no more rights as citizens and attained the ability to limit their liberty. It was called the law for the protection of German blood and German honor and it began the gradual marginalization of the Jewish people.

The Altar of Zeus with a bronze bull at its center was originally located in Pergamos, now

Bergama (TR) 39°11'N 27°11'E, where in AD 92 Antipas was slain, in the place the book of Revelation calls the throne of Satan. In the 1st century, it was a thriving city comprising of splendid temples of Zeus, Jupiter, Athena, Apollo and Aesculapius, but after countless wars and natural disasters the temples lay in ruins. By the mid 19th century the locals used the site as a quarry, looting the marble for new buildings, until 1864 when a German engineer paid a visit and decided to excavate the desolated artifacts. The discovered monument was stone by stone brought to Berlin and reassembled in its own museum finished in 1930. Then when the grand stand was being built, in the middle of the Satan's seat where the bronze bull stood in ancient Pergamum, Albert Speer built Hitler's podium. And from there after declaring the Nuremberg laws, Adolf Hitler announced his "final solution" to the world or what is now known as the holocaust, from the Greek word (Holókauston) that means "a wholly burnt animal sacrifice", but this time the burnt sacrifice was millions of Jews. In this century, during an event of similar worldwide importance, at the site of a white horse, structure resembling the Altar of Zeus was again brought before the public eyes.

Descending from a mile high, the Hindenburg disaster took away lives of many passengers and crewmen. The majority of the victims were burnt to death. The airship was assumably named after the president of Germany who appointed Hitler the chancellor of Germany on January 30th, 1933. On February 1st, Hitler gave his "Proclamation to the German people" in Berlin. The Reichstag, the parliament building in Berlin was set on fire on February 27th. Someone else was blamed and the next day, the Reichstag Fire Decree passed in response to the fire. After banning other parties, from July 1933, the Reich was a single-party state.

Pergamum is revised version of Pergamos. Word parchment was supposedly also derived from the name Pergamos. Some even believe the Führer had the spirit of antichrist. 1 John 2:18 states there isn't just one antichrist, there are many. There have been many in history that brought through deceit, death and destruction. In 70 AD, Roman Emperor Titus said to the Jews; if you want to celebrate Passover, you can go into the city. And then when Jerusalem was filled, he then shut the gates, roughly from April to August, and literally starved them to death. It is claimed 1.1 million Jews were killed and 97 thousand enslaved. Philostratus wrote contemporaneously: *"After Titus had taken Jerusalem, and when the country all round was filled with corpses, the neighboring races offered him a crown; but he disclaimed any such honor to himself, saying that it was not himself that had accomplished this exploit, but that he had merely lent his arms to god, who had so manifested his wrath."* Hitler said he was tapping in to the third millennial reign of the great German people. Daniel 8:23-24 mentions a ruler of mighty power. The arch of Titus still stands in the city of Rome.

### Inheritance

One of the laws for the new functioning empire of thousand years was to order amalgam as the only medical insurance filling for dental cavities. By then wealthy were offered gold and the poor amalgam. Government was to control every facet of lives of its population. Either by the contributing work and loyalty or by doing nothing and being of no resistance, officials and citizens alike would eventually become victims of their own success. Hitler's driver Graf, as he was very warmhearted, talked with Hitler on long, distant drives and was somewhat aware of his difficulties. Hitler had many amalgam fillings since early youth and when he had gotten depressed and neurotic, he was advised to get the amalgams out. Rotten teeth were pulled out and other were firmed with metallic bridges. As he loved loud speeches, a lot of gold was used, which was supposed to make him more energetic. The dental reconstruction caused him

a lot of physical pain up until the end of his life and later had to use a cane due to strong hip pains. Since he was afraid he would not be able to hold martial speeches anymore after pulling out the most suppurated teeth, he put the matter on hold for years.

That is if he at the end of the war did not escape to Argentina or to different parts of South America or of the world. Which is more considerable about other high ranked officials who weren't mentioned during the Nuremberg trials, even though less important Nazis, missing or dead, were mentioned despite their absence. Then would the published X ray of the state of his teeth after suicide come also into question.

Roughly half of dental amalgam consists of metallic mercury. The element shares name with the horned Venus and the messenger god Mercury or Hermes. Hermes was given a herald's wand by Apollo and carried it on Mount Olympus, a staff often intertwined by one or two serpents reaching sometimes atop depicted sphere. The staff is as well typically winged. It is called caduceus, as if caducity is its spell. Metallic mercury comes out as a waste product from various industries that is expensive to properly dispose of. During the war, it was some thousands of kilograms of liquid mercury with no further use that the Reich had at disposal.

It is easy to get one's hands on something someone else seeks a way with difficulty to get rid of. EU announced years ago, and the media passed it on, that they plan to ban use of amalgam as a dental filling for women and children, or was it just pregnant women, by year 2030 or something like that, in order to protect the environment. And nothing, nothing happened. And that's not even the second part of it why. But they have at least let us know. It is not disputed metallic mercury is toxic to humans and mammals not exclusively, but if it is part of an amalgam, then it's safe as a toothpaste, any toothpaste, counting out the ones trying so hard to give the title up. Without seeing it in business, the word toxic alone doesn't really explain anything. Metallic form of mercury isn't so well absorbed in a healthy gut. It is supposedly better absorbed through skin, but breathing its vapors, for organisms with lungs is worse. Other forms of mercury are inorganic and organic. Inorganic are salts  $Hg^+$  or  $Hg^{++}$ . Organic form is created through conversion when  $Hg^0$  binds to a methyl group and becomes methylmercury that has, compared to  $Hg^0$ , excellent GI and mucous membrane absorption.

Developing brain neurons consist of central cell bodies and their growing branches, neurites. At the end of each neurite is a growth cone where structural tubulin proteins are assembled to form a microtubule neurite membrane surrounding a neurofibril, a strand that conducts neurotransmitters and what neural cells need to remain. The other main protein involved in growth cone is actin. Growth cones in humans as well in other living beings have the same structural characteristics and use proteins of essentially identical composition. Tubulin is a building block for neural networks in humans, by linking to each other they provide the base for the rail line, which is neurofibril, while holding the whole railroad together. Axon is term used for the fibre. Synapse is the junction between two neurons or neuron and muscle.

When mercury comes in contact with a growing neurite, the ions of mercury attach themselves with the binding site of newly created tubulin molecules, like by magnetic attraction, disallowing tubulin proteins to bind to one another. Consequently the neurite microtubule begins to disassemble into wandering around mercury bound tubulin proteins, leaving behind denuded neurofibril. Without the structure, both the developing fibril and its growth cone ultimately collapse. Some denuded neurofibrils form contracted tangles, these

residues can be observed in brains of Alzheimer patients decades prior the symptoms manifest. Why are the ill called patient, synonymous to meek willing to endure. Cadmium, aluminium, lead and manganese, each of them alone, do not cause disintegration of tubulin microtubule structure as effectively as mercury does in minimal concentrations.

Neurons in brain are also responsible for mental development and inherent behavior. More complex the neural web throughout brain, more ways there are in-between the brain cells with the means to sustain it, greater the canvas of conception, memory, vision, control. To have a body without alien elements should be enough to attain peace. When people in the past had destructive tendencies despite having a healthy body, it is maybe fair to say body itself does not alone represent the reason behind consciousness. Or maybe were just bored.

They understand a bulb not switching on when its cord is severed, but they act like they are unable to comprehend why someone would not react when you wave in front of one's face. Without the web that is supposed to transmit information of social interaction, whether it is torn or there wasn't even a chance for it to be created, the impulses are not transmitted, so the light bulb won't light up or flickers when the person reacts to incentives differently than is expected, out of social standards. Emotions are result of physical works within organism. Soul is really only individuality, a shard which is able to express through a carnal vessel. So the body is the gate to this world, the temple and the mind is its instrument for the soul to use. Even though terms psychiatry and psychology imply role of a soul in human behavior, mental diseases are about chemistry of elements which are capable to intercept processes within the brain. Mental disorders develop on physical level, that's what they are, they are disorders of natural order, whether it is believed all of it happens on chance or it is divinely ordained. Hippocrates stated all living beings have the same soul even though their bodies differ. One may wonder what the source of the confidence was.

There is potential for mercury to intervene with organic processes in the body when it is alone and there is a potential when mercury combines with different metallic particles. Suppose toxicity unit of one ion of mercury is 1, then potency of 2 ions would be 2, yet when ion of mercury is joined by an ion of cadmium, the resulting toxicity isn't 2, but it is much higher. The potency can continue to increase at a higher rate when other metals or elements are added to the group. These particles have together enhanced potency to do harm with greater power than is the sum of their individual power, that's synergetic effect.

As a universal toxin, mercury is able to magnify initial potency of vast array of elements to interfere within biological tissues. Mercury that is not bound and expelled out gathers inside the body, in fatty tissues and in accumulative organs which are meant to rid the body of these substances such as kidneys and liver, consequently limiting their ability to function, as well in the brain and in the nervous system. Testosterone increases impact of mercury while estrogen has rather an opposite effect.

Mercury evaporates at relatively low temperature, under pressure and in contact with acids. Its vapors are odorless and invisible to human eye without equipment like phosphorescent screen. All mercury based fillings leak mercury. Rubbing surface of an amalgam tooth causes mercury to evaporate in higher amounts and continues to evaporate after the stimulation in common circumstances for well over an hour at minimum. Scrubbing or scraping the surface of the filling releases into the air even more mercury. The amounts when scraping the filling

are over 0.1 mg/m<sup>3</sup> just seconds after stimulation. The amounts evaporating while chewing were measured in tens of micrograms per cubic meter that are released out of the amalgam constantly, and slowly decrease after the incentive in the next half an hour or more. Drilling into amalgam spews enormous amounts of mercury out of the filling during and after the procedure is over. Removal of mercury fillings shouldn't be done without proper precaution at all, nor should be a dentist found willing to do the procedure under such circumstances.

An Italian study was done by Andrea Frustaci and another medical doctors who examined enlarged hearts of young people suffering with cardiomyopathy, a condition which occurs also within professional athletes, and the biopsies discovered higher amounts of mercury in muscle cells of the hearts with idiopathic dilated cardiomyopathy, at average 22 thousand times higher amount compared to a heart with cardiovascular disease. The study concluded with the question; could be the occurrence in the tissues related to the heart disease.

There have been some precautionary steps instructing safer amalgam removal for enough time which include staffing mouth with cotton or use of rubber dam, proper gloves and breathing equipment and concern extraction of the mercury vapors away from the patient and dental personnel. It is recommended to place the saliva extractor underneath the rubber dam as the mercury is deemed to easily penetrate latex. Everyone who visit a dentist should be aware not to breathe in through their mouth during any dental procedure, not only the ones which involve mercury. And there are many additional points which are taken into account in these instructions approved by association which members are dentists from throughout the world with experience in the field. It is not an unknown issue and has not been in terms of toxicology for years. So how is it still not generally known, where were the media on this issue. Once it is considered of enough importance, the amalgam removal from the mouths of the population could be developed, improved and standardized with respect to the containment and neutralization of the contaminated waste and hazardous material. Even with governmental intervention to lift the financial limits for proper cause, that's what the role of true government of the people is, to redistribute wealth according to the needs substantiated by reason for greater benefit, just like allocating finances of one business to another when there is a better use for them and the investor who owns them chooses so.

Questionable also is what is the right substitute for amalgam fillings. The one material which is without any adverse effects is still the one that was not put in by a human being. The law the amalgam was introduced with says once in place, it should not be taken out. Unless the tooth breaks off or something, then it is pulled out with the tooth. Amalgam is cheap, fast and easy to use, usually lasts a lifetime and health damages most likely do not affect, and appear in one's work life, at least those were the arguments for its use in the last century. All the spared gold during the war could be used later for future warfare. In no point in time had the safety of amalgam fillings to human health be proven, its reputation probably just stems from its long time use coupled with lack of doubt, mainly from the side of the public.

Abrasion of a newly placed amalgam filling may chip off small bits of various sizes which can get with saliva into the stomach. Metallic mercury vapors that aren't definitely breathed out are absorbed through lungs or other inner tissues, or continue down to the digestive tract. Mercury has no metallic taste or any taste, it simply takes out biochemical taste sensory as it does any senses. A study of amalgam was done with a sheep, the studies which were done and published for the public medical knowledge were done already around the end of the

last century and earlier. Irradiated amalgam filling was put in the mouth of the sheep, so the possible consecutive spread from the filling could be traced. After four weeks, the filling was removed and image of the whole body was taken to show whether any mercury leaked out after those 28 days. The body image showed the sheep had accumulated particles in the jaw, stomach, intestine, liver and kidneys. Identical procedure was done unto a seven year old monkey. Correlating study wasn't done on a human being, at least not by the same group of researchers because the filling would have to be radioactively marked, but they were also confronted by an ethical commission and were told they can't put an amalgam in a tooth of a living human for the purposes of a study for ethical reasons, because it is known it is highly toxic. The sheep's kidneys decreased in their ability to clear inulin by fifty percent.

The whole body imaging of the monkey revealed presence of mercury equivalent to the one found in the sheep. Successive autopsy of the monkey showed substantial quantities in the jaw tissue, gumline, gastrointestinal tract and kidney tissues. These studies were conducted, among others, by Murray J. Vimy and Fritz L. Lorscheider and published in FASEB Journal in 1990 with an editorial addressing individual claims of amalgam proponents. Doctor Fritz L. Lorscheider was later also involved in the forementioned study reviewing impact of mercury on tubulin proteins which took place and was as well video documented at the University of Calgary in Canada. The research paper was published in 2001, in NeuroReport magazine and the research grant for the study was provided by the IAOMT (International Academy of Oral Medicine and Toxicology) that publicized the precautional steps for safer amalgam removal.

A study was done with human cadavers which found that people who had amalgam fillings during their life, had significantly higher amounts of mercury in brains and kidneys than the dead that did not have mercury containing fillings, and more amalgams a person had during the life, more mercury was found in brain. Another German study, financed by then largest manufacturer of amalgam components in the country was done in 1993 by professor Drasch to investigate how much mercury can be found in fetal tissues from interrupted pregnancies and infants which died of sudden death. He also found out how much amalgam mothers had in their mouths before and during the pregnancies and found directly proportional increase, more amalgams mother had, more mercury was in fetus and the infants which abruptly died had even higher concentrations of mercury. He also found people with amalgam fillings had up to four times more mercury in brains than people without amalgam and concentration in kidneys was at average twelve times higher in the examined corpses. Additional study with radioactively tagged amalgam fillings was conducted on pregnant sheep around 1990, with mercury being traced into the body of fetuses. Mercury was found in mothers and in blood, urine and liver tissues of fetuses in only 33 days after amalgam placement. It was also done at the University of Calgary. The levels in the lamb increased after birth from mercury in the mother's milk. In primates isn't an effective barrier to filter out mercury during a pregnancy.

There isn't an enzyme in human body which is not blocked by mercury. It's the most harmful non-radioactive element to humans, not only the most harmful metallic element. Amalgam sometimes falls out of the tooth, often it is pulled out while chewing and the individuals bite on something hard like a rock. Mercury dissolved in stomach acid is enough to impair every vital organ in the body, cause dilatation of the heart and consequent heart failure as well as disabling both kidneys in a relatively short amount of time, within weeks. In a long term, mercury can contribute to every disease in human body including neural diseases, which are and manifest as mental illnesses, disorders and deficits. Mercury increase in gastrointestinal

tract causes disruption of microbial flora and development of resistant, dystrophic bacteria.

Patients with many amalgams can over time accumulate high amounts of mercury in lower jaw, deposits in milligrams which have to be cleaned away surgically. Gingiva recession and even inflammation of appendix are conditions that could be affected by past presence of an amalgam. Amalgams should not be replaced by another metal, nor a gold dental appliance should be used in vicinity where once was an amalgam. Amalgam components come from manufacturers, or probably rather vendors, with statements when the use of amalgam is contraindicated, not when the use is recommended. Because the safety was never proven by the resellers of the amalgam components beyond anecdotal claims, there wasn't much proof provided to substantiate the reason why it should be used in practice.

There was also a belief that approximately half of mercury evaporates out of an amalgam in a time span of 7 years, leaving the composite with quarter structurally gone. This served as a reason that an old filling does not represent a health risk anymore. If it was true, roughly how much grams of mercury vapors would be gone from a filling. So when the methods to see vapors coming off the fillings became known, teeth with old fillings were also examined. Even though metallic mercury particles are not as well absorbed by tissues as are metallic vapors, gastrointestinal bacterial flora can cause conversion from metallic mercury particles into methylmercury.

Increasing mercury levels in the oceans and in the life within were blamed on volcanos, coal power plants, and quarries. Indeed radioactive rods may be more attractive as a waste than burning coal. Beyond other industries, hundreds of tons of mercury are released into the air in the US alone from water treating plants and as a byproduct in chlorine manufacturing. It was estimated the mercury concentration in fish increased from 1890 to 1990 270 times. In Switzerland existed a law and probably still does and not just there, which ordered a dentist to remove amalgam fillings from a deceased person before it is allowed to be incinerated as crematoriums also contribute to environment with mercury and all else people during life accumulate. Even streams in the Himalayas have been contaminated by mercury from the air. In 1991 the World Health Organization acknowledged that the predominant source of mercury exposure to humans comes from dental amalgam fillings, with less than 18 µg/day.

Since 1976, the Food and Drug Administration has to test everything human is exposed to, yet the dental amalgam has not been toxicologically tested. The reason is the amalgam has to be prepared by a dentist and is not sold in this state. So its components were considered. A dentist takes liquid mercury and puts in it metallic dust to be dissolved, then the amalgam is hardened. The metallic dust was classified into Class II and the dental mercury into Class I. "Class I" representing "no risk of harm", there are no known harmful effects. Liquid mercury in thermometers and all the other forms of mercury are in the most harmful category, only the dental mercury is not, but shares the class with a toothbrush and dental floss.

Mercury is also used as fungicide in seed and grain, in several diuretics, teething powders, in glues used in estrogen skin patches, adhesive bandages and so on, in dyes (e.g. pink dye for dentures), skin disinfectants, vaccines, eye drops and homeopathics. Merbromin is a topical antiseptic used for minor cuts and scrapes marketed as Mercurochrome® and discontinued after its reclassification from "generally recognized as safe" to "untested" on October 19, 1998, due to a lack of studies and supporting evidence of its non-toxicity. Sales were halted

in the next years in Brazil, Germany, France and it is also no longer sold in Switzerland, but it still remains readily available in most countries. As an organomercuric disodium compound, it is notable that it was ever recognized as safe.

Thiomersal, also known as thimerosal, is an organic mercury compound, an antiseptic and antifungal agent for its efficiency to eliminate micro-organisms in small concentrations and life in greater concentrations. It has been used as a preservative in multi-dose vaccine vials, immunoglobulin preparations, skin test antigens, antivenins, ophthalmic, nasal products and tattoo inks. Its use as a vaccine preservative was phased out from routine childhood vaccines in the US, EU and some other countries, because its safety was called into question by anti-vaccination idiots. The patent application for thiomersal was filed in 1927 by Morris Kharasch, a chemist then at the University of Maryland, supposedly, you never know when you read the facts on the Wikipedia the unfinished globe. The pharmaceutical corporation Eli Lilly and Company later marketed the compound under the trade name Merthiolate. *"In vitro tests conducted by Lilly investigators H. M. Powell and W. A. Jamieson found that it was forty to fifty times as effective as phenol against Staphylococcus aureus."* Preservative substance containing mercury was first time used in vaccines in 1931 and mass vaccination was done on dozen patients with meningitis, patients that were already susceptible, even it was not yet properly toxicologically tested and all of them died after they had been given thiomersal. Scientists thought it was caused by some kind of allergy, but they did not find any. The conclusion was the patients had meningitis and the cause of death is not related with thiomersal. Prefix thio denotes synthesis with sulphur in a compound.

Back then, thiomersal *"was used to kill bacteria and prevent contamination in antiseptic ointments, creams, jellies, and sprays used by consumers and in hospitals, including nasal sprays, eye drops, contact lens solutions, immunoglobulins, and vaccines. Thiomersal was used as a preservative (bactericide) so that multidose vials of vaccines could be used instead of single-dose vials, which are more expensive. By 1938, Lilly's assistant director of research listed thiomersal as one of the five most important drugs ever developed by the company."*

Now, on Wikipedia they reason in a different way, they choose which information goes in and what does not, that in one 1928 incident, 12 of 21 children vaccinated with a diphtheria vaccine were killed by the Staphylococcus infection as the vaccines lacked a preservative such as thiomersal. As a result, thiomersal in that situation failed to save lives, because it was not contained can you believe. Even if the infection was the true cause of death, there was still an option to use one dose vials. An option that has not been given to a person by vaccine manufacturers, which can open up a question whether vaccine preservatives do not hold a greater import than to disinfect and sterilize, and are more than a mere requirement resulting out of an effort to save money. *"Unlike other vaccine preservatives used at the time, thiomersal does not reduce the potency of the vaccines that it protects."* The vaccine preservative itself likely makes up most of the potency of the vaccine it includes, so it does not change the potency unless it is an increase. *"Bacteriostatics such as thiomersal are not needed in single-dose injectables."* The reality they came up with such claim themselves is significant of the possibility that it is not about money or them not being the main reason.

Autism was described on 11 children in 1943 by Dr. Kanner, a psychiatrist and in his publication he explicitly stated that there had not been an occurrence of such illness before. After its definition, autism has been rising ever since. The amounts had been increasing at

equivalent rates until 1990, when occurrences in USA and UK began to increase at a higher rate. One of the possible reasons may be because in 1989, these countries added three new vaccines containing thiomersal in their mandatory childhood vaccination schedules, and by one of them, hepatitis B vaccine, were infants injected already within 24 hours after birth. In another study published in 1975 were cases of death of infants with navel infections after they had been given disinfectant containing thiomersal.

Thiomersal is in the body *"metabolized or degraded to ethylmercury (C<sub>2</sub>H<sub>5</sub>Hg<sup>+</sup>) and thiosalicylate."* In 1999 was in the USA issued recommendation to not use thiomersal as a preservative in vaccines, but at the same time was propagated its use in less developed and underdeveloped third world countries. To the recommendation contributed risk assessment for effects on the nervous system made by extrapolation from dose response relationships for methylmercury. *"Since then, it has been found that ethylmercury is eliminated from the body and the brain significantly faster than methylmercury"*. Or maybe significantly faster, one can imagine so. Methylmercury has practically no half-life once in the brain, unless it is mobilized by an adequate chelating agent and then still, there is no way to ensure it will not effect different tissues. With all the pollutants and chemicals people are commonly exposed to and the way of life, the body doesn't get much chance to rid itself of unwanted elements through its own natural and inherited means, unless the individual is knowledgeable enough to consciously and successfully pursue such intent. And there is also the predisposition. The half-life there is, is the one many of us live, or quarter of a life would be closer to the truth.

Around the verge of the new century was also conducted humanitarian effort in China by the private interests in pursuit of disease prevention through mass vaccination, whether mandatory or not, they claimed they want to eradicate measles. In 1999, it was unheard of to have autism in China. In 2005, they already had 150 000 with autistic disorder. It does not prove direct or any relation, but whatever. So thiomersal is no longer used as a preservative in routine childhood vaccination schedules in the US, EU and a few other affluent countries.

In the U.S. for example, *"the only exceptions among vaccines routinely recommended for children are some formulations of the inactivated influenza vaccine for children older than two years."* Several vaccines that are not routinely recommended for young children contain thiomersal, including diphtheria and tetanus vaccines. Vaccines without mercury, mainly active vaccines, can contain traces of mercury as thiomersal is also used in the production of vaccines and then, because it binds so strongly to proteins, it is not further filtered out. Rest of the world have ordinarily used vaccines containing thiomersal as a preservative.

The World Health Organization (WHO) *"has concluded that there is no evidence of toxicity from thiomersal in vaccines and no reason on safety grounds to change to more expensive single-dose administration. The United Nations Environment Program backed away from an earlier proposal of adding thiomersal in vaccines to the list of banned compounds in a treaty aimed at reducing exposure to mercury worldwide. Citing that eliminating the preservative in multi-dose vaccines, primarily used in developing countries, would lead to high cost and a requirement for refrigeration which the developing countries can ill afford,"* the UN's final decision at the Minamata Convention on Mercury in 2013 was to not include thiomersal in the treaty.

*"Animal experiments suggest that thiomersal rapidly dissociates to release ethylmercury after*

*injection; that the disposition patterns of mercury are similar to those after exposure to equivalent doses of ethylmercury chloride; and that the central nervous system and the kidneys are targets, with lack of motor coordination being a common sign. Similar signs and symptoms have been observed in accidental human poisonings. The mechanisms of toxic action are unknown."*

The time span and the amount of prior doses matter. *"Fecal excretion accounts for most of the elimination from the body. Ethylmercury clears from blood with a half-life of about 18 days in adults by breakdown into other chemicals, including inorganic mercury. Ethylmercury is eliminated from the brain in about 14 days in infant monkeys."* The text in the next section continues: *"Though inorganic mercury metabolized from ethylmercury has a much longer half-life in the brain, at least 120 days, it appears to be much less toxic than the inorganic mercury produced from mercury vapor, for reasons not yet understood."*

The hazard pictograms of the Globally Harmonized System of Classification and Labeling of Chemicals (GHS) may be also somewhat indicative of a compound, but are commonly, as in case of laundry detergents, not given much attention. Chemicals are as well appended with GHS hazard and precautionary statements. *"Methylmercury and ethylmercury distribute to all body tissues, crossing the blood-brain barrier and the placental barrier, and ethylmercury also moves freely throughout the body."* Why a child or an infant should be injected with a compound containing chemical with a skull and bones pictograph on it, certainly one would want to limit the amount and risk by making sure to be able to afford to not share the vial.

By the end of the last century, children in the U.S. had in extent of standard vaccinations about 30 doses unto the age of two, and a dose containing 25 µg of mercury from thiomersal used as a preservative, to an infant with an average weight, represented 350 times the limit set by the Environmental Protection Agency (EPA) for methylmercury. How much difference use of ethyl instead of methyl mercury makes. Is it as a difference between ethanol and methyl alcohol. The multi-dose versions of the influenza vaccines used in the U.S. can contain up to 25 micrograms of mercury per dose from thiomersal.

To quote the opening sentence of the section addressing general toxicity on the same page: *"Thiomersal is very toxic by inhalation, ingestion, and in contact with skin (EC hazard symbol T+), with a danger of cumulative effects."* Disproven autism hypothesis is the title of the last section, instead of them letting you find out from the paragraph yourself, they have to let you know already in the caption. Maybe I cannot trust my own judgment, or is it me.

*"Following a review of mercury-containing food and drugs mandated in 1999, the Centers for Disease Control and Prevention (CDC) and the American Academy of Pediatrics asked vaccine manufacturers to remove thiomersal from vaccines as a purely precautionary measure, and it was rapidly phased out of most U.S. and European vaccines."* Many parents saw in the setting of a perceived increasing rate of autism as well as increasing number of vaccines in the childhood vaccination schedule as an indication that the preservative was the cause of autism. *"The scientific consensus is that there is no evidence supporting these claims, and the rate of autism continues to climb despite elimination of thiomersal from routine childhood vaccines."* There has been also no evidence of an incentive to look for the real causes why the rate is still rising on the side of some established reigning reservoirs for scientific truths.

*"Major scientific and medical bodies such as the Institute of Medicine and World Health Organization, as well as governmental agencies such as the Food and Drug Administration and the CDC reject any role for thiomersal in autism or other neurodevelopmental disorders. This controversy has caused harm due to parents attempting to treat their autistic children with unproven and possibly dangerous treatments, discouraging parents from vaccinating their children due to fears about thiomersal toxicity, and diverting resources away from research into more promising areas for the cause of autism." To consider results of approved treatments, how bad the unproven treatments have to be. "Thousands of lawsuits have been filed in a U.S. federal court to seek damages from alleged toxicity from vaccines, including those purportedly caused by thiomersal." To win such case is to prove the causation in a court despite the conclusions and claims of the governmental agencies.*

A 2004 study concerning the synergy was done by Haley & Lowell. Used were cultivations of human brain cells and the results were compiled into graphs. A cultivation with no additions survived at the end of 24 hours in amount of approximately 95% of the initial amount. With aluminium added into equivalent cultivation, roughly 90% of the cells was still living after 24 hours passed. When solely a small concentration of thiomersal was added to a cultivation, it was less than 40%. And when thiomersal was added along with aluminium which did not do a lot alone, then in 24 hours were practically all cells dead. Added was as well testosterone together with mercury and in that case all cells died within 4 hours. The synergetic effect of testosterone was taken into consideration as a contributing factor why autism and diseases of like character are dominantly represented by the male gender.

Prof. Boyd Haley was in charge of the chemical institute at the University of Kentucky in Lexington and was considered as one of the major chemists and toxicologists in the US until he began studying mercury. He has published more than two hundred scientific papers and received grants from the National Institutes of Health (NIH) for basically all the research, but since he began researching health effects of mercury, he practically hasn't received a grant.

Another study with human brain cell cultivations by a U.S. pharmacologist, Deth. published in 2004 compared cells that were left alone and cells which were for 96 hours accompanied with thiomersal in the same concentration that was found in blood of an average infant four days after vaccination with a vaccine containing thiomersal as the preservative. In 2004 was also published a study by an immunologist (Hornig et al.) in which were rats sensitive to autoimmune diseases injected with mercury according to old protocols valid in the U.S. for vaccination and found out it had resulted in autoimmune reactions against some brain cells. That was one of the first published studies in which mercury was given 2 or 3 times, not just once. Observed then was the injected cases of rats were less curious, moved a lot less than other rats and showed increased sensitivity to new incentives.

Glutathione is one of the body's own most important detoxicating and chelating agents that the body creates or also does not. A study by James et al. from 2005 showed among other results that autistic children had only about half the amount of this enzyme than healthy children, but people with other neurologic diseases have low glutathione levels as well. Glutathione peroxidase is dependent on selenium which also binds strongly to mercury. Apolipoprotein E is a substance that exists in humanity in 3 forms and can contain none to two molecules of cysteine which is able to bind heavy metals and move them out of the cell. The forms are genetically inherited. Form E2 has two cysteine molecules, E3 has one and E4

none. A study published in 1995 shown that those who had the form without cysteine were susceptible to development of the symptoms of the Alzheimer's disease in much earlier age.

A test was developed which could show predisposition which newborn is genetically slightly in disadvantage and will presumably bear vaccines containing neurotoxins with a higher risk of developing long term adverse effects, it was available prior to 2005. A study by Holmes et al., including Boyd Haley published in 2003 compared mercury content in the hair of healthy and autistic children. After births were taken hair samples from born babies, it was not yet known which will become autistic. The hair measurements were appended with information how many amalgam fillings the mothers had and how many immunoglobulins mothers got during their pregnancy. Then they waited 2 or 3 years and found out which children became autistic. Despite the fact mothers of autistic children got significantly more immunoglobulins and had higher amount of amalgam fillings during their pregnancy, autistic children had only about 1/8 the amount of mercury content in their hair than had the children after birth that have not become autistic. Autistic children had only a portion of the typical mercury amount found in hair of healthy children after birth.

Known is also from other studies, more amalgams mothers had, higher amounts of mercury were in hair of healthy children, but the same isn't true about autistic children, amounts in their hair were low no matter the amount of amalgam fillings their mothers had. Notable is that children with milder forms of autism, such as Asperger's syndrome, have in their hair significantly more mercury compared to children with the most severe forms. Toxins as heavy metals which are to be eliminated from the body, fat, muscle, organ tissues, from the cells, have to be first loosened and transferred into blood. From blood they move to liver and kidneys, and from liver they get with bile into the intestine, and from intestine they get back to blood, and like this around until the toxin is eliminated from the body, or definitely excreted as term "elimination" of a substance from a tissue is apparently synonymous with the substance being metabolized or synthesized into a different form, or just settling in the tissue. Hair is nourished out of blood and slowly grows so values of elements that show up also in hair are indicative of the concentration which could be found in blood. Amount of mercury in 3 centimeters long hair is an estimate of median mercury value in blood during 3 months. Interpretation of the results therefore was that autistic children could not transfer mercury particles so well from tissues, from the cells and release them into bloodstream.

In a study by J. Bradstreet et al., published in Journal of American Physicians and Surgeons Volume 8 Number 3, in fall 2003, were compared mercury levels in urine *"after a three-day treatment with an oral chelating agent, meso-2, 3-dimercaptosuccinic acid (DMSA), in children with autistic spectrum disorders and a matched control population. Overall, urinary mercury concentrations were significantly higher in 221 children with autistic spectrum disorders than in normal controls"*; relative increase 3.15. *"Additionally, vaccinated cases showed a significantly higher urinary mercury concentration than did vaccinated controls"*; relative increase 5.94. *"Similar urinary mercury concentrations were observed among matched vaccinated and unvaccinated controls, and no association was found between urinary cadmium or lead concentrations and autistic spectrum disorders."* Cadmium had relative increase of 1.3 in urine of cases with autistic spectrum disorders and lead 1.5.

A study by Aposhian, H.V., et al., published in 1992, in FASEB Journal Vol. 6(6) pp. 2472-2476 analyzed mercury concentrations after administration of 2,3 dimercapto propane-1-sulfonic

acid in relation to dental amalgam amount. Another chemical used for detoxification called DMPS, which can be given orally, intravenously or transdermally, has been associated with undesired effects, which are as well during intensive chelation, even with use of herbal and natural chelating agents, no rarity. Established medicine does not touch the issue of heavy metals until the cause is obvious and the individual is already about to die from poisoning as in case of skin exposure to organic forms of mercury. How long would advocates for use of an organomercury based preservative in vaccines like to hold an eyedrop of such compound in palms of their hands. Presumably, they would prefer to not hold it at all as it is also alone not associated with preservation of any of the alleged, in long term health beneficial toxins or antigens nor it's in comparison a small concentration. But the effects as in a high amount so in a small amount, are the same. The difference is small concentrations aren't enough to kill the whole organism, but the same actions that lead to an impairment or death in greater concentrations, occur as well in smaller concentrations as a result of direct effects or simply effects of the chemical.

Nor is ordinary exposure limited to mercury or just to selection of metallic elements. Study done prior to 2005 compared bones of people living in this age and bones of people living during the ancient period, not bones of roman aristocrats which were also abundant in lead, but bones of a common husbandman, and they found 500 times increase. Even though it is questionable whether bones of a farmer living under the Roman rule, were best suited for a comparison as containers in which they prepared food were as well commonly made out of lead, supposedly to attain a strange special taste. Containers used to process wine were also made out of plumbum and so was tubing serving to transport water. Merchants in the effort to raise weight of expensive spices, were allegedly, as in case of pepper, adding to them red lead, and that is often used as an explanation for high amounts of lead in most bones of the roman privileged class. Keep it in mind of course that it is also a neurotoxin.

Alzheimer's disease was described in 1907 by Alois Alzheimer. It is the predominant form of dementia. Medical science says 3-5% of all cases is caused by amyloid metabolism. Cause of the rest 95-97% of all cases is unknown. Average time span since the progressive symptoms first appear until death is 5 to 10 years. Medical science split the forms of dementia into two categories, into an early type when the symptoms manifest between 30-65 years of age and later type with onset of the disease after age of 65. When onset of disease happens on 65th birthday, is it an early or later type. Typical changes in brains of Alzheimer's patients already occur 50 years before onset of disease in form of neurofibrillary tangles. The disease used to manifest only in later years, but the amount of affected, which is continuously increasing, is more and more represented by younger population. The unknown cause therefor, could be as well ever more relevant.

There prevailed an opinion Alzheimer's disease is caused by aluminium, but in case of the patients, it is in the brain always associated together with substantial amounts of mercury. Research comparing brains of Alzheimer's patients and regular brains of people who died for example after an accident, found levels of aluminium were about twice as high and levels of mercury were about four times as high as in brains of people which were relatively healthy. Only mercury out of all metals, can alone elicit all typical symptoms of Alzheimer's disease in low concentrations. Aluminium, cadmium or lead cannot replicate such effects in low concentrations.

In blood of patients who were diagnosed with Alzheimer, who have already manifested active symptoms after developmental latent phase, can be found heightened mercury concentrations. The condition used to be reasoned that they presumably ate more fish than others, especially the larger predatory ones, but eventually came out an explanation it is the disintegrating brain that is falling apart and releasing mercury bound tissues. That mercury which originally contributed to the development of the disease. Patients with this condition often can't stand to wear clothing because of an irritative feeling. People with Parkinson's or Alzheimer's disease also, as it is prevalent for those with active symptoms of a neurological cause, have often depleted glutathione levels in organism. Miller et al. 1991; Zalups & Lasch 1996; Queiro et al. 1998 are some of earlier studies regarding glutathione reduction as well as inhibition of glutathione synthetase and reductase.

Study concerning mercury concentration in blood of patients with Alzheimer's disease was published in Journal of Neural Transmission 105: 59-68, in 1998 by C. Hock et al. Research relating impact of mercury to degeneration of nerve cells and formation of neurofibrillary tangles was conducted by Leong et al. before 2001. Other studies describing neurological and organic changes were published by Olivieri et al. (2000, 2002): formation of NFT; Tau-protein Hyperphosphorylation; Secretion of  $\beta$ -amyloid; Heightened oxidative stress; also Duhr et al. (1993) and Pendergrass et al. (1995, 1996, 1997) regarding tubulin activation.

Because the symptoms are different, Parkinson's and Alzheimer's disease are characterized as separated forms of illness, but can come consecutively in effect. Different symptoms are prescribed by different portions of nervous system affected. Neurological diseases "of old age" manifest in old age, or also sooner, but the symptoms are usually result of a long time degeneration of once healthy nervous system from a time when health care beginning from earliest age, was not yet so elaborated and advanced.

To the issue of metallic elements and metals containing chemicals, which amounts continue to increase in environment, belong all the widely used pesticides, fungicides, herbicides, and various substances used in industry, combusted fuel emissions as well as different forms of plastics and their emollients. Underground waters in proximity of cultivated fields contain all the chemistry that has been used on those fields, it is in the plants, it is in the grains grown on those fields, it gets into the produced food and accumulates in the soil. Winds take it into nearby areas and as far as bees fly, it can be found in honey. Honey has ample properties to be money. Under circumstances of this century it is debased by contaminants and no longer alkaline. Bees don't necessarily die when the pollen is brought into hive, but later when they are to bring up a new generation, has been the pollen sufficiently contaminated, then often they can't. Use of herbicides can be adjusted solely by subsidizing possible alternative rather than subsidizing its use. There is as well the price on health and the matter of sustainability.

Burnt emissions of benzene, naphtha and other fuels, just emitted into the environment are most relevant in inner cities, between buildings, where the exhausts sometimes just hang in the air in high concentrations. Benzene toxicity is also increased by phenol and diacid phenol known as hydroquinone that can be found in alcohol, coffee or black tea. Cigarettes contain both benzene and phenol compounds. Pathogenic intestine bacteria can metabolize amino acids like tyrosine into phenol substances. Perchlorate is a salt of the highest oxygen acid of chlorine. So it has a metal or metal like radical instead of hydrogen. Perchlorates have been added into rocket fuel as additives which are dispersed in the atmosphere and are basically

everywhere. Animal studies have linked low dose exposure to a wide range of health effects previously not observed in higher dose studies. According to conducted research before the year 2000, a perchlorate causes changes in the brain at 0,01 - 1 mg/kg per day, but not at 30 mg/kg per day. Adverse effects of a low dose supposedly, do not occur at a higher dose. It's called a human or an animal has biphasic dose response. Were it be true, there is no way to control the extent of exposure or body distribution to different tissues. More abundant it is in the environment, higher is just the chance the adverse effects of the low doses will occur.

In case of plastics it is the softeners, bisphenol A also known as BPA and phthalates, that are used for molding and unstable under ordinary conditions. Scent of new plastics, the odor of opening a new DVD packaging or whatever type of a disc medium, or the scent in interior of a newly manufactured car, that's possibly phthalates, even exposure by inhalation is seldom continuous. Bisphenol A is known from dentistry, white dental fillings, when made of plastic, contain BPA. BPA is molecule invented as a synthetic estrogen. Out of 104 studies funded by the U.S. government which were conducted around the beginning of this century in span of 7 years to review implications of bisphenol A on health, 94 of them reported adverse health effects. Out of 11 industry funded studies, none found an adverse effect on health. Traces of plastic emollients, that are also absorbed by the skin, can be sometimes represented in very high concentrations in some toys. Toothbrushes have body and individual bristles made out of plastic containing emollients, even though there are exceptions when they are both made out of vegetative materials and the toothbrush can, with proper use and maintenance, long last. The components are present in plastic containers of home cleaning products, cosmetics and hygiene products, it is in air fresheners and chemically scented candles. They are used in the manufacture of plastic bottles and polyvinyl chloride (PVC) pipes or even devices used in medicine for containment of medication. Pacifiers on children's plastic bottles are made out of highly softened plastic, but those on glass bottles may be made of more suited materials.

One should not rely on manufacturer's good will that only a proper material will be used, as only materials that are sufficient for the product to be sold may be used. Quality of products has been determined in the range of available materials, by the ones who in effect fund the production. Phthalates affect kidneys and liver, but most sensitive to them are reproductive organs, especially male and prostate. Effects on health of bisphenol A are similar to those of phthalates, but it also increases oxidative stress and affects brain activity and development. Plastic softeners are also endocrine disruptor chemicals (EDC's) that effect hormonal glands and everything their function is related to. Another form of plastic is styrene, the monomer for polystyrene which accumulates in kidneys and blood vessels. Styrene cups have been in coffee vending machines, polystyrene is as well used for packages and containers that often come in direct contact with cold, warm or even hot food or drinks, in which a substance can leave visible, melted marks, even though the packaging has a symbol denoting its suitability to contain food. Hot water can melt through the cup in case of coffee automat malfunction.

Inner coating of cans of food consists of plastic polymers. Most of people living in industrial world have one kind or more phthalates in blood and tissue. Unfortunately highest amounts were measured in women in reproductive age. Centers for Disease Control and Prevention (CDC) has according to conducted survey established that every American is exposed to BPA within the relevant range of exposure and that further complicates epidemiological studies, as there aren't controls against which to compare cases. Mercury is the key toxin because it alone or in synergy first reduces capabilities of liver, gallbladder and kidneys to rid the body

of all the hostile elements and substances. More the body is burdened by heavy metals that impede its normal function, better are conditions for life and growth of fungi, parasites and bacterial infections in the body. In other words, more crucial it is for the body to rid itself of undesired organisms to heal, more prevalent is the presence of toxins in the body impeding the very same process. Once the liver and kidneys get a chance to function properly again, it becomes easier for the body to eliminate the rest of unwanted elements, plastics and other toxins, until their abilities are reduced in the process, as the filters of blood they are. Before healing begins however, it is necessary to minimize any new, further, unnecessary exposure.

There can be no healing with an amalgam filling in one's mouth or great mercury deposits in the vicinity of the jaw. A chelating agent should be only administered to those patients with amalgam fillings which the theRapist seeks to bestow with bountiful sores, notwithstanding no one should be in custody of such individual. It is in the eyes of modern everyday lifestyle, that the healing process is seen as radical, as it is so remote to what is considered normal. A greater study published in 2002 in the U.S., in which were taken blood samples from women in reproductive age and measured mercury concentrations, found that every twelfth woman had in blood higher levels than what was set as limit by the EPA. Resulting statistic was that from 300 thousand to 630 thousand of newborn infants per year, are born with high enough mercury levels to have implications on health. The recommendation from the CDC and from the Food and Drug Administration (FDA) was to stop eating the fish burdened with mercury.

According to an old report of the Environmental Protection Agency from 2002, over 7.1 billion pounds of 650 different industrial chemicals were released in the air and water, 266 of which are linked to birth defects. An insecticide that has been used in agriculture in the U.S. since 1956 known as diazinon was found in 1/3 of tested waters. It is a neurotoxin and one of the 266 chemicals which were measured. More than eighty thousand chemicals that are used in everyday products are unregulated. Kitchen utensils coated with fluoro non-stick polymer surfaces get heated on high temperatures in contact with food, often visibly worn after heavy use to an underlying layer which is usually aluminium. Particles also get in the waste water. The coatings repel water and oil, how are the particles meant to be bound in the body and eliminated out unless by chance. One of the chemicals used to make Teflon®, probably the most known stick resistant surface, has been found in the blood of 99% of all tested Americans. Half-life in blood stream of ammonium perfluorooctanoate compounds (also known as C-8) has been estimated from 1100 to 1500 days. Used frying oils end up abundantly in the waste water in great quantities. One liter of used frying oil contaminates 10,000 liters of water that could be otherwise treated. There are also kitchen products with descriptions that state claims like; made with health risk free aluminium.

Fluoride has been ever more often called to be a nutrient with a little bit of controversy. It can be found naturally in water in some places, but it is filtered out when there are means to do it, due to health complications its drinking brings. As it is well known, it has been put in toothpastes in increasing concentrations, sometimes labelled on the packaging together in combination with another mineral like zinc, to prove its health benefits. It is put in small amounts, parts per million, like one thousand ppm, at least that's what labels say, but it is also encouraged to avoid swallowing. Quite challenging to explain it to a kid with strawberry toothpaste. It can be found in some forms in different edible products like powdered eggs in similar amounts or also nutritional products. In many countries, fluoridated water is used in production of beverages like sodas, and because its almost undisputed health benefits on

teeth and logically bones are so evident, it has been put in tap water in some countries. It is not so long ago people had to be confined in small areas surrounded by fences with barbed wires to drink water that undergo similar treatment, at least those who hadn't lived in cities. Who would have thought they cared about dental health of the prisoners already back then.

Then there are some views that claim fluoride is not a nutrient, nor it is needed in the body for any purpose and as a nutrient, it has a quite low lethal dose. It is plausibly as well lethal to rodents, as it has been commonly used in rat poison. Fluoride does not improve water's quality or safety, but it changes both of these aspects. All other water treatment chemicals are added to improve the water's quality, fluoride is added solely for the purpose of medical treatment. Water fluoridation is a form of mass medication without informed consent, the standard practice for all medication and one of the main reasons why most of the Western Europe rejected fluoridating own water. Most of the U.S. public water supplies are treated with fluoride, which is over half the amount of people drinking artificially fluoridated water worldwide. With people absorbing fluoride from many different sources beside water, it is difficult to control individual doses. Exposure to non-water sources of fluoride has increased since the water fluoridation program began. Many children exceed maximum daily fluoride intake from toothpaste alone. Unregulated exposure to fluoride may interfere with different medications in an unpredictable way. On May 30th 1991, a fluoride based drug (fluoxetine) with trade name Prozac has had the highest number of adverse event reports submitted to the FDA National Adverse Drug Reaction Reporting System database. The database dates back to 1969, reported then Acting Chief of Surveillance and Data Processing Branch of Center for Drug Evaluation and Research (CDER), Alan Gelberg and the statement was followed by the FDA Advisory Committee Hearing on September 20th, 1991.

Prozac is a commonly prescribed antidepressant, because it effectively treats the symptoms of depression, but by suppression of all emotions, leaving the patient lethargic. An example characteristic of how pharmacologic drugs work. Fluoride as in drugs, so in water consumed uses up enzymes created by the body to excrete the particles. In case of absence of fluoride in the body, the enzymes or their resources could be used for a different cause requiring an action. The Food and Drug Administration classifies fluoride as a drug when used to prevent or mitigate disease. Amount of fluoride eliminated from the blood is dependent on nutrition and function of the liver and kidneys, the rest accumulates in the body, mostly in the bones and pineal gland. The potential highest exposure to fluoride by bodyweight from fluoridated water in the population have infants that rely solely on liquid nutrition. It was advised to not use fluoridated water in baby nutrition as earlier research have repeatedly recognized early exposure to be a precursor for developing dental fluorosis later in life. Often dismissed only as a visual effect in its milder forms, dental fluorosis is a visible evidence of fluoride's impact on permanent teeth before their eruption and possibly other calcified tissues. According to the CDC, since 1999 to 2004, 41% of Americans aged from 12 to 15 years living in areas with fluoridated and also unfluoridated water had a form of dental fluorosis. Between 1986 and 1987, it was 23%. Some early symptoms of skeletal fluorosis are similar to those of arthritis. In parts of Africa, India and China, where some areas have high natural fluoride levels in the water, millions of people have been affected by the disease. Because the first two phases of skeletal fluorosis can be easily misdiagnosed, it is questionable whether the high occurrence of arthritis in fluoridated countries is related to growing fluoride exposure. According to the CDC, 1 in 3 American adults self-reported arthritis or chronic joint symptoms in 2001.

After an early fluoridation trial (Newburgh-Kingston 1945-55), study by Schlesinger ER et al. (1956), found a two-fold increase in cortical bone defects among children in the fluoridated community. Cortex of a bone is protective against fracture. In 2001, Alarcon-Herrera MT, et al. reported a linear correlation between the severity of dental fluorosis and bone fractures in adults and children in a high fluoride area, the Guadiana Valley in Mexico. When very high doses of fluoride (averaged at 26 mg per day) were used to treat patients with osteoporosis in an effort to harden their bones and reduce fracture rates, it actually led to higher number of fractures, particularly hip fractures. The only human epidemiological study to assess bone strength in relation to bone fluoride concentration, researchers at the University of Toronto found the strength of bones declined with increasing fluoride content (Chachra et al. 2010).

Just because fluoride molecules may strongly bind together, doesn't mean they also strongly bind to bone substance. Following the U.S. government funded National Toxicology Program study published in 1990 with a finding of dose dependant increase in osteosarcoma in mice and rats treated with sodium fluoride, the National Cancer Institute (NCI) reviewed national cancer data in the U.S. and found a significantly higher occurrence of osteosarcoma in young men living in fluoridated areas compared to those unfluoridated (Hoover RN, et al. 1991a,b). The NCI has concluded that fluoride was not the cause, but no explanation was provided to clarify the higher rates in the fluoridated areas. In 2001, Elise Bassin, a dentist, defended her doctoral thesis at Harvard in which she found that boys had five to seven fold increased risk of developing osteosarcoma before the age of twenty if they drank fluoridated water during their mid-childhood growth from 6th to 8th year of age. The study was eventually published (Bassin EB et al. 2006), but has been largely discounted on a basis of a promise of her thesis advisor Chester Douglass (then water fluoridation advocate and consultant to Colgate) to do a broader study which would invalidate the findings. That study has been already published (Kim FM et al. 2011), with fewer controls and without assessing the identified specific group at heightened risk, truly by the authors' own admission, the study had no capacity to assess the risk of osteosarcoma in children and adolescents.

A Ph.D. thesis by Jennifer Luke has shown in animal studies that fluoride reduces melatonin production and leads to an earlier onset of puberty. (Luke J. 1997, 2001) Consistent with her other finding the human pineal gland accumulates fluoride to high levels, the early study by Schlesinger ER et al. reported that on average young girls in the area with fluoridated water reached menstruation 5 months earlier than girls in the area with no water fluoridation. In Ukraine, a 1985 study by Bachinskii et al. found lowering of thyroid function among healthy people at 2.3 ppm of fluoride in water. Apparently it's not a new thing as fluoride used to be prescribed to reduce activity of the thyroid gland already in the middle of the 20th century to those diagnosed with hyperthyroidism (overactive thyroid). A clinical study by Galletti & Joyet published in 1958 found the thyroid function of hyperthyroid patients was effectively reduced at 2.3 to 4.5 milligrams of fluoride ion per day. The Department of Health & Human Services (DHHS) has in 1991 publicly estimated that total fluoride exposure in communities with water fluoridation ranges from 1.6 to 6.6 mg/day. In this regard, the fluoridation critics bring up the increasing cases of hypothyroidism (underactive thyroid) in the U.S. and other countries with fluoridated waters. To source from a document that was updated in August 2011 and was again updated one year later, the second most prescribed drug of the year in 2010 was Synthroid (sodium levothyroxine), a hormone replacement drug used to treat an underactive thyroid gland. The ones conscious about health issues are those who read the studies, or publish them, or those who get the information from the aforementioned two.

The chemicals used to fluoridate public waters are not pharmaceutical grade. They are still considered, just before they are added to water supply, hazardous wastes that come mostly from wet scrubbing systems of phosphate fertilizer industry, which spares the corporations' finances that would be otherwise used to properly dispose of the waste. The two chemicals mostly used for this purpose are sodium fluorosilicate and hydrofluorosilicic acid, which are in their form impure and contain various contaminants. A testing by the National Sanitation Foundation (NSF) concluded the levels of arsenic in these silicon fluorides are relatively high (up to 1.6 ppb after dilution in public water). The chemical used in animal studies is usually pharmaceutical grade sodium fluoride, not industrial grade fluorosilicic acid. Silicon fluorides have not been comprehensively tested, the fluoridation proponents claim there is no need to examine toxicology of these compounds, because once the silicon fluorides are diluted at the public water works, they are totally dissociated to free fluoride ions and hydrated silica. While a study from the University of Michigan (Finney WF et al. 2006) affirmed dissociation at neutral pH, in acidic conditions (pH 3), there was a stable complex with five fluoride ions. What about the toxicology of the individual substances, the absorbent form of silica is used in those little pockets that state clearly, do not eat, throw away, often packed together with clothing or shoes that is to be transported.

In laboratory experiments, Maas et al. (2007) have shown that the fluoride chemicals used to fluoride public waters in combination with chlorinating agents as chloramine increase the leaching of lead from lead pipes and leaded brass fittings used in plumbing. Studies done by Masters RD & Coplan M. (1999, 2000, 2007), and to a lesser extent Macek M, et al. (2006), show an association between the use of fluorosilicic acid (and its sodium salt) to fluoridate water and an increased uptake of lead into children's blood. A study by Sawan RMM et al. (2010) observed that exposure of rats to a combination of fluorosilicic acid and lead in their drinking water 3 times increased the uptake of lead into blood over exposure to lead alone.

Governments were thought to consciously choose panels that will deliver a pro-fluoridation result, particularly in time when their fluoridation program is under threat. In a book slanted towards fluoridation published in 2009, Alan Freeze and Jay Lehr admit the point when they write:

*"There is one anti-fluoridationist charge that does have some truth to it. Anti-fluoride forces have always claimed that the many government-sponsored review panels set up over the years to assess the costs and benefits of fluoridation were stacked in favor of fluoridation. A review of the membership of the various panels confirms this charge. The expert committees that put together reports by the American Association for the Advancement of Science in 1941, 1944 and 1954; the National Academy of Sciences in 1951, 1971, 1977 and 1993; the World Health Organization in 1958 and 1970; and the U.S. Public Health Service in 1991 are rife with the names of well-known medical and dental researchers who actively campaigned on behalf of fluoridation or whose research was held in high regard in the pro-fluoridation movement. Membership was interlocking and incestuous."* It is known what that exactly means. The more recent examples of these self-fulfilling prophecies have come from the Irish Fluoridation Forum (2002); the National Health and Medical Research Council (NHMRC, 2007) and Health Canada (2008, 2010). The latter used a panel of six persons to review the health literature, out of which four were pro-fluoridation dentists and the other two had no demonstrated expertise on fluoride. A notable exception to this trend was the appointment

by the U.S. National Research Council of the first balanced panel of experts ever selected to look at fluoride's toxicity in the U.S. This panel of twelve reviewed the US EPA's safe drinking water standards for fluoride. After three and half years the panel concluded in a 507 - page report that the safe drinking water standard was not protective of health and a more strict maximum contaminant level should be determined (NRC, 2006). On January 7th 2011, the U.S. EPA Office of Water made it clear they would not determine a new maximum value that would jeopardize the water fluoridation program (U.S. EPA Press Release, 2011).

Regular measurements are not conducted or provided by any governmental health agency to monitor concentrations of fluoride in blood, hair, urine, nails or bones of the population or the sensitive individuals. There has not been a randomized trial to determine the safety and effectiveness of water fluoridation. The CDC has acknowledged that the mechanism of fluoride's benefits is topical (CDC 1999, 2001), therefore there is no need to ingest fluoride to protect teeth. Tooth decay rates were coming down before fluoridation was introduced in Australia and New Zealand, and have continued to decline even after its benefits would have been maximized (Colquhoun J. 1997; Diesendorf M. 1986, Nature. 322: 125-129). The early North American trials (conducted 1945 - 1955) that helped launch water fluoridation, have been criticized for their methodology and choice of control communities (De Stefano™ TM. 1954; Sutton 1959, 1960, 1996; Ziegelbecker R. 1970). According to Dr. Hubert Arnold, a statistician from the University of California at Davis, the early fluoridation trials are *"rich in fallacies, improper design, invalid use of statistical methods, omissions of contrary data, and just plain muddleheadedness and hebetude."* Serious questions have been also raised about Trendley Dean's famous 21-city study from 1942 (Ziegelbecker R. 1981). Countries that have rejected water fluoridation have experienced the same decline in childhood dental decay as fluoridated countries, and when fluoridation has been discontinued in communities in the former East Germany, Cuba, Canada and Finland, tooth decay hasn't increased, but has generally continued to decrease (Kunzel W, et al. 2000; Kunzel W, Fischer T. 1997, 2000; Maupomé G, et al. 2001; Seppä L, et al. 2000). Tooth decay does not reflect low-fluoride exposure and it's high in low-income communities that have been fluoridated for decades, largely as a result of attainability of cheap, inadequate food.

But the truth is the largest survey ever conducted in the U.S. (over 39,000 children from 84 communities) found improvement in health of the teeth in fluoridated areas. According to National Institute of Dental Research (NIDR), the study found an average difference of 0.6 DMFS (Decayed, Missing and Filled Surfaces) in the permanent teeth of children aged 5-17, residing entire lives in either fluoridated or unfluoridated areas (Hileman B. 1989; Brunelle JA, Carlos JP. 1990). Other large surveys done by three Australian states have found decay reductions ranging from 0 to 0.3 of a permanent tooth surface (Armfield JM & Spencer AJ 2004; Spencer AJ et al. 1996). The studies haven't allowed consideration of the possibility that delayed eruption of the teeth may be caused by fluoride exposure (Komárek AE 2005). A multi-million dollar study funded by the U.S National Institutes of Health (NIH) showed no significant relationship between tooth decay and fluoride intake among children. (Warren JJ et al. 2009) In this study, it is the first time tooth decay has been investigated as a function of individual exposure, as opposed to mere residence in water fluoridated community.

In January 2008 issue of Scientific American, Professor John Doull, the chairman of the 2006 National Research Council review, Fluoride in Drinking Water: A Review of EPA's Standards, is quoted as saying:

*"What the Committee found is that we've gone with the status quo regarding fluoride for many years—for too long really—and now we need to take a fresh look . . . In the scientific community people tend to think this is settled. I mean, when the U.S. surgeon general comes out and says this is one of the top 10 greatest achievements of the 20th century, that's a hard hurdle to get over. But when we looked at the studies that have been done, we found that many of these questions are unsettled and we have much less information than we should, considering how long this (fluoridation) has been going on."*

Fluoride's interaction with the CNS, especially brain and the consequent impact on I.Q. score had been addressed in numerous more studies since the U.S. NRC 2006 report came out. In a review of the EPA commissioned literature, fluoride has been listed among 100 chemicals for which there is a "substantial evidence of developmental neurotoxicity." A rat study done by Mullenix et al. (1995) showed sodium fluoride accumulates in the brain and alters mental behavior in a manner consistent with a neurotoxic agent. In total, there have now been over 100 animal studies with an adverse outcome of fluoride exposure on the brain and learning behavior, but are often dismissed by the fluoridation proponents, because high doses were used in these experiments. It is worth to note, the study by Sawan found that rats generally had to be exposed to five times more fluoride to reach the equal plasma levels compared to humans. A study by Varner JA et al. (1998) found effects with rats that were for one year fed with 1ppm of fluoride in their water using either sodium fluoride or also aluminium fluoride. The rats had an increased uptake of aluminium to brain and developed structural changes to brains and kidneys, and the formation of beta-amyloid deposits associated with Alzheimer's.

Some other human studies have observed IQ reductions at 1.9 ppm (Xiang Q et al. 2003a,b); 2.97 ppm (Lo Wang X et al. 2001; Yang Y et al. 1994); 0.3-3.0 ppm (Ding Y et al. 2010), with 1 ppm increase of fluoride in urine associated with a loss of 0.59 IQ points; and among others, several other studies at 1.8-3.9 ppm (Xu Y, et al. 1994); 2 ppm (Yao Y, et al. 1996, 1997); 2.5 ppm (Seraj B, et al. 2006); 2.45 ppm (Eswar P, et al. 2011); 3.15 ppm (Lu Y, et al. 2000); 4.12 ppm (Zhao LB, et al. 1996); 2.85 ppm (Hong F, et al. 2001); 2.38 ppm (Poureslami HR, et al. 2011); and 2.1-3.2 ppm (An J, et al. 1992). Research by (Rocha-Amador D et al. 2009; Li J et alii 2004; Calderon J et al. 2000) have looked into fluoride's influence on children's motorial distortion and visuospatial organization, while other studies have explored prenatal fluorine exposure in relation to fetal brain (Han H, Cheng Z, Liu W. 1989; Du L. 1992; Yu Y et al. 1996; Dong Z et al. 1993). The National Research Council (2006) report has stated about the I.Q. relation to fluoride: *"the consistency of the results appears significant enough to warrant additional research on the effects of fluoride on intelligence."* The conclusion has been supported few years later by a group of Harvard scientists whose fluoride on I.Q. meta-review concludes that fluoride's impact on the developing brain should be a *"high research priority."* (Choi AL, et al. 2012). Out of fluoridating countries, a study from New Zealand has also investigated the relation (Spittle B, et al. 1998). There have as well been opinions that fluoride could exacerbate the symptoms of the Attention Deficit Hyperactivity Disorder.

Despite the fact the earliest opponents of fluoridation were biochemists, proponents of fluoridation have maintained for many years that the only people opposed to fluoridation are not bona fide scientists. As more and more professionals read the primary literature for themselves, rather than relying on statements, they are realizing that they and the general

public have not been properly informed by their governmental bodies on this subject. Over 4,000 professionals have signed a statement calling for an end to water fluoridation, even though many scientists, doctors and dentists who have spoken out publicly on this issue have been subjected to censorship and intimidation. Dr. Phyllis Mullenix was fired from position as Chair of Toxicology at Forsythe Dental Center for publishing her findings on fluoride related to the brain, as well as Dr. William Marcus was fired from the EPA after questioning government's handling of the National Toxicology Program 1990 cancer study.

Even when challenged to do so by organizations as the Association for Science in the Public Interest, the American College of Toxicology or the U.S. EPA, the pro-fluoridation advocates usually refuse to defend the practice in open public debate (Bryson C. 2004). As Dr. Michael Easley have put it, a prominent lobbyist for fluoridation in the US, *"Debates give the illusion that a scientific controversy exists when no credible people support the fluorophobics' view"* (Easley, M. 1999). In light of proponents' refusal to debate the issue, Dr. Edward Groth, a Senior Scientist at Consumers Union has observed, *"the political profluoridation stance has evolved into a dogmatic, authoritarian, essentially antiscientific posture, one that discourages open debate of scientific issues"* (Martin B. 1991, *Scientific Knowledge in Controversy: The Social Dynamics of the Fluoridation Debate*, SUNY Press, Albany NY).

Precautionary principle requires action once the potential of harm exists, or abides by the rule, simply; if in doubt leave it out. Fluoridation programs don't need consent of the people which are not in their extent comprised, as they don't even regard disagreement of those in them involved. In concentration camps during the WW II, fluoride was added to drinking water to make prisoners more docile and controllable, so they would not start a rebellion. So there is also more reason to fluoridate the population in time of public conditioning.

Fluoride is for those who declare or believe in its positive health effects. It is in the power of the law, but not in the power of a government controlled by the special interest, to subject them and the respective products to additional taxation on the account of the environment. Were prisons be build, it would be in an area with natural fluoride levels, and those who had interchanged a combination of fluorine for an essential mineral would accommodate them.

Even though vaccination was done as early in 1796, a French chemist and biologist, Louis Pasteur (1822-1895) is on whom stands the vaccination industry and theory of infections, which is still called a theory. He is also recognized for his first vaccine he introduced in 1885 against rabies. Edward Jenner (1749-1823), an English physician is another important figure who pioneered vaccination. Breakthrough the history of vaccination was presented by Anita Petek-Dimmer at the first AKZ conference in Chur, Switzerland on 23. February, 2008. Some could find her voice annoying, but she also mentioned vaccine contents relevant to that day. Beside thiomersal, two other compounds were used at the time as preservatives, of which natriumtimerfonat also contains a form of mercury, and 2phenoxyethanol is a neurotoxin, they are meant to disinfect organisms, but who will tell them which organic human tissues they should not affect. Vaccines are tested on the population first few years after they are approved, mainly their safety. She also mentioned that every vaccine contains about 80 to 100 different substances, and listed some of them. Vaccines commonly contain aluminium in some form, it is said, to enlarge the pathogenic surface, so the organism better recognizes the threat and creates antibodies, sometimes it is present in a form of nano-particles. A man just got to wonder how much mischief will a person in this world let pass by without giving it

any attention. How much a person is willing to give up and give it into hands of another on the basis of a promise of protection, when there is an interest involved, and then to not even look back and evaluate the choice from a distance, was it true, what did it profit.

Most vaccines intended for animals are genetically cultivated and contain substances which are outlawed in humane vaccines, the legislation on animal vaccines is even more loose. The vaccine ingredients necessary for the production, she continued, aren't required to be listed in the pamphlet, only what is added between the production of a vaccine and packaging has to be listed. And when the law doesn't require it, then it as well isn't listed. So she called an institution which approved and had a control over vaccines, with a relatively newly released genetically produced vaccine before her, with the hope they would tell her what it contains, because the documentation barely stated anything beside the imaginary viruses and sodium salt solution. So someone kind picked up the phone at the German institution and told her to read the documentation. She said that it isn't too exhausting and he replied that when it is not written there, then he don't even need to look in their files, because they also do not know what is in them. She thought they would have some more details, some studies from the manufacturer, and he replied it is only a thin file, and there isn't stated what it contains.

So they have approved the vaccine when they have not even known everything about it. No, that falls within the law under the company's trade secret, he said. Then she called an equal institution residing in Switzerland, there is everything according to the law she thought, sure there is, and she got the same reply, a trade secret. At last, she called an institution in Wien only to find out that there rule the same terms as in Berlin and Bern, and everywhere in the world where the pharmacies have the regulating law wrapped around their fingers, because the general public barely keeps the politicians in check. The pharmaceutical industry admits that a vaccine without additives in the solution won't incite the body into reaction to create antibodies and thus protect against the viral disease. There also wouldn't be a reason to use them without similar claim. Why is it called an antibody when it acts against a genetic tissue of foreign origin, and an antigen acts against the body. A vaccine solution gets into the body in a different way than the cause of the disease itself, when injected into a muscle or blood, it bypasses all the tissue layers and suddenly, the mixture solution with its additives start to circulate the whole body all at the same moment. And now the body go crazy which garbage to catch first, and of course it cannot bind, transport and excrete all the floaters, or abruptly produce enzymes for all of them, and those available get depleted. The big pharma has also stated the concentration of enzymes in the body has no relevancy in determination whether the reaction have made the body protected. It is worth noting that the body does recognize an intruder every time, even when the body has not been injected with such vaccine before. So a vaccine can potentially, remind the body what it already knows, at best, and at a price which comes in the form of additives, supposedly required for the reaction to even occur.

When the body has created enzymes, all it means is, the body had a contact with disease or a malefactor rather, potent to develop a disease. So when the body creates more enzymes, it does not mean it will be better protected, or even whether it will be protected at all. That is what the pharmaceutical companies have admitted to be true. Even vaccines that are sold to prevent diseases like cancer, have nothing to do with the causation of the disease, which arises out of persistent or intensive exposure to carcinogens, and not out of cancer itself or out of exposure to any foreign tissue cells which just appear out of the blue in bloodstream, unprecedented, with no prior contact, bundled in a mix of additives. The organism does not

need to be briefed beforehand to recognize a growing tumor it already knows to distinguish, what it may lack however is the capacity to change the condition in which the cancer grows. A carcinogen is present in the vicinity of a tumor and the conditions of growth are generally acidic, and that is something the body is not always able to adjust, or not in a sufficient way without conscious persistent actions and changes on the part of the individual. People living nearby industrial plants which release chemicals into the air are not surprisingly, often more likely to develop cancer. So also habits, conditions and way of living may have a decisive role in determining the state of the body. Cancer cells have a hard time to remain or replicate in a tissue with normal pH, under healthy conditions, while they thrive in abnormal conditions. By chemotherapy, we kill the one and only instrument which can cure and recover from the disease.

Encephalitis and meningitis are direct side effects of practically every vaccine. Encephalitis is inflammation of the brain and meningitis is inflammation of the meninges, the tissues which surround the brain or spinal cord. They are characterized as infectious diseases, caused by a bacterial infection or a virus in case of encephalitis. Out of vaccine contents, aluminium and mercury are basic examples of substances which can also irritate the tissues of the CNS and lead to inflammations. The declared vaccine additives alone that aren't subjected to secrecy can make the body susceptible to diseases later in life. The cause of Guillain-Barre syndrome is unknown. The vaccine studies have no real control group. A proper double blind study has a control group which is given a placebo and the other group, the group of cases is given the medication of which efficacy and safety is to be tested, under the condition that no one can know which group received the placebo and which group got the tested drug. Then the two groups are compared to determine which group is better protected, and whether they have any undesired effects. But in vaccine studies, at the time of the presentation, was no control group, the cases were injected with the tested vaccine and the supposed controls received a different vaccine. Then the study conclusion often was the cases did not have more notable side effects worthy of mention. The efficacy was determined solely out of concentrations of enzymes which the body had created during the reaction. The studies commissioned by the pharmaceutical companies are also property of the respective companies. When a professor or a doctor delivers the study with undesired results, the company is not required to pay the acknowledged price for the work, nor can the doctor publish it, because the company owns it. There wasn't one independent double blind vaccine study proving the efficiency or safety, at that time, such study had not existed, but vaccines were approved and used nevertheless.

Living conditions, hygiene, variety and availability of food, even though nutrition isn't always the best term to describe all mass produced products overflowing store shelves, but there is still something that can be used, and then water condition which is relative even in all the industrialized countries, are also some of the circumstances that have changed over the last two hundred years long regression of diseases. The control of humidity and temperatures in homes was allegedly responsible for eradication of tuberculosis, by eliminating conditions in which the bacteria prosper. She had found that there isn't a vaccine that could protect us, children, or animals against any disease, not even for an hour, and for twenty years nobody proved her different. The people still get the disease for which they've been vaccinated and the cure won't have a better development, after relatively permanent organ suppression, it can only have more severe progress and the chance for getting the disease be greater. Only diseases the vaccinated people don't get, are the diseases which no one gets. And when the statistics aren't fudged, the people who get the disease are often also those who have been

either partially or fully vaccinated against the same or other disease, because they suppress the organism in a long term. Among potent immunosuppressors also belong processed and concentrated sugars, which cause cells in bloodstream to stick together for few hours. They can suppress immunity in a short term.

Some other individuals have spoken against the claims of the vaccine manufacturers among which were as well former employees, as in the case of Brandy Vaughan. After speaking out against vaccination and her former employer, somebody got inside her house several times while she was gone, without any marks of breaking in and left symbolic notices, or she could have also made it up on a basis of some different reason. To grasp the virus problematic on which the vaccine industry is based, which Louis Pasteur has introduced into the medicine in the late 19th century when the originator of the disease could not be identified, HIV virus is possibly a good example to reexamine. On Dec. 7th, 1994, at the Hollywood Roosevelt Hotel in Greensboro, N.C., Dr. Robert E. Willner, a medical doctor of 40 years of experience, stood in front of a gathering of about 30 alternative medicine practitioners and several journalists to represent his views about the AIDS hypothesis. A year before in 1993, Dr. Willner stunned Spain by inoculating himself with the blood of Pedro Tocino, an HIV positive hemophiliac, to demonstrate devotion to the truth and the Hippocratic oath he took nearly 40 years before. When asked why he would put his life on the line to make a point, Dr. Willner replied: *"I do this to put a stop to the greatest murderous fraud in medical history. By injecting myself with HIV positive blood, I am proving the point as Dr. Walter Reed did to prove the truth about yellow fever. In this way it is my hope to expose the truth about HIV in the interest of all mankind."* It has been stated he has performed these stunts in order to sell a book, but still, he was either sufficiently crazy, or sufficiently convinced to do them, to prove that HIV virus, whether it even exists, is not the cause of AIDS, but mainly malnutrition, living conditions, to emphasise the susceptible population in Africa, and the use of drugs; illegal and medical, are the primary reasons of the body suppression and immune deficiency that can lead to death. The additional causes of the acquired immune deficiency, which have been listed in medical texts for almost a century, are irradiation and chemotherapy. Even in the Nazi death camps, the prisoners were first emaciated, and only then, malnourished were put in gas chambers.

The body co-exists with many small organisms at all times, some more potent, they become a threat, and can eventually cause a disease or even death when the body loses its ability to restrain them by the defending mechanisms. In order for the microorganisms to prevail, the body has to become susceptible. Streptococcus, Mycobacterium tuberculosis, Pneumocystis carinii, as Dr. Willner has explained, and the excerpts from the book are freely available, are but a fraction of the organisms, that are considered infectious, with which the majority of us live constantly. Pneumocystis carinii are present in the lungs of virtually every individual, yet only precious few ever get the disease they cause; pneumocystis pneumonia, why. Acquired Immune Deficiency Syndrome (AIDS) is a fruitful ground for a variety of diseases, rather than a disease itself, it is a state under which are diagnosed, at the time in the U.S. and Europe, it was 25 to 35 distinct diseases, while in Africa, the diagnosis was virtually only fever, wasting and diarrhea, which fully correlated with malnutrition and parasitic disease. These diseases were diagnosed and existed before the day HIV was discovered, or allegedly discovered and, to equip it with relevancy, proclaimed to be the probable cause of AIDS, but also the indirect cause of all diseases consequently arising out of the condition. Quite unlikely would anyone take interest in an invisible organism that does not cause anything, but a retrovirus that can kill the patient... or in fact kill off the whole unaware world population. Acronym AIDS is the

official scientific designation of the "disease".

Immune deficiency is when the body lacks the ways to sufficiently defend itself by defensive means like are white cells. Leukocytes surround and absorb bacteria and fungi. Lymphocytes or T cells increase in the blood in a presence of malignant organisms. High T cell count signs severe infection, but it can also be low in the same case, when the immune system has been suppressed. It is not a measure out of which other conclusions should be drawn. High T cell count in the circulation without a purpose to fulfill is abnormal. There are several types of T cells, also called T lymphocytes that develop, as do B cells, from progenitor cells in the bone marrow, but mature in the Thymus while B cells in the Bone marrow. Any threat challenging the immune system in a healthy body leads to an initial elevation of the T cell count, but the levels go way down when the threat prevails and immunity becomes suppressed. The prefix Leuc(o)- is a combined term signifying white or colorless, while the suffix cyto denotes a cell. It has been suggested the cells are sensitive to what is on the mind, and fear can swing with the immune system as well as irradiation has an effect or exposure to an electrical magnetic field can affect charge of the cells and cause them by linking together to form coin like rows, making capacity of their presence in blood ineffective. The condition is also called rouleaux.

Retrovirology had gained importance because of Nixon's 20 billion worth "War on Cancer", and the belief that a retrovirus may be the cause of cancer in humans. A retrovirus differs in theory from an ordinary virus by its typical ability to increase proliferation of cells, cause the cells to abnormally multiply, what is characteristic of cancer cells. Its replication depends on the viability of the host cell as opposed to an ordinary virus which causes destruction of cells during a viral infection, even though there are no facts. It has been claimed that a retrovirus can multiply this way by converting its RNA into DNA by an enzyme called transcriptase in an action of reverse transcriptase. In 1980, retrovirologists along with National Cancer Institute announced that the first human retrovirus (HTLV-I; human T-cell leukemia virus-1) has been discovered. It was suggested, but not proven, that the very same retrovirus caused a specific type of leukemia that was occurring in Japan. In 1981, it was proposed an acquired immune deficiency was the basis for a new syndrome of diseases that appeared to be emerging out of a selected population of male homosexuals and intravenous drug users. In the absence of any scientific experimental proof, was in 1983 pledged discovery of a virus that causes AIDS.

At widely publicized press conference held in Washington, D.C. on April 23, 1984 was made an announcement that another virus (named HTLV-III) that was discovered probably caused AIDS. The very same day or the following day, a U.S. patent for an HIV test kit was filed. The claim as presented was largely accepted by the scientific community as true with exceptions that arose. The claim wasn't substantiated by any scientific document that would prove the probability, and it was found only later, there was no evidence the virus caused any disease. But the statement already made the headlines, and a virus that once probably caused AIDS, was now a virus that caused AIDS. It was verified in the press and consequently in scientific journals or at lectures the hypothesis has become presented as an established scientific fact.

Eventually, it was discovered that the HTLV-III (HIV) retrovirus had been isolated in blood of some AIDS patients by Dr. Luc Montagnier of the Pasteur Institute in Paris, more than a year before its 1984 announcement, not unveiling. On several occasions, Dr. Luc Montagnier sent samples of the virus he had isolated to the U.S. virologist for assessment. A scandal erupted and a battle ensued over the credit for the discovery and the rights to the patents. It took an

intervention of the French Prime Minister Jacques Chirac and U.S. president Ronald Reagan in order to reach an agreement that resulted in sharing of proceeds and credit for discovery. The supposed discoverer of the mysterious, inert, now known as HIV virus was investigated and has been found guilty of a "scientific misconduct".

Dr. Peter Duesberg, Professor of Molecular Biology at the University of California, Berkeley, and the world's foremost retrovirologist; Dr. Charles A. Thomas, Professor of Microbiology at Harvard; Dr. Kary Mullis, 1993 Nobel Laureate (for his development of the Polymer Chain Reaction, or PCR) and numerous Nobel prize nominee, are few of many scientists who have come together to form a group for the reevaluation of the AIDS hypothesis. Dr. Willner died of a heart attack 4 months after the Dec. 7th conference, on April 15th, 1995. He had tested negative multiple times, even though he himself did not believe in the reliability of the tests.

A test for the human immunodeficiency virus (HIV) is a test for what is still called antibodies, not for the virus, and they are non-specific, because the HIV virus doesn't make the body to produce enzymes specific to the virus. It's the first pathogen when you are immune to it you gonna die from it. A group of Australian scientists have also declared the test for HIV invalid. They observed malnutrition, multiple infections, multiple sclerosis, malaria, measles and the "flu" can result in a positive test, as well as other diseases. In Russia, testing with the Elisa test resulted in 30,000 positive tests, yet out of the 30 thousand, only 66 were confirmed by the Western Blot. Those tests, even though likely based on the same method, were used to confirm results of Elisa tests. It is reminiscent of the famous old law which said a testimony of two men is truth. And of course when one test is used to confirm another, then the tests do no need to contend for a patient.

Azidothymidine (AZT) was an experimental drug in search of a disease that had been sitting on the shelves of the National Institutes of Health since the 1960's, because it had failed as a cancer remedy and had been declared too toxic to use. AZT was the first drug presented for the treatment of AIDS. The only supposed double blind study on AZT published in 1987 was discontinued after four months. The two groups were not matched at all. The AZT group had 56 side effects and the placebo group had 31 side effects. Other "concomitant medications" were used. The AZT group received transfusions 6 to 1 over the control group. Drug sharing occurred between the AZT and placebo groups. Following, AZT was approved as an antiviral drug for the treatment of AIDS. Human and animal tests have shown that AZT causes severe depression in the production of red and white blood cells, inflammation and damage of the liver, lymphomas, encephalopathy, inflammation of muscles and muscle atrophy. Additional adverse effects include suppression of the bone marrow. AZT terminates DNA structures, it's toxic to all cells. A private laboratory found AZT to be 1,000 times more toxic than shown in the studies conducted by the NIH and the manufacturer. In 1994, the package insert clearly stated that one of the effects of AZT is pancytopenia, pan - all, penia - loss of; loss of all cells or an abnormal deficiency of all blood cells (red and white blood cells, and platelets), usually associated with bone marrow tumor or anemia. That's the definition of immune deficiency.

The pharmaceutical companies, the medical agencies, the media and scientists conformists have been painting the body as this hopeless, impotent organism, which, every time when a disease comes around, depends on an intervention from their side, and then it dies anyway, because the virus or whatever, the cause of the disease was just too powerful, it couldn't be anything done about it. The difference between misinformed and uninformed person is that

the misinformed person reads the scientific studies by oneself and makes own conclusions, while the uninformed person is informed by those who have found a placebo has several side effects. And the reason why those using own wits are misinformed, is because those who inform the uninformed said so.

When the great bubonic plague killed one third of the population of Europe, why did not the other two thirds also die. Despite the ever more densely populated cities, and the increasing air contamination, the plague is rare in developed countries, but it still occasionally occurs in poor areas of undeveloped countries to this day. In the United States, when the great flu of 1919 took lives of 18 million people, why did not the rest of 92 million people also succumb. Even Louis Pasteur, to cherry pick, has at the end of the life reputedly asserted; *"It is not the organism, it is the terrain."* When a plague annihilates the susceptible population, epidemic ceases to exist.

The HIV hypothesis exists because there was no one in Africa and elsewhere, making people undergo a possibly lethal treatment, who could be blamed for the deaths. Nor anyone who had provided them with a reason to be treated in such way. How is it the medical personnel, which had been helping in Africa and had the greatest exposure to the highly infectious and deathly disease, had the smallest incidence of the disease among general population. AIDS-HIV hypothesis also exists because there is not a sufficient amount of respect for, as of now, the number one cause of immune deficiency, drugs. They are real, and they can kill, unlike a theory.

Pharmaceutical corporations and the media giants who own most of the news outlets in the western world, daily pouring information into homes what exactly to feel and what to think, are in very intimate relationship. Some tend to forget the media possess the power to issue the truth to virtually whole nations, and their potent potential to also act like contractors. It is mainly the viewer who is responsible for all the things that can be said on television today with no repercussions. Even though the problem also is what all is not said on the news. The media just talk what they want to talk about, and omit what they want to omit. Run debates about matters which they want the people to think about, with individuals they choose, and asking questions to which they want the answers for, to be heard. But there are exceptions, some outlets, sometimes state owned, do not completely share their voice with the uniform and prevailing information stream. The rest may as well operate under the common law, he who pays, tells the truth and good is what is profitable, but nevertheless be in control of the narrative. To know with who they are affiliated, simply pay attention who they say ought to be worshipped. The credibility of the unaccountable, unelected United Nations organization formed after the capitulation of Nazi Germany and the credibility of its governmental panels were built solely on the testimonies and conditioning of the public by the mainstream media and politicians. Coincidentally, the central banks who have stood behind the United Nations and its founding be in control, be affillietd, happen to also own majority of the media groups.

AIDS is just as contagious as malnutrition, starvation, irradiation or taking drugs is, why AIDS being infectious was ever part of the debate is beyond one's presumption. AIDS does not kill cells, not even according to the HIV hypothesis. The people do realize that there at no point

in time was a need for the virus to cause anything, let alone to exist, to cause the diagnosed with immune deficiency or the people that tested positive to consequently die, right? All the patients were looking for a virus of which they knew no evidence to even exist, while taking the prescribed medicine at the reach of their hand, they asked not one question about. That is called worship. The mistake that could have occurred may be the assumption to be good, blameless, without guilt, which not necessarily got to be true, and even if it was true, it does not ordain or guarantee others to treat the one in such way, not in this world. What ensures one's safety or well being if the one won't ensure them on one's own by reasonable distrust through questioning. An unaware person can be hardly innocent, but under condition when the person's blind actions are only detrimental to the respective person. The world's unsaid law claiming we have never left the heaven, we have just loosened the rules, says; there is a bound between everyone, and if we are to preserve it, also a bound between everyone and the world, which all require certain attitude in order to coexist. We barely see consequences of our decisions, our own choices and actions. It was divulged in ancient times. In case there is a way to everyone's happiness, it is known by the common conscience, god or providence if you will, but we all have free will to do what we see right, which often results in suffering.

Everyone who takes drugs, pharmaceutical or harmful illegal, in sufficient quantity and for a long time becomes eventually immuno-deficient, and therefore suitable and destined, if the one caves in due fear, to take antivirals. If everyone was on large amount of drugs, everyone would be immuno-deficient. When the condition of immune deficiency was designated as a new standalone syndrome of diseases, it became a group of about three symptoms in Africa and many more symptoms in countries where people don't suffer by malnutrition, but take illegal chemical drugs or great amounts of medications. The AIDS diseases occur also in HIV-free individuals, or more specifically those who tested negative, but the diseases are simply reported under their respective old names instead of being called AIDS. Louis Pasteur called the pathogen he couldn't find, virus, meaning venom. The first edition of the Merck Manual, published in 1952 listed the causes of acquired immune deficiencies by order of occurrence; malnutrition, drugs, radiation... Several studies have revealed recovery of cellular immunity and general improvement when administration of AZT was discontinued. An estimation has been made that around half the American AIDS patients were presumptively diagnosed with no positive HIV test. The AIDS diseases are not gender specific, but in the United States and Europe the virus had preferred men carriers over women 9 to 1. According to statistics, AIDS had not spread until 1992, when 5 more diseases were added to the group of the syndrome.

Approximately one third of the AIDS cases in Europe and America were diseases that are not caused by immune deficiency; lymphoma, Kaposi's sarcoma, wasting disease and dementia. 80% in U.S.A to 98% in Africa of the HIV positive individuals, had not developed AIDS in time span of ten years (1984-1994). Statistics also show that those who want to develop immune deficiency, i.e. "get AIDS" from an HIV positive male, have to be on sufficiently potent drugs for a long time. More than a dozen concurrent co-factors have been proposed as necessary for the development of AIDS along with the presence of HIV virus, which is usually not even present according to the tests. The HIV retrovirus that according to the theory is dependent on the host cell in order to replicate and spread from the carriers, at some point supposedly becomes cell destructive and consequently causes AIDS diseases, what's almost forty years later, yet to be laboratory demonstrated. The incredible conclusions of the intensive, twenty years of research contradict the claims of the same virologists, that a retrovirus is cytotoxic.

The proponents of the HIV hypothesis have avoided conducting scientific controlled studies that would be universally accepted as evidence. HIV-AIDS theory, sufficiently addressed, yet not well widely acknowledged, is remnant of a partially successful attempt.

The belief of the potent lethality of HIV virus stands on the framework of indications, unified claims of governmental health agencies and organizations, regular and rich in amount media reports and testimonies of many individuals with notable public influence, which can also be engraved in the content of their work, including entertainment, while from the other side, it is the human aspect of inherent trust that is also given to colleagues in the scientific sphere. A disease is a complex of symptoms, while a syndrome is a complex of diseases that do not necessarily have to be well attributed. Iatrogenic means induced by a physician's therapy or words, often used in the term iatrogenic disease that points to a different understanding of disease, otherwise they are iatrogenic causes. To this day, people are still getting treated on the basis of testimonies, not on the basis of evidence or results, which the medicine has, but those aren't evoking a great amount of confidence in effectiveness of treatments or healing.

### Incoherent Babbling

A disease is only able to come into being, remain or progress, when the organism provides it with suitable conditions, when the organism allows it to happen. It is proof of an unhealthy state, developed either abruptly or in a long term that makes disease to show up and take a chance to prevail, to finish off the organism that is unable to adapt and opposed to healthy, natural behavior. With average nutrition, the body still manages well chemicals it is exposed to, of the environment and of the products, unless bypassing all the ways, are injected right into a muscle or vein. The people treated by medications have usually one thing in common, they do not seem to want to recognize they had done something wrong, let alone to change the way of life that led to the complications in order to put the disease in remission or heal.

The body is blamed; the back, the bones, the joints or muscles; the stomach, apparently an ache has not much to do with our actions and what is done with the body. We will take a sip of a homeopathic remedy that produces symptoms, allegedly, similar to those being treated or an allopathic remedy that produces symptoms that have nothing to do with those unique to the disease, and voila, it is gone. Hopefully an allopathic medicine is prescribed according to the etiology of a disease. Prescription drugs sort of absolve a patient of need to continue looking for the real cause of acquired symptoms treated by the drugs, but only seemingly. It is also viruses that provide a causation to virtually any disease or health complication, which may be most well received by some individuals not really seeking any changes on their side.

A virus as the cause of disease, why not, while the true causes actually have a substance and are corresponding with our everyday lives, including everything we're exposed to. A virus as a cause of cancer, a retrovirus in fact, according to the few billion dollar research, may leave carcinogens as mere contributing factors. Viruses almost seem to draw attention and gather blame from all the relevant and real causes. It is worth noting that at the end of the 20 years long search for a retrovirus, which was the hoped-for, asserted, but unlikely cause of cancer, the virologists not only didn't find the responsible retrovirus, but any piece of a mysterious, way too small to be seen, inanimate, randomly floating tissue bit that would be accepted as a clinically relevant causation of any symptom, let alone a disease, except until a "new" kind of a syndrome of diseases has been introduced, and the HIV virus presented as its causation.

Before the dawn of the 20th century, John D. Rockefeller (1839-1937) controlled most of all oil refineries in the U.S. through his oil company, Standard Oil, which was later broken up to 34 distinct companies. Around the same time, researchers were discovering petrochemicals and exploring the ability to transform oil into all kinds of chemicals. Bakelite, the first or one of the initial forms of plastic was allegedly made from oil in 1907. Various synthetic vitamins were being discovered and the presumption at the time was that many drugs for treatment of diseases could be produced out of oil. It became an opportunity to monopolise chemical, medical and oil industry at the same time, while petrochemicals could be patented and sold for high profits. But there was a problem for the medical industry, natural medicine was still very popular in America at the time. An abundant amount of doctors and medical colleges in the U.S. were using knowledge of Native Americans and from Europe, and practising holistic medicine. A man from the Carnegie Foundation called Abraham Flexner traveled around the country to report on the status of medical colleges and hospitals of the country, what led to the Flexner Report that gave birth to the modern medicine. The report furnished a need for revamping and centralizing the medical institutions. As a supposed consequence, more than half of all medical colleges were soon closed, but the newspapers and other powers helped with the transition tremendously. Natural cures were suppressed. More than \$100 million in those days value went to hospitals and colleges, as a part of a method some may call carrot and stick approach. In 1903, additional funds were dispensed for the creation of the General Education Board (GEB). Those who fund the education control what the educated learn. In a very short time, medical colleges were streamlined and homogenized, all the students were learning the same thing, the medicine became focused on the treatment by patented drugs.

Scientists received huge grants to study healing properties of plants. The aim was to identify which chemicals in the plant were effective and then to reproduce a similar chemical in a lab that could be patented. A pill for an ill became the formula of modern medicine. Most of the countries today spend enormous amounts of finances on health care, which in the meaning is what the term denotes. A fund dedicated to curing of illnesses would be named sick care. In spite of the great subsidies, there is no cure for cancer, diabetes, autism, asthma, or even a flu and their causes remain uncertain. Most of medical schools teach about seven hours of nutrition.

### In the Land

It starts with money. What is money, a matter of exchange, in case of notes, piece of an art, items of set abstract, imaginary value. They are used while they are accepted and there isn't a better alternative. Notes and coins are the ideal form as an exchange medium. They are easy to carry and can be used for anonymous payments, but there may be a possible catch.

In 1694, a Scottish trader William Paterson (1658-1719) founded the Bank of England that in his pamphlet he described "A Brief Account of the Intended Bank of England". After 50 years of war England had just suffered, William Paterson proposed a loan of £1.2 million, which in today's volume equates to more than £28 billion, to the English government. In return, Bank of England would receive certain privileges including the issuing of money notes. The English government embraced this idea and the very first private central bank was created. Through the Central Bank of England, William Paterson was able to sell new issues of securities to the English government with interest, and the bank has been doing so ever since.

In 1774, muskets, a type of firearms, the original "assault rifles", were banned by the British

from importation to further arm the American colonists. In 1775, British attempted to seize arms of the colonists what led to the American Revolutionary War of Independence, fought against Great Britain. On July 4th, 1776, the Declaration of Independence was promulgated by the leaders of the thirteen British colonies in America, asserting the independence of the colonies from Great Britain and declaring unanimously the formation of the original thirteen United States of America. The oppressions of the King of Great Britain led to the separation.

*"Life, Liberty and the pursuit of Happiness. — That to secure these Rights, Governments are instituted among Men, deriving their just Powers from the consent of the governed, — That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its Powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shown, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when along train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future Security."*

— U.S. Declaration of Independence, signed in the hall, July 4, 1776.

In 1781, after the three week siege of Yorktown by American and French troops, the British under Cornwallis surrendered, resulting in the end of the American Revolution. In 1783, the Paris Peace Treaty was signed, that treaty also identifies the King of England as the Prince of the United States. On Monday, September 17th, 1787, the state delegations represented, all the states except Rhode Island, in convention approved the Constitution. In 1788, when the 9th state ratified it, the Constitution has become established between the 9 states. The first Congress under the Constitution convened in New York City on March 4th, 1789. In April the same year, George Washington was inaugurated as the first president. On September 25th, 1789, Congress approved 12 amendments and sent them to the states for ratification. On December 15th 1791, 10 out of the 12 proposed amendments, then renumbered, also known as the Bill of Rights, were ratified and have become part of the U.S. Constitution.

*"No State shall enter into any Treaty, Alliance, or Confederation; grant Letters of Marque and Reprisal; coin Money; emit Bills of Credit; make any Thing but gold and silver Coin a Tender in Payment of Debts; pass any Bill of Attainder, ex post facto Law, or Law impairing the Obligation of Contracts, or grant any Title of Nobility."*

— U.S. Constitution: Article I Section 10 Clause 1

In 1794, another treaty describing few terms between the U.S. and Great Britain was signed. On May 1st, 1810, the Titles of Nobility Amendment was approved by Congress and sent to the states for ratification. Additional to the Article I Section 9 Clause 8, the Titles of Nobility Amendment would strip citizenship from any U.S. citizen who accepts a title of nobility from a foreign country without the consent of Congress. So no person could be endowed in such way after leaving any office of profit or trust, and as well remain citizen of the United States.

Benjamin Franklin, who led a group of high ranking leaders of the American colonies, one of the members of the Constitutional Convention, which drafted the Constitution in 1787, also proclaimed as "the First American" for his early, unrelenting campaigning for colonial unity, in his autobiography stated, the prime reason for the American War of Independence was a battle over who controlled and issued the money of the colonies.

The first Central Bank of the United States was created after the Bank of England, already in 1791 by Alexander Hamilton who solely represented state of New York at the Constitutional Convention, and became the 1st United States Secretary of the Treasury, as well as with the signature of George Washington, but its existence was bitterly opposed by several founding fathers including Thomas Jefferson who saw the potential for speculation and manipulation that would, with opportunity and time, develop. The abolishment of the Charter of the First National Bank in 1811 resulted in, immediately afterwards, arrival of 4500 British troops and their work of burning down the White House, both Houses of Congress, the War Office, the U.S. State Department and Treasury as well as destroying the ratification records of the U.S. Constitution. The War of 1812 lasted until the Bank Charter was reestablished in 1816 after the ratification of the Treaty of Ghent in 1815. The second central Bank of the United States also lasted about twenty years until it was abolished by Andrew Jackson (7th U.S. president), who took it into battle as soon as he stepped into office in what was called "the Bank War".

Andrew Jackson was unique for the times, beside being the first American president to have been a democrat, he was elected by the voters without the direct support of any recognized political organization. On July 10, 1832, he vetoed the renewal of the charter for the Bank of the United States. The vice president under his first term happened to resign later that year. In 1835, president Andrew Jackson expressed his disdain for the international bankers: *"You are a den of vipers. I intend to rout you out, and by the eternal god I will rout you out!"* There followed an unsuccessful assassination attempt, the president is also quoted to have said to his vice president, Martin Van Buren, *"The Bank, Mr. Van Buren, is trying to kill me..."* Nicholas Biddle who was the 3rd and eventually last president of the second Central Bank of the United States at the time allegedly declared, *"I will pull the country down. The nation will fall, the people will fall, but the bank will not fall."* To an extent the intention succeeded, but ultimately the debt was repaid, Andrew Jackson killed the bank and the economy recovered.

When James Madison held the presidency, during which the War of 1812 happened, both of the vice presidents died while holding the office. William Henry Harrison, 9th U.S. president, died within 31 days in office. William R. King, elected in 1852 as vice president with the 14th U.S. president, have also died the next month after taking office. They are among presidents and vice presidents that have died in office, were they young, there would not be that many deaths, or if there were to be it would be fishy. It may be well to see a list with all the terms.

*"Of all the enemies to public liberty, war is, perhaps, the most to be dreaded, because it comprises and develops the germ of every other. War is the parent of armies; from these proceed debts and taxes — known instruments for bringing the many under the domination of the few."*

— James Madison, 4th U.S. President (1809-1817), and founding father proclaimed as "the Father of the Constitution".

In 1861, after the secession of the southern states from the United States and formation of the Confederate States of America, the Confederacy, and consequently the northern states, needed money to pay wages of troops and fund the American Civil War (1861-1865). Lincoln who had been recently sworn in as the president worked to prevent international interest in financing the federal Union Army. It was the Czar of Russia who provided assistance against the British and French, who were the main forces behind the secession of the South and the funding of the Confederate Army. Russia intervened by providing naval forces for the Union blockade of the South in European waters, and so also by letting both countries know that if they attempted to join the Confederacy with their military, they would as well have to wage war with Russia. The private banking interest did succeed through the Secretary of Treasury Salmon P. Chase, by passing through Congress the National Banking Act, creating a federally chartered private central bank with the power to issue nation's currency.

*"The money power preys upon the nation in time of peace and conspires against it in times of adversity. It is more despotic than monarchy, more insolent than autocracy, more selfish than bureaucracy. I see in the near future a crisis approaching that unnerves me and causes me to tremble for the safety of our country. Corporations have been enthroned, an era of corruption will follow, and the money power of the country will endeavor to prolong its reign by working upon the prejudices of the people, until the wealth is aggregated in a few hands, and the republic is destroyed."*

— Abraham Lincoln, 16th U.S. President from 1861, until his assassination on April 15, 1865. (Little over a month into his second term, and the vice president succeeded to presidency.)

Some believe it was his anticipated success in influencing the Congress to limit the life of the Bank of the United States only to the years of war, that was the motivating factor behind his assassination. The emitted notes of currency had to be paid off to get back to the backed by gold and silver money, which the U.S. notes were in the beginning years of the 20th century.

The circumstances surrounding the assassination raise a lot of questions. Notions have been passed on naming Edwin Stanton, Lincoln's Secretary of War, other government officials and over seventy businessmen to be involved in the conspiracy. John Wilkes Booth, portrayed in the newspapers as a crazed lone gunman with a few radical friends, supposedly escaped by way of the only bridge in Washington that wasn't guarded. John Wilkes Booth was allegedly found hiding in a barn near Port Royal, Virginia, 3 days after escaping from Washington, and was shot by Boston Corbett, a soldier who fired without orders. Whether the man killed was John W. Booth is still a matter of contention, whoever the identified person was, the corpse had no need for a fair trial. Alleged Booth's diary was found and delivered to Stanton. When it was later produced during the investigation, eighteen pages had been torn out. The pages containing names of the aforementioned individuals and officials were allegedly later found in the attic of one of Stanton's descendants. Different conjecture linked John W. Booth with the Civil War campaign manager in the South, Judah P. Benjamin, a hand of the British bank.

Lincoln also once gave a speech so enthralling that reporters in the audience stopped taking notes, and now we don't know what he said.

*"Whoever controls the volume of money in our country is the absolute master of all industry and commerce ... when you realize that the entire system is very easily controlled, one way or another by a few powerful men at the top, you will not have to be told how periods of inflation and depression originate."*

— James A. Garfield, 20th U.S. President from March 4th, 1881, until being shot at a railroad station on July 2, 1881, and his resulting death on September 19, 1881. (He had previously been Chairman of the House Committee on Appropriations, and was an expert on fiscal matters.)

William McKinley's vice president died on November 21st, 1899, and almost two years later, McKinley, the 25th president of the United States has become the third U.S. president to be assassinated. There never occurred an instance when both U.S. president and vice president died within one term or prior to February 10, 1967, when the 25th Amendment has become part of the Constitution (pending since July 6, 1965), which had not specified such condition.

Nelson Wilmarth Aldrich, born into a middle-class family descending from a family of English immigrants, was a prominent American politician and a leader of the Republican Party in the United States Senate, where he served, can you believe, from 1881 to 1911. A politician and businessman, most people living today have likely never heard of him, nor dictionaries know him, however what this forgettable fellow did in the closing years of his life would have had some of the founding fathers, in their times, spinning in their graves like fans after they had departed from the world of the living. In December of 1910, Senator Nelson Aldrich boarded a private rail car with six other men, parked at a New Jersey train station. The six men were Paul Warburg, Frank Vanderlip, Benjamin Strong, Henry P. Davison, Charles Norton, and Abe Andrews. Their destination? Jekyll Island off the coast of Georgia, island of a popular retreat for billionaires like William Rockefeller and JP Morgan. The men that were brought together included the heads of banks, branches of government such as the treasury and some of the richest men on earth at that time. Gathered under one roof, they conducted a meeting that went for nine days, and out of that meeting, they laid the foundation for the creation of the latest central bank in the United States.

Frank Vanderlip, Assistant Secretary of the Treasury (1897-1901), wrote about their meeting in his autobiography: *"I was secretive, indeed, as furtive as any conspirator. I do not feel it is an exaggeration to speak of our secret expedition to Jekyll Island as the occasion of the actual conception of what eventually became the Federal Reserve System."*

*Discovery, we knew, simply must not happen, or else all our time and effort would be wasted. If it were to be exposed that our particular group had got together and written a banking bill, that bill would have no chance whatever of passage by Congress."*

The alleged purpose for the creation of the system was to stabilize the economy and release the grip of the Wall Street banks, but those who wrote the bill were the people they claimed they would stop. The bill, which was initially drafted as the "Aldrich Bill", did not get through Congress, which decided against passing the bill. In 1912, on its first voyage from England to New York, the large ocean liner sunk with hundreds of people on board. We know how it all

happened, the iceberg, just bounced off the captain's eyes. And when it came out of the fog, the underwater ice tore through the steel hull including many chambers, enough to sink the unsinkable. Much less was said about the legislative opposition to the bill that sunk with it. The next time the bill was carried into the Congress, it was called the "Federal Reserve Act".

The newspapers posted articles depicting bankers, screaming and protesting against the bill, "It would ruin the banks!", they explained in these articles, inducing the impression that the statute will tighten up the legislature under which banks operate. The statute also contained clauses that limited the power of the Federal Reserve, only to be removed once the bill had been signed into law. And while majority of the 535 members of Congress were at home for Christmas or preparing to leave for the holidays, Congress passed the Federal Reserve bill by the vote of 43 to 25. The bill was then represented to the newly elected president Woodrow Wilson and signed into law on December 23rd, 1913. Shouldn't there be a proper quorum of the legislature to exercise power over statutes concerning the most important issues beside the issue of war. An image of W. Wilson was printed on 100,000 dollar Federal Reserve bank notes used from December 1934 to January 1935, for transactions between Federal Reserve banks.

*"We have come to be one of the worst ruled, one of the most completely controlled governments in the civilized world — no longer a government of free opinion, no longer a government by a vote of the majority, but a government by the opinion and duress of a small group of dominant men."*

— Woodrow Wilson, 28th U.S. President from 1913 to 1921, three years after he signed the Federal Reserve Act.

Among Nelson's Aldrich accomplishments was also conception of the sixteenth Amendment to the Constitution, which he authored and led to be approved by Congress on July 12, 1909 and enacted on February 3, 1913. This overachiever accomplished this the same year he co-directed the conception of the most relevant central bank to have ever existed in the world.

*"The Congress shall have the power to lay and collect taxes on incomes, from whatever source derived, without apportionment among the several States, and without regard to any census or enumeration."*

— Amendment XVI to the United States Constitution.

Soon after the end of 1913, the World War I began. The supply of the Federal Reserve notes was expanded greatly by the government to fund the war. There wasn't gold to back up that currency, but the treasury issued bonds to back it up with gold, which are promises to get to the value of the bond, whether it will be in gold or whatever, later in the future. Bond, from the word bondage, a certificate of debt, usually interest bearing, issued by a government or corporation in order to raise money. The issuer is required to pay a fixed sum annually until maturity and then a fixed sum to repay the principal, the original amount of a debt on which interest is calculated. And of course the most known incentive creating a demand to expand a currency for a funding that cannot be delayed is a presence of a jeopardising threat, a war.

Since the creation of the Federal Reserve System, the Federal Reserve notes have been used as the medium of exchange among the public, and Federal Reserve bank notes between the

banks of the Federal Reserve System. The Federal Reserve notes (today commonly known as the U.S. dollar) were also borrowed by the federal government from the Federal Reserve in order to fund the military, and during the years of World War I, the federal government has become a debtor to the system. Because every dollar is issued with interest, at no point is in the circulation enough money to repay both the debt and its calculated interest. In order for the debt to be repaid, the debtor would have to hold notes or credit issued without interest, in sufficient amount to pay the interest, and so every note of the currency in the circulation.

If the nations were to scramble all of the currency and bring it before the bank, it would not be enough. Everyone obligated to pay the tax used to pay the interest on the debt is forever indebted in this system, everyone but the shareholders of the system the interest is paid to. Income taxes, which are considered direct taxes, were enacted so the government is able to pay the interest on the debt. The income tax is sufficient to pay the interest on the debt, but not the debt. The government is therefore obligated to keep borrowing the money from the entity that has authority over the issuance.

In the early days of the American colonies, long before the United States was established, in states of Maryland, Virginia, North and South Carolina, the legislature voted tobacco may be used as money to pay for all sorts of things, but as tobacco grew in the fields, so did inflation and at the end of the process, prices were 40 times as high in terms of tobacco as they had been at the beginning of the process. Because the amount of tobacco available was greater, and the demand did not increase with availability, it was worth less. Almost a century after they had started using tobacco as money, they established warehouses where tobacco was deposited in barrels, certified by an inspector according to its quality and quantity, and they issued warehouse certificates that people gave from one to another to pay for the bills they have accumulated. Back then the money did not grow on trees, but it did grow on the fields.

During the gold standard, a bank was a place to safely store gold or silver coins at a small fee in exchange for bank notes, which were certificates of deposits. The bank notes were issued by the banks and used by people to pay for goods and services just as actual gold and silver. Another part of the banking business was providing loans out of deposits. A banker offered to split received interest payments for any deposits made available to be lend. The interest rates were determined by the supply of deposits made available and the demand for loans. With all the gold sitting in a vault, a banker could possibly loan bank notes covering deposits without the knowledge of their respective owners. When Mr. Stevenson comes to the bank to withdraw his gold, a gold of someone else could be used instead to cover it. As long there is enough gold and silver in the vault to cover all the bank notes in circulation, a run on bank would not result in anyone leaving dispossessed of their postulates and property. The state governments did not outlaw misappropriation of depositors funds, but passed laws setting a reserve requirement, a percentage of total deposits banks must have in their reserves at all times, as related to issued bank notes in the circulation. The banks could under this system, called the fractional reserve system, legally lend many more notes than they had secured by actual gold and silver deposits stored in their reserves. The values set by the states averaged around 15%. The banks could therefore, not only lend bank notes backed by gold and silver deposited by customers, but according to the law, lend bank notes several times in excess of their deposits at a demand for a new loan, they could create money, or debt owed to them. But under the gold standard, the amount of banknotes issued as debt, in excess of the bank deposits could or should legally increase only so far, unless the gold standard is eliminated.

*"On Sept. 1st, 1894, we will not renew our loans under any consideration. On Sept. 1st, we will demand our money. We will foreclose and become mortgagees in possession. We can take two thirds of the farms west of Mississippi, and thousands of them east of Mississippi as well, at our own price... Then the farmers will become tenants as in England..."*

— American Bankers Association, 1891 as written in Congressional Record, April 29, 1913.

The reasons why the Federal Reserve was established were, supposedly, to cut back on bank failures, by providing loans to the banks in form of Federal Reserve notes to make up for the reserve deficits in case of a run on bank, and then to reduce inflation and prevent deflation. With the power to create debt, when the Federal Reserve provides a loan to a bank to make up for the shortfall and get it out of a financial trouble, it is called providing liquidity. Due to the presumption the Federal Reserve is part of the government, and not a private bank with a misleading name, the Federal Reserve did succeed to prevent runs on banks by inducing a sense of security in the banking system. Has the Federal Reserve ever owned any gold prior to 1934, and were any notes used under the Federal Reserve System ever backed by gold.

In early 1920, to decrease the inflation created during the war, the Federal Reserve interest rate was raised from 1.25% to 6%. The volume of the Federal Reserve notes in circulation is adjusted by interest rates determining how fast the notes flow back to the Federal Reserve, but also by the amount of new notes created. When Warren G. Harding took office in 1921, the unemployment rate was about 12%. As a consequence, when the government's revenue failed to meet the expenses because of the downturn, he simply cut government's spending. The same year, the supply of notes in circulation was reduced, resulting in the depression of 1921, the greatest deflation of the currency, as in proportion to all notes issued, the U.S. has ever seen, associated with bank failures, foreclosures and confiscations of private property. Not every bank in the states likely was, also at the time, part of the Federal Reserve System.

*"I believe banking institutions are more dangerous to our liberties than standing armies" ... "To preserve our independence we must not let our rulers load us with perpetual debt." ... "If the American people ever allow private banks to control the issue of their money, first by inflation and then by deflation, the banks and corporations that will grow up around them will deprive the people of all property, until their children will wake up homeless on the very continent their fathers conquered."*

— Thomas Jefferson, 3rd President of the United States (1801-1809) & the principal author of the Declaration of Independence.

The possibility of acquiring funds in a moment gives any business advantage in the question of time or efficacy over another business, that would save up money for the same purpose. As consequence of the availability, any enterprise is instigated to borrow money in order to compete with like companies using this advantage to their benefit. And when the funds lent are created at the instance of signing a loan contract, others are furthermore discouraged to save up by the effect of inflation. When a currency is accepted and widely used, the benefit to be had is in the well, those that pull up the new money created benefit, while greater the benefit, greater is the reason for anyone else to reject the money or use a form that is more difficult to inflate instead. But new money are only created under the circumstance they are initially owned by the bank, yet the bank relies on the borrower to be able to create money.

When a new loan agreement is being made, a bank, the lender and the borrower, both offer a legitimate form of property for the exchange. A bank lending in excess of its deposits does not own the property offered at the time of making the agreement, but the credit is created soon after the borrower signs the promise to pay the amount stated in the loan agreement. A bank that did lend credit within the value of its gold deposits had not owned the property offered at the time of filling the loan agreement as well. The borrower guarantee to pay the loan with owned property or the property to be acquired by the bank. One aspect of money issued with interest a borrower does not control is the volume of currency at any given time in the future, which is enough to render the ability to pay the interest to naught. A business is more prone to increase prices during an inflation, than it is prone to lower prices during a deflation. Businesses are more easily adapted to broadening of commerce trails by inflation, than they bear an abrupt change of the rich current that broadened the troughs, into a small stream barely passing through. The vessels of commerce, simply, are more easily broadened than they contract. Deflation of currency is associated with collapse, when many don't have money anymore to meet the established prices, businesses, unable to continue paying their debts, fail, and the banks claim the liens.

A reseller is quite unlikely to sell a machine for 70% of the price one acquired it for when the total value of money in circulation goes down by 30 percent, especially when nobody else is lowering their prices. When the total value of money in circulation decreases, value of a unit as the value of one dollar rises in relation to value of a different commodity (which quantity on the market, or people's esteem of that commodity had not decreased). Paper currency is a commodity on the market as any other, distinguished only by the peculiarity that it has no particular purpose except its use as an exchange medium. Its value increases and decreases only in relation to a different commodity. When quantity of money in circulation decreases, the exchange value for one unit on the market increases, but the prices do not change until they are too high to be met, and unless the money quantity in circulation will increase again, the deflation will result in a price crash. Another thing that also do not change are mortgage payments.

*"It is well enough that people of the nation do not understand our banking and monetary system, for if they did, I believe there would be a revolution before tomorrow morning."*  
— Henry Ford, founder of the Ford Motor Company, 1922.

Warren G. Harding died in the 3rd year of his presidency on August 2, 1923. In 1924, the 6% interest rate was reduced to 3% to ease the unemployment. Coupled with loosened lending policy, the banknotes supply increased and resulted in inflation. In 1928, to reduce inflation, the interest rate was increased from 3% to 5%, and followed by strict lending policy in 1929. The October 29, 1929 stock market crash began the period of deflation that is referred to as the Great Depression, at the depth of which in the spring of 1933, the Federal Reserve itself along with the branch Federal Reserve banks closed their doors. During the depression, the amount of currency in the United States decreased by one third, the amount of banks in the country also decreased by one third and unemployment increased to 24%. In 1934, gold was made illegal for the United States citizens to own. The law ordained the people to take their gold to a Federal Reserve bank and exchange it for the notes. It had not eliminated the gold standard, but it made the standard irrelevant. By the time, a bank run was the common way to expose a banking fraud. The vast funding of armament industries at the time, aggregation and development of military power abroad, impelled the United States by a necessary need

to muster its potential for war. Most of World War II documentaries do not touch the issue of funding as concerning Germany, how did it recover in a decade to wage another war with the world. What kind of money they used to transform natural resources into war machine. The Nazi Party was founded in 1919. How was the Sturmabteilung (SA) financed, armed and organized after Hitler created the militia in 1921.

Around 1933, there as well was a plot in America to overthrow the government with a coup d'état, sometimes referred to as the business plot. A retired army Major general Smedley D. Butler was to have raised a private militia of five hundred thousand men out of unemployed army veterans, but testified before Congressional committee after he learned more of what the plan entailed. It was uncovered in November 1934 and several newspapers reported on it. The plot against America, which involved businessmen and Wall Street financiers, was cut short of retaliatory measures against the plotters. The Philip Roth's fictional novel, and book by Sinclair Lewis, *It Can't Happen Here* were based upon information from the investigation. There probably was enough finances from the *you owe me money creation business*, to fund the takeover and weapons to arm the insurrection, but not that many of those to be bought to take part in such plan.

*"We must especially beware of that small group of selfish men who would clip the wings of the American eagle in order to feather their own nests."*

— Franklin D. Roosevelt, 32nd U.S. President from 1933, until his death on April 12th 1945, little over two and a half month into his fourth term.

In 1934, congressman Louis T. McFadden of Pennsylvania gave a speech accusing individuals who were behind the Federal Reserve System. Without naming them, he expressed a belief it was the same people, which by their financial means, influenced important world events.

The 20th Amendment ratified on January 23, 1933 (proposed March 2, 1932) also, among other things, changed the dates on which terms of the president, vice president and of members of Congress, end and begin to January 20th and January 3rd respectively.

The 22nd Amendment ratified on February 27, 1951 (proposed March 21, 1947) limits the number of times a person can be elected as president.

From 1913, gold was rising in price, following the shadows of the proliferating currency until 1934, when it was revalued from \$20.67 to \$35 for an ounce. With gold withdrawn from the public possession and circulation, the currency could be inflated to fill the needs of national security without having to answer to relatively stable gold quantity. At the end of the war in 1944, the U.S. government chose the Mount Washington Hotel as the site for a gathering of representatives from 44 countries to attend a monetary conference held by United Nations. It was the famed Bretton Woods monetary conference, which established the arrangement by which, from 1945 onward, all currencies were exchangeable for the dollar and the dollar for gold at the fixed standard of \$35.00 an ounce. At the time, gold was the final mechanism for settling balance of payments deficits between reserves of the central banks, but Bretton Woods conference forestall this process by establishing the sole reserve currency, the main reserve currency, to be considered as official reserves for foreign central banks, so that they could settle all their deficits in dollars as opposed to gold, that is the fundamental difference between the classical gold standard and the Gold Exchange standard, which Bretton Woods

enshrined in law and in treaty. With this done, the American dollar (the notes of the Federal Reserve System) have become the currency of international exchange, under agreement the dollars are backed and convertible to gold. The conference also established the World Bank.

After the Second World War, a branch of United States military officials persuaded Congress to sanction the transportation of Nazi scientists into the United States. The reason given was simply if the U.S. won't contain them, then the Soviets will. Then there was also an option to bring them to the trial like few others that were. The former vice president Harry S. Truman who assumed the presidency, agreed under condition that none of the scientists would have been active members of the Nazi Party. Because of the Nazi Germany capitulation, everyone conformed. The title of the recruitment process was Project Paperclip, or also referred to as the Operation Paperclip. President Harry S. Truman approved Project Paperclip in 1946. The first wave consisted of more than 700 propulsion scientists and less than 700 mind scientists or scientists of human behavior. The Central Intelligence Agency (CIA) was given authority of placing the individuals (which were given new identities) within different establishments. In the occupied countries, the Nazis were endeavoring to impose their world view of unity and power onto the lay population, by what was called the Weltanschauungskrieg (Welt - world, Anschauung - opinion, Krieg - warfare) or ideological warfare. The means were adopted and developed through further research with American scientists, while the imported propulsion scientists were moved to work on missiles, weapon systems of various kinds and in the U.S. space program. The U.S. got theirs few hundred scientists and Soviets got theirs, meanwhile they fought against a common enemy during the war, after the war was over, they suddenly became each other's enemies. It is like their alliance was mainly dictated by existence of the enemy, and once the threat was gone, it was time to defend the country from former allies.

On July 4th, 1947, it is supposed, two objects fell from the sky crashing into the ground near Roswell, New Mexico, while one of those vehicles was sufficiently intact to be recovered. On July 8th, Roswell airfield commanding officer, colonel William Blanchard disclosed in a press release the recovery of a flying disc. Later that day, brigadier general (an officer in rank next above a colonel) Roger Ramey, commander of the 8th Air Force, presented a different story. He claimed the army had recovered a target device of some kind, suspended by a neoprene balloon. The National Security Act passed in 1947 and a control group of twelve persons was set up by president Truman, which consisted of scientists and military officers, known as the Majestic-12 or MJ-12. They issued a memorandum including instructions how to respond to the sightings by saying that the objects observed were, indeed not objects, but were natural phenomena, such as plasma or gas, or that the observer might have been drinking too much alcohol. An expedition revisiting Antarctica was also conducted by the U.S around that time.

The United Nations (UN) was chartered in 1945 and the International Monetary Fund (IMF), a United Nations agency. The CIA was created in 1947, the United Nations divided Palestine, and in 1948, the state of Israel declared independence. The World Health Organization was created, enhancing UN's list of agencies, and in 1949, the North Atlantic Treaty Organization (NATO) was created.

On January 17, 1961, president Dwight D. Eisenhower, soon about to hand over the office to his successor, John F. Kennedy, in his farewell address took time to mention the past growth and development of the military, the enormous size it had gained and had at that time, and the potential it attained, more importantly when the hidden potential is shrouded in secrecy

from the public view. With understanding the importance of the national defense, he stated that three and a half million men and women were, at the time, directly involved in defense establishment, while the government have been annually spending more money on military security than had been the net income earned by all United States corporations. The idea is that probably due to the immense funding of the military, coupled with secrecy surrounding the ongoing programs in Nevada, prompted Eisenhower to threaten to send in the 1st army from Colorado to look at the Area 51 and S-4, as he himself was not given access to visit the restricted areas to see what was going on. They capitulated and allowed him to send several confidants, which had to be trusted members of the CIA. They allegedly reported back what was really expected, that the research programs involved back-engineering of the recovered vehicle from the Roswell area. It is thought that Eisenhower did not trust the military branch that have gotten control over the acquired vehicle, and that was what made him concerned. Those in charge of the military branch who were conspiring against the lay world population already before the Second World War was over, may have possibly thought that a president with a notable military background will make up for a good public appearance of the whole military, but they were not in charge of his opinions.

On June 4, 1963, John F. Kennedy signed Executive Order 11,110. What the order's changed, amended or influenced may be implied in the particular order. The true is a number of U.S. notes were issued through the U.S. Treasury, rather than issuing a government bond for the Federal Reserve System, so that they would lend their notes with interest. The notes issued had in their top part heading saying "United States Note" (instead of Federal Reserve Note), and comprised red markings in place of green ones printed onto the Federal Reserve notes. As we now know president Kennedy died on November 22nd, 1963, from a fatal shot to the head out of the total of three shots fired. It is questionable whether the United States notes issued through the treasury were backed, at a ratio, by any commodity, but most have been withdrawn from the circulation after the end of Kennedy's administration.

*"Kennedy's comptroller of the currency, James J. Saxon, had been at odds with the powerful Federal Reserve Board for some time, encouraging broader investment and lending powers for banks that were not part of the Federal Reserve System. Saxon also had decided that non-Reserve banks could underwrite state and local general obligation bonds, again weakening the dominant Federal Reserve banks."*

...

*"According to information from the Library of the Comptroller of the Currency, Executive Order 11,110 remains in effect today, although successive administrations beginning with that of President Lyndon Johnson apparently have simply ignored it and instead returned to the practice of paying interest on Federal Reserve notes."*

— Jim Marrs, in his book Crossfire published in 1990.

Abraham Lincoln prevented private entities to fund the Union armies by issuing an executive order allowing the Federation to print greenbacks (first issued in 1862) to fund the Civil War and died years later, after being shot to the back of his head. James A. Garfield was trying to have the greenbacks reinstated, so the government could, in time of need, especially before and during a war, make use of variability of the inflatable paper currency rather than rely on private individuals who would offer to provide the same, only with interest rates binding the nation to a privately owned bank, through the law and enforcement of the government, so ensuring that the payments of interest will be paid. William McKinley tried to limit power of

the central banking model present in his time and John F. Kennedy wanted the government to return to issuance of its own interest free currency, by issuing the instated red seal notes.

In 1864, when Abraham Lincoln, the first republican president ran for reelection, he formed a bipartisan electoral alliance by selecting democrat Andrew Johnson as his running mate on the National Union Party ticket. In 1960, democrat nominee J. F. Kennedy decided to choose Lyndon Baines Johnson from the conservative camp to run with him as the vice president. In 1868, Andrew Johnson, under suspicion for complicity in the Lincoln assassination, escaped impeachment by one vote and handed over the presidency on March 4, 1869. In the coming century, president Lyndon Baines Johnson would quit his political career under the suspicion of complicity in Kennedy's assassination with the end of his presidency on January 20, 1969.

In 1968, in a Minnesota court case, the defendant, Jerome Daly was opposing foreclosure of his home by the First National Bank of Montgomery, which provided the loan to purchase it. The plaintiff, the bank, appeared by its president Lawrence V. Morgan and was represented by its counsel R. Mellby. The defendant argued the mortgage contract required both parties, being he and the bank, each put up a legitimate form of property for the exchange, or what is in law called consideration, an equivalent compensation that makes a contracting party to enter into an agreement. Jerome Daly claimed that the money were not the property of the bank as they came to existence with or after signing the loan agreement. The issues tried by the jury were whether there was a lawful consideration and whether the defendant had not waived his right to complain about the consideration, having paid on the note for almost 3 years. Plaintiff admitted that in combination with the Federal Reserve Bank of Minneapolis, did create the money or credit upon its own books by a bookkeeping entry and that this was the consideration used to support the note and the mortgage. The money and credit first came into existence when they created it. Mr. Morgan admitted that no United States law existed that gave him the right to do it. Plaintiff further claimed that defendant, by using the ledger book created the credit, and by paying on the note and mortgage waived any right to complain about the consideration.

Later that day on December 7, 1968, members of the jury returned a unanimous verdict for the defendant and the judge ruled the note and mortgage null and void because of failure of a lawful consideration. No complaint was made that the plaintiff had not received a fair trial. Martin Vincent Mahoney, justice of the peace (the judge), wrote a memorandum in support of the judgment. The jury and the judge refused to recognize the credit offered by the bank in the loan agreement as a legitimate consideration even though defendant entered into the loan agreement voluntarily. The plaintiff filed a notice of appeal within 10 days. In order for the appeal to be effective, the plaintiff had to deposit \$2.00 with the clerk within 10 days for payment to the justice of the peace, when he made his return to the district court. The bank deposited two \$1.00 Federal Reserve notes. On January 6, 1969, justice Martin V. Mahoney filed a notice of refusal to allow the appeal as the notes beared no promise to pay, and were not redeemable in gold or silver coin. Being bound by oath to uphold the Constitution of the United States and the Constitution and laws of Minnesota, he continued in a memorandum that he was not justified to accept the notes and take further steps toward the allowance of the appeal, saying that the notes were not a legal tender to pay any debt under the Article I, Section 10 of the U.S. Constitution; "*No State Shall make any Thing but gold and silver Coin a Tender in Payment of Debts*". The clerk of the district court is an officer of the judicial branch of the state of Minnesota, his act is an act of the state of Minnesota. A reference was made

to case *Briscoe et al v. The Bank of the Commonwealth of Kentucky*, 11 Peters Reports, page 319, "A State can act only through its agents; and it would be absurd to say that any act was not done by a State which was done by its authorized agents." The justice continued, he was ready and willing to reverse the determination to not allow the appeal if plaintiff filed a brief on the law and the facts with the court within 10 days, or if plaintiff filed for and proved in a hearing before the court on the determination, that the said notes are lawful money issued in pursuance of and under the authority of the Constitution of the United States of America.

The court further found, from the evidence introduced on January 22, 1969, that from 1913 down to date, the Federal Reserve banks and the National banks have been privately owned and as of March 18, 1968, gold or silver backing was removed from the said Federal Reserve notes. They were fiat money, neither backed by gold or silver coin nor redeemable in specie.

A note in legal language means, a promise to pay, as a promissory note, but Federal Reserve notes have not contained a promise to anything of weighty value, as were the notes prior to 1913, which were redeemable gold and silver certificates. Federal Reserve notes are nothing but pieces of paper money notes, or cotton or what they are made of. They are through the act of Congress that vested power into a private, independent agency, declared legal tender just as standardised gold or silver coin or specie, but not convertible to them at a fixed ratio.

The judge recognized the defendant could be charged with a waiver or estoppel as a matter of law, since he was denying weight of a consideration he had subsidized with a promissory note from his own will and paid on the note for almost three years, therefore was now as a defendant, contradicting his own previous actions, but the judge concluded the jury had not found the consideration offered by the bank lawful, and neither did he, so the contract was null and void even though the defendant had no defense, neither had the plaintiff the claim.

The Credit River decision did not set legal precedent, supposedly, because it was undertaken by a lesser, justice of the peace court, and if the decision was overruled, it was done so after the demise of the justice, since he recognized as a judicial agent of the state he did not have the authority under the United States Constitution, to accept the Federal Reserve notes as a legal tender, therefore the plaintiff did not comply with the terms required to file a notice of appeal within 10 days and the judgment of the jury and decision of the justice remain as the valid ruling of the Credit River district court. More is written in the available, case transcript, according to which Martin V. Mahoney stated and quoted on January 30, 1969:

*"Nothing on the Constitution or laws of the United States limits the jurisdiction of this Court. The Constitution of Minnesota does not limit the jurisdiction of this Court. It therefore has complete Jurisdiction to render justice in this cause in accordance with and agreeable to the Supreme Law of the Land. See 16 Am. Jur. 2d on Constitutional Law Sections 210 thru 222.*

*'When a Court is created by Act of the Legislature the Judicial Power is conferred by the Constitution and not by the Act creating the Court. If its Jurisdiction is to be limited it must be limited by the Constitution.' See Minn, Const. 'Bill of Rights'; In any event the Bank has not raised any question as to the jurisdiction of this Court."*

The judge recognized that state of Minnesota cannot limit or impair the power of the court to render complete justice. The truth is courts should not accept a fiat currency as legal

tender for a payment of debt as long they function under the U.S. Constitution, but under the law of the separate government created by the Act of 1871, the Federal Reserve notes can be accepted and the oaths judges make are but a charade of those who are aware. The U.S. Constitution has not prohibited the Congress to enact the Federal Reserve Act. The A1 S10, Clause 1 of the U.S. Constitution uses term "State", the terms states and Congress are used as two distinct words within the Constitution, but the Federal Reserve is an agency, a new word not used in the Constitution and contrived likely quite later, which is independent from Congress and is not under the law of any United States, as it should be located, the management, in Washington, D.C. (District of Columbia), which is not part of the United States, neither is subject, nor answers to the U.S. Constitution. It is a separate state as is Vatican surrounded by Italy, and then there is the third state similar to them, which completes the trinity, or what is also called the Empire of the City, the three City States, although geographically separate, but considered as one interlocking Empire. The Federal Reserve notes used within the United States and abroad, are the notes of the District of Columbia, not of any of the 50 United States. The 23rd Amendment ratified March 29, 1961, granted the District of Columbia electors in the Electoral College, while the approved by U.S. Congress, but unratified by the states, District of Columbia Voting Rights Amendment would have treated the District of Columbia as a state of the United States (including repealing the 23rd Amendment), but the ratification period, supposedly, ended on August 22, 1985, and that the amendment failed. As long it was in pending state, it likely had power in the District of Columbia sweating, as the area houses both the Federal Reserve Board and the Capitol Building, and ratification would make the Federal Reserve notes unconstitutional. There is total of 33 constitutional amendments approved by Congress and sent to the states for ratification since March 4, 1789, of which 27 have been ratified by the requisite number of states (which is set to 38 since 1959), and are part of the United States Constitution.

The United States Constitution does not legitimize, nor outlaws the matter of the Federal Reserve notes as used within the United States by private entities, but it does in case of the individual states. The use is neither permitted, nor prohibited. It is not addressed at all. That is some entomology. The notes are issued within Washington, D.C. and fall under the law of the separate corporate government of the District of Columbia, created by the Act of 1871, under the law of the forum or court, *lex fori*. And so when Federal courts accept the notes, they do not operate under the authority of the United States, but under the law of the city state, which some even referred to as the United States Corporation. Jordan Maxwell has, after explaining references of few words and terms (by bending them in a way sufficient to make paraphrasing needless), also stated, without anything to support it, that the U.S. have been under the international maritime law, or admiralty law since 1868. Maritime admiralty is the law of water or law of the high seas, superior to the law of the land, *lex terræ*, which the U.S. Constitution, under the Article V, declares itself, and so on to be. Corporation or not corporation, whatever it is called does not change how it functions, and governments have income and expenses just as any company, only with means to enforce higher privileges.

When a bank makes a loan, what it does is to accept promissory note in exchange for credits to the borrower's transaction account. The credit, the money created are given to borrower in exchange for the promise to pay the specific amount, plus interest. Banks grant money to borrowers under condition the money added to borrowers' transaction accounts are initially property of a bank, and become negative value after being withdrawn by borrowers, or also known as debt. When banks charge interest on loans, it makes for the assumption that they

actually put up money out of their own reserves, or rather out of the reserves of depositors. Reserves are unchanged by the loan transactions. The new money or deposit credits created only add to the total money or deposits of the entire banking system.

Mortgage is a loan agreement with the condition of conveyance of property as security that the debt will be repaid. A borrower exchanges real property for money or credit provided by a bank as security to repay the debt with condition that when the debt is repaid conveyance of the possession right shall be void. Inflation happens when banks provide loans, to private entities or governments, of sufficient value, and then when interest rates rise, lending slows down and money in the circulation decrease causing deflation, because the past loans don't change along the volume of the currency, the borrowers now under new decreased amount of money supply fail to pay their debts on loans and banks claim their right to the property. Interest rate set by the Federal Reserve, interest rate of the twelve regional Federal Reserve banks determines interest rates of all commercial banks operating under their authority.

*"...contrived to present the matter of loans to them in such a light that they have even seen in them an advantage for themselves."*

Furthermore, the justice has mentioned: *"Slavery and all its incidents including Peonage, thralldom, and debt created by fraud is universally prohibited in the United States."*

Article XIII (13th Amendment - Slavery and Involuntary Servitude) states: *"Neither slavery nor involuntary servitude, except as a punishment for crime whereof the party shall have been duly convicted, shall exist within the United States, or any place subject to their jurisdiction."* Although the founding fathers understood implications of paper money used in Great Britain, which use have spread over to Europe, and so did men holding high offices of the government at the time of ratification of the amendment (December 6, 1865; proposed on January 31), the article has not explicitly held debt as a form of slavery nor defined fraud.

Likewise Article 1 Section 10 Clause 1 had not outlawed use of greenbacks as money except prohibiting the individual states from such actions. It is up to individual to decide whether a bank offers equal value in exchange for work or property, in truth, repaying fiat money with interest is not slavery. To those who think printing of notes or granting of credit is according and equal to the value of a property, or work over a period they gather finances to pay back the debt, it is not. That is what promissory notes are, promises to pay, to work, to get funds needed to repay the loan. A borrower which has no need to work, has money, and therefor is not a borrower.

*...tHe borrower is servant to the lender.*  
— Proverbs 22.7

The borrowers gain advantage over everyone else that do not borrow money, as in business money is power, but the power acquired by the banks, to which they have become bonded, is greater, and so is power of the regional Federal Reserve banks greater over power gained by the commercial banks. A system in which saving is discouraged by inflation and spending encouraged, while it is necessary to keep borrowing more.

A company which conducts business distinct to that conducted by any bank, has to create or

acquire resources rather, in order to have a chance, to be able to compete and keep up with the terms under which banking institutions acquire wealth. A privately owned industry, such as any oil company privatising natural resources may be able to compete with its income for a time, but unlike most of material counterparts, money can be produced under unimpeded conditions as long loans are made and indefinitely. Banks still create wealth for themselves, they just, most of the time, need a borrower willing to work to trigger the gain. The Federal Reserve System is at the top of the pyramid. The money issued and given to a slave are after being spent, sucked back to the top through payments of the debt. The Federal Reserve is a dam, or a spring of water, but the money given flow upward, or inside back to the source. In this way, because there is never enough money to pay off both the interest and debt, every note is a certificate of indebtedness and servitude to the system. Some even called the FRS, the Babylonian money magic system. Currency are money that are being inflated, which are created, which are granted to a borrower and flow back to the well. The quality of currency is mainly determined by the condition to who is restricted control over its issuance. Who do the people in charge of the system worship, can they be trusted how they use the surpluses.

Jerome Daly had been an attorney and was later disbarred by a decision of the Minnesota Supreme court, after he again brought the matter of the Federal Reserve notes before the courts. He was later also arrested and charged with criminal charges involving tax frauds. Has Jerome Daly kept his home, maybe for a little while, but ultimately, quite unlikely, as it after all, wasn't even his home. Justice Martin V. Mahoney was found dead in a fishing boat in June of 1969. The case is known as the Mahoney Credit River decision or also referred to as the First National Bank of Montgomery vs. Jerome Daly, or the 1968/69 Credit River case.

On August 15 1971, pressured by the Treasury, or by the Federal Reserve Board, or both, president Nixon suspended, temporarily, the gold exchange standard (the Bretton Woods promise system), by suspending (temporarily) the convertibility of the dollar into gold or other reserve assets, except in amounts and conditions determined to be in the interest of monetary stability, and in the best interest of the United States, in pursuit to protect the dollar from international speculators, i.e. those who wanted to withdraw gold for dollars under the Bretton Woods system, at \$35 for an ounce (in 1971!). In 1973 began the oil crisis and the petrodollar system was established. In 1974, it is said, the gold exchange standard was finally eliminated. Since then the American dollar became, officially, a fiat currency. Fiat in Latin means "let it be done", or "so be it". The notes were no longer convertible to gold at any Federal Reserve bank, if the notes ever were, (they had not written on them that they are gold or silver certificates), but they were still exchangeable and accepted by anyone else for goods (including gold) and services. Under the petrodollar system, the dollar reserves of the nations found their additional use as the sole medium of exchange used in transactions for an essential natural resource, at least for every country anyway, for oil, petroleum.

Other than that, the nations that accumulated their dollar reserves have been still investing the notes where they were accepted. Because the notes are created only in one place, others have to acquire them by providing something exchangeable for them, so that they are able to buy oil. The petrodollar system marks Saddam Hussein's proclamation that Iraq will no longer accept dollars for oil, because it does not want to deal in the currency of the enemy. Then began in Iraq forming forces, armed with weapons and ideology to overthrow Saddam's rule. The nation's military was used to retaliate the attacks, consequently Saddam Hussein was found guilty of using the military against the civilians, other nations intervened in the conflict,

and executed Saddam by hanging, without a trial. Euro is also a fiat currency, the only difference would be who has the privilege. Next thing you know, Saddam is down in hell with satan.

Later Muammar al-Qaddafi had a speech asking why Saddam was hanged and claiming that any leader in the Arab world could be next. The idea of the Islamic gold dinar was in essence revived when he made effort to unite the African continent with a single currency, what he called the African gold dinar. To use gold in exchange for oil and in other transactions would mean that other nations would have to come up with an actual value. It is an acceptable claim, when it was said that Libya became a threat to the financial security of mankind. The plan came to naught when insurrections began to emerge in Libya, in another revolutionary pursuit to liberate the nation. Libya's military happened to confront the armed rebels, then Qaddafi was found guilty of using his military against civilians, and later was defeated and died. Before NATO invaded Libya to pacify the regime, Libyans enjoyed the highest standard of living in Africa. Homes were considered a human right. Newly married couples received money to buy their own home, electricity was paid by the government, free for all people as was education, as was healthcare. When a Libyan bought a car, the government paid half of the price. New farmers were given land to use, a home, equipment, livestock and seeds. The Libyan central bank was state owned and all loans were interest free by law. After Qaddafi was deposed from his ruling position, one of the first acts done by the rebels was to create a new central bank. Qaddafi wrote his green book, might be the material that can make one understand what his vision was. Beside all the natural wealth that could be privatized, there were some assets in Iraq and Libya, what happened to Iraqi gold and the gold found in Libya after Qaddafi's demise (shrug).

Gold and silver reserves of the United States Treasury, which had backed the gold and silver certificates in the circulation before 1913, have been consequently removed, because of the need to fund wars, which money received through taxes alone at that time, could not cover, therefore the government had to expand its note or coin currency beyond the initial ratio at which they could be redeemed for gold or silver coin, so that the government had the ability to fund the war efforts. Sometimes it was needed more than other times. The notes supply began to increase as the consequence of funding the war efforts in World War I, then after currency fluctuations, the currency began to increase at a higher pace after 1934 to prepare and fund the efforts that fought in World War II. The government did not raise taxes, except the income tax, to pay the risen interest on the notes printed. Furthermore, increase of the currency imposed inflation as a tax on everyone who saved the notes during the periods of inflation. The currency supply began to rise again in 1971, after it has become apparent the total value of the currency was greater than what could be redeemed at the set ratio under the Bretton Woods system. The Korean War (1950-1953), the war between North and South Korea, aided by the United States and other members of the United Nations, has also led to increased deficit spending of the U.S. government. The fight was over who issued money in these countries, while at the same time, about transfer of wealth and population reduction.

The United Nations used the population in pursuit to establish one of their own new central banks, while profiting from the interest payments provided by the governments, which their central banks have already occupied. The Vietnam War, which was prolonged (1954-1975), fought by the communist armies of North Vietnam, supported by the Chinese government, against the armies of South Vietnam, who were supported by the United States, was as well

about the issuance of the currency in North Vietnam. It has been no secret for quite a while, which numerous public reports have supported, that the unprovoked attack, the 2nd attack, the Gulf of Tonkin incident of August 4 1964 has never occurred, that the Captain at the gulf reported what he was ordered to report, and that the information led to the Congress to pass the Gulf of Tonkin Resolution, which gave the president the authority to make war, without a declaration of war. Article 1 Section 8 Clause 11 of the U.S. Constitution gives Congress the power to declare war and Article 1 Section 10 Clause 3 bars individual states to engage in war without the consent of Congress, unless in imminent danger. There never was a declaration of war with North Vietnam. The question may also be what was the American navy still doing thousands of miles away from its shores.

The private central banking model, which started in England, has spread to almost all other countries since then. The only countries in the world, which still do not have a central bank to provide loans of fiat currency, at interest, to the respective local governments, are North Korea, Iran, and Cuba maybe has a privately owned central bank established by now, or not. In the year 2000, the list included Afghanistan, Iraq and Libya.

Central banks in all countries operate the same way. The central bank in each country is the legal entity that issues nation's currency and lends it, with interest, to government, or other private banks, or corporations in the country. When a government needs more money than it receives through taxes, the treasury department issues an IOU, a promise to pay, (literally representing 'I owe you'), or government bond, which is a bond issued by government with promise to pay periodic interest payments and to repay the face value on the maturity date, and forwards it to the nation's central bank. The central bank then causes the issue of credit in the value of the bond. The government receives the money created, and can be now used to pay government bills.

*"When you or I write a check, there must be sufficient funds in our accounts to cover the check. But when the Federal Reserve writes a check, there is no bank deposit on which that check is drawn. When the Federal Reserve writes a check, it is creating money."*

— Putting it Simply, the Public Services Department, Federal Reserve Bank of Boston, 1984.

Why there are pictures of United States presidents and founding fathers on the notes, which attempt to be a legal under a system some of them were opposed to, for all the rest of their lives. It creates the assumption the monetary system that has been in use within the United States has been in harmony with their vision of the dollar, and presumably in harmony with the United States Constitution. The past U.S. presidents; Thomas Jefferson, Andrew Jackson and Abraham Lincoln, all made efforts to prevent a private monopoly to issue money for use by, and within the states. Benjamin Franklin is pictured on the highest note issued for public circulation as he was one of the main and leading figures, which led to the separation of the thirteen American colonies from the Great Britain, consequently wrecking the use of money of the Kingdom by the colonies. The other obvious assumption is that they were not able to object to any proposals of being represented on the notes, even though, they are not really notes, they are just bills, certificates of debt, belonging to the Federal Reserve that has been owned out of England, by an entity, through the financial district of the inner City of London.

When a commercial bank in America provides a loan today, it still accepts a promissory note in exchange for credits. The bank receives the note, a promise to pay from the borrower and

creates a bond in the value of the note. The commercial bank then takes the bond to one of the Federal Reserve banks and they give them in return approximately 10 times the amount of the bond. Because money lent could be further invested, this way there isn't a chance for a savvy borrower to compete in the capital arena with any bank. But, the borrower has not received any money yet. The bank only created the bond, but it still had the promise to pay.

With the signature of the borrower, the promise to pay became an asset for the bank in the value of the money promised to be paid. The bank then takes the note to a wholesaler party and the wholesaler takes it to an aggregator or trustee and it is then sold to a trust, and 95% of the trust are in New York, so it is sold on Wall Street. The trust then files what is called an 8k filing with the Securities and Exchange Commission (SEC), and the security finds investors willing to invest into the note backed by the promise to pay, or mortgage when the loan is a mortgage loan. The investors are given, let's say, seven percent return on their investments, but the borrower pays maybe 8%, so the trust is earning money. The investors then receive their purchased investment certificates and the funds come backwards to the bank, and the bank through the federal agency provides the money for the loan or for the borrower to buy a house that will secure the mortgage. Additionally it should be noted that according to SEC rules, the trustee for the trust provides a pooling and services agreement including a clause, which causes the party to enter into an insurance contract, so when borrower fails to pay on the note or mortgage, insurance company would pay it. Therefore in case the borrower fails to pay within the period set in the insurance contract, the insurance triggers what is called a credit default swap and the trust gets the full amount of the note, regardless how much the borrower had paid on the note. The trust is also allowed by the Federal Reserve to leverage the amount of the asset 30 times. So in case of a failure of the borrower, the note is paid off by an insurance company, but what often happens is one of the parties may try to foreclose on the borrower to redeem the mortgage, and in that case the only borrowers able to stand in a courtroom are those who have enough knowledge or enough money to afford attorney. In 1909, allegedly only 9% of American homes were owned by banks through mortgages. In 2013 however, banks owned possession rights on more than 70% of the homes in America.

So the bank instead of providing the amount in the loan agreement, monetizes the promise to pay, the asset, through the Federal Reserve, and then sells the promise for a little less to a different party, and an aggregator passes it to a trustee and a trust, and they find through the SEC investors willing to invest into that security and provide the funds for the note, and in case the debtor fails to pay the promise some of the parties may attempt to foreclose the conveyance of the property backing the note. And in that case the bank, or the trust is most of the time successful. However in 1872, the U.S. Supreme Court ruled that if the mortgage and the note are separated, they are both null and void. So in case a loan is bifurcated, that is divided into two separate parts, the mortgage and the note are nullified, because the note is secured by the mortgage, therefor a party which is not the lender cannot claim lien to the property, and the insurance company insured unsecured note. So in court, the borrower has to provide information about the trust, who really has possession of the note, and evidence that the note was insured, and that is done through securitization and financial reports. The money mechanism under which insurance companies operate is likely also a story by itself. The court system serves for settling disputes between parties able to afford to play, not for the poor. The role of the federal courts, it seems, has also been to bar the lay populace from touching the established monetary system.

In the 70's, U.S. congressman Lawrence McDonald from Georgia made efforts against the international private money interests. His efforts ended on August 31, 1983, on the way to Seoul, South Korea to attend ceremonies of the 13th anniversary of the Mutual Defense Treaty, between the South Korea and the United States, when Korean Airlines 007 was "accidentally" shot down in Soviet airspace. Senator Jesse Helms of North Carolina, senator Steven Symms of Idaho, and representative Carroll J. Hubbard, Jr. of Kentucky were aboard sister flight KAL 015, which flew 15 minutes behind KAL 007. The Soviets insisted former U.S. president Richard Nixon was to have been seated next to Larry McDonald on KAL 007, but according to some sources it was CIA, which warned him not to go. Senator Henry John Heinz III and former senator John Goodwin Tower had served on senate banking and finance committees and were outspoken critics of the Federal Reserve. On April 4, 1991, 52-year old republican senator from Pennsylvania, Henry John Heinz III, crashed in Piper PA60 Aerostar after it collided with Bell 412 helicopter near Philadelphia. Burning wreckage fell down on the grounds of an elementary school nearby Lower Merion township. Two of the dead were children playing outside at noon recess. On April 5, 1991, a twin-engine commuter plane, Atlantic Southeast Airline 2311 flying from Atlanta, carrying 23 people, including former 65-year old republican senator John Tower from Texas, went down crashing and burning in a thickly wooded area within view of motorists on Interstate 95, a mile and a half short of the airport, killing everyone on board. An assassination attempt was also made on Reagan's life, he found out all income taxes were used to pay the national debt through the Internal Revenue Service (IRS), an agency independent from congress, bypassing the United States Treasury, and was through the Gold Commission re-examining the idea of returning to some form of gold standard. The commission was retracted after the assassination attempt.

*"I look at all the things that could have gone wrong that day—yet god controlled every circumstance. I believe he spared me for a purpose... I've made a decision to recommit the rest of my life, and the rest of my presidency, to god."*

— Ronald Reagan, 33rd governor of California who became to be 40th president of the United States (1981-1989).

If he was religious, then why did he stop the efforts. To those religious out there, the idea is things don't happen just because god said to himself; ah, now I feel like doing some evil, but because there's an ideal, and anything else holding it back or obstructing it causes suffering. The assumption that god is all good, is usually held by those who think they themselves are good. And can an order be established by only doing good. John F. Kennedy was allowed to become a candidate for the president, because the actions he was eventually making as the president, were not expected at the time by the people that helped him during the election. John Hinckley, Jr., Reagan's shooter has a picture from younger age as he is standing in front of the Ford's theatre, the theatre where Lincoln was assassinated. Did he know he will shoot a future U.S. president, sometimes things happen as a matter of a coincidence (providence), that he may have had many photos from his early life, while one of them happened to bear a significant statement into the future, but maybe he knew somehow, that may be possible.

On May 5, 2009, a congressional hearing, the Financial Services Subcommittee on Oversight and Investigations hearing was conducted, after the Federal Reserve extended \$9 trillion in credit for their own purposes. To put it in comparison, when Trump's administration rebuilt the whole military, \$3 trillion was used, as it was left rusting at the beginning of his term. It's fair to say he won some friends among the people working within the military industry, after

all, there was the expression saying the "military stands behind Trump." Alright, so it wasn't three trillions to rebuild the national defense, but \$2.2 trillion, as he stated during the State of the Union address, on February 4, 2020. It is less than hour and a half long address, which may be a good source to gain little understanding of what his administration was doing. So what has been the impetus for the Federal Reserve to extend for themselves such amount of credit. It is likely that the owners in charge of the central banks in countries all around the world, had already enough financial potential from harvesting interest payments provided by individual governments and private interest. The hearing did not find what the need was, because the bank is exempt from audit.

The supposed revolutions around the world which have transferred the issue of money from the hands of communist governments into private hands were just that, the people did not do anything. To once again clarify what money really is, it is a thing people decide to use as a medium of exchange. Why gold, silver and other precious metals were chosen as the final backing mediums of their certificates, is because they are hardly inflatable. The metals also, are not required in many spheres of life, therefore in them have no value, but so is paper. It is the rarity what gives it value, desire of the people living to own it increases the value, and so the amount of the people of the same thinking. It is the quantity, total weight of gold, silver or a different metal, that gives it value over, or under, other commodity. The problem is the people do not think in real values, that they have bought into the money thing, into the folie of earning and spending instead of working with the substances of the world in a reasonable way, expanding, but not improving, and lies are mistaken for truth, and truth for lies, and it is not even a great deal, and one is like the other even though vastly separated. Additionally, gold increases in value, and so any other commodity, as long its quantity does not increase along with the expanding commerce as a result of booming industry or population growing.

It is both the total value made up of quantity, and the conscious estimate of the beings that use the currency, which determine its value. There is enough leaves on the trees, that would make for a terrible currency that is replenished periodically. And so anything of quantity can be used as money. The danger of paper money is, simply, that someone can just print it, and buy everyone else for free, or for the sole expense of the printing. Those individuals are in a sense and reality, as long the society is receptive of the currency, real emperors and masters of money, or is it money that does all the work. Resources, properties, knowledge and labor are principal possessions money can buy, but cannot substitute for. Currency is money that flows, current-cy, inflated stream of money flowing back to its source from whence it came. The Federal Reserve notes are, in essence, negative values owed to the Greek temple on the Constitution avenue, tied with interest you don't have, tied to interest which does not exist.

Since the gold exchange standard has been nixed in 1971 or 74, the central bank reserves of the rest of the world holding the Federal Reserve notes (U.S. dollar), became unredeemable. The last value to retain their validity as a currency was oil, the fact that other countries had to hold the U.S. dollars and further acquire them, to be able to import oil as the petrodollar was the only currency accepted in transactions for oil, so the countries exporting oil could at least further invest them in the New York money market. Beside some lesser transactions to keep up with the expanding use of a currency, there is no desire on our part for new money to be created, it is only in time of war that inflation becomes an unpleasant consequence of a necessary funding. In this way, an easily inflatable fiat currency is superior to any precious metal being used as money by any nation, so in time of war the necessary money power can

be relegated to the nation's government in order to lift financial limits, therefore take use of natural resources for the purposes of warfare, to eliminate threats, at unimpeded condition.

One of the things a government can do during an inflation, is to issue recommendations that inform producers and resellers by what percentage should prices increase reflecting the real expansion of the currency, which the authority over the money issuance knows at all times. The amount by which prices increase merely follows shadow of the real amount of the new money created, the money that have made their way into circulation among general public, it is the amount of increase felt by the public, the true rise of a currency is greater as a result of a considerable delay at which new money become further transferred. Every nation could use a fiat currency within its borders to give more power to the nation's government for the larger benefit of nature preservation, and especially in time of need under imminent threat.

It may be little easier to file a tax return with a paperwork a person can understand without a greater deal of effort, when the money aggregated are invested into a forbearing purpose, instead of being tunneled through governments, to the banks, and to health care providers in exchange for their services, who with the privilege to receive them use them for purposes they see fit. Gold and precious metals can be in a unit of weight used in commerce between nations to settle debts under equal conditions. Any country, likely a country holding natural resources, could at will, return to a form of gold standard as a matter used in the payments for their exports. Those who hold gold could choose not to engage in this kind of transaction or would have to use their gold reserves, unless they have anything else to offer, it would be a one time expense. One good reason to back a fiat currency with bullets. But no matter the cost, fiat or sound money become rather worthless without resources that can be acquired in exchange for them. A government can subtract from a currency by simply ousting specific notes which have returned through taxes, and likely to couple it with a way to reduce prices.

There has been also held an established claim known as monetarism, saying that the rate of growth of the money supply is the principle cause of changes in inflation, economic growth, and unemployment. Unemployment likely is, caused by reduction of a money supply, when employers do not have enough money anymore to pay the wages. But the established claim was that monetarism is an economic theory, a myth. That's why if only the money could rain from the sky, we could finally all live a wealthy life. Putting it aside, moneys are mediums to transfer power, money don't do the work, and it is as well not the money who create riches.

So there has been a potential to accumulate forces behind the backs of the nations. It is that kind of a misplaced power to be cautious about. Order of Rainbow and Job's Daughters are examples of female youth organizations affiliated with masonic lodges, while there are some masonic organizations admitting both women and men. Degrees of Freemasonry are the standard recognized by various occult societies known, less known, or even unknown to the general public. There is the total of 33 degrees in regular Freemasonry with 33rd being honorary. 33, because one third.

The upper degrees then tend to open up doors into different orders, to take part in different rites. They are orders because the members are stacked precisely in order like pack of cards.

Freemasonry is god's social order and masons are god's minions. Freemasonry, Rosicrucianism, Mormonism and several other more known theological belief systems have their roots in ancient mystery religions of Babylon and Egypt. The Babylonian gnostic religious system was held by Pharisees during the times Jesus taught, but after Jerusalem fell to the Romans, the religious leaders of the Jews returned to Babylonia, which became the center of Judaism until they began to move into Europe in the Middle Ages. The military order of Knights Templar were the medieval bankers which during expeditions fought in Christ's name, but the doctrines they acquired were more elaborated.

Masonry is as well built on writings of the Pentateuch, Torah, the first five books chosen to constitute the Old Testament. The period of American Revolutionary War for Independence also represented a break off from the British lodges. What have changed since the Declaration of Independence is that the Federal Reserve has been established, and British Freemasonry regained in the states full control of the power that moves the world, which represented a key addition to the centralized money power in Europe. A pyremind scheme about exploiting those under you with deception, authority or force. The pyramid represents fire ascending to heaven. Fire is a purifying element as water. Every iniquity, cut, bruise or pain leading to us is a mathematical value that can be washed in fire. The pyramid at the back of one dollar Federal Reserve note has stones arranged in 13 rows, surrounded by inscriptions (13 and 17 letters); *Annuit Cœptis* (favors our undertakings) from above, and *Novus Ordo Seclorum* (New Order of the Ages) from below. The hexagram of the left obverse side of the Great Seal interconnects the inscriptions. The opposing right reverse side depicts the eagle with 33 feathers on each wing, and the head inclined toward his right hand, grasping a branch of 13 leaves and 13 olives, while in its left claw clutching 13 arrows, and bearing a shield with 13 bars and 12 lines. Blue is the sky and stained is the Earth. God is above and the devil below him. The beaklike mouth holds above a scroll with straight edges saying in 13 letters; *E Pluribus Unum* (Out of Many, One). The sacred emblem of the ancient initiates, composed out of 13 five-pointed stars, bursts through a cloud with 28 rays "above" the head of the phoenix. Out of both sides of the G-seal sticks out an ending of a tail with 13 sections, adding to the 4 separate pearl shapes with 5 pearls each, reaching to the center of the note, to the total of 46 pearls, representing every cell chromosome in the human body.

*"...What sign shewest thou unto us, seeing that thou doest these things? Jesus answered and said unto them, Destroy this temple, and in three days I will raise it up." — John 2.18-19; 20*  
*"...Forty and six years was this temple in building, and wilt thou rear it up in three days?"*

Believers were imposed with the assumption that religious buildings are the temples, while the temple has been the body and the place of worship at the temples. That is not the only verse in the Bible by any measure, even as pillaged and corrupted as the Bible is, that refers to human anatomy. The two sides of the Great Seal represent the pommel of the chapters placed atop each of the two pillars written about in the second book of Chronicles, or Kings. They are two sides of the same coin but the reverse side is the opposite of the obverse side. One eliminates the other. They are the poison and antidote, malady and remedy, death and life, lies and truth, retribution and redemption. Obverse side is sure end, but the reverse is a change of one's mind. The reverse side is the countering agent. Nullifier. The political parties are also divided into left and right, and their pursuits are not overly different from the aims symbolized by the sides of the seal. The lattice filament in the back is held by demon figures guarding the underworld, while the front of the note exhibits a small owl peeking out of the frame in the upper right corner and two spiders at the bottom of the note, which pertain to the Bohemian Grove phrase; *"Weaving spiders, come not here"*. Some other amounts on the bill refer to nature's geometry. The left eye upon the pyramid represents providence or god.

In the lobby of the Bank of America Corporate Center are three frescoes showing events to happen one after the other as they appear to portray themes of beginning, turmoil and final stage inducing a notion of common endeavor and awareness. The right side of the painting showcases a pyramid, a burning bush or a tree rather, a common woman on strings hanging in the confines of the world, the darkened sun and a staircase to heaven. Who knows what the man sitting on the lawn is doing. The dirty road ends in a dichromatic floor. It is not clear who the boy in dark blue is meant to represent, but taken out of the time space, his position and appearance as depicted resemble and seem to fit to Donald J. Trump. Do you recognize the individuals in the pit. The centerpiece is the image of transition and features a person in a protective suit, a soldier, but also a symbolic cluster of bodies. In the final fresco, land is at rest, the letters EQ could sign an earthquake, maybe symbolic, and the workers hold upright bright shovels, in a direction as against an oppressor. The paintings are bit more mysterious and less ominous than are the murals exhibited, or formerly exhibited at the Denver airport. It is not the only airport to depict an occult message which can be seen from the aerial view.

Swastika, with the arms bent in the direction as the one used during the Second World War is oriented in the opposite direction as compared to the symbol made from the consonants of the Hebrew god "YHWH", germanic Emanuel (der Gott mit uns) or Immanuel, god within. The cross oriented in opposite direction has also the opposite meaning to the life force, and it symbolizes return to god or back to god. Everytime a person is born into this world, one's journey of moving away from god begins. The floor in the south of Great hall depicts eclipse of the sun by a different celestial body. The paintings were on display on four separate murals. One of the paintings showcases a forest on fire, a dead whale, animals and plants that have gone extinct and ceased to exist, and three caskets containing a body of an African woman, an indigenous woman, and a girl holding the Bible and the yellow star used for the identification of Jews. It is said the city in the background was repainted throughout the years, but there is more to pinpoint. The title of that painting is peace and harmony with nature. The two other murals depict a transition from peace to war or genocide, and the last one shows the world reconciled. With all the theories that have emerged through the years, the Denver airport, or the DEN as they refer to themselves, took time in the past to address them in their own way. The cherry on top is the pale horse welcoming the incoming visitors. It is a 32 feet tall laminate statue with eyes that glow at night. How about that smile. There is also a symbolic set of pillars at the entrance to the temple church in New York.

Another place known for its demonstrative viewpoints is located in rural area near Elberton, Georgia, which is the place of a monument unveiled in 1980 known as Georgia Guidestones. The structure is composed out of the total of six granite stones, including 4 panels inscribed

on eight surfaces with 10 guidelines in the total of eight modern languages; English, Spanish, Swahili, Hindi, Hebrew, Arabic, Chinese and Russian. The capstone placed atop the pillar and four panels is inscribed on each of its cardinal sides with four ancient languages (Babylonian Cuneiform, Classical Greek, Sanskrit, Egyptian Hieroglyphs); *"Let these be guidestones to an Age of Reason"*. It is said the global population began to increase at a higher rate before the 18th century after surpassing the amount of five hundred million, but the increase may have been as well affected by aspects different from the population count. In the ground near the structure is placed an explanatory tablet covering a time capsule buried beneath, and listing the three astronomic features of the monument. The Guidebook includes additional details.

It would be better were we still in the 80's, but with what we know now, fairly independent, and with a lot of time on our hand.
